## **Results Announcement**

**For the nine months ended 31st December, 2002**

**Characteristics of the Growth Enterprise Market (“GEM”) of The Stock Exchange of Hong Kong Limited (the “Exchange”)**

GEM has been established as a market designed to accommodate companies to which a high investment risk may be attached. In particular, companies may list on GEM with neither a track record of profitability nor any obligation to forecast future profitability. Furthermore, there may be risks arising out of the emerging nature of companies listed on GEM and the business sectors or countries in which the companies operate. Prospective investors should be aware of the potential risks of investing in such companies and should make the decision to invest only after due and careful consideration. The greater risk profile and other characteristics of GEM mean that it is a market more suited to professional and other sophisticated investors.

### SUMMARY

- Turnover for the nine months ended 31st December, 2002 amounted to HK\$10,382,000.
- Loss attributable to shareholders amounted to HK\$3,082,000 corresponding to a basic loss per share of HK1.23 cents.

## 2 Taxation

No Hong Kong profits tax was provided for as the Group did not generate any assessable profits arising in and derived from Hong Kong for the nine months ended 31st December, 2002.

## 3 Loss per share

The calculation of basic loss per share is based on the loss attributable to the shareholders for the nine months and three months ended 31st December, 2002 of HK\$3,082,000 and HK\$389,000 respectively (nine months and three months ended 31st December, 2001: HK\$7,687,000 and HK\$4,064,000 respectively) and on the weighted average of 250,060,000 shares for the nine months and three months ended 31st December, 2002 (2001: 250,060,000 shares) in issue.

No diluted loss per share is presented as the outstanding share options were anti-dilutive.

## DIVIDEND

The board of directors of the Company does not recommend payment of dividend for the nine months ended 31st December, 2002 (nine months ended 31st December, 2001: Nil).

## MOVEMENT IN RESERVES

There were no movement in reserves for the Group for the nine months ended 31st December 2002 and 2001 other than the accumulated losses for the period amounted to HK\$3,082,000 (2001: HK\$7,687,000).

## REVIEW

The Group's turnover for the three months ended 31st December, 2002 were HK\$4,359,000, increased by 76.7% as compared with the corresponding period last year and by 19.6% as compared with that of three months ended 30th September 2002. Loss attributable to shareholders was approximately HK\$389,000 for the three months ended 31st December, 2002. The increased turnover and decreased loss reflect the Group's effort put in sales and marketing. During the period under review, the Group's sales force were strengthened with the joining of several additional sales executives who are highly experienced in the software industry. On the other hand, the success of the Group's cost controlling measures, such as salaries and headcounts freeze, also contributed to the improved results. Looking forward, there are still many difficulties ahead, the Group will also closely monitor and review its marketing plan and continue to invest in research on application of new technologies and development of new products to meet different market needs.

## DIRECTORS' AND CHIEF EXECUTIVES' INTERESTS IN SECURITIES

*Note: The 191,250,000 shares in the Company are beneficially owned by and registered in the name of Noble Class Group Limited. The entire issued share capital in Noble Class Group Limited is in turn held by Sunrise International (Holdings) Limited ("Sunrise"), a company incorporated in the Cayman Islands. Mr. Lau and his spouse, Mr. Lai, Mr. Wong, Mr. Fung Yiu Fai (Mr. Fung) and Mr. Yip Ho Pong (Mr. Yip) (both Mr. Fung and Mr. Yip were formerly executive directors of the Company) are the holders of all the issued non-voting redeemable and retractable preferred shares of Sunrise with the rights to a fixed 5% cumulative dividend and redemption at fixed redemption prices in the aggregate amount of HK\$9 million only. All the issued ordinary shares of Sunrise are held by Arawak Trust Company Limited, a corporate trustee of a discretionary trust, the discretionary objects of which include:*

*Each of Mr. Lau, Mr. Lai, Mr. Wong, Mr. Fung and Mr. Yip is therefore taken to have an interest in the 191,250,000 shares held by Noble Class Group Limited under the SDI Ordinance.*

Save as disclosed above, none of the Directors, chief executives or their associates had any interests in any securities of the Company or any of its associated corporations as defined in the SDI Ordinance.

## DIRECTORS' RIGHTS TO ACQUIRE SHARES OR DEBT SECURITIES AND OPTIONS GRANTED

The Company adopted a share option scheme on 1st August, 2000, pursuant to which it may grant options to full-time employees of the Group and including executive directors of the Company to subscribe for shares in the Company. As at 31st December, 2002, certain options had been granted to the following executive directors and full-time employees:

Save as disclosed above, at no time during the nine months ended 31st December, 2002 was the Company or any of its subsidiaries a party to any arrangements to enable any of the Company's Directors and chief executives or members of its management to acquire benefits by means of the acquisition of shares in, or debt securities (including debentures) of, the Company or any other body corporate.

Save as disclosed above, none of the Directors or chief executives, or their spouses or children under the age of 18 had any right to subscribe for the securities of the Company, or had exercised any such right during the nine months ended 31st December, 2002.

## SUBSTANTIAL SHAREHOLDERS

Other than the interests as disclosed above in respect of the Directors and their associates, as at 31st December, 2002, the register of substantial shareholders maintained under Section 16(1) of the SDI Ordinance shows that the Company had been notified of the following substantial shareholders' interests, being 10 percent or more of the Company's issued share capital.

Save as disclosed above, no other person was recorded in the register pursuant to Section 16(1) of the SDI Ordinance as having an interest in ten per cent or more of the issued share capital of the Company as at 31st December, 2002.

## COMPETING INTERESTS

None of the directors or the management shareholders of the Company (as defined under the GEM Listing Rules) had any interest in a business which competes or may compete with the business of the Group or had any other conflicts of interest with the Group.

## SPONSOR'S INTERESTS

As updated and notified by the Company's sponsor, Core Pacific – Yamaichi Capital Limited ("Core Pacific – Yamaichi"), neither Core Pacific – Yamaichi, nor its directors, employees or associates had any interest in the share capital of the Company as at 31st December, 2002 pursuant to Rules 6.35 and 18.63 of the GEM Listing Rules.

Pursuant to the sponsor agreement dated 11th August, 2000 entered into between the Company and Core Pacific - Yamaichi, Core Pacific - Yamaichi has received and will receive a fee for acting as the Company's retained sponsor for the period from 17th August, 2000 to 31st March, 2003 or until the sponsor agreement is terminated upon the terms and conditions set out therein.

## **AUDIT COMMITTEE**

The Company established an audit committee on 1st August 2000 with written terms of reference in compliance with the requirements as set out in Rules 5.23 and 5.24 of the GEM Listing Rules. The primary duties of the audit committee are to review and to provide supervision over the financial reporting process and internal control system of the Group. The audit committee comprises the two independent non-executive directors, Mr. Chan Wai Choi, Glenn and Ms. Kwan Ngan Hing, Edith and an executive director, Mr. Wong Kit Mei. The Group's unaudited results for the nine months ended 31st December, 2002 have been reviewed by the audit committee. Members of the committee were of the opinion that the preparation of such results complied with applicable accounting standards, requirements of the Exchange and legal requirements and that adequate disclosures had been made.

## **PURCHASE, SALE OR REDEMPTION OF SECURITIES**

During the nine months ended 31st December, 2002, neither the Company nor any of its holding companies or subsidiaries purchased, sold or redeemed any listed securities of the Company.

## **BOARD PRACTICES AND PROCEDURES**

Throughout the nine months ended 31st December, 2002, the Company has complied with rules 5.28 to 5.39 of the GEM Listing Rules concerning board practices and procedures. None of the independent non-executive directors have been paid any fees or other reimbursements or emoluments during the period.
