The expected loss was mainly due to the decrease in turnover and overall profitability of the Group as a result of the global economic downturn.

The Company has proceeded to prepare its annual results for the year ended 31 March 2009. The overall financial results of the Group for the year ended 31 March 2009 will only be ascertained when the financial results of the Group are finalised. Details of the Group’s performance will be disclosed as and when the final results for the financial year ended 31 March 2009 are announced.
