The Board wishes to inform the shareholders of the Company and potential investors that the results of the Group for the three months ended 30 June 2010 is expected to record a further loss as compared to a loss for the three months ended 30 June 2009 based on assessment of the current unaudited financial information available.

This announcement is made by Rojam Entertainment Holdings Limited (the “Company”, and together with its subsidiaries, the “Group”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

The board of directors of the Company (the “Board”) wishes to inform the shareholders of the Company and potential investors that it expects that the results of the Group for the three months ended 30 June 2010 will record a further loss as compared to a loss for the three months ended 30 June 2009. Such expected loss is mainly attributable to the further drop in turnover due to fierce competition in the industry and increase in operating expenses incurred for development of existing and potential new business.

Information contained in this announcement is only the preliminary assessment by the management of the Company based on the unaudited management accounts of the Group for the three months ended 30 June 2010 and the current information available, which have not been confirmed by the Company's auditors. Further details of the Group's financial information will be disclosed in the unaudited quarterly results of the Group for the three months ended 30 June 2010 to be published on 13 August 2010.
