The Company has entered into the Sale and Purchase Agreement on 7 January 2011, a supplemental agreement on 29 June 2011 and a second supplemental agreement on 23 December 2011 (as disclosed in the Company's announcements dated 7 January 2011, 29 June 2011 and 23 December 2011 respectively), pursuant to which the Company will issue convertible bonds in the principal amount of HK\$113,740,000. Based on the initial conversion price of HK\$0.04 per conversion share (subject to adjustment), an aggregate of 2,843,500,000 new shares will be allotted and issued upon exercise of the conversion rights attached to the convertible bonds. Completion of the agreement is subject to the terms and conditions as set out in the announcement. Reference is made to the announcement made by the Company on 7 January 2011, 7 March 2011, 31 May 2011, 29 June 2011 and 23 December 2011 in relation to the Acquisition.
