#### 1. GENERAL

Orient Securities International Holdings Limited (the "Company") was incorporated and registered as an exempted company with limited liability on 5 January 2009 under the Companies Law of the Cayman Islands and acts as an investment holding company. Its shares are listed on the Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 15 January 2014. The Company's registered office address is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands and the principal place of business of the Company is Rooms 2801-2804, 28th Floor, Dah Sing Financial Centre, No. 108 Gloucester Road, Wanchai, Hong Kong. #### 2. BASIS OF PREPARATION AND SIGNIFICANT ACCOUNTING POLICIES

The Group's unaudited condensed consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards ("HKAS") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinances. The unaudited condensed consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the GEM of the Stock Exchange.

The unaudited condensed consolidated financial statements have been prepared in accordance with the same accounting policies adopted in the 2013 annual financial statements except for the adoption of the standards, amendments and interpretation issued by the HKICPA mandatory for the annual periods beginning on 1 January 2014. The effect of the adoption of these standards, amendments and interpretation is not material on these unaudited condensed consolidated financial statements.

#### 2. BASIS OF PREPARATION AND SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### a) Business combinations

The unaudited condensed consolidated financial statements incorporate the financial statements items of the combining entities in which the common control combination occurs as if they had been combined from the date when the combining entities first came under the control of the controlling party.

The unaudited condensed consolidated financial statements include the results of each of the combining entities from the earliest date presented or since the date when the combining entities first came under the common control, where this is a shorter period, regardless of the date of the common control combination.

The comparative amounts in the unaudited condensed consolidated financial statements are presented as if the entities had been combined at the end of the previous reporting period or when they first came under common control, whichever is shorter.

#### b) Basis of preparation of the unaudited condensed consolidated financial information

The unaudited condensed consolidated financial statements for the three months and nine months period ended 30 September 2014 comprises the Company and its subsidiaries.

Items included in the financial statements of each entity in the Group are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The unaudited condensed consolidated financial statements is presented in Hong Kong dollars ("HKD"), rounded to the nearest thousand except for per share data. Hong Kong dollar is the Company's functional and the Group's presentation currency.

The measurement basis used in the preparation of the unaudited condensed consolidated financial statements is the historical cost basis.

The preparation of unaudited condensed consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying amounts of assets and liabilities not readily apparent from other sources. Actual results may differ from these estimates.

## MANAGEMENT DISCUSSION AND ANALYSIS

#### **BUSINESS REVIEW AND OUTLOOK**

The Group is principally engaged in the provision of (i) brokerage service; (ii) underwriting and placing service; and (iii) financing service.

The Group was successfully listed on GEM on 15 January 2014. The proceeds received have strengthened the Group's cash flow and the Group was focusing on developing existing business services by utilizing own networks and new opportunities such as Shanghai-Hong Kong Stock Connect program, a securities trading and clearing links programme between the Mainland and Hong Kong.

Specifically to the third quarter, the Group has completed the placing of its new 60,000,000 shares to independent third parties on 14 October 2014 at the price of HK\$0.98 per share and raised HK\$58.8 million before deducting all direct costs including commission. Proceeds from placing can further strengthen the cash position of the Group including enhancing the capacity of providing financing services to clients or providing underwriting service with a larger commitment.

Commission income from brokerage services increased as compared to corresponding period in 2013. The increase is generally in line with the increase in turnover value for securities traded on the Stock Exchange. Interest income from financing service remains stable. Commission income from underwriting and placing remain volatile. The business activities of various industries may slow down and the demand on brokerage services and underwriting and placing services may be impacted. The management of the Group will get prepared for keen competition business environment in order to maximise the shareholders' return.

The Group's revenue is mainly generated from (i) commission income from the brokerage service; (ii) commission income from the underwriting and placing service; and (iii) interest income from the financing service.



## MANAGEMENT DISCUSSION AND ANALYSIS

The turnover for the first nine months in 2014 was approximately HK\$22.2 million (2013: HK\$24.0 million) which represents a HK\$1.8 million or 7.5% decrease. Such drop was mainly due to the decrease in commission income from underwriting and placing service by HK\$5.7 million even there was an increase in commission income from brokerage service by HK\$3.6 million.

As at 30 September 2014, the Group had 841 active securities accounts as reported pursuant to Securities and Futures (Financial Resources) Rules (Cap 571N) (2013: 767 active securities accounts).

For the first nine months ended 30 September 2014, the Group had undertaken 19 placing and underwriting transactions as compared to 16 transactions for the same period in 2013. Similar to the situation as described in the 2014 interim report, the scale of placing and underwriting transactions carried out during the corresponding period in 2013 were relatively large such that despite the number of transaction was higher in 2014, the commission income from underwriting and placing service during the first nine months ended 30 September 2014 was lower than the corresponding period in 2013. Notwithstanding the drop in commission income from underwriting and placing service, the Board is confident that revenue attributable to this segment will regain its ground and continue to grow, in particular, following the provision of placing services in October 2014 to a company listed on GEM.

Interest rates charged by the Group to customers remained at similar level, and the interest income remained stable. Funds available to the Group has been enlarged by proceeds of placing in January and October 2014 and the Group has greater capacity to provide financing service and underwriting service should opportunity be identified.

As stated in the section headed "Recent development" and "Risk factors" in the prospectus of the Company dated 31 December 2013 ("Prospectus"), the financial performance as well as revenue mix of the Group may continue to change depending on the stock market environment. Brokerage income will continue to be directly correlated with the overall stock market trading volume while underwriting and placing income to market fund raising activities the number of underwriting and placing exercises the Group can be involved in and/or the size of fund the customers intended to raise. Such external factors are beyond the Group's control and the Group's financial performance is susceptible to fluctuation as a result.

#### **Profit for the period**

The drop of profit from operation for the first nine months ended 30 September 2014 was approximately HK\$4.9 million or 31.4% as compared with the corresponding period in 2013 and was mainly attributable to the drop of turnover by HK\$1.8 million, in addition to the respective increase in staff cost and administrative expenses by approximately HK\$1.5 million and HK\$1.6 million as compared to the corresponding period in 2013. Increase in staff cost was mainly attributable to the brokerage sharing arrangement and was in line with the Group's increase in commission income from brokerage service, and increase in administrative expenses was mainly attributable to increase in compliance cost upon listing.

The Group also incurred approximately HK\$3.9 million listing expenses for the first nine months ended 30 September 2014, which represents a HK\$2.7 million or 2.16 times increase as compared with the corresponding period in 2013.

## MANAGEMENT DISCUSSION AND ANALYSIS

#### LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

During the nine months ended 30 September 2014, the Group financed its operations by cash flow from operating activities and proceeds from listing. As at 30 September 2014, the Group had net current assets of approximately HK\$175.7 million (2013: HK\$130.9 million), including cash of approximately HK\$209.8 million (2013: HK\$96.5 million).

The current ratio, being the ratio of current assets to current liabilities, was approximately 2.9 times as at 30 September 2014 (2013: 3.3 times). The decline in the current ratio was mainly attributable to the 64.4% increase in payables to cash clients and margin clients and clearing house as at 30 September 2014 as compared to 2013. Given the nature of the Group's operation, the amount of trade payables and trade receivables are volatile depending on the scale and number of transaction, and the amount to be paid to / received from customers and clearing house on the period end date.

The capital of the Group comprises only ordinary shares. Total equity attributable to owners of the Company amounted to approximately HK\$176.5 million as at 30 September 2014 (2013: HK\$131.6 million).

#### **EMPLOYEE INFORMATION**

Total remuneration for the nine months ended 30 September 2014 (including directors' emoluments and commission paid to staff and directors excluding MPF contributions) was approximately HK\$5.6 million (2013: HK\$4.1 million). Such increase was mainly due to the increase in directors' emoluments (effective from the date of listing on 15 January 2014) and staff salaries.

The share option scheme enables the Company to grant options to any full-time or part-time employee of the Company or any member of the Group (the "Eligible Participant") as incentives or rewards for their contributions to the Group, the Company conditionally adopted a share option scheme (the "Scheme") on 19 December 2013 whereby the Board are authorised, at their absolute discretion and subject to the terms of the Scheme, to grant options to subscribe for the shares of the Company to the Eligible Participant. The Scheme will be valid and effective for a period of ten years commencing from the date of adoption of the Scheme.

As at the date of this report, the total number of shares available for issue under the Scheme is 30,000,000 shares, representing 8.3% of the issued share capital of the Company.

Upon acceptance of an option to subscribe for shares granted pursuant to the Scheme (the "Option"), the Eligible Participant shall pay HK\$ 1.00 to the Company by way of consideration for the grant. The Option will be offered for acceptance for a period of 28 days from the date on which the Option is granted. The subscription price for the shares subject to Options will be a price determined by the Board and notified to each participant and shall be the highest of: (i) the closing price of the shares as stated in the Stock Exchange's daily quotations sheet on the date of grant of the Options, which must be a day on which trading of shares take place on the Stock Exchange (the "Trading Day"); (ii) the average closing price of the shares as stated in the Stock Exchange's daily quotations sheets for the 5 Trading Days immediately preceding the date of grant of the Options; and (iii) the nominal value of a share.

The Company shall be entitled to issue options, provided that the total number of shares which may be issued upon exercise of all options to be granted under the Scheme does not exceed 10% of the shares in issue from the Listing Date. The Company may at any time refresh such limit, subject to the shareholders' approval and issue of a circular in compliance with the GEM Listing Rules, provided that the total number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under all the share option schemes of the Company does not exceed 30% of the shares in issue at the time. An option may be exercised in accordance with the terms of the Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof.

As at the date of this report and since the adoption of the Scheme, no share option has been granted by the Company.

#### **RIGHTS TO ACQUIRE SHARES OR DEBENTURES**

Save as disclosed above, at no time during the nine months ended 30 September 2014 was the Company or any of its subsidiaries a party to any arrangements to enable the Directors to acquire benefits by means of the acquisition of Shares in, or debentures of, the Company or any other body corporate.

Save as disclosed above, at no time during the nine months ended 30 September 2014 had the Directors and the Chief Executives (including their spouses and children under 18 years of age) any interest in, or been granted, or exercised any rights to subscribe for the Shares (or warrants or debentures, if applicable) and its associated corporations (within the meaning of the SFO).

#### **COMPETING INTERESTS**

As at 30 September 2014, none of the Directors, the substantial Shareholders and their respective associates (as defined in the GEM Listing Rules) had any interest in a business which competes or is likely to compete, either directly or indirectly, with the business of the Group.

#### **COMPLIANCE ADVISER'S INTERESTS**

As at 30 September 2014, neither Altus Capital Limited, the compliance adviser of the Company, nor any of its directors, employees or associates had any interests in the securities of the Company or any other companies of the Group (including options or rights to subscribe for such securities) pursuant to rule 6A.32 of GEM Listing Rules.

#### **DIRECTORS' SECURITIES TRANSACTIONS**

The Company has adopted the required standard of dealings set out in rules 5.48 to 5.67 of the GEM Listing Rules as the code of conduct for dealing in securities of the Company by the Directors. The Company had made specific enquiries of all the Directors and the Directors have confirmed they had complied with the Required Standard of Dealings throughout the nine months ended 30 September 2014.

#### PURCHASE, SALE OR REDEMPTION OF SHARES

During the nine months ended 30 September 2014, neither the Company nor any of its subsidiaries had purchased, sold or redeemed any of the Company's listed securities.

#### **COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE**

The Company is committed to achieving high standards of corporate governance to safeguard the interests of the Shareholders and enhance its corporate value. The Company's corporate governance practices are based on the principles and code provisions as set out in the Corporate Governance Code in Appendix 15 to the GEM Listing Rules (the "**CG Code**").

Throughout the nine months ended 30 September 2014, to the best knowledge of the Board, the Company had complied with the code provisions in the CG Code, save for the deviation from the code provisions A.2.1 as explained below:

Pursuant to A.2.1 of the CG Code, the roles of Chairman and CEO should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and CEO should be clearly established and set out in writing.

Mr. Lam Shu Chung is the Chairman of the Board and is responsible for formulation of corporate strategy, overseeing the management of the Group and business development. The Chairman also takes the lead to ensure that the Board works effectively and acts in the best interest of the Company by encouraging the Directors to make active contributions to the Board's affairs and promoting a culture of openness and debate.

The Company has no such position as the CEO and therefore the daily operation and management of the Company is monitored by the executive Directors as well as the senior management.

The Board is of the view that although there is no CEO, the balance of power and authority is ensured by the operation of the Board, which comprises experienced individuals who would meet from time to time to discuss issues affecting operation of the Company and the Group.

#### AUDIT COMMITTEE

The Audit Committee has been established with written terms of reference in compliance with Rules 5.28 and 5.29 of the GEM Listing Rules and code provision C.3.3 of the CG Code. The Audit Committee currently comprises three independent non-executive Directors and is chaired by Mr. Lee Siu Leung. The other members are Mr. Choy Sze Chung Jojo and Mr. See Lee Seng Reason. The primary duty of the Audit Committee is to review and supervise the Company's financial reporting process, the internal control systems of the Group and the monitoring of continuing connected transactions. All members of the Audit Committee are appointed by the Board.



The Audit Committee had reviewed the unaudited consolidated results of the Group for the nine months ended 30 September 2014 and is of the opinion that such results complied with the applicable accounting standards, the requirements under the GEM Listing Rules and other applicable legal requirements, and that adequate disclosures had been made.
