On 10 May 2015, the Company entered into a subscription agreement with Aisidi (HK) Limited (the “Subscriber” and the “Subscription Agreement”, respectively), pursuant to which the Subscriber has conditionally agreed to subscribe for, and the Company has conditionally agreed to issue, 6% unsecured convertible bonds due 2018 in the aggregate principal amount of HK\$300,000,000 convertible into 115,384,615 shares at an initial conversion price of HK\$2.60 per share, subject to fulfillment or waiver of the conditions precedent set out in the Subscription Agreement.
