BUSINESS REVIEW

Overall Business of the Group in 2015

In 2015, the Group achieved the targets set at the beginning of the year and doubled the profits. The outstanding performance mainly came from our three key products, including the "Bank-Business Express", capital and risk control products, and banking outsourcing service products (merchant), and was complemented by the "Bank-Hospital Express" and "Bank-School Express".

As the structural reform of the financial market in China, the People's Bank of China tightened the capital requirements for commercial banks, and a standardized management approached was adopted for online and offline merchants and markets, creating new opportunities for our offerings. Meanwhile, our industry-leading R&D efforts and investment generated a positive return that surpassed our expectation, contributing to a continual growth in our overall performance in the last two years. The implementation of policies targeting the internet and related industries, and banking risk control products further highlighted the value of consolidating the online and offline markets of the core "Bank-Business Express". Our capital and risk control products also gained greater recognition by banks and financial institutions. 本人謹代表新利軟件(集團)股份有限公司(「本 公司」)之董事局(「董事局」),欣然提呈本公司 及其附屬公司(統稱「本集團」)截至二零一五 年十二月三十一日止年度之經審核財務業績。

業務回顧

本集團2015年整體業務情況

本集團2015年達成年初指標及盈利翻倍,主要 來源於集團的三大支柱產品一銀商通、銀行資 金風控產品、銀行外包服務產品(商戶),加上 銀醫通及銀校通業務產出的輔助。

隨著中國金融市場持續的結構性改革,包括人 民銀行對各商業銀行資金監管的加強、線上線 下商戶及收單市場更規範的管理,給集團相關 產品不斷帶來新的市場機遇。同時,不斷提前的 研發及投入得到正面、甚至超出預期的回報, 使過往2年整體業績持續上升。國家對互聯網+ 相關行業、銀行風控相關產品政策的進一步落 實,讓本已是支柱產品的銀商通線上線下相結 合的時代進一步體現其發展價值,資金風控產 品也更加得到銀行和金融機構的重視。

Chairman's Statement 主席報告

The Group entered into a strategic partnership agreement with ICBC Zhejiang branch, one of the flagship branches in China's banking network, in relation to the Offline to Online (O2O) business platform that serves merchants and cardholders in mid-2015. The platform extended its reach to other branches across the province upon completion of the pilot run. Leveraging our sensitivity to O2O market as well as our flexibility and understanding of the banking sector, the Group deepened the partnerships with various banks, manifesting the long-term value of the banking outsourcing service products (merchant). The new market trend will encourage merchants to adopt intelligent technologies and offer new opportunities to our products, especially the business platform serving the merchants.

FUTURE OUTLOOK

The banking outsourcing service products, business platform evolved from traditional operations and "Bank-School Express" remain our main sources of big data. With the help of these products, the Group will consolidate the big data and the online and offline businesses to form a unique O2O model. We also plan to extend the collaborative model of the business platform with ICBC Zhejiang branch to other commercial banks.

FINANCIAL REVIEW

The Group is principally engaged in the development and sales of information and network technologies and services to the financial industry in the People's Republic of China (the "PRC").

Revenue of the Group comprises of:

For the year ended 31 December 2015 ("the financial year"), the Group recorded a total revenue of approximately RMB55,819,000, an increase of 14% as compared to the year ended 31 December 2014 (2014: approximately RMB48,908,000).

財務回顧

本集團主要在中華人民共和國(「中國」)從事開 發及銷售有關金融業的信息、網絡科技及服務。

本集團的營業額包括:

截至二零一五年十二月三十一日止年度(「呈 報年度」),本集團錄得銷售收入約人民幣 55,819,000元,較去年同期增加約14%(二零 一四年:約人民幣48,908,000元)。

The increase in the turnover of the Group was mainly attributable to the increase of 23% in the revenue of the Group's provision of software-related technical support services when compared to the same period of last year. Cost of sales for the year ended 31 December 2015 increased to approximately RMB29,223,000 (2014: approximately RMB27,392,000). The Group's gross profit ratio increasing to 48% (2014: 44%) was mainly due to our effective cost control measures in the year.

本集團營業額增加主要由於本集團提供軟件相 關技術支援服務與去年同期比較增長約23%所 致。截至二零一五年十二月三十一日止年度,本 集團之銷售成本上升至約人民幣29,223,000元 (二零一四年:約人民幣27,392,000元)。本集 團之毛利率上升至48%(二零一四年:44%), 主要原因由於本集團於本期間實施了各項有效 的節流方案。

FINANCIAL REVIEW (Cont'd)

Administrative expenses for the year ended 31 December 2015 is increased by 9% to approximately RMB12,707,000 (2014: approximately RMB11,657,000). For the distribution and selling expenses, it is increased by 25% to RMB8,564,000 (2014: approximately RMB6,831,000). The increase in administrative expenses and distribution and selling expenses were mainly due to equity-settled share-based payment recognized during the year. Other administrative expenses and distribution and selling expenses do not have significant change due to our effective cost control measures. Other income included refund of value added tax, government grants subsidy related to products and interest income; and other gains and losses included exchange differences and fair value changes in investment fund.

Finance costs for the year ended 31 December 2015 was approximately RMB1,028,000, not much movement when compared to the same period of last year. (2014: approximately RMB957,000).

The Group recorded a profit of approximately RMB1,294,000 for the year ended 31 December 2015, representing a substantial improvement of the results of the Group as compared to the profit of approximately RMB571,000 for the year ended 31 December 2014. Increase in revenue is the main factors leading to the profit increased.

During the year ended 31 December 2015, the Company recorded equity-settled share-based payment of approximately RMB3,302,000 (2014: RMB592,000). The equity-settled share-based payment for the year ended 31 December 2015 was allocated between the cost of sales, distribution and selling expenses and administrative expenses amounting to RMB617,000, RMB525,000 and RMB2,160,000 respectively.

We will continue striving our best to increase sales and strengthen our cost control measures. With the products of our Group becoming more mature in the market and the effective cost control, we expect that financial results of the group would be further improved in the coming year.

財務回顧(續)

截至二零一五年十二月三十一日止年度,管理 費用約為人民幣12,707,000元(二零一四年:約 人民幣11,657,000元),上升9%。而分銷及銷 售費用約為人民幣8,564,000元(二零一四年:約人民幣6,831,000元),上升25%。管理費用 及分銷及銷售費用上升的主要原因是由於本年 度產生了股權結算以股份為基礎的開支。而由 於本集團實施了各項有效的節流方案,其他管 理費用及分銷及銷售費用並無顯著改變。其他 收入包括增值税返還、政府補貼相關產品及利 息收入。另外,其他收益及虧損包括匯兑變動及 持作買賣投資之公允值變動。

截至二零一五年十二月三十一日止年度,融資成 本約人民幣1,028,000元,與去年同期相約(二 零一四年:約人民幣957,000元)。

本集團於二零一五年十二月三十一日止年度 錄得盈利約為人民幣1,294,000元,較二零一四 年十二月三十一日止年度盈利淨額約人民幣 571,000元顯著改善。盈利增加主要原因為收入 增加。

截至二零一五年十二月三十一日止年度,本公 司之股權結算以股份為基礎付款約為人民幣 3,302,000元(截至二零一四年:人民幣592,000 元)。截至二零一五年十二月三十一日止年 度之股權結算以股份為基礎付款分別分佈人 民幣617,000元、人民幣525,000元及人民幣 2,160,000元在銷售成本、分銷及銷售費用及管 理費用。

本集團將繼續努力,於加大營銷力度的同時,將 繼續各項節流方案的實施。隨著本集團產品於 市場漸趨成熟,以及各項成本費用的控制,未來 一年的業績將會進一步改善。

LIQUIDITY, FINANCIAL RESOURCES AND GEARING RATIO

As at 31 December 2015, the Group's loans from a shareholder of approximately RMB43,164,000, which bear interest at 3.3% –3.5% per annum (2014: RMB37,068,000, which bear interest rate of 3.3% –3.5% per annum).

In addition, the Group has a new bank borrowing from a bank in the PRC with a principal amount of RMB3,000,000, which is unsecured, interest bearing at 4.02% per month.

No interest was capitalized by the Group during the year (2014: Nil).

As at 31 December 2015, the Group held cash and cash equivalents denominated in RMB, US dollars and HK dollars, amounted to approximately RMB18,901,000. (2014: approximately RMB12,217,000)

The gearing ratio of the Group, based on total liabilities over total assets, as at 31 December 2015 was approximately 108% (2014: 126%).

CAPITAL STRUCTURE

During the year, our employee exercised 3,250,000 share options granted on Jan 2010. Our director and employee exercised 4,000,000 and 16,450,000 share options respectively granted on June 2013. As at 31 December 2015, the total number of issued ordinary shares of the Company was 864,430,000 shares (2014: 840,730,000 shares).

ACQUISITION AND DISPOSALS OF SUBSIDIARIES AND AFFILIATED COMPANIES

On 15 April 2015, the Group de-registered a sino-foreign equity joint ventures established in the PRC, Singlee Zhuhai.

此外,本集團於中國一家銀行有一筆新的銀行 貸款,本金為人民幣3,000,000,該筆貸款並無 抵押,每月利息為百份之四點零二。

於本年度,本集團並無資本化利息(二零一四年:零)。

於二零一五年十二月三十一日,本集團持有人 民幣、美元及港元的現金及現金等價物約為 人民幣18,901,000元(二零一四年:約人民幣 12,217,000元)。

於二零一五年十二月三十一日,本集團資產負 債比率(界定為負債總額除以資產總額)約為 108%(二零一四年:126%)。

股本架構

於二零一五年十二月三十一日止年度,本集團 之員工行使了本集團於二零一零年一月授予 之3,250,000股購股權。本集團之董事及員工 分別行使了本集團於二零一三年六月授予之 4,000,000及16,450,000股購股權。因此,本公 司已發行之普通股份為合共864,430,000股(二 零一四年: 840,730,000股)。

附屬及關連公司收購及出售

於二零一五年四月十五日,本集團註銷了新利 軟件(珠海)有限公司,為在中國成立的中外合 資合營公司。

RISK MANAGEMENT

The Group has established and maintained sufficient risk management procedures to identify and control various types of risk within the organisation and the external environment with active management participation and effective internal control procedures in the best interest of the Group and its shareholders.

SEGMENTAL INFORMATION

Segmental information is presented for the Group as disclosed on note 6 of the notes to the consolidated financial statements.

EMPLOYEE INFORMATION

As at 31 December 2015, the Group had 270 employees (2014: 261 employees), including both the PRC and Hong Kong employees. Remuneration and bonus policy are basically determined by the performance of the individual employees and financial results of the Group. Total staff costs for the year amounted to approximately RMB25,496,000 (2014: RMB21,817,000).

The Group adopted a share option scheme, details of which were set out in the Report of the Directors.

CHARGE ON GROUP ASSETS

As at 31 December 2015, the Group did not have any charges on group assets.

FUTURE PLANS FOR MATERIAL INVESTMENTS AND EXPECTED SOURCE OF FUNDING

Details of the Group's future plans for material investments or capital assets and their expected source of funding have been stated in the Company's prospectus dated 30 August 2001 under the sections headed "Statement of Business Objectives" and "Reasons for the New Issue and Use of Proceeds" respectively.

The Group's revenue generating operations are mainly transacted in RMB. The directors consider the impact of foreign exchange exposure to the Group is minimal.

CONTINGENT LIABILITIES

As at 31 December 2015, the Group did not have any material contingent liabilities (2014: Nil).

ENVIRONMENTAL POLICY

Our commitment to protect the environment is well reflected by our continuous efforts in promoting green measures and awareness in our daily business operations. The Group encourages environmental protection and promote awareness towards environmental protection to the employees. The Group adheres to the principle of Recycling and Reducing. It implements green office practices such as double-sided printing and copying, setting up recycling bins, promoting using recycled paper and reducing energy consumption by switching off idle lightings and electrical appliance. The Group is also using office equipment carrying Energy Label issued by the Electrical and Mechanical Services Department which save energy in the offices.

The Group will review its environmental practices from time to time and will consider implementing further eco-friendly measures and practices in the operation of the Group's businesses to move towards adhering the 3Rs – Reduce, Recycle and Reuse and enhance environmental sustainability.

本集團在日常業務營運中不斷推廣綠色措施和 意識,以達到其保護環境的承諾。本集團鼓勵環 保,並推動僱員提升環保意識。本集團堅守循 環再用及減廢的原則,實施各項綠色辦公室措 施,例如雙面打印及複印、設置回收箱、提倡使 用環保紙及透過關掉閒置的電燈及電器以減少 耗能。本集團亦使用貼有機電工程署發出能源 標籤的辦公室設備,以在辦公室內節省能源。

本集團將不時檢討其環保工作,並將考慮在本 集團的業務營運中實施更多環保措施及慣例, 以堅守3R 原則(即減廢(Reduce)、再造(Recycle) 及再用(Reuse))為目標,加強環境的可持續性。

RELATIONSHIPS WITH STAKEHOLDERS

The Company recognizes that employees are our valuable assets. Thus the group provides competitive remuneration package to attract and motivate the employees. The group regularly reviews the remuneration package of employees and makes necessary adjustments to conform to the market standard.

The group also understands that it is important to maintain good relationship with business partners and bank enterprises to achieve its long-term goals. Accordingly, our senior management have kept good communication, promptly exchanged ideas and shared business update with them when appropriate. During the Year, there was no material and significant dispute between the group and its business partners or bank enterprises.

KEY RISKS AND UNCERTAINTIES

The Group's financial condition, results of operations, and business prospects may be affected by a number of risks and uncertainties directly or indirectly pertaining to the Group's businesses. The followings are the key risks and uncertainties identified by the Group. There may be other risks and uncertainties in addition to those shown below which are not known to the Group or which may not be material now but could turn out to be material in the future.

Market Risks

Market risk is the risk that deteriorates profitability or affects ability to meet business objectives arising from the movement in market prices, like foreign exchange rates, interest rates and equity prices. The management of the Group manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

市場風險

Foreign Exchange Rates Risk

The Group's assets and liabilities were denominated in Renminbi, Hong Kong Dollars and United States dollar, in view of the potential HKD and USD exchange rate fluctuation the Group undertake foreign exchange rate risk. The Group currently does not have a foreign currency hedging policy. However, the management monitors foreign exchange exposure and will consider hedging significant foreign currency exposure when the need arises.

Interest Rate Risk

For interest-sensitive products and investments, the Group analyses its interest rate exposure on a dynamic basis and considers managing this risk in a cost-effective manner when appropriate, through variety of means.

Equity price risk

Equity price risk arises from fluctuation in market prices of the Group's investment in financial assets. The investment portfolio is frequently reviewed and monitored by our senior management to ensure prompt action taken and the loss arising from the changes in the market values is capped within an acceptable range.

Liquidity Risk

Liquidity risk is the potential that the Group will be unable to meet its obligations when they fall due because of an inability to obtain adequate funding or liquidate assets. In managing liquidity risk, the Group monitors cash flows and maintains an adequate level of cash and cash equivalent to ensure the ability to finance the Group's operations and reduce the effects of fluctuation in cash flows.

流動資金風險

流動資金風險即是本集團由於未能取得充足資 金或變現資產,在責任到期時未能履約的可能 性。管理流動資金風險時,本集團監察現金流 量,並維持充足之現金及現金等價物水平,以確 保能為本集團營運提供資金及降低現金流量波 動之影響。

Operational Risk

Operational risk is the risk of loss resulting from inadequate or failed internal processes, people and systems or from external events. Responsibility for managing operational risks basically rests with every function at divisional and departmental levels.

Key functions in the Group are guided by their standard operating procedures, limits of authority and reporting framework. Our management will identify and assess key operational exposures regularly so that appropriate risk response can be taken.

Investment Risk

Investment risk can be defined as the likelihood of occurrence of losses relative to the expected return on any particular investment. Key concern of investment framework will be balancing risk and return across different investments, and thus risk assessment is a core aspect of the investment decision process. Proper authorisation system has been set up and detailed analysis will be made before approving investments. Regular updates on the progress of the investments of the Group would be submitted to the Board.

Manpower and Retention Risk

The Group may face the risk of not being able to attract and retain key personnel and talents with appropriate and required skills, experience and competence which would meet the business objectives of the Group. The Group will provide attractive remuneration package to suitable candidates and personnel.

Business Risk

Performance of the Group's core business will be affected by various factors, including but not limited to economic conditions, performance of property markets in regions where our investments locate, the performance of the fund managers for our invested funds, which would not be mitigated even with careful and prudent investment strategy and strict procedure.

As a result, a new share option scheme which was approved on 28 February 2011 (the "New Scheme"), take effect immediately after the expiry of the Scheme. The principal terms of the New Scheme are same with the Scheme.

Pursuant to the ordinary resolution passed by the shareholders at the special general meeting of the Company held on 28 February 2011 (the "SGM"), the Scheme mandate limit was refreshed so that the Company was authorized to grant share options under the existing Scheme for subscription of up to a total of 81,184,000 shares, representing approximately 10% of the issued share capital of the Company as at the date of the SGM.

Although the Group had net liabilities as at 31 December 2015, the Board obtain financial support confirmation from its shareholder and director – Mr. Hung Yung Lai that remove significant doubt upon the Group's ability to continue as a going concern, the Board therefore continues to adopt the going concern approach in preparing the financial statements.

The Company Secretary is responsible to the Board for providing with Board papers and related materials, for ensuring that all Board procedures and all applicable laws, rules and regulations are followed, and for reporting to the Chairman on governance matters. All directors have unrestricted access to the advice and services of the Company Secretary. The Company secretary keeps minutes of all meetings which are available for inspection at any reasonable time on reasonable notice by any Directors. The Company Secretary also plays an essential role in the relationship between the Company and its shareholders, including assisting the Board in discharging its obligations to shareholders pursuant to the Listing Rules.

In compliance with rule 5.05A, 5.05(1) and (2) of the GEM Listing Rules, the Company has appointed three independent non-executive directors representing more than one-third of the Board and at least one of whom has appropriate professional qualifications, or accounting or related financial management expertise. The Company has received from each independent non-executive director an annual confirmation of his independence, and the Company considers such directors to be independent in accordance with each and the various guidelines set out in rule 5.09 of the GEM Listing Rules.

With the various experience of both the executive directors and the non-executive directors and the nature of the Group's business, the Board considered that the directors have a balance of skills and experience for the business of the Group.

The Company has arranged for Directors' and Officers' liability Insurance to indemnify its Directors against potential liabilities incurred by them in discharging their duties. The increase coverage for the Directors is reviewed on an annual basis. Throughout the year, no claim had been made against the Directors and the officers of the Company.

The Company has established a Nomination Committee. The Nomination Committee will evaluate the independence of all independent non-executive Directors each year and make sure that they comply with the independence requirement of the Listing Rules. All members of the Board are not related to one another in all aspects, including finance, family and business.

The articles of association of the Company provide that any Director appointed by the Board, (i) to fill a casual vacancy in the Board, shall hold office only until the next following general meeting of the Company and shall be subject to re-election at such meeting and (ii) as an addition to the Board shall hold office until the next AGM of the Company and shall then be eligible for re-election.

TRAINING AND SUPPORT FOR DIRECTORS

Directors must keep abreast of their collective responsibilities. Each newly appointed Director would receive an induction package covering the Group's businesses and the statutory and regulatory obligations of a director of a listed company. The Group also provides briefings and other training to develop and refresh the Directors' knowledge and skills. The Group continuously updates Directors on the latest developments regarding the Listing Rules and other applicable regulatory requirements, to ensure compliance and enhance their awareness of good corporate governance practices. Circulars or guidance notes are issued to Directors and senior management where appropriate, to ensure awareness of best corporate governance practices.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The Chairman of the Company is Mr. Hung Yung Lai. The roles of the Chairman and the Chief Executive Officer are segregated and assumed by two separate individuals who have no relationship with each other. The Chairman of the board is responsible for the leadership and effective running of the board, while the Chief Executive Officer is delegated with the authorities to manage the business of the Group in all aspects effectively.

Under the code provision A.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive officer should be clearly established and set out in writing. Subsequent to the resignation of Mr. Chan Kam Fai, no replacement of the post of the chief executive officer has been fixed as at 31 December 2015. The Board will keep reviewing the current structure from time to time. If candidate with suitable knowledge, skills and experience is identified, the Company will make appointment to fill the post of chief executive officer as appropriate.

BOARD COMMITTEES & CORPORATE GOVERNANCE FUNCTIONS

The board has established three Board committees, namely, the Remuneration Committee, the Nomination Committee and the Audit and risk management Committees, for overseeing particular aspects of the Company's affairs. All Board committees have been established with defined written terms of reference, which are posted on the GEM's website www. hkgem.com and the Company's website at www.singlee.com. cn. All the Board committees should report to the Board on their decisions or recommendations made.

The practices, procedures and arrangements in conducting meetings of Board committees follow in line with, so far as practicable, those of the Board meetings set out in above.

The remuneration committee has been charged with the responsibility of making recommendations to the Board on appropriated policy and structures for all aspects of all Directors and senior management remuneration. The duties of the nomination committee are mainly to review the structure, size and composition of the Board and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy; identify suitable candidates for appointment as directors; make recommendations to the Board on appointment or reappointment of an succession planning for directors; assess the independence of independent non-executive directors; formulate and review the Board Diversity Policy and the progress on achieving the objectives set for implementing the policy.

The nomination committee considered the past performance, qualification, general market conditions and the Company's articles of association in selecting and recommending candidates of directorship. The nomination committee discussed and reviewed the retirement and re-election of Directors.

AUDIT AND RISK MANAGEMENT COMMITTEE (Cont'd)

The primary duties of the audit and risk management committee are mainly to review the financial information and reporting process, internal control procedures and risk management system, audit plan and relationship with external auditors and arrangements to enable employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

The Company has complied with Rules 5.28 of the GEM Listing Rules in that at least one of the members of the Audit and risk management Committee (which must comprise a minimum of three members and must be chaired by an Independent-non executive director) is an independent non-executive director who possesses appropriate professional qualifications or accounting related financial management expertise.

The Audit and risk management Committee held five meetings during the year, so that full attention can be given to the matters submitted. The Group's unaudited quarterly results for the 3 months ended 31 March 2015, 9 months ended 30 September 2015 and interim results for the 6 months ended 30 June 2015 as well as audited annual results for the year ended 31 December 2015 have been reviewed by the audit and risk management committee, which was of the opinion that the preparation of such results complied with the applicable accounting standards and requirements and that adequate disclosure have been made.



BOARD DIVERSITY POLICY (Cont'd)

We believe that board diversity enhances decision-making capability and a diverse board is more effective in dealing with organisational changes and less likely to suffer from group thinking. The objectives of this Policy are, with the support of our shareholders, to have a Board which

- a) is characterised by a broad range of views arising from different experiences when discussing business;
- b) facilitates the making of informed and critical decisions; and
- c) has sustainable development as its core value,

and thus promotes the interests of all our stakeholders, particularly the long-term interests of our shareholders, fairly and effectively.

For the purpose of this Policy, we considers the concept of diversity incorporates a number of different aspects, such as professional experiences, business perspectives, skills, knowledge, gender, age, cultural and educational background, ethnicity and length of service. The achievement of these objectives is measurable on an objective review by shareholders of the overall composition of the Board, the diversity of background and experience of individual directors and the effectiveness of the Board in promoting shareholders' interests.

In order for shareholders to judge for themselves whether the Board as constituted is a reflection of diversity, or a gradual move to increased diversity, on a scale and at a speed which they support, we shall continue to provide sufficient information to shareholders about the size, qualifications, characteristics etc. of each individual Board member and therefore, the Board as a whole.

INDEPENDENT AUDITORS' REMUNERATION

The Directors are responsible for the preparation of the financial statements which give a true and fair view of the state of affairs of the company and its subsidiaries, in accordance with accounting principle generally accepted in Hong Kong. The Directors' responsibilities in the preparation of the financial statements and the auditor's responsibilities are set out in the Independent Auditor's Report in this annual report.

INTERNAL CONTROL

The Company has conducted a review on the effectiveness and adequacy of the Group's internal control system during the year. Management is primarily responsible for the design, implementation, and maintenance of internal controls, while the Board of Directors and its Audit and risk management Committee oversee the actions of management and monitor the effectiveness of the controls that have been put in place. The Company convened meetings periodically to discuss financial, operational and compliance controls and risk management functions. The Directors are of the view that the key areas of the Group's internal control system are reasonably implemented with rooms for improvement. Such requisition must state the object of business to be transacted at the meeting and must be signed by the Requisitionists and deposited at the registered office of the Company or the Company's principal place of business in Hong Kong. Shareholders should follow the requirements and procedures as set out in such Article for convening an extraordinary general meeting. Shareholders may put forward proposals at general meeting of the Company by sending the same to the Company at the principal office of the Company in Hong Kong.

For putting forward any enquiries to the Board, shareholders may send written enquiries to the Company. Shareholders may send their enquiries or requests in respect of their rights to the Company's principal place of business in Hong Kong.

This condition, along with other matters as set forth in note 2 to the consolidated financial statements, indicates the existence of a material uncertainty which may cast significant doubt about the Group's ability to continue as a going concern.

1. GENERAL

Sing Lee Software (Group) Limited (the "Company") is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on The Growth Enterprise Market of The Stock Exchange of Hong Kong Limited. The address of its registered office and principal place of business of the Company are disclosed in the section headed "Corporate Information" in the annual report. Its immediate holding company is Goldcorp Industrial Limited, a company incorporated in the British Virgin Islands. Its ultimate controlling party is Mr. Hung Yung Lai, who is also the Chairman and an executive director of the Company.

The consolidated financial statements are presented in Renminbi ("RMB"), which is the same as the functional currency of the Company and its subsidiaries.

The principal activities of the Company and its subsidiaries (collectively the "Group") are development and sales of software products, sales of related hardware products and provision of software-related technical support services. The principal activities of its subsidiaries are set out in note 30.

2. BASIS OF PREPARATION OF CONSOLIDATED FINANCIAL STATEMENTS

The consolidated financial statements have been prepared on a going concern basis. The Group's total liabilities exceeded its total assets by approximately RMB4,580,000 as at 31 December 2015. In preparing the consolidated financial statements, the directors of the Company have reviewed the Group's financial and liquidity position, and taken into consideration the following factors:

- ongoing financial support from a director, who is also the substantial shareholder of the Company, for a period of twelve months from the date of approving the consolidated financial statements by the directors;
- cost control measures; and
- possible additional external funding.

All other debt investments and equity investments are measured at their fair value at the end of subsequent accounting periods. In addition, under IFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.

In addition, the retrospective quantitative effectiveness test has been removed. Enhanced disclosure requirements about an entity's risk management activities have also been introduced.

The directors of the Company anticipate that the adoption of IFRS 9 in the future may not have a significant impact on the amounts recognised in respect of the Group's financial assets and financial liabilities.

IFRS 15 Revenue from Contracts with Customers

IFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. IFRS 15 will supersede the current revenue recognition guidance including IAS 18 *Revenue*, IAS 11 *Construction Contracts* and the related interpretations when it becomes effective.

IFRS 15 Revenue from Contracts with Customers (*Cont'd*)

The core principle of IFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the Standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under IFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in IFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by IFRS 15.

The directors anticipate that the application of IFRS 15 in the future may have an impact on the amounts reported and disclosures made in the Group's consolidated financial statements. Amendments to IAS 1 Disclosure Initiative

The amendments to IAS 1 *Presentation of Financial Statements* give some guidance on how to apply the concept of materiality in practice.

The amendments to IAS 1 are effective for annual periods beginning on or after 1 January 2016. The directors do not anticipate that the application of these amendments to IAS 1 will have a material impact on the amounts recognised in the Group's consolidated financial statements.

Right-of-use asset includes the amount of initial measurement of lease liability, any lease payment made to the lessor at or before the lease commencement date, estimated cost to be incurred by the lessee for dismantling or removing the underlying assets from and restoring the site, as well as any other initial direct cost incurred by the lessee. Lease liability represents the present value of the lease payments. Subsequently, depreciation and impairment expenses, if any, on the right-of-use asset will be charged to profit or loss following the requirements of IAS 16—Property, Plant and Equipment, while lease liability will be increased by the interest accrual, which will be charged to profit or loss, and deducted by lease payments.

As set out in note 27, total operating lease commitment of the Group in respect of rental premises as at 31 December 2015 amounted to RMB652,000, the directors do not expect the adoption of IFRS 16 as compared with the current accounting policy would result in significant impact on the Group's result but it is expected that certain portion of these lease commitments will be required to be recognized in the consolidated statement of financial position as right-of-use assets and lease liabilities.

Statement of Compliance

The consolidated financial statements have been prepared in accordance with International Financial Reporting Standards issued by the International Accounting Standard Board. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Growth Enterprise Market of The Stock Exchange of Hong Kong Limited and by the Hong Kong Companies Ordinance.

The provision of the new Hong Kong Companies Ordinance (Cap. 622) regarding preparation of accounts and directors' reports and audits became effective for the Company for the financial year ended 31 December 2015. Further, the disclosure requirements set out in the Listing Rules regarding annual accounts have been amended with reference to the new Hong Kong Companies Ordinance and to streamline with IFRSs. Accordingly the presentation and disclosure of information in the consolidated financial statements for the financial year ended 31 December 2015 have been changed to comply with these new requirements. Comparative information in respect of the financial year ended 31 December 2014 are presented and disclosed in the consolidated financial statements based on the new requirements. Information previously required to be disclosed under the predecessor Hong Kong Companies Ordinance or Listing Rules but not under new Hong Kong Companies Ordinance or amended Listing Rules are not disclosed in these consolidated financial statements.

Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values, as explained in the accounting policies set out below. Historical cost is generally based on the fair value of the consideration given in exchange for goods.

Basis of preparation (Cont'd)

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of IFRS 2, leasing transactions that are within the scope of IAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in IAS 2 or value in use in IAS 36.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are guoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Group. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee: and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods sold and services provided in the normal course of business, net of discounts and sales related taxes.

Revenue from the sales of goods is recognised when goods are delivered and titles are passed at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Revenue from sales of hardware and software products is recognised when the goods are delivered and title has passed upon customers' acceptance.

Service income for provision of software-related technical support is recognised when services are provided.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of revenue can be measured reliably. Interest income from a financial asset is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Property, plant and equipment

Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of items of property, plant and equipment less their residual values over their estimated useful lives, using the straightline method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Group as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Nonmonetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Impairment losses on tangible and intangible assets (Cont'd)

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

5. KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 4, the directors of the Company are required to make estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The following are the key assumptions concurring the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Allowance for doubtful debts

The Group's management assesses the recoverability and determines impairment of trade receivables and loan receivable in accordance with the accounting policy stated in note 4. Such estimation is based on the credit history of its customers and the current market conditions. Management reviews the debtor settlement status periodically and reassesses the sufficiency of allowance for doubtful debts accordingly. If the customer's financial position were to deteriorate, actual impairment loss or write off would be higher than estimated. As at 31 December 2015, the carrying amount of trade receivables is RMB21,650,000, net of allowance for doubtful debts of RMB8,933,000 (2014: carrying amount of RMB16,331,000, net of allowance of doubtful debts of RMB8,432,000).

Estimated impairment of intangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately. As at 31 December 2015, the carrying amount of intangible assets is RMB2,168,000 (2014: RMB522,000).

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of borrowings from a director and bank balances and cash, and equity attributable to owners of the Company, comprising share capital, share premium, accumulated losses and other reserves.

The directors review the capital structure on a semiannual basis. As part of this review, the directors consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debt or the redemption of existing debt.

Credit risk

As at 31 December 2015, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets, which is stated in the consolidated statement of financial position.

The directors continuously evaluate the creditworthiness and financial strength of the counterparty of the loan receivable as well as considering potential business development of the counterparty. The term of the loan receivable is stipulated in a loan agreement. The loan receivable due from the counterparty is a private entity which engaged in research and development of software.

The Group also has policies in place to ensure that sales of products are made and services are provided to customers with an appropriate credit history and the Group assesses the credit worthiness and financial strength of its customers as well as considering prior dealing history with the customers. Generally, customers are granted with credit periods from 120 – 180 days and the Group usually does not require collaterals from its customers. An ageing analysis of trade receivables is set out in note 17.

Management makes periodic individual assessment as well as collective assessment on the recoverability of trade receivables based on historical payment records, the length of the overdue period, the financial strength of the customers and whether there are any trade disputes with them. In this regard, the directors of the Company consider the Group's credit risk is significantly reduced.

The Group has concentration of credit risk of 48% (2014: 46%) of the total trade receivables was due from the Group's top five largest customers in relation to the provision of software-related technical support services business segment.

The credit risk of the Group on liquid funds is limited because the majority of the counterparties are stateowned banks and local commercial banks with good reputation.

Liquidity risk

As set out in note 2, the Group is currently dependent upon the continuing financial support from the shareholder with significant influence over the Company and additional external funding to meet in full its financial obligation as they fall due for the foreseeable future.
