Remarks (if any):

(1) On 10 May 2015, the Company entered into a subscription agreement with Aisidi (HK) Limited (the “**Subscriber**”), pursuant to which the Subscriber had conditionally agreed to subscribe for, and the Company had conditionally agreed to issue, 6% unsecured convertible bonds due 2018 (the “**Convertible Bonds**”) in the aggregate principal amount of HK\$300,000,000 convertible at 100% of the principal amount of the Convertible Bonds into 115,384,615 ordinary shares at an initial conversion price of HK\$2.60 per share. Please refer to the Company’s announcement dated 11 May 2015 for details. On 15 June 2015, the Convertible Bonds were issued by the Company to the Subscriber.

(2) On 30 October 2015, a sale and purchase agreement (as amended by a supplemental agreement dated 24 February 2016) was entered into between Bonus Partners Worldwide Limited and Essential Perfection Enterprises Limited (collectively, the “**Vendors**”) and Wise Park Group Limited (a direct wholly-owned subsidiary of the Company) in relation to the acquisition of an indirect 35% equity interest in 上海即富信息技術服務有限公司 (Shanghai Jifu Information Technology Service Co., Ltd.\*). Please refer to the Company’s circular dated 7 April 2016 for details. On 30 April 2016, the Company allotted and issued 258,318,335 shares to the Vendors as consideration.

(3) The number of new shares of the Company which may be issued pursuant thereto as at close of the month under the exercise price of HK\$2.13 per share of the Share Option Scheme should be 34,450,000 instead of 33,450,000.
