#### Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Thursday, 7 June 2018, and, in any event, not later than Tuesday, 12 June 2018. If you apply for the Public Offer Shares under the Public Offer, you must pay the maximum Offer Price of HK\$0.60 for each Public Offer Share plus a 1.0% brokerage fee, 0.005% Stock Exchange trading fee and 0.0027% SFC transaction levy. This means a total of HK\$3,030.23 is payable for every board lot of 5,000 Shares. If, for any reason, the Offer Price is not agreed by Tuesday, 12 June 2018 between the Company and the Joint Lead Managers (for themselves and on behalf of the Underwriters), the Share Offer will not proceed and will lapse.
