1. You and any person(s) for whose benefit you are applying must be 18 years of age or older and must have a Hong Kong address.
2. If you are a firm, the application must be in the individual members' names.
3. The number of joint applicants may not exceed four.
4. If you are a body corporate, the application must be signed by a duly authorised officer, who must state his representative capacity, and stamped with your corporation's chop (bearing the company name).
5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the Securities Act of the United States) and not be a legal or natural person of the PRC (except qualified domestic institutional investor).
6. Unless permitted by the GEM Listing Rules, you cannot apply for any Public Offer Shares if you are:
 - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;
 - a Director or chief executive of the Company and/or any of its subsidiaries;
 - a connected person (as defined in the GEM Listing Rules) of the Company or any of its subsidiaries or a person who will become a connected person of the Company or any of its subsidiaries immediately upon completion of the Share Offer;
 - an associate (as defined in the GEM Listing Rules) of any of the above; or
 - have been allocated or have applied for or have indicated an interest in any Placing Shares under the Placing or otherwise participate in the Placing.

B. If you are a nominee

You, as a nominee, may make more than one application for the Public Offer Shares by: (i) giving electronic application instructions to HKSCC via Central Clearing and Settlement System ("CCASS") (if you are a CCASS Participant); or (ii) using a **WHITE** or **YELLOW** Application Form, and lodge more than one application in your own name on behalf of different beneficial owners.

C. Effect of completing and submitting this Application Form

By completing and submitting this Application Form, you (and if you are joint applicants, each of you jointly and severally) for yourself or as an agent or a nominee on behalf of each person for whom you act:

- **undertake** to execute all relevant documents and instruct and authorise the Company and/or the Sole Global Coordinator (or their agents or nominees), as agents of the Company, to execute any documents for you and to do on your behalf all things necessary to register any Public Offer Shares allocated to you in your name as required by the Articles of Association;

D. Power of attorney

Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Wednesday, 11 July, 2018. Applicants are required to pay the maximum Offer Price of HK\$1.42 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Sole Global Coordinator (for itself and on behalf of the Underwriters) on or before Wednesday, 11 July, 2018 or such other day as may be agreed between the Company and the Sole Global Coordinator (for itself and on behalf of the Underwriters), the Share Offer will not proceed. Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

The allocation of Offer Shares between the Public Offer and the Placing is subject to reallocation, as described in the paragraph headed "Structure and conditions of the Share Offer — The Public Offer — Reallocation" in the Prospectus. The Sole Global Coordinator (for itself and on behalf of the Underwriters) may reallocate the Offer Shares from the Placing to the Public Offer to satisfy valid applications under the Public Offer in accordance with the Guidance Letter HKEx-GL91-18 issued by the Stock Exchange. In accordance with Guidance Letter HKEx-GL91-18, if such reallocation is done other than pursuant to Practice Note 6 of the GEM Listing Rules, the maximum total number of Offer Shares that may be reallocated to the Public Offer following such reallocation shall be not more than double the initial allocation to the Public Offer (i.e. 13,500,000 Public Offer Shares).
