DIRECTORS

Executive Directors

Mr. NGAI Chun Hung (魏振雄先生), aged 38, is the Chairman of the Company. Mr. Ngai has over twenty years' experience in the construction industry. Since February 1996, he has been the director of Able Engineering and became Managing Director of the Group in April 1998.
