# CHAIRMAN'S STATEMENT 主席報告



本人謹代表寰宇國際控股有限公司(「本公司」)董事會呈奉本公司及其附 屬公司(「本集團」)之二零零一/二零零 二年度全年業績。

## 業績

回顧年度對本集團而言無疑是困 難重重的一年,尤其正值香港經濟仍然 飽受失業率飆升、業內競爭激烈及零售 市場不景氣等問題困擾,大大影響本集 團於錄像發行,授出及轉授電影版權與 電影放映等核心業務的邊際利潤。儘管 面對種種困難,本集團截至二零零二年 六月三十日止年度的綜合營業額仍由港 幣306,600,000元輕微增至約港幣 306,700.000元。股東應佔溢利約為港 林小明 主席兼董事總經理 Lam Shiu Ming, Daneil Chairman and Managing Director

On behalf of the Board of Directors of Universe International Holdings Limited (the "Company"), I hereby present the 2001/ 2002 annual results of the Company and its subsidiaries (the "Group").

### RESULTS

The year under review was undoubtedly a difficult period for the Group, especially as the Hong Kong economy was still experiencing rising unemployment rate, severe competition within the industry and a sagging retail market, which materially affect the profit margin of our core business in video distribution, film licensing & sublicencing and film exhibition. Despite these difficulties, the Group's consolidated turnover slightly increased from HK\$306.6 million to approximately HK\$306.7 million for the year ended 30 June 2002. Profit attributable to shareholders was about HK\$10.0 million, compared with HK\$40.2 million last year,

除本地消費疲弱外,本集團多個 主要海外市場(尤其是亞洲區)的經濟亦 持續不振,而若干新成立的收費電視頻 道延遲啓播及退出經營,亦對本集團旗

下的影片版權授出及轉授 業務構成重大不利影響; 然而,在拓展龐大的中國 市場上卻取得令人鼓舞的 佳績,來自中國的營業額 由港幣600,000元增至港 幣7,200,000元。

雖然業內的經營環境欠佳,但在 考慮電影版權之減值虧損港幣 22,400,000元及因於結算日後贖回可 換股票據而須承擔的額外贖回利息港幣 7,000,000元之因素後,營業額仍錄得 增長,且取得溢利,表現令人鼓舞,足 證管理層於過去數年採取的策略奏效, 令本集團不僅能維持盈利能力,甚至能 在日前經濟不景的大氣候下維持增長。 economic climate persisted in our major overseas markets especially in Asia, and the delay in commencement and withdrawal of broadcast of some new pay TV channels also create

Apart from the subdued domestic consumption, the adverse



considerable negative impact on our film licensing and sublicencing business. However, we are encouraged by the development of the vast market of the PRC, the turnover generated from the PRC which recorded a turnover growth from HK\$0.6 million to HK\$7.2 million.

Notwithstanding the unfavourable operating environment for the industry, we are encouraged by the growth of the turnover and our profitable performance, after taking into account of impairment loss of film rights of HK\$22.4 million and additional redemption interest of HK\$7.0 million arising from redemption of convertible notes subsequent to the year end. Such performance is evident that the strategies adopted by the management in last few years have been successful in enabling the Group to remain not only profitable but to maintain growth in the current macro environment. 展望未來,本集團將繼續採取務 實而審慎之態度透過產品及市場多元化 策略不斷拓展業務。中國市場的發展潛 力無可限量,本集團採取的策略是加強

與國內的電影製作公司合作 攝製電影,及成立合營公司 專注拓展中國之錄像發行市 場,藉以不斷擴展國內業 務。雖然經營環境惡劣,但 集團深信憑藉本身周詳的策 略和精湛的專業知識,定能 穩中求勝,維持盈利能力及 增長。 Looking ahead, the Group will continue to develop through continual product and market diversification in a pragmatic and prudent manner. The PRC market looks highly promising and our strategy is to continue to expand our PRC operation by strengthening



film co-production with the PRC film production companies and by means of establishing the joint-venture for exploring the PRC video distribution market. Despite the difficult environment, the Group is confident that our well-defined strategies and expertise will establish a solid foundation for maintaining profitability and sustaining growth.
