Executive directors

Mr. Kwong Wui Chun, aged 47, is the Chairman and the founder of the Group. He oversees the Group's operations and is responsible for formulating and monitoring the Group's overall corporate strategic plans and policies and business development. Prior to the establishment of the Group in 1992, he had over 24 years of experience in the trading of non-ferrous metals and the manufacturing of non-ferrous metal products in Hong Kong and the People's Republic of China (the "PRC"). Mr. Kwong has extensive understanding on the metal trading mechanism and regulatory framework, especially in the non-ferrous metal sector in the PRC.

Mr. Hung Pann Yi, aged 54, is the Deputy Chairman of the Company. He is responsible for the purchasing, sale and marketing activities of the Group and the development of the Group's overseas sale strategies. Prior to joining the Group in November 1994, he has over 25 years of experience in the non-ferrous metal industry especially in Taiwan and the United States.

Mr. Chan Yiu Tsuan, Benby, aged 41, is the Managing Director of the Company. He is responsible for formulating and monitoring the Group's overall strategic plans and policies. Prior to joining the Group in December 2001, he had over 18 years of experience in international banking specializing in trade and commodity finance, corporate finance, investment banking and structured trade finance. He had held senior positions with major international banks and had stationed in the PRC for over seven years. Mr. Chan graduated from the University of Hong Kong with a Bachelor Degree in Social Sciences. He also holds a Diploma in Chinese Law from the University of East Asia, a Diploma in China investment and Trade from the Peking University, a Diploma in Appreciation of Historical Relics from the Beijing Normal University, a Master Degree in Business Administration from the Open University of Hong Kong and a Master Degree in International Relations from the Flinders University of Australia. He is also a fellow member of the Hong Kong Institute of Directors.
