# Group management committee

The Group Management Committee, the company's management and operations decision-making authority, is comprised of senior executives who represent the various key functions and operations of the company. In addition to Clement Kwok, chief executive officer, and Mark Broadley, chief financial officer, the following are members:

### Peter Borer

Age 50. General manager of The Peninsula Hong Kong since 1994, he holds regional responsibility for the group's hotel operations in Hong Kong, the People's Republic of China, The Philippines and Thailand. He chairs the Marketing Strategy Committee. Mr Borer joined the company in 1981 and has held a number of senior positions within the group.

## Niklaus Leuenberger

Age 49. General manager of The Peninsula New York since 1992, he holds regional responsibility for the group's hotel operations in the USA, and is a member of the Marketing Strategy Committee. Mr Leuenberger joined the company in 1980 and

has held various positions in the group's operations in Hong Kong, the People's Republic of China and The Philippines.
