Sir Sidney Gordon

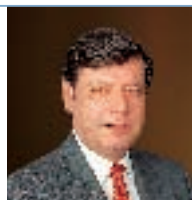
Sir Sidney Gordon,


William Elkin Mocatta

Dr Li also serves on the board of the Mandatory Provident Fund Schemes Authority.</p>
<p>Robert Chee Siong Ng</p>	<p>Age 52. Called to the English Bar in 1975, Mr. Ng was appointed to the Board in 1987. He is chairman of Sino Hotels (Holdings) Limited, which owns 3.58% of the company's issued share capital. He is also chairman of Sino Land Company Limited and its holding company Tsim Sha Tsui Properties Limited. He is a non-executive director of SCMP Group Limited and a director of Yeo Hiap Seng Limited, which is listed in Singapore. (A)</p>

A Bachelor of Science in Hotel Administration (Cornell University) and a presidential councillor and trustee emeritus of the University, he was appointed to the Board in July 2001. He is an independent non-executive director of Johnson Electric Holdings Ltd, Kingsway International Holdings Ltd, Pacific Basin Shipping Limited and a member of the Managing Board of the Kowloon-Canton Railway Corporation.
