Pursuant to a sale and purchase agreement dated 17th August, 2006 (as supplemented by supplemental agreements dated 28th August, 2006 and 4th October, 2006), an indirect whollyowned subsidiary of the Company conditionally agreed to acquire 22,812,359 shares of Hanny. The sale and purchase agreement was completed on 7th November, 2006.

By virtue of his deemed interests in approximately 34.99% of the issued ordinary share capital of the Company, Dr. Chan Kwok Keung, Charles was deemed to be interested in these shares and underlying shares of Hanny.

 Dr. Chan Kwok Keung, Charles owns the 2% convertible bonds of Hanny due 2011 with principal amount of HK\$2,841,810. Upon full conversion of such convertible bonds at an initial conversion price of HK\$9.0 per share (subject to adjustments), 315,756 new shares of Hanny will be issued to Dr. Chan Kwok Keung, Charles.
