I ESTIMATED RESULTS FOR THE CURRENT PERIOD

1. Estimated Results Period: From 1 January 2009 to 31 December 2009.
2. Previous Estimated Results: The Group's net profit attributable to equity holders of the Company for the period from 1 January 2009 to 31 December 2009 was estimated to increase by more than 400% over the previous year.

3. Amended Estimated Results: The Group's net profit attributable to equity holders of the Company for year 2009 is estimated to increase by more than 480% over the previous year.
4. The estimated results have not been audited.

1. Net profit attributable to equity holders of the Company: RMB1,115,187,000.
2. Basic earnings per share: RMB0.05.
