The Board of the Company wishes to inform the shareholders of the Company and potential investors that it is expected that the interim results of the Group for the six months ended 31 December 2011 may experience a significant reduce in net profit as compared to the net profit for the last year.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).

The board of Directors (the “Board”) of Cheuk Nang (Holdings) Limited (the “Company”) wishes to inform the shareholders of the Company and potential investors that it is expected that the interim results of the Company and its subsidiaries (collectively the “Group”) for the six months ended 31 December 2011 may experience a significant reduce in net profit as compared to the net profit for the last year. Such reduction was mainly attributable to decline of increasing amount in fair value of the Group’s investment properties and property and loss on fair value adjustment on financial assets at fair value through profit or loss as a result of the recent less favourable conditions of the global market.

As the Company is still in the process of finalizing the interim results for the six months ended 31 December 2011, the information contained in this announcement is only based on the preliminary assessment by the Company's management according to the management accounts of the Group which have not been audited or reviewed by the Company's auditors. Shareholders of the Company and potential investors should read the Group's interim results announcement for the six months ended 31 December 2011 carefully, which is expected to be published before by end of February 2012.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.
