The Board of Directors ("Board") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that, based on a preliminary review of the Group's unaudited management accounts, the Group is expected to record a loss for the year ended 31 March 2012 which is higher than that for the year ended 31 March 2011. Such expected loss is mainly attributable to the realised and unrealised loss of investments in listed equity securities.

The Company is in the process of finalizing the annual results of the Group for the year ended 31 March 2012. The information contained in this announcement is only a preliminary assessment by the Board according to the unaudited management accounts of the Group and is not based on any financial figures or information which have been audited or reviewed by the Company's auditors. Further details of the Group's financial results and performance will be disclosed in the Company's annual results announcement to be published in late June 2012.
