If you have already submitted your application and obtained an application reference number from the designated website prior to 11:30 a.m., you will be permitted to continue the application process (by completing payment of application monies) until 12:00 noon on the last day for submitting applications, when the application lists close.
- (3) If there is a “black” rainstorm warning or a tropical cyclone warning signal number eight or above in force in Hong Kong at any time between 9:00 a.m. and 12:00 noon on Wednesday, 4 July 2012, the application lists of the Hong Kong Public Offer will not open and close on that day. Particulars of the arrangements are set out in the section headed “How to apply for the Hong Kong Offer Shares — Effect of bad weather on the opening of the application lists” in this prospectus.

- (5) The Price Determination Date, being the date on which the Offer Price is to be determined, is expected to be on or about Friday, 6 July 2012 or such other date as may be agreed between the Company and the Joint Global Coordinators (for themselves and on behalf of the Underwriters). If, for any reason, the Offer Price is not agreed at or prior to 12:00 noon on Thursday, 12 July 2012, the Global Offering will not proceed. In such event, the Company will issue an announcement to be published in South China Morning Post in English and Hong Kong Economic Times in Chinese and to be posted on the website of the Stock Exchange (**www.hkexnews.hk**) and on the website of the Company (**www.putian.com.hk**).
- (6) e-Auto Refund payment instructions or refund cheques will be issued in respect of wholly or partially unsuccessful applications and in respect of successful applications if the Offer Price as finally determined is less than HK\$0.98 payable on application. Part of the applicant’s Hong Kong identity card number or passport number, or, if the application is made by joint applicants, part of the Hong Kong identity card number or passport number of the first-named applicant, provided by the applicant(s) may be printed on the refund cheque, if any. Such data would also be transferred to a third party for refund purpose. Banks may require verification of an applicant’s Hong Kong identity card number or passport number before cashing the refund cheque. Inaccurate completion of an applicant’s Hong Kong identity card number or passport number may lead to delay in encashment of or may invalidate the refund cheque.

which opt for personal collection may do so through their authorised representatives bearing letters of authorisation from the corporations duly stamped with the company's chop. Identification documents and (where applicable) authorisation documents acceptable to Tricor Investor Services Limited must be produced at the time of collection of share certificates and/or refund cheques (if any).
