This is a voluntary announcement made by the Company and reference is also made to the announcement of the Company dated 6 July 2012.

The Board announces that the PRC Partner entered into the Hebei Cooperation Agreement with the Hebei Procurement Centre on 9 July 2012 in relation to, among others, the Proposed Project. The provisions of the Hebei Cooperation Agreement shall form the basis for the preparation of further agreement(s) regarding the Proposed Project.

The PRC Partner also entered into the Conference Cooperation Agreement with the Hebei Procurement Centre on 9 July 2012 in relation to, among others, the organisation of the Proposed Conference. The provisions of the Conference Cooperation Agreement shall form the basis for the preparation of further agreement(s) regarding the organisation of the Proposed Conference.

On 10 July 2012, the PRC Partner issued the Authorisation Letter to the CPP Subsidiary granting it the authority to execute the Proposed Project under the Cooperation Agreement, to undertake the organisation of the Proposed Conference under the Conference Cooperation Agreement and to enter into further agreements for such projects.

PRINCIPAL TERMS OF THE HEBEI COOPERATION AGREEMENT

Pursuant to the Hebei Cooperation Agreement, the PRC Partner agreed, among others, to cooperate with the Hebei Procurement Centre to set up the electronic public procurement platform of the Hebei Procurement Centre and the PRC Partner's obligations under such agreements include:

- (i) to provide the necessary software and hardware, as agreed between the PRC Partner and the Hebei Procurement Centre, for the establishment of the electronic public procurement platform at its own costs;
- (ii) to provide technical training to the staff of the Hebei Procurement Centre regarding the application systems of the electronic public procurement platform;
- (iii) to ensure the normal operation of the electronic public procurement platform and the procurement services system to satisfy the business demand for the Hebei Procurement Centre; and

(iv) to provide professional services, for which the PRC Partner may charge a service fee in accordance with the government regulations in the PRC, in relation to the establishment of procurement services system, including, among others, procurement transaction services, digital certification services, supplier management and credit investigation services, supply chain management services, financial services, insurance agency services and training and conference services.

Pursuant to the Hebei Cooperation Agreement, the Hebei Procurement Centre agreed, among others:

- (i) to cooperate with the PRC Partner in the development, integration and optimisation of the software and hardware for electronic public procurement;
- (ii) to prepare for the development of electronic public procurement in the Hebei Procurement Centre, including the obtaining of regulatory approval for relevant development proposals, establishing the management system and the business model of the electronic public procurement platforms and providing advisory services in relation to the improvement of such platforms;
- (iii) to maintain the normal operation of the electronic public procurement platform in terms of their management;
- (iv) to support and supervise the development of the market-oriented services of the PRC Partner; and
- (v) to provide assistance to the PRC Partner in its activities relating to the government procurement business.

PRINCIPAL TERMS OF THE CONFERENCE COOPERATION AGREEMENT

Pursuant to the Conference Cooperation Agreement, the PRC Partner agreed, among others, to undertake the organisation of the Proposed Conference at its own costs and the Hebei Procurement Centre agreed, among others, to supervise and assist the PRC Partner in organising the Proposed Conference. The PRC Partner shall be entitled to all profits arising from the Proposed Conference pursuant to the Conference Cooperation Agreement. As set out in the Conference Cooperation Agreement, the expected participants of the Proposed Conference would include the Vice Premier of the State Council of the PRC, the Director of 國務院機關事務管理局 (the Government Offices Administration of the State Council of the PRC*), the directors of 機關事務管理局 (bureaus for government offices administration*) of various provinces and cities in the PRC and the directors of various provincial-level and city-level government procurement centres in the PRC and it was expected that about 350 guests would be invited to take part in the Proposed Conference.

The Hebei Cooperation Agreement and the Conference Cooperation Agreement constitute strategic cooperation agreements between the PRC Partner and the Hebei Procurement Centre. Further agreement(s) may be signed between the CPP Subsidiary and the PRC Partner pursuant to the Hebei Cooperation Agreement, the Conference Cooperation Agreement and the Authorisation Letter may or may not constitute notifiable and/or connected transaction(s) for the Company under the Listing Rules. The Company will keep the shareholders and potential investors of the Company informed of any material development in connection with the above matter by way of further announcement(s) as and when appropriate.
