"AUM"	assets under management
"average securities brokerage commission rate"	equals commission and fee income on securities brokerage of our Group as divided by our brokerage trading turnover of stocks and funds in the PRC
"CAGR"	compound annual growth rate
"ChiNext Board"	the growth enterprise board launched by the Shenzhen Stock Exchange (深圳證券交易所創業板)
"collective asset management plan(s)"	an asset management contract entered into with multiple clients by a securities firm in the PRC, pursuant to which the clients' assets are placed in custody of commercial banks with qualification to hold client transaction settlement funds or other institutions approved by the CSRC, and the securities firm provides asset management services to the clients through designated accounts
"corporate pension funds"	the supplementary pension insurance scheme established voluntarily by enterprises and their employees in addition to the basic pension insurance in which they participate in accordance with the law
"CSI 300 Index"	a capitalization-weighted stock market index designed to replicate the performance of 300 stocks traded on the Shanghai Stock Exchange and the Shenzhen Stock Exchange, which is compiled by the China Securities Index Company, Ltd.* (中證指數有限公司)
"ETFs"	exchange-traded funds
"futures IB business"	the business activities in which securities firms, as commissioned by futures companies, introduce clients to futures companies to provide futures brokerage and other related services
"H shares"	overseas-listed shares of PRC companies that are traded on the Hong Kong Stock Exchange
"HS300 Index Futures"	Shanghai-Shenzhen 300 index futures contracts* (滬深300股票指數期貨合約)

"margin and securities refinancing"	a business in which securities firms can act as intermediaries to borrow funds or securities from the CSFC and lend such funds and securities to their clients

"Net Capital"	equals net assets minus risk-adjusted financial assets minus other risk-adjusted assets and contingent liability plus/ minus capital from other adjustments recognized or approved by the CSRC
"net revenue from securities brokerage business"	brokerage commission and fee income received less commission paid to account executives and commission and fee expenses primarily paid to the exchanges
"New OTC Board"	a pilot board launched to provide an OTC market for quotations and transfers of shares of unlisted joint stock companies registered in the Zhongguancun Science and

"SIFMA"	Securities Industry and Financial Markets Association in the U.S.
"SME Board"	the Small and Medium Enterprises Board of the Shenzhen Stock Exchange* (深圳證券交易所中小企業板)
"sponsor representative"	professional representative qualified in the PRC to sponsor and execute the offerings and listings of securities pursuant to the Measures for the Administration of the Sponsorship of the Offering and Listing of Securities of the PRC* (證券發行上市保薦業務管理辦法)
"stock index futures"	cash-settled standardized futures contracts on the value of a particular stock market index
"targeted asset management plan(s)"	a targeted asset management contract entered into by a securities firm in the PRC with a single client, pursuant to which the securities company provides asset management services to the client through accounts under the client's name
"VaR"	value at risk
"XBRL"	a freely available, open and global standard for exchanging business information (also known as "eXtensible Business Reporting Language"), which allows the expression of semantic meaning commonly required in business reporting
