The unaudited pro forma financial information should be read in conjunction with the section entitled "Financial Information" in this prospectus and the "Accountant's Report" set forth in Appendix I to this prospectus.

A. UNAUDITED PRO FORMA STATEMENT OF ADJUSTED NET TANGIBLE ASSETS

The following unaudited pro forma statement of adjusted net tangible assets of the Group prepared in accordance with Rule 4.29 of the Listing Rules is for illustrative purposes only, and is set out below to illustrate the effect of the Global Offering on the net tangible assets of the Group attributable to the equity holders of the Company as at 30 April 2013 as if the Global Offering had taken place on 30 April 2013.

This unaudited pro forma statement of adjusted net tangible assets has been prepared for illustrative purposes only and because of its hypothetical nature, it may not give a true picture of the combined net tangible assets of the Group as at 30 April 2013 or at any future dates following the Global Offering. It is prepared based on the combined net assets of the Group as at 30 April 2013 as set out in the Accountant's Report of the Group, the text of which is set out in Appendix I to this prospectus, and adjusted as described below. The unaudited pro forma statement of adjusted net tangible assets does not form part of the Accountant's Report.

- (1) The audited combined net tangible assets attributable to the equity holders of the Company as at 30 April 2013 is extracted from the Accountant's Report set out in Appendix I to this prospectus, which is based on the audited combined net assets of the Group attributable to equity holders of the Company as at 30 April 2013 of HK\$263,029,000 with an adjustment for the intangible assets as at 30 April 2013 of HK\$30,801,000.
- (2) The estimated net proceeds from the Global Offering are based on the indicative Offer Price of HK\$2.22 and HK\$2.81 per Share after deduction of the estimated underwriting fees and other related expenses (excluding approximately HK\$8.70 million listing expenses which has been accounted for prior to 30 April 2013) payable by the Company and takes no account of any Shares which may be allotted and issued pursuant to the options which have been or may be granted under the Pre-IPO Share Option Scheme and the Share Option Scheme.
- (3) The unaudited pro forma net tangible assets per Share is arrived at after the adjustments referred to in the preceding paragraphs and on the basis that 720,000,000 Shares were in issue assuming that the Global Offering has been completed on 30 April 2013 but takes no account of any Shares which may be allotted and issued or repurchased by the Company pursuant to the General Mandate to Issue Shares or the General Mandate to Repurchase Shares as described in the section headed "Share Capital" in this prospectus and any Shares which may be allotted and issued pursuant to the options which have been or may be granted under the Pre-IPO Share Option Scheme and the Share Option Scheme.
- (4) No adjustment has been made to reflect any trading results or other transactions of our Group entered into subsequent to 30 April 2013. In particular, the unaudited pro forma adjusted net tangible assets has not been adjusted for dividends of HK\$151,000,000 declared and paid by the Group subsequent to 30 April 2013. Had the dividends been taken into account the unaudited pro forma adjusted net tangible assets per Share would be reduced to HK\$0.62 and HK\$0.77 based on the Offer Price of HK\$2.22 and HK\$2.81 per Share respectively.

INDEPENDENT REPORTING ACCOUNTANT'S ASSURANCE REPORT ON THE COMPILATION OF UNAUDITED PRO FORMA FINANCIAL INFORMATION INCLUDED IN A PROSPECTUS**TO THE DIRECTORS OF INTERNATIONAL HOUSEWARES RETAIL COMPANY LIMITED**

We have completed our assurance engagement to report on the compilation of unaudited pro forma financial information of International Housewares Retail Company Limited (the "Company") and its subsidiaries (collectively the "Group") by the directors for illustrative purposes only. The unaudited pro forma financial information consists of the unaudited pro forma statement of adjusted net tangible assets of the Group as at 30 April 2013 and related notes (the "Unaudited Pro Forma Financial Information") as set out on pages II-1 to II-2 of the Company's prospectus dated 12 September 2013, in connection with the proposed initial public offering of the shares of the Company. As part of this process, information about the Group's financial position has been extracted by the directors from the Group's financial information for the year ended 30 April 2013, on which an accountant's report has been published.

The directors are responsible for compiling the Unaudited Pro Forma Financial Information in accordance with paragraph 4.29 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and with reference to Accounting Guideline 7 "Preparation of Pro Forma Financial Information for Inclusion in Investment Circulars" ("AG 7") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA").

We do not accept any responsibility for any reports previously given by us on any financial information used in the compilation of the Unaudited Pro Forma Financial Information beyond that owed to those to whom those reports were addressed by us at the dates of their issue.

We conducted our engagement in accordance with Hong Kong Standard on Assurance Engagements 3420 "Assurance Engagements to Report on the Compilation of Pro Forma Financial Information Included in a Prospectus", issued by the HKICPA. This standard requires that the reporting accountant comply with ethical requirements and plans and performs procedures to obtain reasonable assurance about whether the directors have compiled the Unaudited Pro Forma Financial Information in accordance with paragraph 4.29 of the Listing Rules and with reference to AG 7 issued by the HKICPA.

For purposes of this engagement, we are not responsible for updating or reissuing any reports or opinions on any historical financial information used in compiling the Unaudited Pro Forma Financial Information, nor have we, in the course of this engagement, performed an audit or review of the financial information used in compiling the Unaudited Pro Forma Financial Information.

The purpose of unaudited pro forma financial information included in a prospectus is solely to illustrate the impact of a significant event or transaction on unadjusted financial information of the entity as if the event had occurred or the transaction had been undertaken at an earlier date selected for purposes of the illustration. Accordingly, we do not provide any assurance that the actual outcome of the proposed initial public offering at 30 April 2013 would have been as presented.

A reasonable assurance engagement to report on whether the Unaudited Pro Forma Financial Information has been properly compiled on the basis of the applicable criteria involves performing procedures to assess whether the applicable criteria used by the directors in the compilation of the Unaudited Pro Forma Financial Information provide a reasonable basis for presenting the significant effects directly attributable to the event or transaction, and to obtain sufficient appropriate evidence about whether:

- The related pro forma adjustments give appropriate effect to those criteria; and
- The Unaudited Pro Forma Financial Information reflects the proper application of those adjustments to the unadjusted financial information.

The procedures selected depend on the reporting accountant's judgment, having regard to the reporting accountant's understanding of the nature of the company, the event or transaction in respect of which the Unaudited Pro Forma Financial Information has been compiled, and other relevant engagement circumstances.
