#### **1. General information about the changes in shareholdings**

The Company received notification on 10 December 2013 from Anbang Property & Casualty Insurance Company Ltd. that Anbang Property & Casualty Insurance Company Ltd. had recently increased its shareholding in the Company by an aggregate of 1,133,260,873 A shares with Anbang Property & Casualty Insurance Company Ltd. – Conventional Insurance Products Account through the trading system on the Shanghai Stock Exchange. Following the increases, Anbang Property & Casualty Insurance Company Ltd. holds 1,260,992,284 A shares of the Company, representing 5.00000002% of the Company's total share capital, which amounted to and exceeded 5% of the Company's total share capital for the first time.

#### **2. General information about Anbang Property & Casualty Insurance Company Ltd.**

Anbang Property & Casualty Insurance Company Ltd. has a registered capital of RMB9 billion and its legal representative is Zhang Feng. The business scope of the company includes: property and casualty insurance, liability insurance, credit and guarantee insurance, short-term health insurance and accidental injury insurance, re-insurance in connection with the above insurance businesses, insurance fund application business permitted under the PRC laws and regulations and other businesses approved by China Insurance Regulatory Commission. The substantial shareholder of the company is Anbang Insurance Group Co., Ltd.

### 3. Follow-up events

As at the date of the announcement, Anbang Property & Casualty Insurance Company Ltd. holds 1,260,992,284 A shares of the Company, representing 5.00000002% of the Company's total share capital and such increase of shareholding in the Company has not caused any changes to the ranking of the existing largest shareholder of the Company.

The Company shall procure that Anbang Property & Casualty Insurance Company Ltd. comply with the information disclosure obligations on a timely basis according to the requirement of relevant laws and regulations.
