INTRODUCTION

The purpose of this circular is to, inter alia, provide you with details of (i) the proposed granting of New General Mandate and New Repurchase Mandate; (ii) an explanatory statement regarding the New Repurchase Mandate; (iii) the proposed re-election of Directors; and (iv) notice of the AGM.

CURRENT GENERAL MANDATE AND CURRENT REPURCHASE SHARES

At the annual general meeting of the Company held on 23 May 2013, Shareholders approved, among other things, an ordinary resolution to grant to the Directors the general mandate to allot and issue not more than 216,540,400 Shares, being 20% of the aggregate nominal amount of the issued share capital of the Company of 1,082,702,000 Shares as at the date of passing of the relevant resolution.

As at the Latest Practicable Date, the Current General Mandate has been utilised by the Company as to, pursuant to the sale and purchase agreement dated 27 November 2013 ("Sale and Purchase Agreement") entered into between Champion Miracle Limited, an indirect wholly owned subsidiary of the Company, and Mr. Fan Lin in respect of the 50% registered and paid up capital of Shanghai Fuchao Investment Company Limited, (i) 33,849,129 new Shares have been allotted and issued; and (ii) 65,280,464 new Shares which may fall to be allotted and issued upon full exercise of the conversion rights attaching to the 65,280,464 convertible notes issued pursuant to the Sale and Purchase Agreement. Please refer to the announcements of the Company dated 27 November 2013 and 28 February 2014 respectively for the details of the Sale and Purchase Agreement. As at the Latest Practicable Date, approximately 45.78% of the Current General Mandate has been utilized and no Shares have been repurchased by the Company; whether on the Stock Exchange or otherwise.

PROPOSED GRANT OF NEW GENERAL MANDATE AND NEW REPURCHASE MANDATE

Unless otherwise renewed, the Current General Mandate will lapse at the conclusion of the AGM. Ordinary resolutions will be proposed at the AGM to grant to the Directors New General Mandates:

- (i) to allot, issue and otherwise deal with new Shares with an aggregate nominal amount not exceeding 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the relevant resolution at the AGM; and
- (ii) to repurchase Shares with an aggregate nominal amount not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the relevant resolution at the AGM.

In addition, a separate ordinary resolution will be proposed at the AGM to extend the New General Mandate to Shares repurchased by the Company pursuant to the New Repurchase Mandate (if granted to the Directors at the AGM).

The Directors have no present intention to exercise the New General Mandate or the New Repurchase Mandate (if granted to the Directors at the AGM).

The New General Mandate and the New Repurchase Mandate will expire at the earliest of (a) the conclusion of the next annual general meeting of the Company; (b) the date by which the next annual general meeting of the Company is required to be held by law or by the Articles; or (c) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company prior to the next annual general meeting of the Company.

As at the Latest Practicable Date, a total of 1,210,649,129 Shares were in issue. Subject to the passing of the ordinary resolutions granting the New General Mandate to the Directors and on the basis that no Shares will be issued and / or repurchased by the Company between the Latest Practicable Date and the date of the AGM, the Company would be allowed to allot and issue a maximum of 242,129,825 Shares, representing 20% of the aggregate nominal amount of the share capital of the Company as at the date of the AGM.

As at the Latest Practicable Date, the Company has no outstanding Options granted under the Share Option Scheme or, except for 65,280,464 conversion shares to be alloted and issued upon conversion of the convertible bond in a principle amount of HK\$270,000,000 pursuant to the Sale and Purchase Agreement, any convertible securities which entitles the holders thereof to convert the same into Shares.

An explanatory statement containing information regarding the New Repurchase Mandate is set out in the Appendix I to this circular.

RETIREMENT OF DIRECTORS AND RE-ELECTION OF RETIRING DIRECTORS

Mr. Chiu Chi Hong and Mr. Lau Wan Cheung will retire from office as Directors by rotation at the AGM and being eligible, offer themselves for re-election pursuant to Article 87 of the Articles. Particulars of the Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

DIRECTOR RESPONSIBILITY

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

As at the Latest Practicable Date, the Company has no controlling Shareholders. Accordingly, Mr. Chiu Chi Hong, being Director, and their associates (if any), who are interested in 61,240,000 Shares, approximately 5.06% of the issued share capital of the Company, shall abstain from voting in favour of the resolution 3(a) at the AGM.

RECOMMENDATION

The Directors consider that the granting of the New General Mandate, the New Repurchase Mandate and the re-election of the retiring Directors are in the best interests of the Company and the Shareholders as a whole. This appendix includes an explanatory statement required by the Stock Exchange to be presented to the Shareholders concerning the New Repurchase Mandate proposed to be granted to the Directors.

This explanatory statement contains all the information required pursuant to rule 10.06 of the Listing Rules which is set out as follows:

STOCK EXCHANGE RULES FOR REPURCHASES OF SHARES

The Listing Rules permits companies with a primary listing on the Stock Exchange to repurchase their shares on the Stock Exchange subject to certain restrictions.

The Listing Rules provide that all proposed repurchases of shares by a company with a primary listing on the Stock Exchange must be approved by shareholders in advance by an ordinary resolution at a general meeting, either by way of a general mandate or by a specific approval of a particular transaction and that the shares to be repurchased must be fully paid up.

SHARE CAPITAL

As at the Latest Practicable Date, the issue share capital of the Company comprised 1,210,649,129 Shares which are fully paid.

Subject to the passing of the relevant ordinary resolutions to approve the general mandates to issue and repurchase Shares and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the AGM, the Directors would be authorized to exercise the powers of the Company to repurchase a maximum of 121,064,912 Shares.

REASONS FOR SHARE REPURCHASE

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earning per Share and will only be made when the Directors believe that such repurchase will benefit the Company and the Shareholders.

FUNDING OF REPURCHASES

Any repurchase will be made out of funds which are legally available for the purpose in accordance with the memorandum and articles of association of the Company, the Listing Rules and the applicable laws of the Cayman Islands. The Companies Law provides that the amount of capital repaid in connection with a share repurchase may be paid out of the profits of the Company or the proceeds of a fresh issue of Shares made for the purposes of the repurchase or out of capital subject to and in accordance with the Companies Law. The amount of premium payable on repurchase may only be paid out of either the profits of the Company or out of the share premium account before or at the time the Company's Shares are repurchased in the manner provided for in the Companies Law.

The Directors do not propose to exercise the New Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital of the Company or the gearing position which in the opinion of the Directors are from time to time appropriate for the Company.

POSSIBLE MATERIAL ADVERSE IMPACT

There might be material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts for the year ended 31 December 2013) in the event that the New Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the New Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the Company's working capital requirements or the gearing levels. occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time having regard to the circumstances then pertaining.

DIRECTORS' UNDERTAKING

EFFECT OF THE TAKEOVERS CODE

If as a result of Shares repurchased by the Company pursuant to the New Repurchase Mandate, a substantial Shareholder's proportionate interest in voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. As a result, a Shareholder, or group of Shareholders acting in concert (as that term is defined in the Takeovers Code), could, depending on the level of increase of the shareholding, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date and to the best of knowledge and belief of the Directors, the following persons were directly or indirectly had an interest in 5% or more of the nominal value of the Shares that carry a right to vote in all circumstances at general meetings of the Company:

In the event that the Directors exercised in full the power to repurchase shares of the Company in accordance with the terms of the Ordinary Resolution no. 5 to be proposed at the AGM, the aforesaid interests of Mr. Li and Mr. Chiu in the Shares as at the Latest Practicable Date would be proportionally increased to approximately 19.23% and 5.62% respectively. In view of this it would be expected that none of the aforesaid parties would give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. However, the Directors have no present intention to exercise the New Repurchase Mandate to such extent as would give rise to an obligation to make a mandatory offer under the Takeovers Code or if the repurchase would result in less than 25% of the issued share capital of the Company being held in public hands. Save as above, the Directors are not aware of any consequences which would arise under the Takeovers Code if the New Repurchase Mandate is to be exercised in full.

DIRECTORS' DEALINGS

None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their associates presently intends to sell Shares to the Company under the New Repurchase Mandate in the event that such mandate as proposed in the Ordinary Resolution no. 5 is approved by the Shareholders.

TO BE RE-ELECTED AT THE AGM

Set out below are details of the proposed Directors to be re-elected at the AGM.

Mr. Chiu Chi Hong (招自康), aged 49, has been appointed as an executive Director of the Company on 11 July 2011. He holds a Bachelor of Business degree from Griffith University, Australia. He has over 15 years' experience in business development, corporate management, finance and accounting fields. Mr. Chiu was an executive director of Siberian Mining Group Company Limited (stock code: 1142), a company listed on the Main Board of the Stock Exchange and resigned in August 2010. Mr. Chiu is currently the director of certain subsidiaries of the Company. Saved as disclosed above, Mr. Chiu did not hold any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years.

Mr. Chiu is the shareholder of the Company within the meaning of Part XV of Securities and Futures Ordinance (the "SFO") but he does not have any relationship with other Directors, senior management, substantial or controlling shareholders of the Company.

Mr. Chiu has entered into a director's service agreement with the Company for a term of three years commencing on 11 July 2011 subject to rotation and re-election at the annual general meeting of the Company in accordance with the articles of association of the Company. Save as disclosed above, Mr. Lau did not hold any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years or any other position with the Company and other members of the Group or other major appointments and qualifications.

Mr. Lau does not have any relationship with other Directors, senior management, substantial or controlling shareholders of the Company and he had no interests in the Shares which are required to be disclosed pursuant to Part XV of the SFO.

 - (iii) the exercise of any option under the share option scheme adopted by the Company or similar arrangement for the time being adopted for the grant or issue to officers and/or employees of the Company and/or any of its subsidiaries of Shares or rights to acquire Shares of the Company; or
 - (iv) any scrip dividends scheme or similar arrangement providing for the allotment and issue of Shares in lieu of the whole or part of a dividend on Shares in accordance with the articles of association of the Company in force from time to time; and
 - (v) a specific authority granted by the shareholders of the Company, shall not exceed 20% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of this resolution, and the said approval shall be limited accordingly; and
- (d) for the purpose of this resolution:

"Relevant Period" means the period from the passing of this resolution until whichever is the earliest of:

- the conclusion of the next annual general meeting of the Company;
- ii. the expiration of the period within which the next annual general meeting of the Company is required by the articles of association of the Company or the applicable laws of the Cayman Islands to be held; or
- iii. the date on which the authority set out in this resolution is revoked or varied by an ordinary resolution of the shareholders of the Company in general meeting;

"Rights Issue" means the allotment, issue or grant of Shares pursuant to an offer of Shares open for a period fixed by the Directors to the holders of Shares whose names appear on the register of members of the Company on a fixed record date in proportion to their then holdings of such Shares as at that date (subject to such exclusions or other arrangements as the Directors may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of any relevant jurisdiction, or the requirements of any recognised regulatory body or any stock exchange in any territory applicable to the Company).

5. To consider as special business and, if thought fit, pass with or without amendments, the following resolution as an ordinary resolution:

- iii. the date on which the authority set out in this resolution is revoked or varied by an ordinary resolution of the shareholders of the Company in general meeting."
- 6. To consider as special business and, if thought fit, pass with or without amendments, the following resolution as an ordinary resolution:

"THAT conditional upon the passing of the resolutions numbered 4 and 5 as set out in the notice (the "Notice") convening this meeting, the unconditional general mandate granted to the Directors to exercise the powers of the Company to allot, issue and otherwise deal with Shares in the capital of the Company pursuant to the resolution numbered 4 as set out in the Notice be and the same is hereby extended by the addition to the aggregate nominal amount of share capital of the Company which may be allotted or agreed conditionally or unconditionally to be allotted by the Directors pursuant to such general mandate of an amount representing the aggregate nominal amount of the share capital of the Company purchased by the Company under the authority granted pursuant to the resolution numbered 5 as set out in the Notice provided that such amount shall not exceed 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of this resolution."
