A. FURTHER INFORMATION ABOUT OUR COMPANY

1. Incorporation of our Company

Our Company was established in the PRC as a joint stock company with limited liability on 26 June 2008. Our Company has established its principal place of business in Hong Kong and was registered as a non-Hong Kong company under Part XI of the Predecessor Companies Ordinance on 7 February 2014. In connection with such registration, our Company has appointed Ms. Kwong Yin Ping Yvonne of Flat A 15/F Block 2, 7 Tai Hang Road, Causeway Bay, Hong Kong as the authorized representative of our Company for the acceptance of service of process and notices on behalf of our Company in Hong Kong.

As our Company was established in the PRC, its operation, corporate structure and the Articles of Associations are subject to the laws and regulations of the PRC. A summary of certain relevant aspects of the laws and regulations of the PRC and various provisions of our Company's Articles is set out in Appendices V and VI to this prospectus.

2. Changes in registered capital of our Company

- (1) As approved by the SASAC and the CSRC, the Company issued 2,500,000,000 RMB ordinary shares (A Shares) which have been listed on the Shanghai Stock Exchange in 2009. Immediately following the A Shares Offering, the registered capital of the Company was increased from RMB5,800 million to RMB8,300 million on 21 January 2010.
- (2) As approved by the SASAC and the CSRC, the Company placed 2,020,056,303 RMB ordinary shares (A Shares). Immediately following the A Shares placing, the registered capital of the Company was increased from RMB8,300 million to RMB10,320,056,303 on 10 April 2012.

Save as aforesaid, up to the Latest Practicable Date, there has been no alteration in the share capital of our Company since incorporation.

3. Shareholders resolutions passed on 3 January 2014

At the 2013 second extraordinary Shareholders' general meeting of our Company held on 3 January 2014, the following resolutions, among others, were passed and approved:

- (a) the issue by our Company of the H Shares of nominal value of RMB1.00 each and such H Shares be listed on the Hong Kong Stock Exchange;
- (b) the number of H Shares to be issued shall not be more than 15% of the total issued share capital of our Company as enlarged by the Global Offering, and the grant to the bookrunners the Over-allotment Option of not more than 15% of the number of H Shares issued pursuant to the Global Offering;
- (c) subject to the completion of the Global Offering, the conditional adoption of the Articles of Association, which shall become effective on the Listing Date and the authorization to the Board to amend the Articles of Association in accordance with the requirements by the relevant regulatory authorities in accordance with the relevant laws and regulations; and

(d) authorization of the Board to handle all matters relating to, among other things, all matters relating to the Global Offering, the issue and listing of the H Shares.

4. Our principal subsidiaries

Our principal subsidiaries, jointly controlled entities and associates are set out in Notes 15 to 17 the Accountants' Report, the text of which is set out in Appendix I to this prospectus.

5. Changes in the share capital of our principal subsidiaries

Save as disclosed below, there has been no alteration in the share capital of the principal subsidiaries of our Company within the two years preceding the date of this prospectus:

(1) CNR Beijing Nankou

The registered capital of CNR Beijing Nankou was increased from RMB86,139,318 to RMB305.0 million on 14 June 2012.

(2) CNR Taiyuan

The registered capital of CNR Taiyuan was increased from RMB295.0 million to RMB327.0 million on 16 May 2012.

(3) CNR Xi'an

The registered capital of CNR Xi'an was increased from RMB290.0 million to RMB610.0 million on 26 June 2013.

(4) CNR Dalian

The registered capital of CNR Dalian was increased from RMB1,470.0 million to RMB2,443.0 million on 14 June 2012.

(5) CNR Changchun

The registered capital of CNR Changchun was increased from RMB2,079,387,600 to RMB 2,452.8 million on 16 August 2013.

3. Litigation

During the Track Record Period and up to the Latest Practicable Date, no member of our Group was engaged in any litigation or arbitration of material importance and no litigation or claim of material importance is known to our Directors to be pending or threatened against any member of our Group.

4. Joint Sponsors

The Joint Sponsors have made an application on behalf of our Company to the Listing Committee for the listing of, and permission to deal in, the H Shares in issue and H Shares to be issued as mentioned herein (including any H Shares falling to be issued pursuant to the exercise of the Overallotment Option).

Each of the Joint Sponsors is independent from our Company pursuant to Rule 3A.07 of the Hong Kong Listing Rules. The total amount of fees payable to Joint Sponsors by the Company is US\$2.7 million.

5. Compliance Adviser

We have appointed China International Capital Corporation Hong Kong Securities Limited as our compliance adviser pursuant to Rule 3A.19 of the Hong Kong Listing Rules. Pursuant to Rule 3A.23 of the Hong Kong Listing Rules, the compliance adviser will advise us on the following circumstances:

- (a) before the publication of any regulatory announcement, circular or financial report;
- (b) where a transaction, which might be a notifiable or connected transaction, is contemplated including share issues and share repurchases;
- (c) where we propose to use the proceeds of the Global Offering in a manner different from that detailed in this prospectus or where our business activities, developments or results deviate from any estimate, or other information in this prospectus; and
- (d) where the Hong Kong Stock Exchange makes an inquiry of us regarding unusual movements in the price or trading volume of our Shares.

The term of the appointment shall commence on the Listing Date and end on the date on which we distribute our annual report in respect of our financial results for the first full financial year commencing after the Listing Date and such appointment may be subject to extension by mutual agreement.

6. PRC Financial Adviser

We have appointed CNR Financial as our PRC financial adviser to provide financial advisory services relating to our fund management and planning. The appointment of CNR Financial is at our own initiative and not a requirement under the Hong Kong Listing Rules. Under the terms of the engagement, principal functions performed by our financial adviser include the provision of financial consulting services and related advisory services.

7. Preliminary expenses

The preliminary expenses of our Company in relation to the Listing amounted to HK\$1,970 and have been paid by our Company.

8. Promoters

The promoters of our Company are as follows: CNRG, Beijing CNR Investment, China Chengtong Holdings Group Limited* (中國誠通控股集團有限公司) and China Huarong Assets Management Co., Ltd.* (中國華融資產管理公司).

Save as disclosed in this prospectus, within the two years preceding the date of this prospectus, no cash, securities or other benefit had been paid, allotted or given, nor are any such cash, securities or other benefit intended to be paid, allotted or given, to the promoter of our Company in connection with the Global Offering or the related transactions described in this prospectus.

Certain categories of taxpayers are likely to be regarded as deriving trading gains rather than capital gains (for example, financial institutions, insurance companies and securities dealers) unless these taxpayers can prove that the investment securities are held for long-term investment.

Trading gains from sales of H Shares effected on the Hong Kong Stock Exchange will be considered to be derived from or arising in Hong Kong. Liability for Hong Kong profits tax would thus arise in respect of trading gains from sales of H Shares effected on the Hong Kong Stock Exchange realized by persons carrying on a business of trading or dealing in securities in Hong Kong.
