PLACING OF EXISTING SHARES AND SUBSCRIPTION OF NEW SHARES

On 25 June 2014 (after trading hours), the Company entered into the Placing and Subscription Agreement with the Vendor and the Placing Agent pursuant to which the Vendor agreed to place, through the Placing Agent, on a best endeavour basis, up to 110,000,000 Placing Shares to not less than six Places at a price of HK\$0.57 per Placing Share.

Pursuant to the Placing and Subscription Agreement, the Vendor conditionally agreed to subscribe for up to 110,000,000 New Shares at a price of HK\$0.57 per New Share.

The Subscription is conditional upon, (i) completion of the Placing; and (ii) the Listing Committee of the Stock Exchange granting the listing of, and permission to deal in, the New Shares.

Assuming all Placing Shares are placed, the Placing Shares (or the New Shares) represent (i) approximately 7.36% of the existing issued share capital of the Company of 1,494,452,000 Shares as at the date of this announcement; and (ii) approximately 6.86% of the issued share capital of the Company of 1,604,452,000 Shares as enlarged by the Subscription.

The Placing Price of HK\$0.57 represents:

- (i) a discount of approximately 19.72% to the closing price of HK\$0.71 per Share as quoted on the Stock Exchange on the Last Trading Day; and
- (ii) a discount of approximately 18.57% to the average closing price of HK\$0.70 per Share as quoted on the Stock Exchange from 18 June 2014 to 24 June 2014, both dates inclusive, being the last five consecutive trading days prior to the date of the Placing and Subscription Agreement.

Assuming all Placing Shares are placed, the net proceeds of approximately HK\$61 million from the Subscription is intended to be used for general working capital and/or to finance potential investment projects.

Shareholders and potential investors should note that completion of the Subscription and Placing are subject to the satisfaction of the conditions precedent in the Placing and Subscription Agreement. As the Placing and Subscription may or may not proceed, Shareholders and potential investors are advised to exercise caution when dealing in the Shares.

THE PLACING

Placing Shares

Pursuant to the Placing and Subscription Agreement, the Placing Agent has agreed to procure, on a best endeavour basis, not less than six Placees for the purchase of up to 110,000,000 Placing Shares at the Placing Price. Assuming all Placing Shares are placed, the Placing Shares represent (i) approximately 7.36% of the existing issued share capital of the Company of 1,494,452,000 Shares as at the date of this announcement; and (ii) approximately 6.86% of the issued share capital of the Company of 1,604,452,000 Shares as enlarged by the Subscription.

Placing commission

The Placing Agent will receive a placing commission of 1.6% equivalent to the Placing Price multiplied by the number of the Placing Shares successfully placed by the Placing Agent, which was arrived at after arm's length negotiation between the Company and the Placing Agent. The Placing Agent and its ultimate beneficial owners are independent of and not connected with the Company and its connected persons.

Placees

The Placing Agent will place the Placing Shares, on a best endeavour basis, to not less than six Placees who are individual, institutional or professional investors and whose ultimate beneficial owners will be (i) independent of and not connected with the Company and its connected persons; and (ii) third parties independent of and not acting in concert with the Vendor or any person acting in concert with him.

Placing Price

The Placing Price is HK\$0.57, representing:

- (i) a discount of approximately 19.72% to the closing price of HK\$0.71 per Share as quoted on the Stock Exchange on the Last Trading Day; and
- (ii) a discount of approximately 18.57% to the average closing price of HK\$0.70 per Share as quoted on the Stock Exchange from 18 June 2014 to 24 June 2014, both dates inclusive, being the last five consecutive trading days prior to the date of the Placing and Subscription Agreement.

The Placing Price was determined with reference to the prevailing market price of the Shares and was negotiated on an arm's length basis among the Company, the Vendor and the Placing Agent. The Directors consider that the Placing Price and the placing commission are fair and reasonable based on the current market conditions and in the interests of the Company and the Shareholders as a whole.

Ranking of Placing Shares

The Placing Shares rank pari passu among themselves and with Shares in issue as at the date of this announcement.

Conditions of the Placing

The Placing is unconditional.

Completion

The Placing is expected to be completed on 26 June 2014, being the next Business Day after the date of the Placing and Subscription Agreement, or such other date as the Vendor and the Placing Agent shall agree.

THE SUBSCRIPTION

The New Shares

The New Shares will be issued under the General Mandate to allot, issue and deal with Shares granted to the Directors by resolution of the Shareholders passed at the AGM, subject to the limit up to 20% of the then issued share capital of the Company as at the date of the AGM. Under the General Mandate, the Company is authorised to issue up to 298,890,400 Shares. Up to the date of this announcement, no Shares have been issued under the General Mandate. Following completion of the Subscription and assuming all Placing Shares are placed, a total number of 110,000,000 New Shares will be allotted and issued, leaving a balance of 188,890,400 Shares to be allotted and issued under the General Mandate.

The Subscription Price

The Subscription Price is HK\$0.57 per New Share. The Subscription Price is the same as the Placing Price and was determined after arm's length negotiation between the Company and the Vendor with reference to the Placing Price.

Number of New Shares

The number of New Shares is equivalent to the number of Placing Shares.

Ranking of New Shares

The New Shares, when issued and fully paid, will rank pari passu among themselves and with Shares in issue at the time of allotment and issue of the New Shares.

Conditions of the Subscription

The Subscription is conditional upon:

- (i) the completion of the Placing; and
- (ii) the Listing Committee of the Stock Exchange granting approval for the listing of, and permission to deal in, the New Shares.

Completion of the Subscription will not take place if any of the above conditions are not fulfilled.

Completion

Subject to fulfillment of the above conditions, completion of the Subscription will take place on the second Business Day following the satisfaction of the above conditions or such other date as the Vendor and the Company shall agree.

The Subscription constitutes a connected transaction under the Listing Rules but it falls within the exemption under Rule 14A.31(3)(d) of the Listing Rules if the Subscription is completed within 14 days from the date of the Placing and Subscription Agreement (i.e. 9 July 2014). In the event that the Subscription is not completed within 14 days from the date of the Placing and Subscription Agreement, the Subscription will not fall within the exemption under Rule 14A.31(3)(d) of the Listing Rules and shall be subject to the approval of independent shareholders of the Company and the Company will comply with the relevant connected transaction requirements of Chapter 14A of the Listing Rules.

In the event that the conditions of the Placing and Subscription Agreement are not fulfilled by 7 July 2014, or such later date as may be agreed between the Company and the Vendor, the obligations and liabilities of the Company and the Vendor in relation to the Subscription shall be null and void and the Vendor and the Company shall be released from all rights and obligations pursuant to the Placing and Subscription Agreement.

REASONS FOR THE PLACING AND SUBSCRIPTION

Assuming all the Placing Shares are placed, the gross proceeds from the Subscription will be HK\$62.7 million. The net proceeds of approximately HK\$61 million from the Subscription is intended to be used for general working capital and/or to finance potential investment projects.

It is the Company's strategy to review from time to time potential business opportunity and investments to enhance the Shareholders' value. The Group has been focusing on finding suitable investments that present development opportunities and also able to provide a sustainable stream of cash flow and profit in the long run. At the date of this announcement, the Company has not entered into any legally binding agreements in relation to any investments, however, the additional capital on hand will facilitate the efficient execution of such potential investment projects, if any.

The Directors had considered various ways of raising funds and consider that the Placing and the Subscription represent an opportunity to raise capital for the Company while broadening the Shareholder base and capital base of the Company. Accordingly, the Directors consider the Placing and the Subscription are in the interests of the Company and the Shareholders as a whole.

Completion of the Placing and the Subscription is subject to the satisfaction of the conditions precedent in the Placing and Subscription Agreement. As the Placing and Subscription may or may not proceed, Shareholders and potential investors are advised to exercise caution when dealing in the Shares.

The Group is principally engaged in 1) manufacture and sale of advanced steel flow control products, such as subentry nozzle, stopper, tundish nozzle and ladle shroud and 2) sales and production of paper converting equipment and other relating equipment.

As at the date of this announcement, the authorised share capital of the Company consisted of 3,000,000,000 Shares out of which 1,494,452,000 Shares are issued and fully paid up.

The New Shares will be allotted and issued pursuant to the General Mandate passed at the AGM. Application will be made by the Company to the Listing Committee of the Stock Exchange for the grant of the listing of, and permission to deal in, the New Shares.
