The Board is pleased to announce that Mr. Jin Bingrong (“**Mr. Jin**”) has been appointed as an independent non-executive Director of the Company, with effect from 20 March 2015.

#### **Biography of Mr. Jin**

Mr. Jin Bingrong, aged 66, is a senior economist and has over 20 years of experience in financial industry. Mr. Jin served as an independent non-executive director of bank of Shanghai, Chairman of Shanghai Da’an Financial Bill Delivery Co., Ltd., a non-executive director of SRE Group Limited (Stock Code: 1207), a company listed on The Stock Exchange of Hong Kong Limited (“**Stock Exchange**”) since April 2007 and an independent director of Shanghai Feilo Company Limited, a company listed on the Shanghai Stock Exchange (SHA:600654) from December 2009 to December 2012. Mr. Jin was previously the General Manager of Shanghai Branch of Agricultural Bank of China. Mr. Jin holds a Master’s degree in economics and a bachelor’s degree in finance management, both from Fudan University.

Pursuant to a letter of appointment entered into between the Company and Mr. Jin dated 20 March 2015, the appointment of Mr. Jin is for an initial term of three years and such appointment will be subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Bye-laws of the Company. Mr. Jin will be entitled to a monthly remuneration of HK\$30,000.00, a discretionary bonus and share options under the share option scheme of the Company.

Upon Mr. Jin’s appointment as an independent non-executive director of the Company he will also be appointed as a member of audit committee of the Company.
