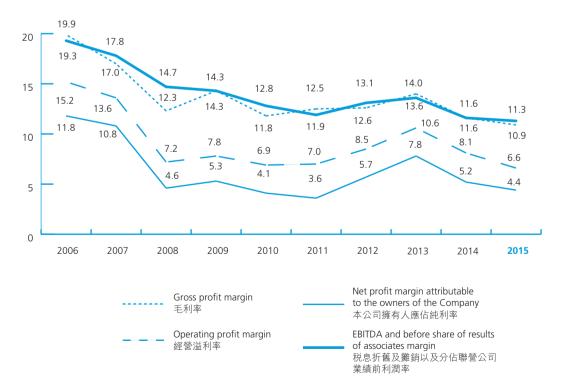

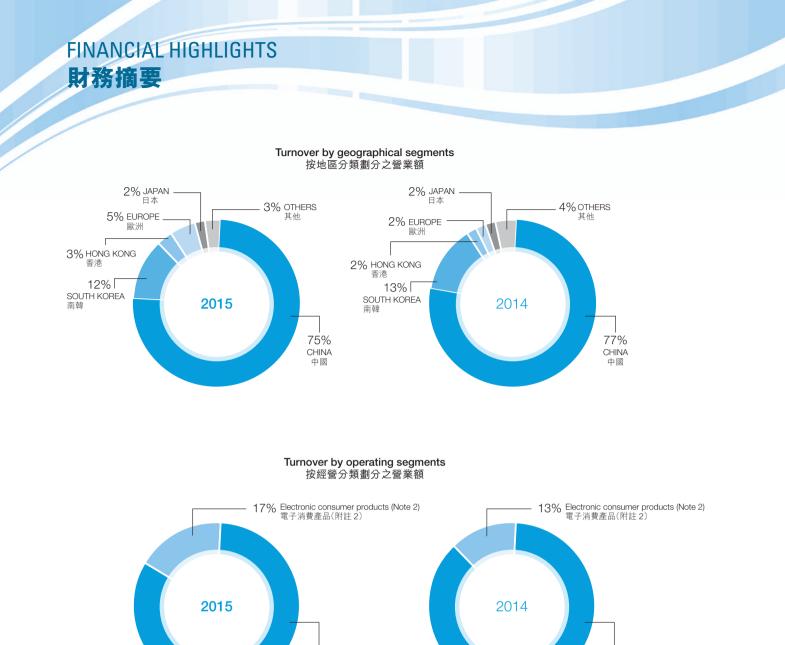


Basic earnings per share, dividends per share and dividend payout ratio 每股基本盈利、每股股息及派息比率

THE CHAIRMAN'S STATEMENT 主席報告書

Truly International Holdings Limited (the "Company" and, together with its subsidiaries, the "Group") has discontinued its consecutive six year revenue growth (2009–2014), the revenue in 2015 was dropped by around HK\$2.0 billion or 9.3% when compared to 2014 (HK\$21.4 billion).

The Group's gross profit margin and net profit margin attributable to owners of the Group in 2015 have been slightly decreased from 11.6% in 2014 to 10.9% in 2015 and 5.2% in 2014 to 4.4% in 2015 respectively. Both gross profit margin and net profit margin attributable to owners of the Group in 2015 were narrowed, which were mainly attributed by the decrease in average selling price of the Group's smartphone related products in 2015. This situation had been one of the major difficulties being encountered by the management team. The management team has reduced the negative impacts on the Group's revenue and profit from the decrease in average selling price of the Group's smartphone related products through optimizing production process, production automation, and enhancing the non-smartphone business development such as automotive and industrial products. Therefore, the management would continue to try their best to enhance the development of non-smartphone businesses and new products, including fingerprint recognition module being launched in late 2015.

Although the Group's key products' average selling price are continuing to drop, the management has confident that the Group's revenue can still grow in 2016 because of better products mix (increasing the revenue proportion by non-smartphone products) and strong market demand on smartphone being maintained.

Our main targets in 2016 are to regain growth in the Group's revenue, improving the profit margins, launching the production of Huizhou factory and raising enough funds to build the 5th generation TFT-LCD production line in Shanwei.

The Group would like to express its appreciation to all the staff and workers for their continuing contribution towards the Group's development. Besides, the Group wishes to extend its gratitude for the continuing support from its shareholders, customers, bankers and business partners.

信利國際有限公司(「本公司」,連同其附屬公司統 稱「本集團」)未能延續連續保持六年的收益增長(二 零零九年至二零一四年),二零一五年收益較二零 一四年(214億港元)下跌約20億港元或9.3%。

於二零一五年,本集團之毛利率及擁有人應佔純 利率分別由二零一四年的11.6%輕微下跌至二零 一五年的10.9%及由二零一四年的5.2%輕微下 跌至二零一五年的4.4%。二零一五年本集團毛利 率及擁有人應佔純利率均收窄,主要由於二零 一五年本集團智能手機相關產品平均售價下跌。 這個情況為管理層團隊面對的主要難題之一。管 理層團隊透過優化生產程序、自動化生產及加強 非智能手機業務發展(如汽車、工業產品等),以 減輕本集團智能手機相關產品平均售價降低對本 集團收益及利潤所造成的負面影響。因此,管理 層將繼續竭盡所能加強非智能手機業務及新產品 發展,包括在二零一五年末量產的指紋識別模組。

縱然本集團主要產品平均售價持續下跌,但憑著 更佳的產品組合(提高非智能手機產品在收益中所 佔比例)及智能手機市場需求依然強勁,管理層有 信心本集團收益可望於二零一六年有所增長。

我們於二零一六年的主要目標為本集團收益重拾 增長、提升利潤率、惠州廠房投產及籌集足夠資 金於汕尾建立第5代TFT-LCD生產線。

本集團謹此感謝所有僱員及員工一直以來為本集 團發展所作出的貢獻。此外,本集團亦向股東、 客戶、銀行及業務夥伴不間斷的支持致以謝忱。

Business Review and Award

Revenue for the year recorded a decrease by approximately 9.3% amounting to HK\$19.4 billion (2014: HK\$21.4 billion) after consecutive six years revenue growth (2009–2014), which was mainly due to average selling price of the Group's smartphone related products being decreased.

Profit for the year attributable to owners of the Company was approximately HK\$845 million which was approximately 24.4% less than last corresponding year in 2014 (approximately HK\$1,118 million). Basic earnings per share decreased to 29.08 HK cents from 38.41 HK cents for corresponding period of the previous year. The 2015 total interim dividends of 7 HK cents per ordinary share were paid and payable during the year 2015 (2014: 10 HK cents per ordinary share). In view of this, the Board of Directors has recommended the payment of a final dividend of 3 HK cents per ordinary share, representing a payout ratio of 34.4%.

The gross profit margin for the year decreased to around 10.9% (2014: 11.6%) and net profit margin for the year attributable to owners of the Company decreased to approximately 4.4% (2014: 5.2%). As stated in the Chairman Statement, decrease in net profit attributable to owners of the Company in 2015 were mainly attributed by the decrease in average selling price of the Group's smartphone related products, including display module and touch module during the year. The main reasons for decreasing in average selling price of smartphone related products were keen competition in the smartphone industry and growth slowdown in smartphone market. However, the negative impacts on the Group's revenue and profit from the decrease in average selling price of the Group's smartphone related products has been minimized through past few years optimizing production process, production automation, and enhancing the non-smartphone business development such as automotive and industrial products.

The Group's LCD business including touch panel products and automotive display business was about 82.7% of the Group's revenue for the year 2015. Other businesses of the Group including the sales of compact camera module and printed circuit board accounted were approximately 17.3% of the Group's revenue in year 2015. LCD business would continue to be the core business of the Group in next few years.

業務回顧及獎項

本年度的收益繼連續六年錄得增長(二零零九年至 二零一四年)後下跌約9.3%至194億港元(二零 一四年:214億港元),主要是由於本集團智能手 機相關產品平均售價下跌所致。

本公司擁有人應佔本年度溢利約為8.45億港元, 較於二零一四年的去年同期(約11.18億港元)減 少約24.4%。每股基本盈利由去年同期的38.41港 仙下跌至29.08港仙。二零一五年每股普通股中期 股息合共7港仙已於二零一五年派付及應付(二零 一四年:每股普通股10港仙)。就此,董事會已 建議派付末期股息每股普通股3港仙,派息比率 為34.4%。

本年度毛利率及本公司擁有人應佔本年度純利率 分別下跌至約10.9%(二零一四年:11.6%)及約 4.4%(二零一四年:5.2%)。誠如主席報告書所 述,於二零一五年,本公司擁有人應佔純利下跌 主要由於本年度本集團智能手機相關產品(包括顯 示模組及觸控模組)平均售價下跌所致。智能手機 相關產品平均售價下跌主要原因是智能手機業競 爭激烈及智能手機市場增長放緩。然而,本集團 智能手機相關產品平均售價下跌對本集團收益及 利潤所造成的負面影響已透過過去數年優化生產 程序、自動化生產及加強非智能手機業務發展(如 汽車、工業產品等)而有所減輕。

本集團的液晶體顯示器業務(包括觸控屏產品及汽 車顯示器業務)佔本集團二零一五年收益約 82.7%。本集團的微型相機模組及印刷電路板銷 售等其他業務則佔本集團二零一五年收益約 17.3%。液晶體顯示器業務將繼續為本集團未來 數年的核心業務。

In order to satisfy continuously the new products specification requirements from the customers and improve the manufacturing processes, the Group continues to put resources in the Group's research and development, the Group spent around HK\$755 million and HK\$803 million in 2015 and 2014 respectively. During 2015, the Group has continued to register many patents related to manufacturing processes of Compact Camera Module, LCD Products and Touch Panel Products in China. Besides, the Group was obtained a few Best Partner Awards from business partners in 2015. Besides, the Group has started to supply the fingerprint recognition module to the customers in late 2015. The fingerprint recognition application will be an indispensable component of a smartphone and would be one of the main driver for revenue growth in 2016.

Segment Information

Information reported to the Board of Directors of the Company, being the chief operating decision maker, for the purposes of resource allocation and assessment of performance focuses on the sales of different types of products. Inter-segment sales are charged at prevailing market rates. Thus the Group is currently organised into two operating segments which are sales of LCD products and electronic consumer products. The information for each operating segment is as follows:

為持續滿足客戶對新產品規格的要求及改良生產 工序,本集團將繼續投放資源於本集團的研發, 本集團於二零一五年及二零一四年的研發開支分 別約為7.55億港元及8.03億港元。於二零一五年, 本集團繼續在中國註冊多項有關微型相機模組、 液晶體顯示器產品及觸控屏產品生產工序之專利。 此外,本集團於二零一五年獲業務夥伴頒發數項 最佳夥伴獎項。此外,本集團於二零一五年年底 已開始供應指紋識別模組。指紋識別應用將為智 能手機不可或缺的組成部分,並將為二零一六年 收益主要增長動力之一。

Outlook

The management expects that the group's revenue could regain the growth in 2016 by the gradually maturing of mobile 4G network in China, the Group's new product, fingerprint recognition module and enhancing non-smartphone business development.

The management would foresee that the situation of decrease in average selling price of the Group's smartphone related products would be continued in 2016 but the magnitude of the price decrease would be reduced when compared to 2015 and 2014. Therefore, apart from the current ways, the management would continue to think other measures to mitigate this situation and improve the profit margins.

前景

憑著中國逐漸走向成熟的移動4G網絡、本集團新 產品指紋識別模組及加強非智能手機業務發展, 管理層預期二零一六年本集團收益可回復增長。

管理層預計本集團智能手機相關產品平均售價下 跌之情況將於二零一六年持續,惟價格下跌幅度 將較二零一五年及二零一四年收窄。因此,除現 行方法外,管理層將繼續考慮其他措施以緩解此 情況,並改善利潤率。

Proposed Spin-off Update

The management would like to update the Shareholders and investors that the Proposed Spin-off is still under progress and the Company has decided to focus on the PRC IPO way to proceed.

Further announcements will be made by the Company as and when appropriate in compliance with the Listing Rules.

Financial Analysis

Results

Results for the year ended 31 December 2015, the Group's audited consolidated revenue amounted to HK\$19.4 billion (2014: HK\$21.4 billion), representing a decrease of 9.3% as compared to that of last year.

The Group's gross profit margin and net profit margin attributable to the owners of the Company decreased to 10.9% and 4.4% in 2015 from 11.6% and 5.2% in 2014 respectively.

EBITDA and before share of results of associates and profit attributable to owners of the Company were decreased to HK\$2,197 million (2014: HK\$2,492 million) by 11.8% and HK\$845 million (2014: HK\$1,118 million) by 24.4% respectively. Basic earnings per share was decreased to 29.08 HK cents (2014: 38.41 HK cents) by 24.3%.

Income tax expenses

Pursuant to the relevant law and regulations in the PRC, two of the Company's PRC subsidiaries were approved as Hi-Tech Enterprise and entitled to 15% PRC enterprise income tax for three years from 2012 to 2014. The PRC subsidiaries were continuously granted the status of Hi-Tech Enterprise in September 2015 by the relevant authority for three years from 1 January 2015 and the whole application for the preferential tax treatment for further three years with effect from 1 January 2015 would expect to be completed in May 2016. Accordingly, PRC Enterprise Income Tax is provided at 15% for the year ended 31 December 2015.

管理層謹此向股東及投資者提供最新資料,建議 分拆仍在進行當中,而本公司已決定專注於以中 國首次公開發售之方式進行。

本公司將於適當時根據上市規則刊發進一步公告。

財務分析

業績

就截至二零一五年十二月三十一日止年度的業績, 本集團的經審核綜合收益為194億港元(二零一四 年:214億港元),較去年下跌9.3%。

本集團的毛利率及本公司擁有人應佔純利率分別 由二零一四年的11.6%及5.2%下跌至二零一五 年的10.9%及4.4%。

税息折舊及攤銷以及分佔聯營公司業績前利潤以 及本公司擁有人應佔溢利分別減少11.8%至21.97 億港元(二零一四年:24.92億港元)及減少24.4% 至8.45億港元(二零一四年:11.18億港元)。每股 基本盈利減少24.3%至29.08港仙(二零一四年: 38.41港仙)。

所得税開支

根據中國相關法律及法規,本公司兩間中國附屬 公司獲批准為高新技術企業,由二零一二年至二 零一四年三年間可享15%之中國企業所得税率, 該等中國附屬公司乃於二零一五年九月獲相關當 局批准繼續成為高新技術企業,由二零一五年一 月一日開始為期三年,而申請將税務優惠由二零 一五年一月一日起延長三年的整個申請程序預期 將於二零一六年五月完成。因此,截至二零一五 年十二月三十一日止年度中國企業所得税按15% 之税率作出撥備。

Investment, Assets and Liabilities

Update on investment in an associate — Truly (Huizhou) Smart Display Limited (信利(惠州)智能顯示有限公司)

Pursuant to the Capital Increase Agreement (refer to the discloseable transaction announcement dated on 11 November 2014), the Group has further contributed RMB460 million in 2015 by cash. After the capital increase of the associate completed in 2015, the associate has been held as to 53% by the Group without change.

Before the associate obtained the bank loans, the Group has lent short term loans with the amount of RMB500 million plus USD22 million to the associate to satisfy its payment schedule as the bank loan cannot be obtained as expected in time. These two short term loans to the associate by the Group were still outstanding as at 31 December 2015. However, the associate has partially repaid RMB200 million to the Group in January 2016.

The bank loans have been successfully obtained by the associate in November 2015 with the maximum loans limit of RMB2,180 million plus USD120 million. In order to satisfy payment schedule for the factory construction and relevant machinery without delay the construction completion date of the Huizhou AMOLED production line of the associate, Truly Semiconductors Limited, an indirectly wholly-owned PRC subsidiary of the Company and as a shareholder of the associate, provided full amount guarantee of the bank loans accordingly. As at 31 December 2015, the associate has partially withdrawn the loan amount of RMB650 million plus USD90 million. The remaining balance of loan amount of RMB1,530 million plus USD30 million would be expected to be withdrawn in 2016.

The construction of this Huizhou factory of the associate would be completed in late March 2016 or early April 2016 and can begin to trial production in April or May 2016.

Build up a 5th generation TFT-LCD production line

On 22 January 2016, the Group has entered an agreement with Samsung Display Co., Limited to purchase the machinery and equipment of the 5th generation TFT-LCD production line with color filter production line with the amount of USD50,880,000. For detail of the transaction, please refer to the discloseable transaction announcement dated 22 January 2016.

Besides, the Group has commenced to communicate with the banks for debt financing arrangement in relation to building up the 5th generation TFT-LCD Production line in early 2016. The management estimated that the total investment amount for completion of this 5th generation TFT-LCD production line would be between RMB3 billion and RMB3.5 billion.

投資、資產及負債

投資於一間聯營公司進展 — 信利(惠州)智能顯示 有限公司

根據增資協議(參閱日期為二零一四年十一月十一 日之須予披露交易公告),本集團於二零一五年進 一步以現金出資人民幣4.6億元。於二零一五年聯 營公司增資完成後,本集團持有聯營公司53%權 益並沒有改變。

於聯營公司取得銀行貸款前,由於預期未能如期 獲得銀行貸款,本集團向聯營公司借出短期貸款 人民幣5億元另加2千2百萬美元以符合其付款時 間表。於二零一五年十二月三十一日該兩筆由本 集團向聯營公司提供之短期貸款尚未償還。然而, 聯營公司已於二零一六年一月向本集團償還人民 幣2億元之部分款項。

於二零一五年十一月,聯營公司成功取得銀行貸 款,最高貸款額為人民幣21.8億元另加1.2億美 元。為符合廠房建設及相關機器之付款時間表, 使聯營公司惠州AMOLED生產線工程竣工日期不 會有所延誤,本公司之間接全資中國附屬公司(及 作為聯營公司股東)信利半導體有限公司因而提供 銀行貸款全額擔保。於二零一五年十二月三十一 日,聯營公司已提取部分貸款人民幣6.5億元加9 千萬美元。預期貸款餘額人民幣15.3億元加3千 萬美元將於二零一六年內提取。

聯營公司惠州廠房之建設工程將於二零一六年三 月底或二零一六年四月初竣工,並可於二零一六 年四月或五月開始試產。

建立第五代TFT-LCD 生產線

於二零一六年一月二十二日,本集團與Samsung Display Co., Limited訂立協議,以50,880,000美 元購買第五代TFT-LCD生產線與彩色濾光片生產 線之機器及設備。有關交易詳情請參閱日期為二 零一六年一月二十二日之須予披露交易公告。

此外,本集團於二零一六年年初已開始就有關建 立第五代TFT-LCD生產線之債務融資安排與銀行 溝通。管理層預計第五代TFT-LCD生產線總投資 額將介乎人民幣30億元及人民幣35億元。

As the Group's existing 2.5th generation TFT-LCD production line does not have enough capacity to satisfy the Automobile and Industrial customers' demand. Therefore, the 5th generation TFT-LCD production is very important for the Group's continuing development on non-smartphone products such as automobile and industrial products.

Further announcements will be made by the Company as and when appropriate in compliance with the Hong Kong Listing Rules.

4.5 generation capacitive touch panel production line

This capacitive touch panel production line is still under the construction on schedule in the Group's Shanwei factory, which would be commenced production in April 2016 and planned mainly for automotive products.

During the year, the Group acquired plant and machinery amounting to approximately HK\$847 million and furniture, fixtures and equipment amounting to approximately HK\$213 million for the purpose of enhancing its manufacturing capacity and production automation in the China factory campus.

Total assets were decreased by approximately 2.7% to approximately HK\$18,234 million which comprised approximately HK\$9,730 million of current assets, approximately HK\$6,969 million of property, plant and equipment and approximately HK\$1,535 million of other non-current assets. Total liabilities were approximately HK\$10,639 million, of which approximately HK\$8,579 million were current liabilities and approximately HK\$2,060 million were non-current liabilities.

Liquidity and Financial Resources

As at 31 December 2015, the outstanding bank and other borrowings, net of restricted bank deposits, cash and bank balances, were approximately HK\$2,755 million (2014: approximately HK\$1,774 million). It was increased by approximately 55% when compared to last year. These borrowing bear interest at prevailing market rate and their maturity profiles are shown in the financial statements. For non-current portion of these borrowings were matured within 5 years.

Except for the 5th generation TFT-LCD Production line plan, the financial position of the Group is still healthy for future capital expansion as at 31 December 2015 while maintaining a sufficiently level of restricted bank deposits, cash and bank balances (approximately HK\$2,128 million at 31 December 2015) together with adequate unutilized banking facilities. The gearing ratio based on total interest bearing debts, net of restricted bank deposits, cash and bank balances was approximately 39%, which has increased from 25% at 31 December 2014.

由於本集團現有第2.5代TFT-LCD生產線之產能無 法滿足汽車及工業客戶之需求,因此,第五代 TFT-LCD生產對本集團非智能手機產品(如汽車及 工業產品)之持續發展而言至關重要。

本公司將於適當時候根據香港上市規則刊發進一步公告。

第4.5代電容式觸控屏生產線

電容式觸控屏生產線仍在按計劃於本集團汕尾工 廠設立,將於二零一六年四月投產並計劃主要用 於汽車產品。

年內,本集團為提升其於中國生產基地之產能及 自動化生產,添置價值約8.47億港元之廠房及機 器,以及價值約2.13億港元之傢俬、裝置及設備。

資產總額減少約2.7%至約182.34億港元,當中 計有約97.30億港元流動資產、約69.69億港元物 業、廠房及設備以及約15.35億港元其他非流動資 產。總負債約為106.39億港元,當中包括約85.79 億港元流動負債及約20.60億港元非流動負債。

流動資金及財務資源

於二零一五年十二月三十一日,未償還銀行及其 他借款(經扣除受限制銀行存款、現金及銀行結存) 較去年增加約55%至約27.55億港元(二零一四年: 約17.74億港元)。此等借款乃根據現行市場息率 計息,其到期狀況載於財務報表內。此等借款之 非即期部份於五年內到期。

除第五代TFT-LCD生產線計劃外,於二零一五年 十二月三十一日,本集團之財務狀況仍然穩健, 以應付未來資本擴展所需,其同時持有充盈之受 限制銀行存款、現金及銀行結存(於二零一五年 十二月三十一日約為21.28億港元),及充足之尚 未運用銀行備用額。資本負債比率按計息債務總 額(經扣除受限制銀行存款、現金及銀行結存)計 算約為39%,較二零一四年十二月三十一日之 25%有所增加。

Capital expenditure commitment of around HK\$190 million for the year 2016 in respect of acquisition of property, plant and equipment was contracted for but not provided as at 31 December 2015.

General

The state of the Group's current order books is very strong.

Except for investments in subsidiaries, an associated company and available for sale investments, neither the Group nor the Company had held any other material investments during the year.

Additions to fixed assets mainly in furniture, fixture and equipment and plant and machinery were approximately HK\$1,538 million. As at 31 December 2015, the Group had no pledge or mortgage on its fixed assets.

Around 21,000 workers and staff are currently employed in our Shan Wei factory in China and around 100 personnel in the Group's Hong Kong office. Total staff costs for 2015 were approximately HK\$2,034 million.

At the balance sheet date, a subsidiary of the Company is a defendant in a legal action in Italy involving the alleged defective goods manufactured by the subsidiary according to its customers' designs and specifications. The claim above against the subsidiary is approximately Euro 7.2 million (equivalent to approximately HK\$61 million) in aggregate. The directors believe, based on legal advice, that the case has legal and factual grounds to defend and therefore it is not probable that losses (including claims for costs) will be incurred. As a result, no provision has been made at the end of the reporting period in this regard.

In addition, at 31 December 2015, the Group has given corporate guarantee for bank borrowings granted to the associate (Truly (Huizhou) Smart Display Limited (信利(惠州)智能顯示有限公司)) with the borrowing limit at approximately HK\$3,538,920,000 and the bank loans with the amount of approximately HK\$1,473,902,000 were withdrawn by the associate.

Furthermore, at 31 December 2015 the other shareholder of the associate provided corporate guarantee to the above bank borrowings in proportion to its respective ownership interest amounting to approximately HK\$867,035,000. A counter-indemnity in favour of the other shareholder is executed pursuant to which the Group undertakes to indemnify the other shareholder 24.5% of the liabilities arising from the bank borrowings.

一般事項

本集團現時之訂單狀況非常穩建。

除附屬公司及一間聯營公司投資以及可供出售投 資外,本集團及本公司均概無於年內持有任何其 他重大投資。

固定資產添置(以傢俬、裝置及設備、廠房及機器 為主)約為15.38億港元。於二零一五年十二月 三十一日,本集團並無將其固定資產質押或抵押。

現時約有21,000名工人及僱員受聘於本集團位於 國內汕尾之工廠,以及大約100名員工受聘於本 集團香港辦事處。二零一五年員工總成本約為 20.34億港元。

於結算日,本公司一間附屬公司於意大利一宗被 指涉及該附屬公司按其客戶之設計及規格製造有 缺陷貨品之法律訴訟中作為辯方。上述針對該附 屬公司之申索合共約為7,200,000歐元(相等於約 61,000,000港元)。董事根據法律意見相信,該案 件有法律及事實理據進行抗辯,因此,案件將不 大可能產生虧損(包括費用申索)。故此,於報告 期末並未就此作出撥備。

此外,於二零一五年十二月三十一日,本集團就 授予聯營公司信利(惠州)智能顯示有限公司之銀 行借款作出公司擔保,借款上限為約 3,538,920,000港元,而銀行貸款為數約 1,473,902,000港元已由聯營公司提取。

另外,於二零一五年十二月三十一日,聯營公司 之其他股東按其相應擁有權權益比例就上述銀行 借款提供公司擔保約867,035,000港元。本集團以 其他股東為受益人簽立反彌償保證,據此本集團 承諾向該其他股東彌償銀行借款所產生債務之 24.5%。

The directors assess the risk of default of the associate at the end of reporting period and consider the risk to be insignificant and it is less likely that any guaranteed amount will be claimed by the counterparties.

Exposure to fluctuations in exchange rates will be considered to hedge, if any.

Other Information

Dividends

The directors recommend the payment of a final dividend of 3 HK cents (2014: 5 HK cents) per share for the year ended 31 December 2015, based on ordinary shares in issue (number of ordinary shares issued at 29 February 2016: 2,907,099,398), to shareholders whose names appear on the Register of Members on 27 May 2016 (Friday). It is expected that the final dividend payments will be made to shareholders on 8 June 2016, Wednesday, subject to the Company's shareholders' approval at the Annual General Meeting of the Company.

The interim dividends in aggregate of 7 HK cents per share (2014: 10 HK cents) were paid in 2015 and 2016 to shareholders on the register of member of the Company at the close of business on 9 June 2015, 28 August 2015 and 8 December 2015, based on 2,907,099,398 ordinary shares in issue.

The total dividend payout ratio for the year was about 34.4%.

Closure of Register of Members

For determining the entitlement to attend and vote at the 2016 Annual General Meeting, the Register of Members will be closed on Friday, 20 May 2016, during which day no transfer of shares can be registered. Mr. Li Jian Hua, aged 52, is a Non-executive Director of the Company and the Managing Director of a PRC subsidiary of the Company, Truly Opto-Electronics Limited. He is mainly responsible for the factory production management of the Group. Mr. Li graduated from the Jilin University of Technology and Engineering Management in 1987 and joined the group in 1989. Prior to joining the Group, he worked in a multinational motor car manufacturer in Guangzhou City, the PRC for almost two years.

The directors present their annual report and the audited financial statements for the year ended 31 December 2015.

Principal Activities

The Company acts as an investment holding company. Its subsidiaries are principally engaged in the manufacture and sale of liquid crystal display products including touch panel products and electronic consumer products including compact camera module, personal health care products and electrical devices.

Results and Appropriations

The results of the Group for the year ended 31 December 2015 are set out in the consolidated statement of profit or loss and other comprehensive income on page 39.

Interim dividends in aggregate of 7 HK cents per share, amounting to approximately HK\$203,497,000, was paid and payable to the shareholders during the year.

The directors now recommend the payment of a final dividend of 3 HK cents per share based on the number of ordinary shares in issue (number of ordinary share issued at 29 February 2016: 2,907,099,398) to the shareholders of the Company whose names appear on the register of members on 27 May 2016, amounting to approximately HK\$87,213,000.

Property, Plant and Equipment

During the year, the Group acquired plant and machinery amounting to HK\$846,742,000 and furniture, fixtures and equipment amounting to HK\$212,705,000 for the purpose of expanding its manufacturing capacity in Shan Wei City, Guangdong Province in the People's Republic of China.

Details of these and other movements in the property, plant and equipment of the Group during the year are set out in note 16 to the consolidated financial statements.

Share Capital

The two Committees are chaired by Mr. Chung Kam Kwong, an independent nonexecutive director and comprise three other members, namely Mr. Ip Cho Ting, Spencer and Mr. Heung Kai Sing, being independent non-executive directors and Mr. Wong Pong Chun, James, an executive director of the Company.

The Board considers that this structure will not impair the balance of power and authority between the Board and the Company's management and believes that this structure will enable us to make and implement decisions promptly and efficiently.
- Code Provision E.1.2 The Chairman did not attend the annual general meeting of the Company held on 21 May 2015 due to unexpected important business meeting.

The Board will continuously review and improve the corporate governance practices and standards of the Company to ensure that business activities and decision-making processes are regulated in a proper and prudent manner. More details are contained in the separate Corporate Governance Report on pages 29 to 36.

Sufficiency of Public Float

The Company has maintained a sufficient public float throughout the year ended 31 December 2015.

Board of Directors and Board Committees

The Board

The Board was responsible for the Company's corporate governance, and was ultimately accountable for the Company's activities, strategies and financial performance.

The Board was mainly responsible for formulating and approving the business strategies, objectives, policies and plans of the Company, and monitoring the execution of the Company's strategies. It was also responsible for overseeing the operating and financial performance of the Company and establishing appropriate risk control policies and procedures in order to ensure that the strategic objectives of the Company are materialized. In addition, the Board was also responsible for improving the corporate governance structure and enhancing communications with shareholders.

The Board has delegated the responsibilities for the execution of strategies and decision-making for day-to-day operation of the Company to the management team headed by the Managing Director, Mr. Lam Wai Wah.

The management reported regularly to the Board on the operating and financial performance of the Company. Development, expansion and other major capital expenditure and commitment, as well as major financing decisions were all reviewed and approved by the Board.

Connections between members of the Board

None of the members of the Board have any connections (including financial, business, family relationship and other material/related relationships) with each other during the period under review.

Director's dealing in securities

Having made specific enquiry of all the Directors, the Company confirmed that all Directors had complied with their obligations regarding dealings in securities under the Model Code set out in Appendix 10 of the Listing Rules during the period under review.

Non-executive directors

The non-executive Directors were not appointed for a specific term but were subject to retirement by rotation in accordance with the Company's Articles of Association.

In addition, the Company Secretary reports from time to time the latest changes and development of the Listing Rules, corporate governance practices and other regulatory regime to the Directors with written materials.

Board committees

The Board was supported by three Board Committees. Each Board Committee has its own responsibilities, power and functions. The chairman of the respective Board Committees reported to the Board from time to time and made recommendations on matters discussed when appropriate.

Remuneration Committee

The Company has established the remuneration committee (the "Remuneration Committee") in compliance with the Listing Rules. The Remuneration Committee is governed by its terms of reference, which have been revised by the Board on 26 March 2012 pursuant to the CG Code, setting out the Remuneration Committee's authority, duties and responsibilities are available on the websites of the Company and the Stock Exchange.

The Nomination Committee is chaired by Mr. Chung Kam Kwong, an independent non-executive director and comprise three other members, namely Mr. Ip Cho Ting, Spencer and Mr. Heung Kai Sing, being independent non-executive directors and Mr. Wong Pong Chun, James, an executive director of the Company.

The primary duties of the Nomination Committee are to review the structure, size and composition of the Board on a regular basis and to make recommendations to the Board on matters relating to any proposed changes.

The Company has adopted a board diversity policy which sets out its approach to achieve and maintain diversity on the Board in order to enhance the effectiveness of the Board.

Four meetings were held during the year by the Nomination Committee to review the nomination procedures and the current composition of the Board. All members of the Nomination Committee attended the said meeting.

Internal Control

The Board was fully responsible for the maintenance of a sound and effective internal control system within the Group. Throughout the year from 1 January 2015 to 31 December 2015, the Board conducted reviews of the effectiveness of the internal control system in all material respects including but not limited to operational, financial, risk management and compliance controls. The Group's system of internal control comprised a well-defined organizational and management structure with levels and limits of authority which was established to help achieve business objectives, safeguard assets against unauthorized access or disposal, ensure the maintenance of proper accounting records to produce reliable management and financial information for internal use and for publication purpose, help management mitigate potential risk factors and ensure compliance with relevant rules and regulations. The system was designed to provide reasonable, but not absolute, assurance against material misstatement or loss and to manage rather than eliminate risks of failure in operational systems so as to achieve the Group's objectives and long-term aoals.

The Group's internal control system comprised the following five components:

- (1) Organizational and Management Structure the Group has established an organizational and management structure with operating policies and procedures, lines of responsibilities and delegated authority has already been established.
- (2) Authority and Control the relevant executive Directors and senior management have been delegated with respective levels of authorities with regard to key corporate strategy and policy, contractual commitments and the dealing of price sensitive information.
- (3) Budgetary Control and Management and Financial Reporting – budgets have been prepared by senior management including various department heads and were subject to review and approval by the executive Directors on a regular basis prior to being adopted. Operating results against budgets have been analyzed and reported to the executive Directors as a reference to monitor the Group's strategy and policy. Regular reviews by the Audit Committee and audits by external auditors respectively have been carried out to ensure the preparation of the management information and consolidated financial statements are in accordance with the generally accepted accounting principles, the Group's accounting policies and applicable laws and regulations.

- (5) Internal Audit the Audit Committee has performed independent reviews of the controls and risks identified to ensure that adequate controls have been put in place and risk elements have been properly addressed.

According to the review results of the Audit Committee for the year from 1 January 2015 to 31 December 2015, the Group's internal control system is functioning effectively and there was no significant weakness found in the course of the review processes. The Board has reviewed the effectiveness of the Group's internal control systems and is of the opinion that there are no suspected frauds, irregularities, internal control deficiencies or suspected infringement of laws, rules and regulations that cause the Board to believe that the systems of internal control are ineffective or inadequate. The Board is satisfied that the Company and the Group have fully complied with the code provisions on internal control as set out in the Corporate Governance Code for the aforesaid year.

Financial Reporting

The directors, having made appropriate enquiries, consider that the Group has adequate resources to continue in operational existence for the foreseeable future and that, for this reason, it is appropriate to adopt the going concern basis in preparing the financial statements for the year 2015. The Management also provides all directors with monthly updates giving them a balanced and understandable assessment of the Company's performance, position and prospects in sufficient detail to enable the Board as a whole and each director to discharge their duties under Rule 3.08 and Chapter 13 of the Listing Rules.

All directors have access to the advice and services of the company secretary to ensure that board procedures, and all applicable laws, rules and regulations are followed.

Since Mr. Ma was appointed in 2011, he has to take no less than 15 hours of relevant professional training for the financing year commencing on or after 1 January 2012 and he has fulfilled the requirement during the year under review.

Shareholders' Rights

To safeguard shareholder interests and rights, a separate resolution is proposed for each substantially separate issue at shareholder meetings, including the election of individual directors. All resolutions put forward at shareholder meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and of the Stock Exchange after each shareholder meeting.

(1) Communication with Shareholders and Procedures for putting forward proposals at general meetings

All published information, including financial statements, results announcements, circulars and notices of general meetings and associated explanatory documents are promptly posted on the Group's website at www.truly.com.hk. Board Diversity Policy

1. GENERAL

The Company was incorporated in the Cayman Islands under the Companies Law of the Cayman Islands as an exempted company. The Company is a public limited company with its shares listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Its ultimate controlling party is Mr. Lam Wai Wah, who is also the Chairman and Managing Director of the Company. The addresses of the registered office and principal place of business of the Company are disclosed in the section headed "General Information" to the annual report.

The functional currency of the Company is United States dollars. The consolidated financial statements are presented in Hong Kong dollars which is different from the functional currency of the Company, as the directors of the Company consider that Hong Kong dollars is the most appropriate presentation currency in view of its place of listing.

The Company acts as an investment holding company. Its subsidiaries are principally engaged in the business of manufacture and sale of liquid crystal display ("LCD") products including touch panel products and electronic consumer products including personal health care products and electrical devices.

HKFRS 9 Financial Instruments (continued) Key requirements of HKFRS 9:

- all recognised financial assets that are within the scope of HKAS 39 Financial Instruments: Recognition and Measurement are required to be subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of subsequent accounting periods. Debt instruments that are held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets, and that have contractual terms that give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, are generally measured at FVTOCI. All other debt investments and equity investments are measured at their fair value at the end of subsequent accounting periods. In addition, under HKFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.
- in relation to the impairment of financial assets, HKFRS 9 requires an expected credit loss model, as opposed to an incurred credit loss model under HKAS 39. The expected credit loss model requires an entity to account for expected credit losses and changes in those expected credit losses at each reporting date to reflect changes in credit risk since initial recognition. In other words, it is no longer necessary for a credit event to have occurred before credit losses are recognised.

The directors anticipate that the adoption of HKFRS 9 in the future will have impact on amounts reported in respect of the Group's available-for-sale investments. However, it is not practicable to provide a reasonable estimate of that effect until a detailed review has been completed.

HKFRS 15 Revenue from Contracts with Customers

HKFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 *Revenue*, HKAS 11 *Construction Contracts* and the related Interpretations when it becomes effective.

The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the Standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

The directors of the Company anticipate that the application of HKFRS 15 in the future may have a material impact on the amounts reported and disclosures made in the Group's consolidated financial statements. 3. SIGNIFICANT ACCOUNTING POLICIES

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules") and by the Hong Kong Companies Ordinance ("CO").

The provisions of the new Hong Kong Companies Ordinance (Cap. 622) regarding preparation of accounts and directors' reports and audits became effective for the Company for the financial year ended 31 December 2015. Further, the disclosure requirements set out in the Listing Rules regarding annual accounts have been amended with reference to the new CO and to streamline with HKFRSs. Accordingly the presentation and disclosure of information in the consolidated financial statements for the financial year ended 31 December 2015 have been changed to comply with these new requirements. Comparative information in respect of the financial year ended 31 December 2014 are presented or disclosed in the consolidated financial statements based on the new requirements. Information previously required to be disclosed under the predecessor CO or Listing Rules but not under the new CO or amended Listing Rules are not disclosed in these consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2, leasing transactions that are within the scope of HKAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 or value in use in HKAS 36.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the noncontrolling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the noncontrolling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 *Impairment of Assets* as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate is recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

Non-current assets held for sale

Non-current assets are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

Non-current assets classified as held for sale are measured at the lower of their previous carrying amount and fair value less costs of disposal.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any, and is presented separately in the consolidated statement of financial position.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cash-generating units) that is expected to benefit from the synergies of the combination.

A cash-generating unit to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. If the recoverable amount of the cash-generating unit is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit on a pro rata basis based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant cash-generating unit, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Revenue is reduced for estimated customer returns, rebates and other similar allowances.

Revenue from sale of goods is recognised when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;

商譽

Revenue recognition (continued)

- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

Property, plant and equipment

Property, plant and equipment including leasehold land (classified as finance leases) and buildings held for use in the production or supply of goods or services, or for administrative purposes (other than properties under development as described below), are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Depreciation is recognised so as to write off the cost of the items of property, plant and equipment (other than properties under development) less their residual values over their estimated useful lives, using the reducing balance method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Group as lessor

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on a straight-line basis over the lease term.

The Group as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

Leasehold land and buildings

When a lease includes both land and building elements, the Group assesses the classification of each element as a finance or an operating lease separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire lease is classified as an operating lease. Specifically, the minimum lease payments (including any lump-sum upfront payments) are allocated between the land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element of the lease at the inception of the lease.

To the extent the allocation of the lease payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis. When the lease payments cannot be allocated reliably between the land and building elements, the entire lease is generally classified as a finance lease and accounted for as property, plant and equipment.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of the reporting period. Income and expenses items are translated at the average exchange rates for the period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of the exchange reserve.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

Retirement benefit costs

Payments to the state-managed retirement benefit scheme and the Mandatory Provident Fund Scheme are recognised as an expense when employees have rendered service entitling them to the contributions.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Intangible assets

Intangible assets including acquired technical know-how with finite useful lives are carried at cost less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development activities (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for an internally-generated intangible asset is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally-generated intangible asset can be recognised, development expenditure is recognised in profit or loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible asset is measured at cost less accumulated amortisation and accumulated impairment losses (if any), on the same basis as intangible assets acquired separately.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost of inventories are determined on a first-in, firstout method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

Financial assets

The Group's financial assets are classified into loans and receivables and available-for-sale financial assets. The classification depends on the nature and purpose of the financial assets and is determined at the time of initial recognition. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Interest income is recognised on an effective interest basis.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Subsequent to initial recognition, loans and receivables (including trade and other receivables, amount due from an associate, restricted bank deposits and bank balances and cash) are measured at amortised cost using the effective interest method, less any identified impairment losses (see accounting policy on impairment loss of financial assets below).

Interest income is recognised by applying the effective interest rate, except for short-term receivables where the recognition of interest would be immaterial.

Available-for-sale financial assets

Available-for-sale financial assets are non-derivatives that are either designated as available-for-sale or are not classified as (a) loans and receivables, (b) held-to-maturity investments or (c) financial assets at fair value through profit or loss ("FVTPL").

Equity securities held by the Group that are classified as available-for-sale financial assets and are traded in an active market are measured at fair value at the end of each reporting period. Changes in the carrying amount of available-for-sale financial assets are recognised in other comprehensive income and accumulated under the heading of investment revaluation reserve. When the investment is disposed of or is determined to be impaired, the cumulative gain or loss previously accumulated in the investment revaluation reserve is reclassified to profit or loss (see the accounting policy in respect of impairment loss on financial assets below).

Dividends on available-for-sale equity investments are recognised in profit or loss when the Group's right to receive the dividends is established.

Available-for-sale equity investments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured are measured at cost less any identified impairment losses at the end of each reporting period (see the accounting policy in respect of impairment loss on financial assets below).

Financial assets, other than financial assets at FVTPL, are assessed for indicators of impairment at the end of the reporting period. Financial assets are considered to be impaired when there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been affected.

For available-for-sale equity investments, a significant or prolonged decline in the fair value of the security below its cost is considered to be objective evidence of impairment.

For all other financial assets, objective evidence of impairment could include:

- significant financial difficulty of the issuer or counterparty; or
- breach of contract, such as default or delinquency in interest or principal payments; or
- it becoming probable that the borrower will enter bankruptcy or financial re-organisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

For certain categories of financial assets, such as trade receivables, assets that are assessed not to be impaired individually are, in addition, assessed for impairment on a collective basis. Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments, an increase in the number of delayed payments or observable changes in national or local economic conditions that correlate with default on receivables.

Financial liabilities and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Group are recognised at the proceeds received, net of direct issue costs.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

Financial liabilities

Financial liabilities (including trade and other payables, bank and other borrowings) are subsequently measured at amortised cost, using the effective interest method.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Interest expense is recognised on an effective interest basis.

Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or they expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

At the end of the reporting period, the Group reviews the carrying amounts of its tangible and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgment in applying accounting policies

The following is the critical judgement, apart from those involving estimation (see below), that the directors have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Classification of Truly (Hui Zhou) Smart Display Limited ("Truly HZ") as an associate

Note 19 describes that Truly HZ is an associate of the Group although the Group has 53% ownership interest and voting rights in Truly HZ. Other than the Group, there are two other shareholders in Truly HZ. The directors assessed whether or not the Group has control over Truly HZ based on whether the Group has the practical ability to direct the relevant activities of Truly HZ unilaterally. Resolutions for relevant activities of Truly HZ require approval in shareholders' meetings as stated in the Articles of Association of Truly HZ. In making their judgement, the directors considered the requirements for shareholders' meeting as stated in the Articles of Association of Truly HZ, in which it states a shareholders' meeting cannot be held without the presence of either one of the other two shareholders, and legal opinions obtained from an independent lawyer practicing in the PRC. On this basis, the directors concluded that the Group does not have control but significant influence over Truly HZ because any resolutions to be passed in shareholders' meetings shall have the consent from either one of the other shareholders demonstrated by their action of being present in the meetings. Accordingly Truly HZ is classified as an associate of the Group.

將信利(惠州)智能顯示有限公司(「信利惠 州」)分類為聯營公司

誠如附註19所述,儘管本集團擁有信利惠 州53%的擁有權及投票權,惟信利惠州為 本集團的聯營公司。除本集團外,信利惠州 另有兩名股東。董事評估本集團是否對信利 惠州擁有控制權時,乃基於本集團是否有實 際能力單方面管理信利惠州的相關業務。信 利惠州的組織章程細則訂明,信利惠州相關 業務的決議案須於股東大會上批准。於作出 判斷時,董事考慮信利惠州組織章程細則訂 明有關股東大會的要求,其規定不得在其餘 兩名股東其中一名缺席的情況下舉行股東大 會,董事亦考慮自一名獨立中國執業律師取 得的法律意見。據此,董事認為本集團對信 利惠州並無控制權但有重大影響力,因任何 於股東大會上通過的決議案須經其餘股東其 中一名藉出席會議來表示同意。因此,信利 惠州分類為本集團聯營公司。

Classification of 杭州登虹科技有限公司 ("杭州登虹科技") as an associate

Note 19 describes that 杭州登虹科技 is an associate of the Group although the Group only owns 12.5% ownership interest in 杭州登虹科技. The Group has significant influence over 杭州登虹科技 by virtue of the contractual right to appoint one out of the five directors to the board of directors of that company.

Key sources of estimation uncertainty Estimated impairment of trade receivables

The Group reviews the carrying amounts of its trade and bills receivables at the end of each reporting period to determine whether those trade receivables have suffered an impairment loss. Management has exercised judgement when estimating the timing and future cash flows expected to be derived from the trade receivables and ascertain their future cash flows. Where the future cash flows of a receivable is estimated to be less than its carrying amount, an impairment loss will be provided for such a receivable and recognised in the profit and loss.

As detailed in note 23, as at 31 December 2015, trade and bills receivables amounting to HK\$4,694,937,000 (2014: HK\$5,048,360,000) are expected to be settled within twelve months from the end of the reporting period. In determining the amount of receivable, the management has exercised judgement in estimating the timing and future cash flows to be recovered and determined no impairment was necessary at the end of the reporting period. If the actual cash flows or timing of recovery are different from expectation, a material impairment loss may arise.

Estimated outcome of a litigation

As at 31 December 2015, a subsidiary of the Company is a defendant in a legal action in Italy involving the alleged defective goods manufactured by the subsidiary according to its customers' designs and specifications. The claim against the subsidiary is approximately Euro 7.2 million (equivalent to approximately HK\$61 million) in aggregate. The directors believe, based on legal advice, that the case has legal and factual grounds to defend and therefore it is not probable that losses (including claims for costs) will be incurred. As a result, no provision has been made at the end of the reporting period in this regard.

32. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as going concern while maximising the return to shareholders through the optimisation of the debt and equity balance.

The capital structure of the Group consists of net debt, which includes the borrowings disclosed in note 29, net of cash and cash equivalents, and equity comprising issued share capital and reserves.

The directors of the Company review the capital structure periodically. The directors consider the cost of capital and the risks associates with the capital, and will balance its overall capital structure through the payment of dividends, new share issues of the Company and share buy-backs as well as raising of bank borrowings.

The Group's overall strategy remains unchanged from the prior year.

Market risk

The Group is exposed to fair value interest rate risk in relation to fixed-rate bank deposits and amount due from an associate. The Group is also exposed to cash flow interest rate risk due to the fluctuation of the prevailing market interest rate on bank balances and variable-rate bank and other borrowings (see notes 26 and 29 for details). The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of HIBOR and LIBOR arising from the Group's Hong Kong dollar denominated borrowings, the fluctuation of the People's Bank of China's benchmark rate arising from the RMB denominated borrowings and the fluctuation of BBSW arising from the Group's AUD denominated borrowings. The management considers the exposure to interest rate risk in relation to bank balances is insignificant due to the low interest rate. The Group currently does not use any derivative contract to hedge its exposure to interest rate risk. However, the management of the Company will consider hedging significant interest rate exposure should the need arise.

Sensitivity analysis

The sensitivity analyses below have been determined based on the exposure to interest rates for variable-rate bank borrowing. The analysis is prepared assuming the amount of liability outstanding at the reporting period was outstanding for the whole year. A 100 basis point (2014: 100 basis point) increase or decrease is used which represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 100 basis points (2014: 100 basis point) higher/lower and all other variables were held constant, the Group's post-tax profit for the year ended 31 December 2015 would decrease/increase by HK\$41,190,000 (2014: decrease/increase by HK\$45,401,000).

The Group is exposed to equity price risk arising from investments in listed equity securities classified under available-for-sale investments.

Price risk sensitivity analysis The sensitivity analyses below have been determined based on the exposure to equity price risks at the reporting period.

If equity prices had been 15% (2014: 15%) higher/ lower, investment revaluation reserve would increase/decrease by HK\$11,497,000 (2014: HK\$20,025,000) as a result of the changes in fair value of available-for-sale investments.

Credit risk

As at 31 December 2015, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to perform an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

The Group had concentration of credit risk as 15% (2014: 18%) of total trade receivables was due from the Group's largest trade debtor, which is a company located in the PRC with good reputation and repayment history.

In order to minimise credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual receivable at the end of each reporting period to ensure that adequate impairment losses are recognised for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The credit risk on liquid funds is limited because the counterparties are banks with good reputation.

With respect of credit risk arising from the loan receivable and other receivables, the Group reviews the recoverable amount of each receivable at the end of each reporting period and allowance for loan receivable and other receivable are made. The management of the Company considers that the Group's exposure to credit risk arising from default of the loan receivable is limited as the amount has been fully provided for. The Group manages its credit risk by closely monitoring the other receivables with and follow up action being taken to recover the overdue receivables. Other receivables consist of a large number of counterparties which do not give rise to significant concentration of credit risk.

Liquidity risk

The Group's liquidity position is monitored closely by the management of the Company.

In the management of liquidity risk, the Group monitors its current and expected liquidity requirements regularly and ensuring sufficient liquid cash and adequate committed lines of funding from reputable financial institutions to meet the Group's liquidity requirements in the short and long term. The management of the Company also monitors and maintains a level of cash and cash equivalents adequate to finance the Group's operations and mitigate the effects of fluctuations in cash flows.

The following table details the Group's remaining contractual maturity for its non-derivative financial liabilities. The table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. The table includes both interest and principal cash flow. To the extent that interest flows are floating rates, the undiscounted amount is derived from interest rate at the end of the reporting period.
