## Chairman's Statement 主席報告

Dear Shareholders,

On behalf of the board of directors of E-Rental Car Company Limited ("E-Rental Car" or the "Company") and its subsidiaries (collectively "the Group"), I am pleased to present the Group's final results for the year ended 31 December 2015 (the "Year").

The Group expedited its strategic transformation and actively implemented its business reorganization. The Company also constantly evaluated its business strategies and the performance of the business operations of the Group. We are dedicated not only to developing the Group's existing businesses but also actively pursuing business diversification to generate new avenues for growth and to improve the overall financial profile of the Group in the long run. To achieve this objective, the Company continued to venture into the car rental business and officially changed its name to "E-Rental Car Company Limited" in June 2015. Furthermore, the Group also diversified into the financing services business in Hong Kong and has, through a wholly-owned subsidiary, successfully applied and obtained a money lenders licence under the money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) in October 2015 and commenced the provision of financing services during the Year.

We believe that sophistication is one of the cores of business success. To optimize the value of the Group and its existing assets, the Group disposed of part of its consumer electronic devices/platforms and related solution/services business during the Year (through the disposal of its entire interests in two subsidiaries engaged in the sales of digital signal processing based consumer electronic devices/platforms (including embedded firmware)) which had been sustaining losses over the past few years.

During the Year, to strengthen the Group's financial capability and flexibility and to facilitate our business expansion, the Company raised funds in an aggregate amount of approximately HK\$533 million, through placing of new shares of the Company. Apart from diversifying into the financing services business as mentioned above, the Group further expanded its electronic components/materials business during the Year.

本集團推進戰略轉型,積極落實業務重組工作。本公司亦不斷為本集團業務營運之業務策略及表現作出評估。本公司致力發展本集團現有業務及積極尋求業務多元化,開拓新增長途徑及改善本集團長遠財務狀況。為達到目標不公司繼續投資汽車租賃業務,並於二零申五有限公司」。此外,本集團亦於香港托展融資服務業務,並通過一家全資附屬公司成功申請及於二零一五年十月獲得放債人條例(香港法例第163章)項下之放債人牌照,以於本年度經營業務及開始提供融資服務。

本公司認為邁向精尖乃業務成功之核心。於本年度,為優化本集團及其現有資產之價值,本集團已(通過出售其於兩間從事銷售數位訊號處理之消費電子器材/平台(嵌入式固件)之附屬公司之全部權益)出售部分消費者電子器材/平台及相關解決方案/服務業務,該業務於過去幾年持續虧損。

於本年度,為加強本集團財務能力及靈活性,並促進業務擴張,本公司通過配售本公司新股份募集資金合共約533,000,000港元。除兼營上述融資服務業務外,本集團已於本年度進一步擴張其電子零件/材料業務。

#### **BUSINESS REVIEW**

#### Car rental business

During the Year, the Company continued to venture into the car rental business which is considered to be always in demand and have growth potential. Amidst the existing fleet size of 北京途安汽車租賃有限責任公司(Beijing Tu An Car Rental Services Limited\*) ("Beijing Tu An"), an indirect. wholly-owned subsidiary of the Company in the PRC and is principally engaged in car rental services business, reaching its full utilization, the Group had further invested approximately HK\$20 million in Beijing Tu An to expand its fleet size, network coverage and services. For the year ended 31 December 2015, revenue from the Group's car rental segment recorded approximately HK\$24.6 million. The Group had successfully completed a subscription transaction of US\$5 million (approximately HK\$39 million) for approximately 10% of the equity interest in Prime Elite Ventures Limited ("Prime Elite") during the Year. "AA租車" (AA Car Rental\*), an online car rental application of Prime Elite launched in 2013, is a mobile internet-based intelligent car rental platform, which provides users with chauffeured car services anytime and anywhere. With its headquarters in Beijing, the "AA Car Rental" service network covers sixteen cities which include Beijing, Guangzhou, Shenzhen, Shanghai, Dalian and Shijiazhuang. For the year ended 31 December 2015, the Group's strategic investment in Prime Elite had provided the Group with (i) fair value gain of approximately HK\$1.2 million recognised as other comprehensive income; as well as (ii) business synergies whereby, as at 31 December 2015, a total of 29 vehicles operated by Beijing Tu An were rented to "AA Car Rental" under long term rental contracts which provided stable returns to the Group.

#### 業務回顧

#### 汽車租賃業務

由於汽車租賃市場於本年度極具需求及具增長 潛力,本公司繼續專注於此業務。本公司於中 國主要從事汽車租賃服務業務之間接全資附屬 公司北京途安汽車租賃有限責任公司(「北京途 安1),其現有車隊規模之使用率已達致飽和, 故本集團進一步投資約20,000,000港元於北 京途安,以擴大其車隊規模、加大網絡覆蓋範 圍及提高服務質素。於截至二零一五年十二月 三十一日止年度,本集團汽車租賃業務分部 之收益錄得約24,600,000港元。本集團本年 度成功認購傑盛創投有限公司(「傑盛」)一項 5,000,000美元(約39,000,000港元)約10%股 權認購交易。傑盛旗下的線上租車應用程式 一 「AA 租車」創立於二零一三年,是一款基於移動 互聯網的智慧型汽車租賃平台,致力為用戶提 供隨時隨地代駕車輛租賃服務。「AA租車」總 部設於北京,其服務網絡覆蓋十六個城市,包 括:北京、廣州、深圳、上海、大連及石家莊 等。截至二零一五年十二月三十一日止年度, 本集團於傑盛之策略性投資為本集團提供(i)公 平值收益約1,200,000港元(已於其他全面收 入確認);及(ii)業務協同效應,於二零一五年 十二月三十一日,由北京途安營運合共29輛汽 車乃根據長期租賃合約出租予「AA租車」,為本 集團提供穩定回報。

#### Electronic components/materials business

Since the electronic components/materials business has been a stable income source, the Group had allocated more resources and investment for the expansion in this segment. For the year ended 31 December 2015, revenue from the Group's trading of electronic components/materials segment increased from approximately HK\$193.5 million for the year ended 31 December 2014, to approximately HK\$240.4 million. The Group also recorded gross profit and gross profit margin from this segment of approximately HK\$10.8 million and 4.5% respectively.

## Consumer electronic devices/platforms and related solutions/services business

The consumer electronic devices/platforms and related solutions/services business continued to make a loss during the Year. To optimise the value of the Group and its assets, the Company had commenced streamlining and reorganising its existing assets and disposed of its entire interests in two operating subsidiaries engaged in the research, design, development and sale of digital signal processing based consumer electronic devices/platforms on 29 April 2015. For the year ended 31 December 2015, revenue from this segment decreased by 85% to approximately HK\$4.1 million, from approximately HK\$28.1 million in 2014.

#### Financing services business

The Company had, through a wholly-owned subsidiary, applied for and in October 2015 successfully obtained a money lenders licence under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) to conduct money lending business in Hong Kong through the provision of loans. The Company will strive to gain position in the financing services market by providing flexible, convenient and tailor-made services to raise accessibility to the Group's financing services. As the provision of financing services was still in early stage, revenue generated from this segment only contributed approximately 2% to the Group's total revenue for the year ended 31 December 2015.

#### 電子零件/材料業務

由於電子零件/材料業務提供穩定之收入來源,本集團已分配更多資源以投資擴展該分部。截至二零一五年十二月三十一日止年度,本集團買賣電子零件/材料分部之收益由截至二零一四年十二月三十一日止年度錄得的約193,500,000港元顯著上升至約240,400,000港元。本集團亦錄得該分部之毛利及毛利率分別約10,800,000港元及4.5%。

#### 消費電子器材/平台及相關解決方案 /服務業務

消費電子器材/平台及相關解決方案/服務業務於本年度持續錄得虧損。為優化本集團及其資產之價值,本公司已著手簡化及重組現有資產,並於二零一五年四月二十九日出售其主要從事數位信號處理消費電子器材/平台的研究、設計、開發及銷售的兩間經營附屬公司之全部權益。截至二零一五年十二月三十一日止年度,來自此分部的收益由二零一四年錄得的約28,100,000港元減少85%至約4,100,000港元。

#### 金融服務業務

本公司於二零一五年十月成功透過其間接全資附屬公司申請並獲得放債人條例(香港法例第163章)項下之放債人牌照,從而通過提供貸款於香港進行放債業務。本公司將致力提升本集團競爭力並積極提供靈活、方便及定制之金融服務以獲得同業中的穩固地位。本公司在此業務中尚在起步階段,其收益僅佔本集團截至二零一五年十二月三十一日止年度之總收益約2%。

#### **FUTURE OUTLOOK**

With an increasing growth in the tourism industry in China and the benefits that car rental services can offer, including greater mobility without the need to pay the relatively higher costs associated with car ownership and the freedom to choose cars based on requirements and budget, the use of car rental services is expected to become more and more popular and a rise in demand is anticipated. The Group will continue to explore the development of its online car rental business in the car rental market. As access to financing services is crucial to business and economic growth, the provision of financing services has potential for high growth and can be sustainable. The Group seeks to grasp on potential business opportunities by strategically tapping into the financial services industry. The Group looks forward to further expanding its income streams and smoothing the road for future development through the provision of a wider array of comprehensive services.

#### 本集團業績

財務回顧

#### 收益

本集團收益由截至二零一四年十二月三十一日止年度約222,300,000港元上升24%至截至二零一五年十二月三十一日止年度約275,300,000港元。誠如「業務回顧」一節所述,收益增加主要由於(i)銷售貨品收入因業務重心轉移以買賣電子零件/材料業務為主,導致銷售貨品收入由截至二零一四年十二月三十一日止年度約205,100,000港元增加至截至二零一五年十二月三十一日止年度約242,100,000港元:(ii)貢獻收入約24,600,000港元之汽車租賃業務之全年業績:及(iii)消費電子器材/平台及相關解決方案/服務分部收入減少。

#### **FINANCIAL REVIEW**

#### Results of the Group

#### Revenue

The revenue of the Group increased by approximately 24% from approximately HK\$222.3 million for the year ended 31 December 2014 to approximately HK\$275.3 million for the year ended 31 December 2015. As mentioned in the section headed "BUSINESS REVIEW", the increase was mainly resulted from (i) the increase in sales of goods from approximately HK\$205.1 million for the year ended 31 December 2014 to approximately HK\$242.1 million for the year ended 31 December 2015, due to the shift of business focus to the trading of electronic components/materials; (ii) the full year results from the car rental business which contributed revenue of approximately HK\$24.6 million; and (iii) the decrease in revenue from the consumer electronic devices/platforms and related solution/services segment.

#### 未來展望

受惠於中國旅遊業增長及汽車租賃需求增加之裨益,包括毋須承擔汽車擁有成本,同時可享更大彈性及可按個人喜好、要求及預算來選擇合適之汽車,由此可見汽車租賃業務將越來越普及和受大眾歡迎。本集團將致力發展互聯網汽車租賃業務及進軍金融服務業,把握潛在高增長及可持續之金融業務商機。本集團旨在提供更廣泛的全面服務,進一步拓寬其收入來源及穩定未來發展。

## 管理層討論及分析

#### Cost of sales

Cost of sales of the Group increased by approximately 22% from approximately HK\$205.3 million for the year ended 31 December 2014 to approximately HK\$251.5 million for the year ended 31 December 2015. The increase was mainly attributable to the increase in sales of electronic components/materials during the Year.

#### Gross profit and margin

The Group recorded a gross profit of approximately HK\$23.8 million for the year ended 31 December 2015, representing an increase of approximately 41% as compared to the gross profit recorded in the prior year. The gross profit margin increased slightly by approximately 1.1 percentage points from 7.6% in 2014 to 8.7% in the Year. The increase was resulted from the financing services business, which had higher profit margin.

#### Other income and gains

Other income and gains of the Group increased by approximately 273%, from approximately HK\$8.0 million for the year ended 31 December 2014 to approximately HK\$29.8 million for the year ended 31 December 2015. The increase was mainly resulted from the income in relation to certain procurement/credit/investment arrangements as well as waivers of other borrowings recognised during the Year.

#### Research and development costs

Research and development costs decreased by approximately 42% from approximately HK\$2.6 million for the year ended 31 December 2014 to approximately HK\$1.5 million for the year ended 31 December 2015, mainly due to the disposal of certain subsidiaries under the consumer electronic devices/platforms segment and related solution/services segment, coupled with the decrease in the number of research and development projects after the implementation of the cost-saving measures during the Year.

#### 銷售成本

本集團的銷售成本由截至二零一四年十二月三十一日止年度的約205,300,000港元增加約22%至截至二零一五年十二月三十一日止年度的約251,500,000港元。錄得升幅主要由於本年度電子零件/材料銷售收入有所增加。

#### 毛利及毛利率

截至二零一五年十二月三十一日止年度,本集團錄得毛利約23,800,000港元,較去年錄得的毛利上升約41%。毛利率由二零一四年的7.6%略為上升約1.1個百分點至本年度的8.7%。有關增幅是由具有較高毛利率的金融服務業務所致。

#### 其他收入及收益

本集團的其他收入及收益由截至二零一四年十二月三十一日止年度的約8,000,000港元增加273%至截至二零一五年十二月三十一日止年度的約29,800,000港元。有關升幅主要由於本年度確認若干有關採購/信貸/投資安排之收入以及放棄其他借貸所致。

#### 研究及開發成本

研究及開發成本由截至二零一四年十二月三十一日止年度的約2,600,000港元減少約42%至截至二零一五年十二月三十一日止年度的約1,500,000港元,主要由於出售若干消費電子器材/平台分部及相關解決方案/服務分部附屬公司以及本年度實行成本減省措施後,研發項目數量有所減少所致。

## 管理層討論及分析

#### Selling and distribution expenses

Selling and distribution expenses decreased by approximately 55% from approximately HK\$14.6 million for the year ended 31 December 2014 to approximately HK\$6.5 million for the year ended 31 December 2015, mainly due to the cost saving effect from the disposal of certain subsidiaries under the consumer electronic devices/platforms and related solution/ services segment.

#### General and administrative expenses

General and administrative expenses increased by approximately 56% from approximately HK\$25.4 million for the year ended 31 December 2014 to approximately HK\$39.7 million for the year ended 31 December 2015, mainly due to the extra cost incurred as a result of business expansion during the Year.

#### Other expenses, net

Other expenses, net, decreased by approximately 96% from approximately HK\$26 million for the year ended 31 December 2014 to approximately HK\$0.9 million for the year ended 31 December 2015 mainly due to the reduction of impairment/write-off of trade and other receivables.

#### Finance costs

Finance costs increased from approximately HK\$0.1 million for the year ended 31 December 2014 to approximately HK\$1.9 million for the year ended 31 December 2015, mainly due to the drawdown of certain new interest-bearing bank and other borrowings utilised to finance the purchase of certain motor vehicles for the car rental business during the Year.

#### Income tax expense

Income tax expense decreased from approximately HK\$3.6 million for the year ended 31 December 2014 to approximately HK\$2.9 million for the year ended 31 December 2015, mainly due to the reversal of deferred tax asset in the prior year.

#### 銷售及分銷開支

銷售及分銷開支由截至二零一四年十二月三十一日止年度的約14,600,000港元下跌約55%至截至二零一五年十二月三十一日止年度的約6,500,000港元,主要由於出售若干從事消費電子器材/平台及相關解決方案/服務分部之附屬公司而達致節約成本之效果。

#### 一般及行政費用

一般及行政費用由截至二零一四年十二月三十一日止年度的約25,400,000港元增加約56%至截至二零一五年十二月三十一日止年度的約39,700,000港元,主要由於本年度擴充業務產生之額外成本引致。

#### 其他開支淨額

其他開支淨額由截至二零一四年十二月三十一日止年度的約26,000,000港元,減少約96%至截至二零一五年十二月三十一日止年度的約900,000港元,主要由於應收賬款及其他應收款項的減值/撇銷減少所致。

#### 融資成本

融資成本從截至二零一四年十二月三十一日 止年度約100,000港元增長至截至二零一五年 十二月三十一日止年度約1,900,000港元,主 要由於本年度提取若干新增計息銀行及其他借 貸為汽車租賃業務購買若干汽車提供資金。

#### 所得税開支

所得税開支由截至二零一四年十二月三十一日止年度之約3,600,000港元減少至截至二零一五年十二月三十一日止年度之約2,900,000港元,主要由於去年撥回遞延税項資產所致。

As at 31 December 2015, cash and cash equivalents of the Group amounted to approximately HK\$5.1 million (2014: HK\$8.1 million).

In view of the Group's current level of cash and cash equivalents, funds generated internally from our operations and from the corporate actions completed during the Year, the Board is confident that the Group will have sufficient financial resources to meet its debt repayment and financing needs for its operations for the foreseeable future.

As at 31 December 2015, the gearing ratio is 3.4% (2014: 4.5%). As at 31 December 2015, the maturity profile of the interest-bearing bank and other borrowings of the Group falling due within one year, and the second year, inclusive, amounted to approximately HK\$26.1 million (2014: HK\$8.4 million) and HK\$5.4 million (2014: HK\$5.3 million), respectively.

The agenda and the accompanying Board papers are normally sent to all Directors at least 3 days before the intended date of a regular Board meeting (and so far as practicable for such other Board meetings). Draft minutes of each Board meeting are circulated to all Directors for their comments before being tabled at the following Board meeting for approval. All minutes are kept by the Company Secretary and are open for inspection at any reasonable time on reasonable notice by any Director.

#### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants, accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for available-forsale investment which has been measured at fair value. These financial statements are presented in Hong Kong dollars.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 December 2015. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

#### Investment in a joint venture

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investment in a joint venture is stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

The Group's share of the post-acquisition results and other comprehensive income of the joint venture is included in the consolidated statement of profit or loss and consolidated other comprehensive income. respectively. In addition, when there has been a change recognised directly in the equity of the joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint venture are eliminated to the extent of the Group's investment in the joint venture, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of the joint venture is included as part of the Group's investment in a joint venture.

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of noncontrolling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

#### Fair value measurement

The Group measures its an available-for-sale investment at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

#### Vehicle rental business licence and licence plates

Vehicle rental business licence and licence plates are accounted for as intangible assets with indefinite useful lives and are not amortised. They are stated at cost less any impairment losses.

All research costs are charged to the statement of profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

Deferred development costs are stated at cost less any impairment losses and are amortised using the straight-line basis over the commercial lives of the underlying products not exceeding three years, commencing from the date when the products are put into commercial production or when the intangible assets are available for use.

#### Leases

Leases that transfer substantially all the rewards and risks incidental to ownership of assets to the Group, other than legal title, are accounted for as finance leases. At the inception of a finance lease, the cost of the leased asset is capitalised at the present value of the minimum lease payments and recorded together with the obligation, excluding the interest element, to reflect the purchase and financing. Assets held under capitalised finance leases are included in property, plant and equipment, and depreciated over the shorter of the lease terms and the estimated useful lives of the assets. The finance costs of such leases are charged to the statement of profit or loss so as to provide a constant periodic rate of charge over the lease terms.

After initial recognition, available-for-sale financial investments are subsequently measured at fair value, with unrealised gains or losses recognised as other comprehensive income in the available-for-sale investment revaluation reserve until the investment is derecognised, at which time the cumulative gain or loss is recognised in the statement of profit or loss in other income, or until the investment is determined to be impaired, when the cumulative gain or loss is reclassified from the available-for-sale investment revaluation reserve to the statement of profit or loss in other gains or losses. Interest and dividends earned whilst holding the available-for-sale financial investments are reported as interest income and dividend income, respectively and are recognised in the statement of profit or loss as other income in accordance with the policies set out for "Revenue recognition" below.

For a financial asset reclassified from the available-for-sale category, the fair value carrying amount at the date of reclassification becomes its new amortised cost and any previous gain or loss on that asset that has been recognised in equity is amortised to profit or loss over the remaining life of the investment using the effective interest rate. Any difference between the new amortised cost and the maturity amount is also amortised over the remaining life of the asset using the effective interest rate. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

#### Financial assets carried at amortised cost

For financial assets carried at amortised cost, the Group first assesses whether impairment exists individually for financial assets that are individually significant, or collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, it includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is, or continues to be, recognised are not included in a collective assessment of impairment.

In the case of equity investments classified as available for sale, objective evidence would include a significant or prolonged decline in the fair value of an investment below its cost. "Significant" is evaluated against the original cost of the investment and "prolonged" against the period in which the fair value has been below its original cost. Where there is evidence of impairment, the cumulative loss - measured as the difference between the acquisition cost and the current fair value, less any impairment loss on that investment previously recognised in the statement of profit or loss is removed from other comprehensive income and recognised in the statement of profit or loss. Impairment losses on equity instruments classified as available for sale are not reversed through the statement of profit or loss. Increases in their fair value after impairment are recognised directly in other comprehensive income.

The determination of what is "significant" or "prolonged" requires judgement. In making this judgement, the Group evaluates, among other factors, the duration or extent to which the fair value of an investment is less than its cost.

In the case of debt instruments classified as available for sale, impairment is assessed based on the same criteria as financial assets carried at amortised cost. However, the amount recorded for impairment is the cumulative loss measured as the difference between the amortised cost and the current fair value, less any impairment loss on that investment previously recognised in the statement of profit or loss. Future interest income continues to be accrued based on the reduced carrying amount of the asset using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. The interest income is recorded as part of finance income. Impairment losses on debt instruments are reversed through the statement of profit or loss if the subsequent increase in fair value of the instruments can be objectively related to an event occurring after the impairment loss was recognised in the statement of profit or loss.

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings, net of directly attributable transaction costs.

#### Subsequent measurement of loans and borrowings

After initial recognition, interest-bearing bank and other borrowings are subsequently measured at amortised cost, using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

#### Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount of the best estimate of the expenditure required to settle the present obligation at the end of the reporting period; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation.

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

## Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### **Provisions**

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

Provisions for product warranties granted by the Group on certain products are recognised based on sales volume and past experience of the level of repairs and returns, discounted to their present values as appropriate.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

### **Government grants**

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced deprecation charge.

- (a) from the sales of goods, when the significant risks and rewards of ownership have been transferred to the buyer, provided that the Group maintains neither managerial involvement to the degree usually associated with ownership, nor effective control over the goods sold.
- (b) from the rendering services, when the corresponding services are rendered;
- (c) rental income, on a time proportion basis over the lease terms; and
- (d) interest income, on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### **Deferred revenue**

Deferred revenue represents service fees received in advance of the rendering of the relevant services. Deferred revenue is released to profit or loss when the corresponding services have been rendered.

## **Share-based payments**

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants after 7 November 2002 is measured by reference to the fair value at the date at which they are granted.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where nonvesting conditions within the control of either the Group or the employee are met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

### Other employee benefits

#### Paid leave carried forward

The Group provides paid annual leave to its employees under their employment contracts on a calendar year basis. Under certain circumstances, such leave which remains untaken as at the end of the reporting period is permitted to be carried forward and utilised by the respective employees in the following period. An accrual is made at the end of each reporting period for the expected future cost of such paid leave earned during the period by the employees and carried forward.

#### Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The subsidiaries are required to contribute a specific percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination benefits.

## Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities of the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively.

The functional currencies of certain overseas subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

#### **Business combination**

On 19 December 2014, the Group acquired the entire equity interest of Gigantic Wisdom Limited and its operating subsidiary, 北京途安汽車租賃有限責任公 司, (collectively, the "Gigantic Group") from Nimble Ring Limited. As at 31 December 2014, the goodwill arising from the above acquisition was determined on a provisional basis as the Group was in the process of completing a valuation to assess the fair values of the identifiable assets acquired and liabilities assumed. During the current reporting period, management has finalised the assessment of fair value of the assets and liabilities of the Gigantic Group at the date of acquisition. Intangible assets acquired by the Group in the acquisition of the Gigantic Group include vehicle rental business licence and licence plates (collectively referred to as the "Intangible Assets"). The residual portion of the purchase consideration was allocated as goodwill, which represents the balance of the purchase consideration over the fair value of identifiable net assets acquired by the Group. The respective fair values of the identifiable intangible assets acquired through the acquisition of the Gigantic Group have been determined using the excess earnings method which represented the discounted present values of the projected annual excess earnings of each of the Intangible Assets. The purchase price allocation has involved significant management judgement and estimation. The Intangible Assets have indefinite useful lives and are subject to impairment review and could affect the future results of the Group. Further information on the valuation basis of the Intangible Assets and the carrying amounts of the Intangible Assets are included in notes 2.4 and 14, respectively, to the financial statements.

#### Legal structure of an available-for-sale investment

As mentioned in note 35 to the financial statements below, the Group subscribed 111,111 new ordinary shares of Prime Elite Ventures Limited ("Prime Elite"), a company incorporated in the Cayman Islands, at a total consideration of US\$5 million (approximately HK\$39 million) during the year and owned as to 10% equity interest of Prime Elite. Prime Elite does not have equity ownership in a company registered in the PRC (the "PRC operating company") which is engaged in the business of online car rental services in the PRC. Nevertheless, under certain contractual arrangements ("Contractual Arrangements") entered into between a wholly-foreign owned enterprise of Prime Elite and the PRC operating company, Prime Elite has obtained the right of control, economic interests and benefits over the PRC operating company. Management assessed the terms and conditions of the Contractual Arrangements and considered they are legally enforceable in the PRC, as such, management considered the Group has obtained certain economic interests and benefits over the PRC operating company through subscription of shares in Prime Elite. The 10% equity investment was accounted for as an available-for-sale investment based on management's classification and it is subsequently measured at fair value in accordance with HKAS 39 Financial Instruments: Recognition and Measurement. The carrying amount of the available-for-sale equity investment as at 31 December 2015 was approximately HK\$40 million. Further details are set out in note 16 to the financial statements.

#### Determination of functional currency

The Group measures foreign currency transactions in the respective functional currencies of the Company and its subsidiaries. In determining the functional currency of each entity of the Group, judgement is required to determine and consider the currency that mainly influences sales prices of goods and services and of the country/jurisdiction whose competitive forces and regulations mainly determines the sales prices of goods and services; the currency that mainly influences labour, materials and other costs of providing goods or services; the currency in which funds from financing activities are generated; and the currency in which receipts from operating activities are usually retained. The functional currency of each entity of the Group is determined based on management's assessment of the primary economic environment in which the entity operates. When the indicators are mixed and the functional currency is not obvious, management uses its judgement to determine the functional currency that most faithfully represents the economic effects of the underlying transactions, events and conditions.

#### Income taxes

The Group has exposure to income taxes in different jurisdictions. Significant judgement is involved in determining the provision for income taxes. Determining income tax provisions involves judgement on the future tax treatment of certain transactions and interpretation of tax rules/tax laws. The Group carefully evaluates tax implications of transactions/arrangements and tax provisions are set up accordingly. The tax treatment of such transactions/arrangements is reconsidered periodically to take into account all changes in tax legislation, interpretations and practices in respect thereof.

#### Finance lease arrangements

The Group has entered into certain arrangements (including sale and leaseback arrangements) with a leasing company to finance its purchases of certain motor vehicles for its car rental business. The Group evaluated the terms and conditions of the arrangements and assessed that the arrangements transfer substantially all the risks and rewards incidental to ownership of the motor vehicles to the Group and so accounts for the arrangements as finance leases.

## **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### Impairment of loans and receivables

The Group assesses at the end of each reporting period whether there is any objective evidence that a loan/receivable is impaired. To determine whether there is objective evidence of impairment, the Group considers factors such as the probability of insolvency or significant financial difficulties of the debtor and default or significant delay in payments. Where there is objective evidence of impairment, the amount and timing of future cash flows are estimated based on, inter alia, historical loss experience for assets with similar credit risk characteristics and/or other relevant facts and circumstances.

The Group maintains an allowance for estimated impairment of receivables arising from the inability of its debtors to make the required payments or if the present value of estimated future cash flows (excluding future credit losses that have not yet been incurred) is less than the financial assets' carrying amount. The Group makes its estimates based on, inter alia, the ageing of its receivable balances, debtors' creditworthiness, past repayment history and historical write-off experience and/or other relevant facts and circumstances. If the financial condition of its debtors was to deteriorate so that the actual impairment loss might be higher than expected, the Group would be required to revise the basis/assumptions/estimates of making the allowance.

#### Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. Further details are given in note 13 to the financial statements.

## Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs to sell and its value in use. The calculation of the fair value less costs to sell is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows. Further details are given in note 13 to the financial statements.

#### Fair value of available-for-sale investment

The available-for-sale equity investment has been valued based on the expected cash flows discounted at current rates applicable for items with similar terms and risk characteristics. This valuation requires the Group to make estimates about expected future cash flows, credit risk, volatility and discount rates, and hence they are subject to uncertainty. The fair value of the available-for-sale investment at 31 December 2015 was HK\$39,987,400 (2014: Nil). Further details are included in notes 16 to the financial statements.

#### Net realisable value of inventories

The Group performs regular review of the carrying amounts of inventories with reference to aged analyses of the Group's inventories, projections of expected future saleability of goods, changes in technological, market, economic and business conditions and management experience and judgement. Based on this review, write-down of inventories will be made when the carrying amounts of inventories decline below their estimated net realisable value. Due to changes in technological, market and economic environment and customers' preference, actual saleability of goods may be different from estimation and profit or loss could be affected by differences in this estimation.

#### Useful lives of property, plant and equipment

The cost of property, plant and equipment is depreciated on a straight-line basis over the estimated economic useful lives of the property, plant and equipment. Management estimates the useful lives of the property, plant and equipment to be two to five years or over the shorter of the lease terms and four years for leasehold improvements. Changes in the expected level of usage, technological developments and/or the period over which future economic benefits are generated could impact the economic useful lives of the assets and, therefore, future depreciation charges could be revised.

## 4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has four reportable operating segments as follows:

- (a) Car rental segment primarily engages in the provision of car rental services;
- (b) Electronic components/materials segment primarily engages in the trading of electronic components/materials;
- (c) Consumer electronic devices/platforms and related solutions/services segment primarily engages in the research, design, development and sale of DSP-based consumer electronic devices/platforms, including embedded firmware, and the provision of solutions/services to customers for their DSP-based consumer electronic devices/platforms; and
- (d) Financing services segment primarily engages in money lending business through the provision of loans.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resources allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/(loss), which is a measure of adjusted profit/(loss) before tax. The adjusted profit/(loss) before tax is measured consistently with the Group's loss before tax except that unallocated interest income, unallocated other income and gains, unallocated depreciation, unallocated finance costs as well as corporate and other unallocated expenses, and share of loss of a joint venture are excluded from such measurement.

Segment assets exclude tax recoverable and cash and cash equivalents, an unlisted available-for-sale debt investment and other unallocated head office and corporate assets as these assets are managed on a group basis, as well as an interest in a joint venture.

# Impairment testing of goodwill and intangible assets

Goodwill and intangible assets acquired through a business combination are allocated to the car rental cash-generating unit for impairment testing.

The recoverable amount of the car rental cash—generating unit has been determined based on a value in use calculation using cash flow projections based on financial budgets covering a five-year period approved by management. The growth rate used to extrapolate the cash flows of the car rental cash-generating unit beyond the five-year period is 3% (2014: 3%) and the discount rate applied to the cash flow projections is 16% (2014: 12%).

In the opinion of the Company's directors, a decrease in the growth rate by 0.5% and an increase in discount rate by 0.5% would cause the carrying amount of the cash-generating unit to exceed its recoverable amount by approximately HK\$728,000 and HK\$2,818,000, respectively.

Key assumptions were used in the value in use calculation of the above cash-generating unit for 31 December 2015 and 31 December 2014. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

Budgeted revenue — The basis used to determine the value assigned to the revenue is the average revenue achieved in the year immediately before the budget year, increased for expected efficiency improvements and expected business and market developments.

Discount rate — The discount rate used is before tax and reflects specific risks relating to the relevant unit.

The United States International Trade Commission also imposed a limited exclusive order to this customer during the prior year, which prohibited the entry of the infringing electronic devices and products of this customer with utilisation of such intellectual property in the United States of America. Accordingly, the directors of the Company consider minimal future economic benefits could be generated from this item of intellectual property to the Group and no value was ascribed to it as at 31 December 2015 and 31 December 2014. The Group currently does not have any policies or detailed plans in respect of such item or for using it in its operations. The Group recognised a full provision of HK\$3,625,541 (2014: HK\$7,616,643) and HK\$18,895,076 (2014: HK\$20,058,594) for the trade receivable and other receivable, respectively, of this customer during the year ended 31 December 2013.

### 31. BUSINESS COMBINATION

On 19 December 2014, the Group acquired the entire equity interest in Gigantic Group from Nimble Ring Limited, at a total purchase consideration of RMB65,000,000 (equivalent to HK\$81,400,447). The Gigantic Group is engaged in the car rental services business. Further details of the transaction were set out in an announcement of the Company dated 28 November 2014. The acquisition was made as part of the Group's strategy to strengthen the Group's capabilities in both hardware such as cars and equipment and software including staff and services with respect to long-term car rental services. The purchase consideration for the acquisition was in the form of cash, with RMB16,250,000 (equivalent to HK\$20,350,942) paid at the acquisition date and the remaining RMB48,750,000 (equivalent to HK\$61,049,505) was settled during the year.

During the year, management has finalised the fair value assessment of the assets and liabilities of the Gigantic Group at the date of acquisition. The amounts of property, plant and equipment and other payables and goodwill were initially recognised on a provisional basis in the consolidated financial statements at approximately HK\$27,216,823, HK\$12,219,368 and HK\$72,383,420 at the date of acquisition in the consolidated statement of financial position for the year ended 31 December 2014. As a result, adjustments have been made to reduce the goodwill arising from the acquisition by HK\$46,173,082 and increase the initial carrying amounts of property, plant and equipment, intangible assets, other payables and deferred tax liabilities by HK\$2,974,110, HK\$68,670,000, HK\$7,560,000 and HK\$17,911,028, respectively. Except for the respective fair values of intangible assets and property, plant and equipment which were determined based on the discounted cash flow analysis and market comparable approach, the carrying amounts of other assets and liabilities approximated to their fair values. Accordingly, the amounts of property, plant and equipment, intangible assets, other payables, deferred tax liabilities and goodwill have been adjusted to HK\$30,190,933, HK\$68,670,000, HK\$19,779,368, HK\$17,911,028 and HK\$26,210,338, respectively, as at the date of acquisition.

The directors of the Company consider the acquisition of the Gigantic Group as an effort to capture the car rental market opportunities in Mainland China and the goodwill on acquisition mainly represents the expected incremental values and potential synergies for the related development and expansion plans of the Group.

The fair values of the trade receivables and other receivables of the Gigantic Group at the date of acquisition approximated to their gross contractual amounts and the directors of the Company do not expect any significant acquired receivables to be uncollectible.

The Group incurred transaction costs of HK\$376,128 for this acquisition. These costs have been expensed and are included in general and administrative expenses in the consolidated statement of profit or loss for the prior year.

Since the acquisition, the Gigantic Group contributed HK\$664,481 to the Group's revenue and HK\$71,568 to a reduction in the consolidated loss for the year ended 31 December 2014.

Had the above acquisition taken place at the beginning of the year ended 31 December 2014, the revenue of the Group for the year ended 31 December 2014 would have been HK\$245,071,461 and the loss of the Group for the year ended 31 December 2014 would have been HK\$48,317,753. The pro forma information is for illustrative purposes only and is not necessarily an indication of revenue and results of operations of the Group that actually would have been achieved had the acquisitions been completed at the beginning of the year, nor is it intended to be a projection of future results.

(a) During the year ended 31 December 2013, the Group borrowed HK\$12 million from a related company pursuant to a loan agreement entered into with the related company, in which, based on information available to the directors of the Company, a then significant beneficial shareholder of the Company had then a beneficial interest in the related company.

The loan from the related company was unsecured, bore interest at 5% per annum and was originally repayable on 31 January 2015.

During the year ended 31 December 2014, the Group early repaid a portion of the loan amounting to HK\$11.6 million and the related company granted the Group a waiver of the remaining principal and interest accrued for the period from July 2013 to July 2014 on the loan amounting to HK\$400,000 and HK\$600,000, respectively.

The other income recognised by the Group for the year ended 31 December 2014 in respect of the wavier of the remaining principal and interest accrued for the period from July 2013 to December 2013 on the loan already made by the Group in the prior year amounted to HK\$700,000.

The fair value of an unlisted available-for-sale equity investment as at 31 December 2015 has been estimated using a discounted cash flow valuation model based on assumptions that are not supported by observable market prices or rates. The valuation requires the directors to make estimates about the expected future cash flows including expected future dividends and proceeds on subsequent disposal of the shares. The directors believe that the estimated fair values resulting from the valuation technique, which are recorded in the consolidated statement of financial position, and the related changes in fair values, which are recorded in other comprehensive income, are reasonable, and that they were the most appropriate values at the end of the reporting period.

# 39. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise interest-bearing bank and other borrowings, pledged bank deposit and cash and cash equivalents. The main purpose of these financial instruments is to finance/raise finance for the Group's operations. The Group has various other financial assets and liabilities such as trade receivables, financial assets included in deposits and other receivables, an amount due from a joint venture, an available-for-sale investment, trade payables and financial liabilities included in other payables and accruals, which mainly arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

#### Interest rate risk

As at 31 December 2015 and 31 December 2014, the Group is exposed to fair value interest rate risk in relation to the interest-bearing bank and other borrowings of the Group with fixed interest rates. The Group currently does not have any fair value interest rate hedging policy. However, management will consider hedging significant interest rate exposure should the need arise.

As at 31 December 2014, the Group was also exposed to the risk of changes in market interest rate related to the Group's available-for-sale investment with a floating interest rate. The Group did not use derivative financial instruments to hedge its interest rate risk. Further details of the available-for-sale investment are set out in note 16 to the financial statements.

#### Foreign currency risk

The Group has transactional currency exposures. Such exposures primarily arise from revenue and other income generated, and cost and expenses incurred by operating units in currencies other than the Group's operating units' functional currencies. For the Group's operating units' that have the United States dollar ("US\$") as their functional currency, their foreign currency transactions during the years ended 31 December 2015 and 2014, and the units' monetary assets and liabilities denominated in foreign currencies as at the end of the reporting period were mainly denominated in Hong Kong dollars. As the Hong Kong dollar ("HK\$") is pegged to the US\$ within a narrow band, the Group does not expect any significant movements in the US\$/HK\$ exchange rate. Accordingly, management considers that the Group's foreign currency risk exposure for US\$ is not significant.

The following table demonstrates the sensitivity at the end of the reporting period to a reasonably possible change in the RMB exchange rate, with all other variables held constant, of the Group's loss before tax (due to changes in the fair value of the pledge bank deposit).

#### Credit risk

The Group primarily trades on credit with recognised and creditworthy third parties or with customers with long term/strategic relationships. The receivable balances of the Group are monitored by senior management on an ongoing basis. Since the Group primarily trades on credit with recognised and creditworthy third parties or with customers with long term/strategic relationships, save as disclosed elsewhere in the financial statements, there is normally no requirement for collateral.

The credit risk of the Group's financial assets, which comprise trade receivables, loan receivables, financial assets included in deposits and other receivables, an amount due from a joint venture, an available-for-sale investment, pledged bank deposit, and cash and cash equivalents, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

Concentrations of credit risk are managed by customer/counterparty, by geographical region and by industry sector. At the end of the reporting period, the Group had certain concentrations of credit risk as 22.4% (2014: 62.2%) and 53.3% (2014: 92.7%) of the Group's trade receivables, loan receivables and other receivables were due from the Group's largest customer/debtors and five largest customers/debtors, respectively.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade receivables and loan receivables are disclosed in notes 19 and 20 to the financial statements, respectively.
