Chairman's Statement and Management Discussion and Analysis

主席報告與管理層討論及分析

On behalf of the board of directors (the "Board") of National Investments Fund Limited (the "Company"), I am pleased to present the annual results of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2015 (the "Review Period").

The Company is an investment company and the Group is principally engaged in investments in a diversified portfolio of listed and unlisted companies.

BUSINESS REVIEW

For the Review Period, the Group's revenue recorded a net loss of approximately HK\$27,193,000 (for the year ended 31 December 2014 ("Last Corresponding Period"): net gain of approximately HK\$56,480,000). Excluding the net loss of approximately HK\$29,776,000 (Last Corresponding Period: net gain of approximately HK\$54,397,000) recorded on the financial assets at fair value through profit or loss ("FVTPL"), the Group's revenue increased by approximately 24% to approximately HK\$2,583,000 (Last Corresponding Period: revenue of approximately HK\$2,083,000). The proceeds on sales of equity and debt securities were approximately HK\$110,693,000 (Last Corresponding Period: the proceeds on sales of equity and debt securities and commodities futures contracts of approximately HK\$183,620,000), and the cost of sales were approximately HK\$140,252,000 (Last Corresponding Period: approximately HK\$162,706,000). The net realised loss on financial assets at FVTPL was therefore approximately HK\$29,559,000 (Last Corresponding Period: net realised gain on financial assets at FVTPL of approximately HK\$20,914,000). Apart from the net realised loss on financial assets at FVTPL, the unrealised loss on financial assets at FVTPL was approximately HK\$217,000 (Last Corresponding Period: unrealised gain on financial assets at FVTPL of approximately HK\$33,483,000).

For the Review Period, the loss attributable to owners of the Company was approximately HK\$310,169,000 (Last Corresponding Period: approximately HK\$108,094,000). The loss was primarily attributable to (i) a net loss of approximately HK\$29,776,000 recorded on the financial assets at FVTPL (Last Corresponding Period: a net gain of approximately HK\$54,397,000); (ii) loss on disposal of subsidiaries of approximately HK\$18,415,000 (Last Corresponding Period: approximately HK\$2,050,000); (iii) loss on disposal of available-for-sale financial assets of approximately HK\$127,138,000 (Last Corresponding Period: HK\$Nil); (iv) impairment loss of other tangible assets of approximately HK\$3,054,000 (Last Corresponding Period: HK\$Nil); and (v) shared loss of associates of approximately HK\$8,743,000 (Last Corresponding Period: approximately HK\$6,062,000).

本人謹代表國盛投資基金有限公司(「本公司」)董事會(「董事會」)欣然呈列本公司及其附屬公司(統稱「本集團」)截至二零一五年十二月三十一日止年度(「回顧期間」)之全年業績。

本公司為一間投資公司，而本集團之主要業務為投資於上市及非上市公司之多元化投資組合。

業務回顧

於回顧期間，本集團收益錄得虧損淨額約27,193,000港元(截至二零一四年十二月三十一日止年度(「去年同期」): 收益淨額約56,480,000港元)。倘剔除於損益表按公允價值列賬之金融資產虧損淨額約29,776,000港元(去年同期: 收益淨額約54,397,000港元)，則本集團之收益增加約24%至約2,583,000港元(去年同期: 收益約2,083,000港元)。股本及債務證券之銷售所得款項約為110,693,000港元(去年同期: 股本及債務證券以及商品期貨合約之銷售所得款項約183,620,000港元)，而銷售成本約為140,252,000港元(去年同期: 約162,706,000港元)。因此，於損益表按公允價值列賬之金融資產已變現虧損淨額約為29,559,000港元(去年同期: 於損益表按公允價值列賬之金融資產已變現收益淨額約20,914,000港元)。除於損益表按公允價值列賬之金融資產已變現虧損淨額外，於損益表按公允價值列賬之金融資產未變現虧損約為217,000港元(去年同期: 於損益表按公允價值列賬之金融資產未變現收益約33,483,000港元)。

於回顧期間，本公司擁有人應佔虧損約為310,169,000港元(去年同期: 約108,094,000港元)。虧損主要源自(i)於損益表按公允價值列賬之金融資產虧損淨額約29,776,000港元(去年同期: 收益淨額約54,397,000港元); (ii)出售附屬公司之虧損約18,415,000港元(去年同期: 約2,050,000港元); (iii)出售可供出售金融資產之虧損約127,138,000港元(去年同期: 零港元); (iv)其他有形資產之減值虧損約3,054,000港元(去年同期: 零港元); 及(v)應佔聯營公司之虧損約8,743,000港元(去年同期: 約6,062,000港元)。

PROSPECT

Affected by China's economy, Hong Kong's economy also experienced decline and adjustment. With the Hong Kong stock market entering into a period of adjustment and down cycle, the investment sentiment is less satisfactory and it is expected that the stock market will remain challenging in 2016. The Group will continue to implement diversified investment strategies and to identify suitable investment opportunities with potential assets appreciation to generate better returns for the Group and the shareholders of the Company. The Group will also continue to adopt and maintain a prudent yet proactive investment approach and will closely monitor the performance of the investment portfolios. The Group remains positive on the prospects of its investments and is confident that shareholders of the Company will be rewarded with strong positive returns under our investment portfolios in the future.

DIVIDEND

The Board does not recommend the payment of final dividend for the Review Period (Last Corresponding Period: Nil).

LIQUIDITY AND FINANCIAL RESOURCES

The Group had cash and cash equivalents of approximately HK\$8,419,000 as at 31 December 2015 (2014: approximately HK\$16,489,000).

As at 31 December 2015, the Company had issued promissory notes in the aggregate amount of HK\$110,000,000. Eleven promissory notes in the denomination of HK\$10,000,000 each were issued to eleven independent third parties. Each promissory note bears interest at a rate of 5% per annum with a maturity period of seven years from the date of issue. The net proceeds were used for investment in securities and as general working capital of the Group.

The net current assets held by the Group as at 31 December 2015 amounted to approximately HK\$63,861,000 (2014: approximately HK\$154,758,000). Save and except the above, the Group had no other outstanding credit facility from other financial institutions as at 31 December 2015. As all cash and cash equivalents were maintained in Hong Kong Dollars accounts with banks in Hong Kong, exposure to exchange fluctuation is considered minimal. The gearing ratio, calculated on the basis of total liabilities over total equity as at 31 December 2015, was approximately 1.715 (2014: approximately 0.585).

展望

受中國經濟影響，香港經濟亦經歷下跌及調整，香港股票市場則進入調整期及下降週期，投資氣氛略為淡靜，故預期股票市場於二零一六年仍然挑戰重重。本集團將繼續實施多元化投資策略，物色具有資產升值潛力之合適投資機會，從而為本集團及本公司股東帶來更佳回報。本集團亦將繼續採取及維持審慎而積極之投資方針，並密切監察投資組合表現。本集團對投資前景仍然抱持樂觀態度，深信旗下的投資組合可於日後為本公司股東帶來豐厚回報。

股息

董事會不建議就回顧期間派發末期股息（去年同期：無）。

流動資金及財務資源

於二零一五年十二月三十一日，本集團持有現金及現金等值項目約8,419,000港元（二零一四年：約16,489,000港元）。

於二零一五年十二月三十一日，本公司已發行總額為110,000,000港元之承兌票據。十一份每份面值為10,000,000港元的承兌票據已發行予十一名獨立第三方。每份承兌票據按年利率5%計息，由發行日期起計七年到期。所得款項淨額已用於投資證券及用作本集團一般營運資金。

於二零一五年十二月三十一日，本集團持有之流動資產淨值約為63,861,000港元（二零一四年：約154,758,000港元）。除上述者外，本集團於二零一五年十二月三十一日並無向其他金融機構取得任何其他未償還信貸融資。由於所有現金及現金等值項目均存放於香港銀行之港元賬戶，故所承擔之外匯波動風險極低。按於二零一五年十二月三十一日之負債總額除以權益總額之基準計算，資產負債比率約為1.715（二零一四年：約0.585）。

CAPITAL STRUCTURE AND FUND RAISING ACTIVITIES

The shares of the Company were listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Changes in the capital structure of the Company during the Review Period are set out below.

On 11 December 2015, the Company completed a placing of 52,085,920 new ordinary shares of HK\$0.01 each through a placing agent to not less than six independent investors at a price of HK\$0.409 per placing share. The net proceeds of the placing in the amount of approximately HK\$20.45 million, representing a net price approximately of HK\$0.393 per placing share, were used as general working capital of the Group. Details of the placing were disclosed in the announcements of the Company dated 4 December 2015 and 11 December 2015.

As at 31 December 2015, the total number of issued ordinary shares of the Company was 1,802,260,913 shares (2014: 1,592,035,953 shares).

EMPLOYEES AND REMUNERATION POLICIES

As at 31 December 2015, the Group had 31 employees (2014: 34 employees), including executive directors, non-executive directors and independent non-executive directors. The total employment costs incurred during the Review Period were approximately HK\$23,472,000 (2014: approximately HK\$18,773,000). The Group's remuneration policies are in line with the prevailing market practice and are determined based on the performance, level of responsibility and experience of individual employees.

Further, the Company adopted a share option scheme on 27 August 2007 (the "Share Option Scheme") as incentives or rewards for the employees' contributions to the Company. For further details of the Share Option Scheme, please refer to the section headed "Interests in Share Options" in this report.

CAPITAL COMMITMENTS

As at 31 December 2015, the Group did not have any material capital commitments (2014: Nil).

股本架構及集資活動

本公司之股份於香港聯合交易所有限公司（「聯交所」）上市。於回顧期間內，本公司之股本架構變動載列於下文。

於二零一五年十二月十一日，本公司透過一名配售代理完成以每股配售股份0.409港元之價格向不少於六名獨立投資者配售52,085,920股每股面值0.01港元之新普通股。配售之所得款項淨額約20,450,000港元（即每股配售股份淨價格約為0.393港元）乃用作本集團之一般營運資金。配售之詳情於本公司日期為二零一五年十二月四日及二零一五年十二月十一日之公告內披露。

於二零一五年十二月三十一日，本公司之已發行普通股總數為1,802,260,913股（二零一四年：1,592,035,953股）。

僱員及薪酬政策

於二零一五年十二月三十一日，本集團共有31名（二零一四年：34名）僱員，其中包括執行董事、非執行董事及獨立非執行董事。於回顧期間產生之僱傭成本總額約為23,472,000港元（二零一四年：約18,773,000港元）。本集團之薪酬政策與現行之市場慣例相符，根據個別僱員之表現、職責水平及經驗釐定。

此外，本公司於二零零七年八月二十七日採納購股權計劃（「購股權計劃」），作為僱員對本公司作出貢獻之鼓勵或獎賞。購股權計劃之進一步詳情請參閱本報告「購股權權益」一節。

資本承擔

於二零一五年十二月三十一日，本集團並無任何重大資本承擔（二零一四年：無）。

CHARGES ON THE GROUP'S ASSETS AND CONTINGENT LIABILITIES

Bank deposits in the amount of HK\$2,020,000 (2014: HK\$2,000,000) were pledged to a bank as security for certain trade credit facilities granted to the Group.

Save as disclosed above, there were no charges over any of the Group's assets or significant contingent liabilities as at 31 December 2015.

EXECUTIVE DIRECTORS

Mr. Wong Danny F., aged 53, was appointed as an executive director of the Company on 21 May 2007. Mr. Wong holds a Bachelor's degree in Economics and Accounting from China Central University of Finance and Economics. Mr. Wong has over 20 years of experience in investment project evaluation, listing planning and asset management. From 2001 to 2005, Mr. Wong was an executive director of Sun Hung Kai International Limited and was in charge of investment banking and responsible for public listing of companies and fund raising activities for private and listed companies. For the period from June 2009 to August 2009, Mr. Wong was an executive director of Mission Capital Holdings Limited (formerly known as Poly Capital Holdings Limited) (Stock code: 1141), a company listed on the Stock Exchange. For the period from February 2014 to June 2014, Mr. Wong served as an executive director and the chairman of Mascotte Holdings Limited (Stock code: 136), a company listed on the Stock Exchange. Since 26 November 2014, Mr. Wong has been a non-executive director of Celyad S.A. (formerly known as Cardio3 Biosciences S.A.) (Symbol: CYAD), a limited liability company listed on NYSE Euronext Brussels, NYSE Euronext Paris regulated markets as well as the National Association of Securities Dealers Automated Quotations (NASDAQ) in the United States of America in the form of American depository shares.

Mr. Wu Tse Wai, Frederick, aged 74, was appointed as an executive director of the Company on 6 January 2004. He also served as the Chief Executive Officer of the Company for the period from 1 November 2005 to 19 May 2014 and the period from 31 August 2015 to 20 March 2016. Mr. Wu was educated in Hong Kong and the United States with a Master of Business Administration degree in Finance. He has over 43 years of experience in insurance, securities business and asset management. He started his career with Paul Revere Life Insurance Company as an assistant actuary. He later worked for Fidelity Management and Research of Boston as an analyst and then moved on to senior positions in research and fund management with various well-known institutions in the United States. In the early 80s, Mr. Wu joined and served as a senior portfolio manager and investment advisor at Bank of America in Hong Kong. In the 90s, Mr. Wu joined and was elected as a director and senior consultant of Lippo Securities Group Limited ("Lippo Securities Group"). He was a member of Lippo Securities Group investment committee and was responsible for supervising the fund management activities including futures-related investments of Lippo Securities Group. Mr. Wu is currently a responsible officer registered under the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the "SFO").

執行董事

汪曉峰先生，53歲，於二零零七年五月二十一日獲委任為本公司之執行董事。汪先生持有中國中央財經大學頒授之經濟及會計學士學位。汪先生在投資專案評估、策劃上市及資產管理方面擁有逾20年豐富經驗。汪先生於二零零一年至二零零五年期間出任新鴻基國際有限公司之執行董事，主管投資銀行業務，負責為私人企業及上市公司提供公開掛牌及集資服務。二零零九年六月至二零零九年八月期間，汪先生出任聯交所上市公司保興資本控股有限公司（股份代號：1141）之執行董事。汪先生曾於二零一四年二月至二零一四年六月期間出任聯交所上市公司馬斯葛集團有限公司（股份代號：136）之執行董事兼主席。自二零一四年十一月二十六日起，汪先生為Celyad S.A.（前稱Cardio3 Biosciences S.A.）（股票代號：CYAD，一間於布魯塞爾紐約泛歐交易所、巴黎紐約泛歐交易所受規管市場以及以美國預托股份形式在美國全國證券交易商協會自動報價系統（納斯達克）上市之有限責任公司）之非執行董事。

吳子惠先生，74歲，於二零零四年一月六日獲委任為本公司之執行董事。彼亦曾於二零零五年十一月一日至二零一四年五月十九日期間及二零一五年八月三十一日至二零一六年三月二十日期間出任本公司之行政總裁。吳先生於香港及美國接受教育，取得財務工商管理碩士學位。彼於保險、證券業務及資產管理方面擁有逾43年經驗。彼曾於Paul Revere Life Insurance Company擔任助理精算師，從而開展其事業。彼之後在Fidelity Management and Research of Boston出任分析員，其後於美國多家著名機構出任研究及資金管理高層職位。於八十年代初期，吳先生加入香港Bank of America並出任高級投資組合經理兼投資顧問一職。於九十年代，吳先生加入Lippo Securities Group Limited（「Lippo Securities Group」）並膺選為董事兼高級顧問。彼為Lippo Securities Group投資委員會成員，負責監管資金管理事宜，包括Lippo Securities Group之期貨相關投資。吳先生現為證券及期貨條例（香港法例第571章）（「證券條例」）下註冊之負責人員。

Mr. Fong Chi Wah, aged 53, was appointed as an executive director of the Company on 1 November 2005. Mr. Fong is a Certified Practising Accountant (Australia), a Chartered Financial Analyst and a member of the Hong Kong Institute of Certified Public Accountants, the Institute of Certified Management Accountants, Australia and The Hong Kong Institute of Directors. Mr. Fong has over 20 years of extensive experience in various sectors of financial industry, including direct investment, project and structured finance and capital markets with focus on the People's Republic of China (the "PRC") and Hong Kong. Mr. Fong was previously a director of Baring Capital (China) Management Limited and held various management positions in ING Bank. Mr. Fong was previously also an executive director of Grand Investment International Limited (15 April 2003 (date of incorporation) to 1 April 2006), a company listed on the Stock Exchange. Mr. Fong has been serving as an independent non-executive director of China Innovationpay Group Limited (formerly known as SYSCAN Technology Holdings Limited) since 19 December 2003 and Real Nutraceutical Group Limited (formerly known as Ruinian International Limited) since 28 March 2008, both of which are listed on the Stock Exchange.

NON-EXECUTIVE DIRECTORS

Mr. Gao Chengming, aged 31, holds a Bachelor of Science degree in Statistics from Beijing Normal University and a Master of Finance degree from the University of Hong Kong. Mr. Gao has over five years' experience in auditing and investment analysis, and used to work at Guosen Securities (HK) Financial Holdings Company, Limited and PricewaterhouseCoopers China. Mr. Gao is licensed to carry out Type 1 (Dealing in Securities) and Type 4 (Advising on Securities) regulated activities under the SFO.

Mr. Lau Chi Lung, Johnny, aged 27, was appointed as a non-executive director of the Company on 17 March 2015. He holds a Bachelor of Arts degree in marketing management from Purdue University in the United States of America. Mr. Lau has over three years' experience in financial research and analysis, and has worked in Barclays Wealth and UBS AG. He is a youth committee member of China Federation of Overseas Chinese Entrepreneurs.

方志華先生，53歲，於二零零五年十一月一日獲委任為本公司之執行董事。方先生為澳洲執業會計師、特許財務分析師、香港會計師公會會員、澳洲執業管理會計師協會會員及香港董事學會會員。方先生於金融業之不同範疇擁有逾20年豐富經驗，包括主要於中華人民共和國（「中國」）及香港進行之直接投資、項目及結構性融資以及資本市場。方先生曾為霸菱投資（中國）基金管理有限公司董事，並於ING Bank擔任不同管理層職位。方先生亦曾任聯交所上市公司大唐投資國際有限公司之執行董事（二零零三年四月十五日（註冊成立日期）至二零零六年四月一日）。方先生分別自二零零三年十二月十九日及二零零八年三月二十八日起為聯交所上市公司中國創新支付集團有限公司（前稱矽感科技控股有限公司）及瑞年國際有限公司之獨立非執行董事。

非執行董事

高城銘先生，31歲，持有北京師範大學之統計學理學士學位和香港大學之金融碩士學位。高先生擁有超過5年審計及投資分析經驗，曾任職於國信證券（香港）金融控股有限公司及普華永道中天會計師事務所。高先生現持有證券條例下第1類（證券交易）及第4類（就證券提供意見）受規管活動之牌照。

INDEPENDENT NON-EXECUTIVE DIRECTORS

Mr. Char Shik Ngor, Stephen, aged 66, was appointed as an independent non-executive director of the Company on 22 May 2007. Mr. Char holds a Bachelor of Laws degree (Honours) from the University of London, a Master's degree in Social Sciences (Criminology) from the University of Hong Kong, a Master's degree in Social Sciences (Counselling) from the University of Hong Kong and a Post-graduate Certificate in Laws from City University of Hong Kong. Mr. Char had been a Chief Investigator and Senior Assignment Officer of the Independent Commission Against Corruption in Hong Kong from 1976 to 2004. Mr. Char was a Chief Executive Officer of Garner Forest Industries Limited. Mr. Char is a Barrister at Law and an Accredited Mediator. Mr. Char has been serving as an independent non-executive director of China Uptown Group Company Limited (stock code: 2330) since September 2015, which is listed on the Main Board of the Stock Exchange.

Mr. Liu Jin, aged 40, was appointed as an independent non-executive director of the Company on 21 May 2007. Mr. Liu holds a Bachelor's degree in International Economic Law from the Zhongnan University of Economics and Law. Mr. Liu has been a qualified solicitor in the PRC since 2001 and has various experience in merger and acquisition and corporate restructure in the PRC. Mr. Liu is currently a qualified solicitor practicing in Shenzhen, the PRC.

Mr. Law Tze Lun, aged 43, was appointed as an independent non-executive director of the Company on 12 December 2013. Mr. Law is a practising Certified Public Accountant in Hong Kong and is currently a director of ANSA CPA Limited. Mr. Law obtained a Bachelor's degree in Commerce (Accounting) from Curtin University of Technology. He is a Certified Public Accountant (Practising) of the Hong Kong Institute of Certified Public Accountants and a Certified Practising Accountant of the CPA Australia. He has over 20 years of experience in auditing, accounting and finance gained from various accounting firms in Hong Kong. Mr. Law has been serving as an independent non-executive director of Come Sure Group (Holdings) Limited (stock code: 794) since February 2009 and Gemini Investments (Holdings) Limited (stock code: 174) since November 2010, both of which are listed on the Main Board of the Stock Exchange. During the period from April 2010 to September 2011, Mr. Law served as an independent non-executive director of China Automotive Interior Decoration Holdings Limited (stock code: 8321), which was listed on the GEM Board of the Stock Exchange.

羅子璘先生，43歲，於二零一三年十二月十二日獲委任為本公司之獨立非執行董事。羅先生為香港執業會計師，現為錦璘會計師行有限公司之董事。羅先生持有澳洲科廷科技大學之商業（會計）學士學位。彼為香港會計師公會之執業會計師及澳洲會計師公會之執業會計師。彼於香港多間會計師事務所累積逾20年審計、會計及財務經驗。羅先生自二零零九年二月起擔任聯交所主板上市公司錦勝集團（控股）有限公司（股份代號：794）及自二零一零年十一月起擔任盛洋投資（控股）有限公司（股份代號：174）之獨立非執行董事。於二零一零年四月至二零一一年九月期間，羅先生曾擔任聯交所創業板上市公司中國汽車內飾集團有限公司（股份代號：8321）之獨立非執行董事。

CHIEF EXECUTIVE OFFICER

Mr. Feng Wen, aged 47, was appointed as the Chief Executive Officer of the Company on 21 March 2016. He graduated from the Medical Department of the Third Military Medical University in 1992 and holds a Master's degree from the School of Public Administration, Renmin University of China (中國人民大學) in 2006. Mr. Feng had worked for the General Office of the Ministry of Health of the PRC and a number of military hospitals for over 20 years. Mr. Feng is currently the chairman of the board of Zhong He Hou De Investment Management Co., Ltd, as well as an independent non-executive director of Golden Meditech Holdings Limited (stock code: 801), which is listed on the Main Board of the Stock Exchange.

Corporate Governance Report

企業管治報告

CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining a high level of corporate governance practices and procedures to safeguard the interests of its shareholders and enhance the performance of the Group. The Board will review and improve its corporate governance practices from time to time to ensure that the Group is under the leadership of an effective Board.

During the year under review, the Company has complied with all applicable code provisions in the Corporate Governance Code (the “CG Code”) as set out in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”), except for the deviation disclosed below. The Company periodically reviews its corporate governance practices to ensure that the Company complies with the requirements of the CG Code. The Company acknowledges the importance of corporate governance and ensures transparency and accountability of the Company’s operations.

Meetings were held throughout the year and where appropriate, circulars and other guidance notes were issued to directors and senior management of the Group to ensure that each and every director and senior management is aware of the importance of corporate governance.

DEVIATION FROM THE CODE

According to code provision E.1.2 of the CG Code, the Chairman of the Board should attend the annual general meeting. In respect of the annual general meeting held on 4 June 2015 (the “2015 AGM”), Mr. Wong Danny F., the Chairman of the Board, was engaged in an important business meeting and was not able to attend. However, Mr. Fong Chi Wah, an executive director of the Company, Mr. Char Shik Ngor, Stephen, an independent non-executive director of the Company, chairman of the Nomination Committee and members of the Audit Committee of the Company, and Mr. Law Tze Lun, an independent non-executive director of the Company, chairman of the Audit Committee and members of the Nomination Committee and Remuneration Committee of the Company, attended the 2015 AGM and answered questions raised during the 2015 AGM.

企業管治常規

本公司致力於維持高水平之企業管治常規及程序，以保障股東利益及提高本集團表現。董事會將不時檢討及改進其企業管治常規，以確保本集團由董事會有效領導。

於回顧年度，本公司一直遵守聯交所證券上市規則（「上市規則」）附錄十四所載之企業管治守則（「企業管治守則」）之所有適用守則條文，惟以下披露之偏離情況除外。本公司定期檢討其企業管治常規，以確保本公司符合企業管治守則之規定。本公司深明企業管治相當重要，並確保本公司營運之透明度及問責性。

年內，本公司曾舉行多次會議，並在適當情況下向本集團董事及高級管理人員刊發通函及其他應用指引，確保所有董事及高級管理人員均知悉企業管治之重要性。

偏離守則

根據企業管治守則之守則條文E.1.2，董事會主席應出席股東週年大會。就於二零一五年六月四日舉行之股東週年大會（「二零一五年股東週年大會」）而言，董事會主席汪曉峰先生因需於該日參與一個重要的商業會議而未能出席。然而，方志華先生（本公司執行董事）、查錫我先生（本公司獨立非執行董事、本公司提名委員會主席兼審核委員會成員）及羅子磷先生（本公司獨立非執行董事、本公司審核委員會主席兼提名委員會及薪酬委員會成員）已出席二零一五年股東週年大會，並於會上回應提問。

BOARD OF DIRECTORS

Responsibilities

The Board provides leadership, approves policies, strategies and plans and oversees their implementation to ensure the healthy growth of the Company and to safeguard the interests of shareholders of the Company.

The Board takes responsibility for all major matters of the Company, including the approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, financial information, appointment of directors and other significant financial and operational matters.

All directors have full and timely access to all relevant information as the management will prepare and supply the same to the Board and its committees. The Company Secretary will render his advice to the Board so that all the Board procedures and applicable rules and regulations are followed. The directors may make further enquiries if they are of the view that the information is not sufficient for them to make an informed decision. In general, each director is able to seek independent professional advice in appropriate circumstances to assist him/her in discharging his/her duties at the Company's expenses upon making such request to the Board.

In case where a conflict of interest may arise involving a substantial shareholder or a director, such matter will be discussed in a physical meeting and will not be dealt with by way of written resolutions. Independent non-executive directors with no conflict of interest will be present at meetings to deal with such conflict issues.

The Board committees, including the Audit Committee, the Remuneration Committee and the Nomination Committee, have adopted the applicable practices and procedures used in Board meetings.

During the Review Period, four Board meetings were held and the attendance of each director at these meetings is set out in the table under the section headed "Directors' Attendance at Shareholders' Meetings, Board and Committee Meetings".

董事會

責任

董事會負責領導、批准政策、策略及計劃並監督該等決策之實施，以確保本公司穩健成長及保障本公司股東之利益。

董事會負責本公司所有重大事項，包括審批及監控所有政策事項、整體策略及預算、內部監控及風險管理系統、財務資料、董事委任以及其他重大財務及營運事項。

管理層將會編製並向董事會及其轄下委員會提供所有相關資料，使全體董事均可全面及時取得所有相關資料。公司秘書將向董事會提供建議，致使董事會程序以及適用規則及規例均獲得遵守。董事於認為資料不足以讓彼等作出知情決定時可作進一步查詢。一般而言，各董事經向董事會要求後，均可在適當之情況下尋求獨立專業意見，協助彼履行職責，費用由本公司支付。

若有主要股東或董事可能在某事項中存有利益衝突，有關事項將透過現場會議進行討論，而不會以書面決議案方式處理。無利益衝突之獨立非執行董事將會出席會議，以處理有關衝突事宜。

董事會轄下委員會包括審核委員會、薪酬委員會及提名委員會，全部已採納董事會會議沿用之適用常規及程序。

董事會於回顧期間曾舉行四次會議，各董事於該等會議之出席記錄載於「股東大會、董事會會議及委員會會議之董事出席率」一節之列表內。

Delegation by the Board

The day-to-day management, administration and operation of the Company are delegated to the Chief Executive Officer and the senior management. The delegated functions and work tasks are periodically reviewed. Approval has to be obtained from the Board prior to the entering into of any significant transactions by the abovementioned officers. The Board has full support from the Chief Executive Officer and the senior management to discharge its responsibilities.

The Audit Committee, the Remuneration Committee and the Nomination Committee have specific terms of reference defining the authorities and responsibilities of the respective committees. The committees are required by their respective terms of reference to report to the Board in relation to their decisions, findings or recommendations, and in certain specific situations, to seek the Board's approval before taking any actions.

The Board reviews, on a yearly basis, all delegations by the Board to different committees to ensure that such delegations are appropriate and remain beneficial to the Company as a whole.

Directors' and Officers' Liability Insurance

The Company has arranged a Directors' and Officers' Liability Insurance Policy to provide appropriate coverage for any potential claims against directors and officers. The insurance policy was renewed in April 2016.

BOARD COMPOSITION

The composition of the Board reflects the necessary balance of skills and experience desirable for effective leadership of the Company and independence in decision making. All directors devote sufficient time and attention to the affairs of the Group.

The Board currently comprises eight members, consisting of three executive directors, two non-executive directors and three independent non-executive directors.

According to the Company's Articles of Association, directors appointed to fill casual vacancy shall hold office until the next following annual general meeting after their appointment and shall be subject to re-election by shareholders. All directors are subject to retirement by rotation at least once every three years.

董事會之授權

本公司授權行政總裁及高級管理人員處理本公司之日常管理、行政及營運。所授職能及工作任務會定期檢討。上述人員訂立任何重大交易前須獲董事會批准。董事會在行政總裁及高級管理人員之全力支援下履行其責任。

審核委員會、薪酬委員會及提名委員會均有特定職權範圍，界定相關委員會之權力及責任。該等委員會須按各自之職權範圍就其決定、發現或推薦建議向董事會報告，並於若干特定情況下，在採取任何行動前徵求董事會批准。

董事會每年檢討董事會轉授不同委員會之所有轉授權力，確保此等轉授權力為恰當，並持續對本公司整體有利。

董事及高級職員責任險

本公司已安排董事及高級職員責任險，為可能針對董事及高級職員提出之任何申索投購適當保險。該等保險已於二零一六年四月續保。

董事會成員組合

董事會之成員組合體現本公司有效領導及獨立決策所須具備之適當技巧及經驗。所有董事均投入足夠時間及精力處理本集團之事務。

董事會現時由八名成員組成，包括三名執行董事、兩名非執行董事及三名獨立非執行董事。

根據本公司之組織章程細則，為填補臨時空缺而委任之董事之任期直至其獲委任後之下一次股東週年大會為止，屆時須接受股東重選。所有董事須至少每三年輪值退任一次。

With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. The Board has adopted a board diversity policy with effect from 4 September 2013. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard to the benefits of diversity on the Board.

Selection of candidates for Board membership will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills and knowledge.

In accordance with Article 88 of the Company's Articles of Association, Mr. Fong Chi Wah, Mr. Liu Jin and Mr. Law Tze Lun shall retire as directors by rotation and, being eligible, offer themselves for re-election as directors at the Company's annual general meeting.

The presence of three independent non-executive directors is considered by the Board to be a reasonable balance between executive and non-executive directors. The Board is of the opinion that such balance can provide adequate checks and balances for safeguarding the interests of shareholders and of the Group. The non-executive directors provide the Group with a wide range of expertise and experience so that independent judgement can effectively be exercised as well as ensuring that the interests of all shareholders are taken into account. They are also responsible for participating in Board meetings, dealing with potential conflicts of interest, serving on the Audit Committee, the Remuneration Committee and the Nomination Committee and scrutinising the Group's performance and reporting. Through their active participation, they provide their valuable skills, expertise and experience to the Board and the committees on which they serve so that the management process can be critically reviewed and controlled.

The Company has received written annual confirmation from each independent non-executive director of his independence pursuant to the requirements of the Listing Rules. The Company considers all its independent non-executive directors to be independent in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules.

The independent non-executive directors bring a wide range of business and financial expertise, experiences and independent judgement to the Board. Through active participation in Board meetings, taking the lead in managing issues involving potential conflicts of interest and serving on Board committees, all independent non-executive directors make various contributions to the effective direction of the Company.

根據本公司之組織章程細則第88條，方志華先生、劉進先生及羅子璘先生將輪值退任董事，且符合資格並願意於本公司之股東週年大會上膺選連任董事。

董事會認為，董事會包括三名獨立非執行董事能為執行董事與非執行董事之間提供合理平衡。董事會認為此平衡能為保障股東及本集團之利益提供充份監察及制衡。非執行董事為本集團帶來廣泛專業知識及豐富經驗，從而能有效作出獨立判斷，並確保所有股東之利益均獲得考慮。彼等亦負責參與董事會會議，處理潛在利益衝突，任職於審核委員會、薪酬委員會及提名委員會，檢視本集團之表現並進行匯報。彼等的積極參與，為董事會及彼等任職之委員會提供寶貴技能、專業知識及經驗，致使管理程序能審慎地得以檢討及監控。

根據上市規則之規定，本公司已接獲各獨立非執行董事就其獨立性作出之年度書面確認。本公司認為，按照上市規則第3.13條所載之獨立性指引，所有獨立非執行董事均為獨立人士。

獨立非執行董事為董事會帶來廣泛業務及財務方面之專業知識、經驗及獨立判斷。透過積極參與董事會會議，在管理涉及潛在利益衝突事項時發揮領導作用及出任董事會轄下委員會成員，全體獨立非執行董事對本公司之有效指引作出多種貢獻。

APPOINTMENT AND SUCCESSION PLANNING OF DIRECTORS

The Company has established formal, considered and transparent procedures for the appointment and succession planning of directors.

The Board as a whole is responsible for reviewing the Board composition, developing and formulating the relevant procedures for nomination and appointment of directors, monitoring the appointment and succession planning of directors and assessing the independence of independent non-executive directors.

The Board reviews its own structure, size and composition regularly to ensure that it has a balance of expertise, skills and experience appropriate to the requirements of the business of the Company.

Where vacancies on the Board exist, the Board will carry out the selection process by making reference to the skills, experience, professional knowledge, personal integrity and time commitments of the proposed candidates, the Company's needs and other relevant statutory requirements and regulations. An external recruitment agency may be engaged to carry out the recruitment and selection process when necessary.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Mr. Wong Danny F. serves as the Chairman.

Under code provision A.2.1 of the CG Code, the roles of Chairman and chief executive should be separate and should not be performed by the same individual. Ms. Tian Jingjing acted as the Chief Executive Officer of the Company ("CEO") as successor to Mr. Chiu Shung Wai, Vincent with effect from 21 April 2015 until her resignation on 31 August 2015. During the interim period from 31 August 2015 to 20 March 2016, Mr. Wu Tse Wai, Frederick, an executive director and former CEO of the Company, assumed duties of CEO while the Company was in the course of identifying suitable candidate for the position. Mr. Wu Tse Wai, Frederick's role as CEO was succeeded by Mr. Feng Wen, who was appointed as CEO of the Company on 21 March 2016.

董事之委任及繼任計劃

本公司已制定正式、經審慎考慮並具透明度之董事委任及繼任計劃程序。

總體而言，董事會負責檢討董事會之成員組合、發展及制定董事提名及委任之相關程序、監控董事委任及繼任計劃以及評估獨立非執行董事之獨立性。

PRACTICES AND CONDUCT OF MEETINGS

Annual meeting schedules and draft agenda of each meeting are normally made available to directors in advance. Notices of regular Board meetings are served to all directors at least 14 days before the meetings, who were all given an opportunity to include matters in the agenda for discussion. For other Board and committee meetings, reasonable notice is generally given.

The Company Secretary assists the Chairman in preparing agenda for the meeting and ensures that all applicable rules and regulations in connection with the meetings are observed and complied with. The finalised agenda and accompanying board papers are then sent to all directors at least three days prior to the meeting.

During the year, the Chairman held a meeting with non-executive directors (including independent non-executive Directors) without the presence of executive directors. The Board and each director also have separate and independent access to the senior management whenever necessary.

The Company Secretary is responsible to take and keep minutes of all Board meetings and committee meetings, including the record of all decisions by the Board together with concerns raised and dissenting views expressed (if any). Draft minutes are normally circulated to directors for comment within a reasonable time after each meeting and the final version is open for directors' inspection.

According to current Board practice, any material transaction, which involves a conflict of interests for a substantial shareholder or a director, will be considered and dealt with by the Board at a duly convened Board meeting. The Articles of Association also contain provisions requiring directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such directors and/or any of their associates have a material interest.

SHAREHOLDERS' MEETINGS

The annual general meeting and other general meetings of the Company are the primary forum for communication by the Company with its shareholders and for shareholders' participation. All shareholders are encouraged to attend the general meetings or to appoint proxies to attend and vote at meetings on their behalf if they are unable to attend the meetings.

During the Review Period, apart from the 2015 AGM, two other general meetings were held by the Company on 17 February 2015 and 8 April 2015 respectively.

會議常規及守則

週年大會之安排及每次會議之草擬議程通常提前提交予董事。定期董事會會議通知均於會議前至少十四天送達全體董事，以便彼等有機會在議程中加入討論事項。至於召開其他董事會會議及委員會會議時，則通常會發出合理通知。

公司秘書協助主席編排會議議程，並確保遵守及依循有關會議之所有適用規則及規例。最終確定之議程及隨附之董事會文件隨後將在會議召開至少三天前送交全體董事。

主席於年內曾於執行董事避席之情況下，與非執行董事（包括獨立非執行董事）舉行一次會議。於必要情況下，董事會及每名董事亦有自行接觸高級管理人員之獨立途徑。

公司秘書負責記錄及保管所有董事會會議及委員會會議之會議紀錄，包括董事會所有決定之紀錄，連同所提出之關注及所表達之反對意見（如有）。會議紀錄初稿通常在各會議後一段合理時間內發送予董事傳閱，供董事表達意見，而最終定稿可供董事查閱。

根據現行之董事會常規，涉及與主要股東或董事有利益衝突之任何重大交易將由董事會於正式召開之董事會會議上考慮及處理。組織章程細則亦載有條文規定，於批准董事及／或其任何聯繫人擁有重大利益之交易之會議上，有關董事須放棄表決，且不得計入該次會議之法定人數內。

股東大會

本公司股東週年大會及其他股東大會乃本公司與其股東溝通及讓股東參與之主要途徑。本公司鼓勵所有股東出席股東大會；若股東未克出席大會，亦可委派代表代其出席並於會上投票。

於回顧期間，除二零一五年股東週年大會外，本公司曾舉行兩次其他股東大會，舉行日期分別為二零一五年二月十七日及二零一五年四月八日。

TRAINING AND SUPPORT FOR DIRECTORS

All directors, including non-executive directors and independent non-executive directors, must keep abreast of their collective responsibilities as directors and of the business of the Group. As such, the Group provides a comprehensive and formal induction to each newly appointed director upon his/her appointment. Briefings and orientations are provided and organised to ensure that the new directors have a proper understanding of and are fully aware of the role of the Board, their legal and other duties as directors as well as the business and governance practices of the Group. Such programmes are tailored for each individual director taking into account his/her background and expertise. The Company Secretary will regularly update all directors on the latest developments regarding the Listing Rules and other applicable regulatory requirements to ensure compliance of the same by all directors.

All directors have participated in continuous professional development programmes provided or procured by the Group, such as external seminars organised by qualified professionals, to develop and refresh their knowledge and skills in relation to the discharge of their duties as directors. Details of the trainings received by the respective director, records of which are kept and updated by the Company Secretary, are as follows:

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules as its own code of conduct regarding securities transactions by directors of the Company. Following specific enquiry by the Company, all directors confirmed that they had complied with the required standards as set out in the Model Code throughout the year under review.

AUDIT COMMITTEE AND ACCOUNTABILITY

The Board is responsible for presenting a balanced, clear and comprehensive assessment of the Group's performance and prospects. The Board is also responsible for preparing the accounts of the Company, which give a true and fair view of the financial position of the Group on a going-concern basis, announcements related to inside information and other financial disclosures. The management of the Group provides all relevant information and records to the Board enabling it to make the above assessment and to prepare the accounts and other financial disclosures.

No member of the Audit Committee is a former partner of the existing auditing firm of the Company within one year from the date of his ceasing to be a partner or to have any financial interest in the auditing firm.

The Audit Committee is satisfied with its review of the independence of auditors, their audit process and also the standard of reports aforesaid. The Audit Committee made recommendations to the Board and that there was no disagreement between the Board and the Audit Committee during the year under review.

The Audit Committee's primary duties include ensuring that the Group's financial statements, annual, interim and quarterly reports and the auditors' report present a true and balanced assessment of the Group's financial position, reviewing the Group's financial control, internal control and risk management systems, and reviewing the Group's financial and accounting policies and practices. Other duties of the Audit Committee are set out in its specific terms of reference which are available on the Company's website.

公司秘書

羅劍輝先生為本公司之公司秘書。彼於年內已接受不少於15個小時之相關專業培訓，以更新其技能及知識。

董事之證券交易

本公司已採納上市規則附錄十所載之上市發行人董事進行證券交易的標準守則（「標準守則」），作為本公司董事進行證券交易之行為守則。於本公司作出具體查詢後，全體董事確認彼等於回顧年度內一直遵守標準守則所載之規定標準。

審核委員會及問責性

董事會負責對本集團表現及前景呈列持平、清晰及全面之評估。董事會亦負責編製以持續經營為基準真實而中肯地反映本集團財務狀況之本公司賬目、有關內幕消息之公告及其他財務披露。本集團管理層向董事會提供所有相關資料及紀錄，致使董事會可作出上述評估，以及編製賬目及其他財務披露。

概無審核委員會成員在其終止出任本公司現時審核公司的合夥人或享有該審核公司之任何財務利益之日期起計一年內，為該審核公司的前任合夥人。

審核委員會對核數師之獨立性及核數程序以及上述報告準則之檢討感到滿意。於回顧年度，審核委員會向董事會提出推薦建議，而董事會與審核委員會之間並無意見分歧。

審核委員會之主要職責包括確保本集團之財務報表、年度、中期及季度報告以及核數師報告真實及持平地評估本集團之財務狀況、檢討本集團之財務監控、內部監控及風險管理系統及檢討本集團之財務及會計政策及常規。審核委員會之其他職責列於其特定職權範圍內，而有關職權範圍可於本公司網站查閱。

The Audit Committee of the Company currently comprises three independent non-executive directors, namely, Mr. Liu Jin, Mr. Char Shik Ngor, Stephen and Mr. Law Tze Lun. Mr. Law Tze Lun serves as the chairman of the Audit Committee.

During the year, two meetings of the Audit Committee were held to review the Company's interim report for the six months ended 30 June 2015 and the annual report for the year ended 31 December 2014. The attendance record of individual members of the Audit Committee are set out in the table under the section headed "Directors' Attendance at Shareholders' Meetings, Board and Committee Meetings".

The Company Secretary keeps full minutes of all Audit Committee meetings. In line with practices consistent with Board meetings and other committee meetings, draft and final versions of Audit Committee meeting minutes are circulated to all members of the Audit Committee for comments, approval and record as soon as practicable after each meeting.

The principal duties of the Audit Committee as per the terms of reference include:

- to monitor integrity of the Company's financial statements and reports;
- to review financial controls, internal controls and risk management system;
- to review the Company's financial and accounting policies and practices;
- to review arrangements by which employees can raise concerns about possible improprieties in financial reporting, internal control or other matters in confidence and to ensure that proper arrangements are in place for the fair and independent investigation of such concerns and appropriate follow-up actions; and
- to act as the key representative body to oversee the Company's relations with the external auditors.

The Audit Committee is provided with sufficient resources to discharge its duties and has access to independent professional advice when necessary. The Company's annual report for the year has been reviewed by the Audit Committee.

審核委員會於年內曾舉行兩次會議，審閱本公司截至二零一五年六月三十日止六個月之中期報告及截至二零一四年十二月三十一日止年度之年報。審核委員會個別成員之出席紀錄載於「股東大會、董事會會議及委員會會議之董事出席率」一節之列表內。

公司秘書保存所有審核委員會會議之完整會議紀錄。為符合董事會會議及其他委員會會議之常規，審核委員會之會議紀錄初稿及最終定稿會於每次會議結束後，在切實可行情況下盡快發送予審核委員會全體成員傳閱，以供評論、批准及記錄之用。

根據職權範圍，審核委員會之主要職責包括：

- 監察本公司財務報表及報告是否符合誠信；
- 檢討財務監控、內部監控及風險管理系統；
- 檢討本公司之財務及會計政策和實務；
- 審閱供僱員可在保密情況下就財務申報、內部監控或其他事宜可能發生之不當行為提出關注之安排，並確保有適當安排，以公平及獨立地調查該等關注事項及採取適當跟進行動；及
- 擔任本公司與外部核數師間之主要代表，監察兩者間之關係。

審核委員會獲提供充足資源履行其職務，亦可在有需要時尋求獨立專業意見。本公司本年度之年報已由審核委員會審閱。

REMUNERATION COMMITTEE

The Remuneration Committee of the Company currently comprises two independent non-executive directors, namely, Mr. Liu Jin and Mr. Law Tze Lun. Ms. Yang XiaoFeng had also been member of the Remuneration Committee during the Review Period until her resignation on 6 July 2015 (for details, please refer to the Company's announcement dated 6 July 2015). Mr. Liu Jin serves as the chairman of the Remuneration Committee.

The specific terms of reference of the Remuneration Committee are available on the Company's website. The Remuneration Committee meets at least once a year. During the year, the Remuneration Committee convened two meetings and all Remuneration Committee members (including Ms. Yang XiaoFeng while still a member) attended the meetings.

The major roles and functions of the Remuneration Committee as set out in the Committee's terms of reference are as follows:

- to make recommendations to the Board on the establishment of a formal and transparent procedure for developing remuneration policy;
- to determine specific remuneration packages of all executive directors and senior management, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment, factors taken into consideration by the Committee include salaries paid by comparable companies, time commitment and responsibilities of directors, employment conditions elsewhere in the Group and desirability of performance-based remuneration;
- to make recommendations to the Board on the remuneration of non-executive directors;
- to review and approve the management's remuneration proposals with reference to the Board's corporate goals and objectives;
- to review and approve compensation payable to executive directors and senior management in connection with any loss or termination of their office or appointment to ensure that such compensation is determined in accordance with contractual terms and that such compensation is otherwise fair and not excessive for the Company;

薪酬委員會

本公司薪酬委員會現時由兩名獨立非執行董事劉進先生及羅子璘先生組成。楊曉峰女士於回顧期間亦曾任薪酬委員會成員，直至二零一五年七月六日辭任為止（詳情請參閱本公司日期為二零一五年七月六日之公告）。劉進先生擔任薪酬委員會主席。

薪酬委員會之特定職權範圍可於本公司網站查閱。薪酬委員會每年最少開會一次。薪酬委員會於年內曾召開兩次會議，而全體薪酬委員會成員（包括時任成員之楊曉峰女士）均有出席該等會議。

薪酬委員會之職權範圍所載之薪酬委員會主要角色和職能如下：

- 就制訂薪酬政策而設立正規及具透明度之程序向董事會提出推薦建議；
- 釐訂全體執行董事及高級管理人員之特定薪酬待遇，包括實物利益、退休金權利及賠償金額（包括就喪失或終止職務或委任而應支付之任何賠償）。委員會所考慮之因素包括同類公司支付之薪金、董事付出之時間承諾及董事職責、本集團內其他職位之僱用條件及是否應按表現釐訂薪酬等；
- 向董事會建議非執行董事之薪酬；

- to review and approve compensation arrangements relating to dismissal or removal of directors for misconduct to ensure that such arrangements are made in accordance with contractual terms and that any compensation payment is otherwise reasonable and appropriate; and
- to advise shareholders on how to vote with respect to any service contracts of directors that require shareholders' approval under the Listing Rules.

The Remuneration Committee shall be provided with sufficient resources to enable it to perform its functions and the Remuneration Committee has right to access professional advice relating to remuneration proposal when it is considered necessary.

The principle elements of the Company's remuneration policy for directors and senior management are:

- to ensure that no director or any of his/her associates is involved in deciding that director's own remuneration;
- to ensure that remuneration packages should be on a par with companies with which the Company competes for human resources;
- to ensure that remuneration packages should reflect the performance and responsibilities of an individual, as well as the complexity of work; and
- to ensure that remuneration packages should be structured in such a way which can provide incentives to directors and senior management to improve their individual performance.

During the year, the Remuneration Committee reviewed performance and remuneration of directors and senior management and made recommendations to the Board on the remunerative packages of individual executive directors and senior management.

NOMINATION COMMITTEE

The Nomination Committee of the Company comprises three independent non-executive directors, namely, Mr. Char Shik Ngor, Stephen, Mr. Liu Jin and Mr. Law Tze Lun. Mr. Char Shik Ngor, Stephen serves as the chairman of the Nomination Committee.

提名委員會

本公司提名委員會由三名獨立非執行董事查錫我先生、劉進先生及羅子璘先生組成。查錫我先生擔任提名委員會主席。

The specific terms of reference of the Nomination Committee are available on the Company's website. The Nomination Committee meets at least once a year. During the Review Period, the Nomination Committee convened two meetings and all Nomination Committee members attended the meetings.

The major roles and functions of the Nomination Committee as per the terms of reference are as follows:

- to formulate nomination policy for the Board's consideration and implement the Board's approved nomination policy;
- to review the structure, size and composition (including the skills, knowledge and experience) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- to identify individuals suitably qualified to become Board members and select or make recommendations to the Board on the selection of individual nominated for directorships;
- to assess the independence of independent non-executive directors;
- to make recommendations to the Board on relevant matters relating to the appointment or re-appointment of directors and the succession planning for the Chairman, the CEO as well as the senior management;
- to do any such things to enable the Committee to discharge its powers and functions conferred on it by the Board;
- to conform to any requirement, direction and regulation that may from time to time be prescribed by the Board or contained in the Company's constitution or imposed by legislation;
- to review the Company's Board diversity policy and the progress on achieving the objectives set for implementing the said policy; and
- to report to the Board on its decisions and recommendations as and when appropriate and at least once annually.

The Nomination Committee is provided with sufficient resources to enable the performance of its functions and is allowed to seek independent professional advice at the Company's expenses where necessary.

根據職權範圍，以下為提名委員會主要角色和職能：

- 評核獨立非執行董事之獨立性；

提名委員會獲提供充足資源以履行其職能，亦可在有需要時尋求獨立專業意見，費用由本公司承擔。

The Nomination Committee performed the following work during the year:

- (i) reviewing the composition of the Board of the Company;
- (ii) assessing the independence of independent non-executive directors; and
- (iii) determining the suitability, duties and responsibilities of Ms. Tian Jingjing as the Chief Executive Officer.

AUDITORS' REMUNERATION

For the Review Period, the total remuneration for the audit services provided by auditors amounted to approximately HK\$350,000 (2014: HK\$350,000). No non-audit services were provided by auditors during the Review Period (2014: HK\$170,000).

The re-appointment of HLB Hodgson Impey Cheng Limited as auditors of the Company has been recommended by the Audit Committee and endorsed by the Board and is subject to approval by the shareholders at the forthcoming annual general meeting.

CORPORATE GOVERNANCE FUNCTION

No corporate governance committee has been established and the Board will therefore be responsible for performing the corporate governance functions such as developing and reviewing the Company's policies and practices on corporate governance, training and continuous professional development of directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, etc.

During the year, the Board has reviewed the Company's policies and practices on corporate governance.

INTERNAL CONTROLS AND RISK MANAGEMENT

The Board has overall responsibilities for the system of internal controls and risk management of the Company and to review its effectiveness. During the year, the Board has reviewed the effectiveness of the Group's internal control system, covering financial, operational and compliance controls and risk management functions.

核數師酬金

於回顧期間，有關核數師提供之審核服務之酬金總額約為350,000港元（二零一四年：350,000港元）。於回顧期間，核數師並無提供非審核服務（二零一四年：170,000港元）。

審核委員會建議再度委任國衛會計師事務所有限公司為本公司之核數師，有關建議已獲董事會同意，惟須待股東於即將舉行之股東週年大會上批准。

企業管治職能

由於本公司並未成立企業管治委員會，故此董事會將負責履行企業管治職能，例如發展及檢討本公司之企業管治政策及常規、董事及高級管理人員之培訓及持續專業發展、本公司在遵守法律及監管規定方面之政策及常規等。

董事會已於年內檢討本公司之企業管治政策及常規。

內部監控及風險管理

董事會對本公司內部監控制度及風險管理負有總體責任，並須檢討其成效。年內，董事會曾檢討本集團內部監控制度之成效，涵蓋財務、營運及合規監控，以及風險管理職能。

In such review, the Board has considered factors such as changes since the last review, scope and quality of the management's monitoring of risks, incidence of significant control failings and identified weaknesses, and effectiveness relating to financial reporting and compliance with the applicable laws and regulations including the Listing Rules.

During the Review Period, the Company was exposed to market risk for its available-for-sale financial assets, including the embedded derivatives, as the Company may not be able to liquidate such investments in time to meet its cash flow requirements. In response to this situation, the Board has maintained a portfolio of listed securities and a relatively strong cash position.

The portfolio of listed securities, classified as financial assets at FVTPL in the statement of financial position, may be exposed to market price risk. The Board will continue to monitor the portfolio with an aim to reduce such risk by diversification.

DIRECTORS' RESPONSIBILITY STATEMENT

The directors acknowledge their responsibilities for preparation of financial statements for each financial period which should give a true and fair view of the state of affairs of the Company and of the results and cash flow for that period. The directors ensure that the financial statements for the year were prepared in accordance with statutory requirements and applicable accounting standards, and will ensure that the publication of which will be in a timely manner.

SHAREHOLDERS RELATIONS

The Company is committed to maintaining a high level of transparency and employs a policy of open and timely disclosure of relevant information to its shareholders. The commitments to fair disclosure and comprehensive and transparent reporting of the Company's activities can be reflected in many aspects.

In endeavouring to maintain an on-going dialogue with shareholders, the annual general meeting provides a useful forum for shareholders to exchange views with the Board.

董事會於檢討時已考慮多項因素，例如自上次檢討以來之轉變、管理層監察風險之工作範疇及質素、重大監控失誤事故及已辨識之弱項，以及有關財務報告及遵守適用法律及法規（包括上市規則）之成效。

於回顧期間，由於本公司未必能及時將可供出售金融資產（包括內含衍生工具）變現，應付其現金流量需求，故本公司須承受該等投資之市場風險。因應此情況，董事會維持由上市證券組成之投資組合及較充裕之現金狀況。

上市證券投資組合（於財務狀況表歸類為於損益表按公允價值列賬之金融資產）可能須承受市場價格風險。董事會將繼續監察該投資組合，並通過分散投資減低有關風險。

董事責任聲明

董事確認彼等負責編製各財政期間之財務報表，以令財務報表真實而公平地反映本公司之事務狀況以及該期間之業績及現金流量。董事確保本年度之財務報表乃按法定規定及適用會計準則編製，並會確保適時刊發該等財務報表。

股東關係

本公司承諾維持高水平之透明度，並設有政策致力向股東公開及適時披露有關資料。對公平披露及全面且透徹報告本公司活動之承諾可在多方面得到反映。

董事會致力維持與股東持續對話溝通。股東週年大會提供一個實用之公開討論機會，以便董事會與股東交流意見。

The proceedings of the annual general meeting are reviewed from time to time to ensure that the Company conforms to the best practices regarding corporate governance. The notice of annual general meeting and the relevant circular, which are circulated to all shareholders at least 21 days prior to the holding of the annual general meeting, set out the details in relation to each resolution proposed, voting procedures (including procedures for demanding and conducting a poll) and other relevant information. At the beginning of the meeting, the chairman of the meeting indicates to the meeting the level of proxies lodged on each resolution and the balance for and against such resolution. At the Company's 2015 AGM, all the resolutions were put to the vote by poll and Tricor Tengis Limited, the Company's Hong Kong branch share registrar, was engaged as scrutineer to ensure the votes were properly counted.

There are no provisions allowing shareholders to propose new resolutions at general meetings under the Cayman Islands Companies Law or the Articles of Association of the Company. Shareholders who wish to propose a resolution may request the Company to convene an extraordinary general meeting.

Pursuant to Article 58 of the Articles of Association of the Company, any one or more shareholder(s) holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary at the Company's principal place of business in Hong Kong, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

股東週年大會之程序會不時檢討，以確保本公司遵從最佳之企業管治常規。股東週年大會之通告及相關通函於舉行股東週年大會前最少二十一天派發予各股東；通函內列明所提呈每項決議案之詳情，投票表決之程序（包括要求及進行以投票方式表決之程序）及其他有關資料。在大會開始時，大會主席向大會表明每項決議案之委任代表投票比例，以及贊成和反對票數。於本公司之二零一五年股東週年大會上，所有決議案均以投票方式表決，而本公司之香港股份登記分處卓佳登捷時有限公司獲聘擔任監票員，以確保妥為點算票數。

開曼群島公司法或本公司組織章程細則並無任何條文允許股東於股東大會上提呈新決議案。有意提呈決議案之股東可要求本公司召開股東特別大會。

根據本公司之組織章程細則第58條，在呈遞要求日期持有不少於本公司繳足股本（附有於本公司股東大會表決權利）十分之一的任何一名或多名股東，於任何時候有權透過向董事會或公司秘書發出書面要求至本公司於香港的主要營業地點，要求董事會召開股東特別大會，以處理有關要求中指明的任何事項；且該大會應於呈遞該要求後兩個月內舉行。倘該呈遞後二十一日內董事會未有召開該大會，則呈遞要求人士可自發以同樣方式召開大會，而呈遞要求人士因董事會未有召開大會而產生的所有合理開支應由本公司向呈遞要求人作出償付。

Where notice of general meeting includes the election of directors of the Company, any shareholder of the Company may propose the election of any person as a director of the Company at the annual general meeting. Pursuant to Article 89 of the Articles of Association of the Company, if a shareholder duly qualified to attend and vote at the general meeting wishes to propose a person other than a retiring director for election as a director at any general meeting (including the annual general meeting), the shareholder should lodge a written notice (the "Nomination Notice") signed by the shareholder at the head office or Registration Office (as defined in the Articles of Association) of the Company not less than seven clear days but not more than 14 clear days before the date of the general meeting. The Nomination Notice must be accompanied by a notice signed by the person to be proposed of his willingness to be elected as a director.

The Company also communicates to its shareholders through its annual and interim reports. The directors, Company Secretary or other appropriate members of senior management also respond promptly to inquiries from shareholders and investors.

Shareholders may at any time send their enquiries to the Board in writing to the Company's branch share registrar in Hong Kong, Tricor Tengis Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong.

INVESTOR RELATIONS

The Company is committed to a policy of open and timely disclosure of corporate information to shareholders and investors. The Company updates shareholders on its latest business developments and financial performance through its annual and interim reports and notices, announcements and circulars. The Company's website (www.nif-hk.com) provides a communication platform to the public and the shareholders.

To strengthen its relationships with investors, the Company regularly meets with analysts and holds interviews with reporters and columnists of the press and other economic journals.

Resolution was passed at the extraordinary general meeting of the Company on 8 April 2015 to approve the amendment to the Company's Articles of Association by removing the borrowing restrictions contained in the then Article 111. For details, please refer to the Company's circular dated 17 March 2015.

Save and except the above, no other significant changes were made to the Company's constitutional documents during the Review Period.

REPORTING SCOPE

The Company is an investment company and principally engages in investments in a diversified portfolio of listed and unlisted companies. As an investment company, the Company does not directly participate in the production and operation of its subsidiaries. While actively seeking to optimise its investment portfolio and maximise shareholder return, the Company lives up to its corporate social responsibility and strikes a balance between the interests of stakeholders such as the shareholders and the community, with the ultimate goal of achieving a sustainable corporation.

In accordance with the requirements of Appendix 27 to the Listing Rules, the Company hereby presents its environmental, social and governance report for the year ended 31 December 2015.

Working Environment

Working conditions

Policies on remuneration and dismissal, recruitment and promotion, working hours, leaves, equal opportunity, diversity and other fringe benefits

The principal place of business of the Group is Hong Kong. The Group has put in place employment policies and guidelines in compliance with the relevant laws and regulations of the local governments, including:

- the formulation of wage allocation system according to laws, and such wages shall not be lower than the minimum wages, if any, for the respective year as promulgated by the government;
- the provision of social security and fringe benefits in accordance with the relevant government requirements, such as providing insurance for employees; and
- the provision of labour protection, labour conditions and protection against occupational hazards in accordance with the relevant government requirements on labour protection.

報告範圍

本公司為一間投資公司，而本公司之主要業務為投資於上市及非上市公司之多元化投資組合。作為投資公司，本公司未直接參與旗下子公司或附屬公司的生產及營運。然而，本公司於積極尋求優化投資組合，提升股東回報的同時，仍然恪守企業社會責任，平衡股東、社區等各持份者的利益，致力取得企業可持續發展。

- we are against any act of discrimination on the basis of gender, age, race, etc.; and
- we make decisions relating to engagement and promotion based on staff/candidate performance.

Remuneration, working hours, leaves and other fringe benefits

- Remuneration and benefit packages are determined with reference to the position, skills, capability and performance of staff;
- Remuneration is adjusted based on local regulations on minimum wages;
- Working hours, leaves and other fringe benefits are in line with industry practice and/or (if applicable) adjusted based on experience, qualifications and seniority of staff; and
- An equitable reward system is in place.

During the year under review, there was no material breach of applicable laws and/or regulations.

Health and Safety

It is the Company's primary concern to provide its employees with safe and convenient working environments.

The Company has developed a set of work safety codes covering areas of environmental hygiene and cleanliness, machine operation, smoking ban and fire prevention, hazardous materials handling, arrangements in times of typhoons and rainstorms, as well as response to emergencies, etc. It also provides training on work safety codes and requires strict compliance therewith by its employees.

Work-related injuries and fatalities

During the year under review, there were no work-related fatalities.

Occupational health and safety measures

The Company provides suitable working environments to ensure adequate protection of the health and safety of its staff.

Development and Training

Policies on employee development and training

The Company places a great deal of importance on the development of the overall ability and professional skills of its staff. It is committed to providing relevant training opportunities to its staff from time to time according to their work requirements, so as to boost the competence and efficiency of staff and hence the Company's professionalism and performance.

Environmental Protection

Emission level

Environmental protection has always been a focus of the Company. In addition to the strict compliance with national regulations, policies and requirements, the Company also checks and supervises the plants of its subsidiaries and associates regularly to ensure that the environmental standards of the plants meet local laws and regulations and that consents and approvals have been obtained from relevant authorities.

Utilisation of resources

As one of its green initiatives, the Company seeks to minimise resource consumption. Average consumption of resources is reduced with advancements in production technology and the implementation of other effective measures and guidelines.

健康與安全

本公司制定了一系列工作安全守則，包括環境衛生整潔、機器操作、禁煙防火、危險品處理、防颱風抗暴雨、以及突發事件處理等，本公司就該等工作安全守則提供培訓，並要求員工嚴格遵守。

本公司為員工提供合適的工作環境，確保員工健康受到充足的保護。

本公司重視員工的綜合素質和專業技能發展，致力於根據員工工作需要，有計劃地為員工提供各種相關培訓機會，旨在提升員工的工作能力及工作效率，增強本公司的業務水平及素質。

環境保護

排放量

本公司一直重視環境保護，積極遵守國家在有關方面的法規政策，符合相關標準。本公司亦定期主動瞭解並監督旗下子公司及聯營公司的廠房，確保廠房的環保標準符合當地有關法律、法規規定，獲得了相關部門的許可及批覆。

資源運用

本公司積極響應環保，儘量減少資源消耗量。透過生產技術提升及各種行之有效的措施指引的配合，平均資源消耗量得到一定程度的降低。

Operational Practice

The Company and its subsidiaries and associates have developed an effective monitoring mechanism to ensure the smooth implementation of, and compliance with, its strategies and policies regarding operation. Various measures such as holding management meetings, conducting site visits, inspecting documents, etc., are adopted to ensure that the following principles are observed.

Supply chain management

Being an investment management company, the Company engages in investments in listed or unlisted equity securities. It does not have any major supplier of products, raw materials or services, nor does it directly participate in any negotiation between any investee and its supplier. However, for the purpose of ensuring a certain degree of management of supply chain risks, the Company maintains close communication with its investees to allow a better understanding of the operation and production of those subsidiaries and associates.

Accordingly, the management believes that the investees have adopted one or more monitoring measures listed below as a part of their supplier management:

- Raw materials are initially procured in small batches and tests are conducted for the raw materials of each product to ensure that the materials meet the local regulations and requirements regarding chemical contents;
- Raw materials are purchased in bulk only after being confirmed to be of no quality issues arising during production;
- As a part of the supplier selection process, samples of raw materials are requested for testing and only those suppliers whose raw materials are certified as suitable for use in production will be qualified;
- Quotations are compared to ensure that they are in line with market rates;
- The procurement process is strictly monitored to ensure against any breach of laws;
- Contracts will be entered into with approved suppliers to ensure that the purchase price and quality of the materials are consistent with those stated in the contracts.

營運慣例

本公司與旗下子公司及聯營公司已建立一套行之有效的監察機制，確保有關營運方面的方向及政策上行下效。本公司透過管理層會議、派員實地考察、文件審查等各項措施，確保旗下項目／公司恪守下述原則。

供應鏈管理

本公司作為一間投資管理公司，業務均為其於上市或非上市股本證券之投資，故沒有任何為本公司提供產品、原材料或服務之主要供貨商。此外，本公司亦沒有直接參與旗下投資組合內之公司與其供應商的協商。然而，本公司密切與投資組合公司溝通，了解該等子公司及聯營公司的營運及生產狀況，確保一定程度之供應鏈風險管理。

因此，管理層相信旗下投資組合公司對供貨商管理採取以下一項或多項監察方法：

- 小規模批量原材料，並測試各項產品的原材料，以確保原材料符合當地就化學成份等各方面的法例標準；
- 使用過程中確保無任何質量，才進行大批量採購；
- 聘用供貨商前，要求供貨商提供原料樣品供本公司測試。測試結果適用於生產的產品方為合格；
- 價格對比，確保符合市場價格；
- 嚴格規管採購過程，確保沒有涉及違反任何法律的行為；
- 經過考核成為的合格供應商後，雙方簽定合同，並確保最終來貨價格、質量等與合同所載相符。

Product liabilities

The management believes that all its investees are responsible product and service suppliers who fulfill all of their service and product commitments and response to their clients' complaints in a diligent manner.

Anti-corruption

Being a responsible corporation, the Company strives to eliminate bribery and corruption across its management and staff. To do so, the Company actively introduces relevant and current anti-corruption laws and punishments to its employees. All employees are fully briefed on the relevant anti-corruption laws and guidelines upon entering into their employment contracts so as to ensure that they comply strictly with them and carry out their duties in good faith. The Company closely monitors the conduct of its staff to prevent wrong-doings amongst the Board, its senior management and its staff, such as prohibiting transfer of benefits while considering any company or project investment.

During the year under review, the Company had not been charged for any corruption within the Board, its senior management and its staff, as well as its investees and their employees, during their employment.

Corporate Governance Responsibilities

To provide reasonable protection for the interests of minority shareholders, the Company strictly complies with the Listing Rules. In addition to maintaining timely disclosures of relevant corporate information as well as transparency and accountability in its operation, the Company also conducts internal reviews from time to time in order to improve its corporate governance. For information on the Company's corporate governance, please refer to the section headed "Corporate Governance Report".

The Board advocates a high level of independence so as to make independent judgements. Therefore, the Company has appointed three independent non-executive directors. The directors believe that all three of the independent non-executive directors have diversified backgrounds and experience as well as sufficient calibre and independence to make independent judgements, provide impartial and professional advice, evaluate the decisions of the Board, and safeguard the interests of the minority shareholders.

產品責任

管理層相信旗下投資組合公司均為負責任的產品及服務供貨商，並嚴謹履行所有服務及產品承諾，以及客戶投訴。

防止貪污

作為負責任的企業，本公司確保管理層及員工廉潔反貪。有鑒於此，本公司積極讓員工知悉現行相關的反貪污法例及刑罰。每一名員工簽訂僱用合約時，均提供清晰指引，確保員工遵守相關反貪污法例及指引，誠信履行職務。本公司嚴格監察員工操守，嚴禁董事會、高級管理層及員工徇私舞弊（包括於衡量是否投資於個別公司或項目時，禁止一切利益輸送行為）。

於回顧年內，本公司概無因本公司董事會、高級管理層及員工，以及旗下公司或其僱員（於受僱期間）貪污而被起訴。

企業管治責任

為確保小股東權益得到合理保障，本公司嚴格遵守上市規則。除適時披露企業相關訊息，確保本公司營運之透明度及問責性外，本公司亦不時進行內部檢討，以進一步提升企業管治水平。有關本公司企業管治，請參閱「企業管治報告」章節。

董事會認為，董事會應具備強烈獨立性，有效行使獨立判斷。因此，本公司已委任3名獨立非執行董事。董事相信，全部3名獨立非執行董事擁有不同背景及經驗，具備足夠才幹以及獨立性，能行使獨立判斷，提供中肯專業意見，以不同角度評估董事會決策，保障少數股東權益。

Community Involvement

The Company always endeavours to serve the community and therefore highly respects its corporate social responsibilities. In July 2015, the Company donated HK\$200,000 to Hong Kong International School for general teaching purposes and the improvement of school facilities, thereby benefiting its students. The Company has high regard for the value of education and is therefore delighted to see that a better campus and excellent teaching is offered to the students. We wish our humble effort today will reap a bumper harvest of great men for the future society.

For the sake of social betterment, the Company will also identify charitable, non-profit or educational institutions and foundations that share its beliefs, and encourage its staff to volunteer for them.

Subsidiaries and Other Investees

The Company has formulated stringent basic internal corporate governance principles and requirements for its projects/subsidiaries. It ensures the observance of these principles and requirements by these projects/subsidiaries through various measures such as holding management meetings, conducting site visits, inspecting documents, etc. It also offers necessary support and training in the implementation of these policies to its subsidiaries and investees from time to time.

For each line of business operation, the Company has adopted different measures to ensure its respective compliance with the above principles and guidelines. In respect of the agriculture and forestry development business, it has adopted a set of principles and guidelines for ecosystem protection and ensures that the workers are adequately protected and remunerated, such as having insurance for work injuries and accidents. In terms of the biological pharmaceutical and regenerative medicine system and product business, measures have been taken to ensure safety in its production and research and development processes. For instance, the research and development and other staff are protected from fatalities as well as inhaling or being exposed to chemical/hazardous elements, the products are certified as meeting national safety standards, and the research and development procedures comply with ethical standards and guidelines. For the development and building of yachts, environmental matters of the building process are taken seriously and green measures such as the reduction of waste and emissions as well as the recycling of materials has already been implemented.

社區參與

就本公司涉及的不同業務，本公司積極採取多方面的措施確保營運過程符合上述原則及指引。開發及種植農林方面，本公司採納對生態環境保護的原則及指引，並確保種植人員得到足夠保護及合理福利，如工傷意外保險保障等。生物製藥及再生醫學系統及產品方面，本公司採取措施以確保生產及科研過程安全，如保障科研人員及其他僱員的生命安全、減少他們吸入或攝取化學／有害物質等，並確保產品符合國家安全標準、以及科研過程符合道德標準的措施及指引。開發及製造游艇方面，積極考慮製造過程中的環保問題，實行減廢減排、物料循環再用等環保措施。

The principal terms of the Share Option Scheme are as follows:

- (i) The total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any options to be granted under any other scheme must not in aggregate exceed 10% of the aggregate of the shares in issue as at the adoption date unless refreshed by the shareholders. However, the total number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and all outstanding options granted and yet to be exercised under any other scheme should not exceed 30% of the shares in issue from time to time.
 - (ii) The total number of shares in respect of which options may be granted to each eligible participant in any 12-month period must not exceed 1% of the issued share capital of the Company for the time being.
 - (iii) The subscription price shall be a price determined by the Board, but shall not be less than the highest of (i) the closing price of the shares as stated in the Stock Exchange's daily quotations on the date of grant, which must be a business day; (ii) the average closing price of the shares as stated in the Stock Exchange's daily quotations for the five business days immediately preceding the date of grant; and (iii) the nominal value of the share.
 - (iv) An option may be accepted by an eligible participant within 28 days from the date of offer of the option. Upon acceptance of the option, the grantee shall pay HK\$1.00 to the Company by way of consideration for the grant of the option.
 - (v) The Share Option Scheme will remain valid for a period of ten years commencing on 27 August 2007.

CONNECTED TRANSACTIONS

Subscription Agreement

On 14 October 2010, the Company and Premium Castle Limited ("Premium Castle"), a company incorporated under the laws of British Virgin Islands, entered into a subscription agreement, pursuant to which Premium Castle agreed to issue and the Company agreed to subscribe the 2% convertible note in the principal amount of HK\$27,000,000 due on 13 October 2013 (the "2010 Convertible Note"). In 2011, Premium Castle repaid HK\$10,000,000 of the outstanding principal amount of the 2010 Convertible Note to the Company. Subsequently, the 2010 Convertible Note was cancelled and Premium Castle issued to the Company another convertible note in replacement of the 2010 Convertible Note (the "2011 Convertible Note"). The Company has not exercised the conversion rights under the 2011 Convertible Note and the principal amount of HK\$17,000,000 was due on 13 October 2013.

關連交易

認購協議

於二零一零年十月十四日，本公司與Premium Castle Limited（「Premium Castle」，一間根據英屬處女群島法律註冊成立之公司）訂立認購協議，據此，Premium Castle同意發行而本公司同意認購本金金額為27,000,000港元並於二零一三年十月十三日到期之2厘可換股票據（「二零一零年可換股票據」）。於二零一一年，Premium Castle向本公司償還二零一零年可換股票據之未償還本金金額10,000,000港元。其後，二零一零年可換股票據已被註銷，而Premium Castle已向本公司發行另一批可換股票據（「二零一一年可換股票據」），以取代二零一零年可換股票據。本公司並無行使二零一一年可換股票據項下之轉換權，而本金金額17,000,000港元已於二零一三年十月十三日到期。

Upon expiry of the 2011 Convertible Note and after negotiation between Premium Castle and the Company, the Company and Premium Castle entered into a new subscription agreement (the "New Subscription Agreement") on 24 December 2013 (after trading hours), pursuant to which the Company has conditionally agreed to subscribe for and Premium Castle has conditionally agreed to issue a convertible note in the principal amount of HK\$18,600,000, being the outstanding principal amount of HK\$17,000,000 under the 2011 Convertible Note and the outstanding interest in the sum of approximately HK\$1,600,000 accrued under the 2010 Convertible Note and the 2011 Convertible Note (collectively "Debt"), with maturity period of five years and coupon rate of 2% (the "Subscription"). The New Subscription Agreement constitutes a discloseable transaction for the Company under Chapter 14 of the Listing Rules as the applicable percentage ratios as defined under Rule 14.06 of the Listing Rules are more than 5% but less than 25%. The New Subscription Agreement also constitutes a connected transaction under Chapter 14A of the Listing Rules as the major shareholder of Premium Castle is Mr. Wong Danny F., the Chairman and an executive director of the Company, Premium Castle is therefore a connected person of the Company. Accordingly, the New Subscription Agreement is subject to the reporting, announcement and independent Shareholders' approval requirements under the Listing Rules. Mr. Wong Danny F., who is the Chairman and an executive director of the Company and a major shareholder of Premium Castle, is regarded as having a material interest in the New Subscription Agreement and therefore he abstained from voting at the meeting of the Board at which the resolution approving the New Subscription Agreement was passed and Mr. Wong Danny F. and his associates were required to abstain from voting on the resolution approving the New Subscription Agreement passed at the extraordinary general meeting of the Company held on 25 February 2014. Details of the Subscription were disclosed in the circular of the Company dated 7 February 2014. The New Subscription Agreement has been approved at the extraordinary general meeting and was completed on the same day.

Upon completion of the Subscriptions on 25 February 2014, the obligation of Premium Castle to pay the Debt has been released and the Debt, which was previously recorded as current assets of the Company, was reclassified as financial asset in the Company's consolidated statement of financial position.

於二零一一年可換股票據到期時，經Premium Castle與本公司磋商後，本公司與Premium Castle於二零一三年十二月二十四日（交易時段後）訂立新認購協議（「新認購協議」）。據此，本公司有條件地同意認購而Premium Castle有條件地同意發行本金金額為18,600,000港元（即二零一一年可換股票據項下之未償還本金金額17,000,000港元及二零一零年可換股票據及二零一一年可換股票據項下之應計未償還利息合共約1,600,000港元（合稱「債務」））之可換股票據，有效期五年，票面息為2厘（「認購事項」）。由於上市規則第14.06條所界定之適用百分比率高於5%但低於25%，故根據上市規則第十四章，新認購協議構成本公司之須予披露交易。由於Premium Castle之主要股東為本公司主席兼執行董事汪曉峰先生，故Premium Castle為本公司之關連人士，而根據上市規則第十四A章，新認購協議亦構成關連交易。因此，新認購協議須遵守上市規則項下之申報、公告及獨立股東批准之規定。本公司之主席兼執行董事及Premium Castle之主要股東汪曉峰先生被視為於新認購協議中擁有重大利益，因此彼已於通過有關批准新認購協議之決議案之董事會會議上放棄表決，而汪曉峰先生及其聯繫人須於本公司於二零一四年二月二十五日舉行之股東特別大會上就批准新認購協議放棄表決。有關認購事項之詳情已於本公司日期為二零一四年二月七日之通函內披露。新認購協議已於股東特別大會上獲批准，並於同日完成。

於二零一四年二月二十五日認購事項完成時，Premium Castle支付債務之義務已解除，而之前入賬列作本公司流動資產之債務已於本公司之綜合財務狀況表內重新分類為金融資產。

Placing Agreement

The Company entered into a placing agreement with Beijing Securities Limited (the "Placing Agent") on 4 December 2015, pursuant to which the Company had agreed to place 52,085,920 new ordinary shares on a fully underwritten basis to not less than six independent investors at the placing price of HK\$0.409 per placing share. The placing shares were fully taken up and no placing share has been allotted to the Placing Agent. Mr. Wong Danny F., the Chairman and an executive director of the Company, holds 75.28% of the shareholdings of the holding company of the Placing Agent. Mr. Wong Danny F. is also a director of the Placing Agent and the holding company of the Placing Agent. Hence, the Placing Agent is an associate of Mr. Wong Danny F. and is therefore a connected person of the Company within the meaning of the Listing Rules. The acting as the Placing Agent is a connected transaction under Chapter 14A of the Listing Rules.

The Board is of the view that that the placing commission of 4% on the gross proceeds of the placing was determined within arm's length negotiation between the parties with regard to the prevailing market practice and the placing commission is on normal commercial terms, fair and reasonable. As the relevant percentage ratios (other than the profits ratio) in respect of the placing commission and the brokerage fees under Rule 14.07 of the Listing Rules is less than 5% and the total consideration is less than HK\$3,000,000, the transaction constitutes a connected transaction which is fully exempt from independent shareholders' approval, annual review and all disclosure requirements under Rule 14A.76(1) of the Listing Rules.

配售協議

於二零一五年十二月四日，本公司與北京證券有限公司（「配售代理」）訂立配售協議，據此，本公司同意按全數包銷基準按配售價每股配售股份0.409港元向不少於六名獨立投資者配售52,085,920股新普通股。配售股份獲全數承購，配售代理並不獲配發任何配售股份。本公司主席兼執行董事汪曉峰先生持有配售代理控股公司之75.28%股權。汪曉峰先生亦為配售代理及其控股公司之董事。因此，配售代理為汪曉峰先生之聯繫人，故屬於本公司之關連人士（定義見上市規則）。根據上市規則第十四A章，擔任配售代理構成關連交易。

董事會認為，相等於配售事項所得款項總額4%之配售佣金乃訂約各方經考慮當時市場慣例後按公平原則磋商釐定，且配售佣金乃符合正常商業條款，屬公平合理。由於根據上市規則第14.07條，配售佣金及經紀費涉及之相關百分比率（盈利比率除外）低於5%，而總代價少於3,000,000港元，故根據上市規則第14A.76(1)條，有關交易構成關連交易，獲全面豁免遵守獨立股東批准、年度審核及所有披露規定。

CONTINUING CONNECTED TRANSACTIONS

Investment Advising Service Agreement

On 16 May 2011, the Company and Beijing Capital Partners Limited ("Beijing Capital") had mutually agreed to terminate the investment management agreement dated 16 November 2010 entered into between the parties and there was no penalty and/or compensation to any party in relation to the early termination of the agreement. At the meantime, the Company and Beijing Capital entered into an Investment Advising Service Agreement (the "IAS Agreement") whereby Beijing Capital was appointed to act as investment adviser of the Company and agreed to provide investment advising services and present suitable investment opportunities to the Company commencing from 16 May 2011. Pursuant to Rule 21.13 of the Listing Rules, an investment adviser shall be regarded as a connected person of the Company. Therefore, the entering into of the IAS Agreement with Beijing Capital constitutes a continuing connected transactions of the Company under Chapter 14A of the Listing Rules. According to the terms and condition of the IAS Agreement, the Company shall pay to Beijing Capital a monthly investment adviser fee of HK\$33,333. Therefore, it is exempted from the reporting, announcement and independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

Investment Management Agreement

The investment management agreement dated 9 May 2014 entered into between the Company and Enerchine Investment Management Limited ("Enerchine Investment") expired on 15 May 2015. Accordingly, the Company entered into a new investment management agreement (the "New Investment Management Agreement") with Enerchine Investment on 11 May 2015 to renew the appointment of Enerchine Investment as the investment manager of the Company on the same terms with a fixed management fee of HK\$100,000 per month. Under the New Investment Management Agreement, the investment manager agreed to provide investment management services to the Company for a period of one year from 16 May 2015. Pursuant to Rule 14A.08 of the Listing Rules, an investment manager is deemed to be a connected person of the Company. By entering into of the New Investment Management Agreement with Enerchine Investment, it constitutes continuing connected transactions for the Company under Chapter 14A of the Listing Rules and is exempted from the reporting, announcement and independent shareholders' approval requirements under the Listing Rules.

持續關連交易

投資顧問服務協議

於二零一一年五月十六日，本公司與北京資本有限公司（「北京資本」）互相同意終止雙方所訂立日期為二零一零年十一月十六日之投資管理協議，訂約方概無須就提早終止該協議而支付任何罰款及／或賠償。同時，本公司與北京資本訂立投資顧問服務協議（「投資顧問服務協議」），據此，北京資本自二零一一年五月十六日起獲委任為本公司之投資顧問，並同意向本公司提供投資顧問服務及提呈適合投資機會。根據上市規則第21.13條，投資顧問將被視為本公司之關連人士。因此，根據上市規則第十四A章，與北京資本訂立投資顧問服務協議構成本公司之持續關連交易。根據投資顧問服務協議之條款及條件，本公司須按月支付33,333港元投資顧問費予北京資本，因此獲豁免遵守上市規則第十四A章有關申報、公告及獨立股東批准之規定。

投資管理協議

本公司與威華投資管理有限公司（「威華投資」）所訂立日期為二零一四年五月九日之投資管理協議於二零一五年五月十五日屆滿。因此，本公司於二零一五年五月十一日以相同條款按每月100,000港元之固定管理費用與威華投資訂立新投資管理協議（「新投資管理協議」），重新委任威華投資為本公司之投資經理。根據新投資管理協議，投資經理同意自二零一五年五月十六日起一年期間向本公司提供投資管理服務。根據上市規則第14A.08條，投資經理被視為本公司之關連人士。根據上市規則第十四A章，與威華投資訂立新投資管理協議構成本公司之持續關連交易，並獲豁免遵守上市規則有關申報、公告及獨立股東批准之規定。

Custodian Agreement

Commencing from 11 March 2005, the Company appointed the Bank of Communications Trustee Limited as its custodian for the provision of custody services. The Bank of Communications Trustee Limited has agreed to provide the Company with securities services including the safe custody and physical settlement of the securities in the investment portfolio of the Company, and the collection of dividends and other entitlements in respect of such securities. The custodian agreement between the parties (the "Custodian Agreement") will continue be in force until being terminated by either the Company or the custodian by the giving to the other party of not less than 90 days' notice in writing at any time.

Pursuant to Rule 14A.08 of the Listing Rules, a custodian shall be regarded as a connected person of the Company. Therefore, the provision of services by the Bank of Communications Trustee Limited under the Custodian Agreement constitutes continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

The Board, including the independent non-executive directors, is of the view that the above continuing connected transactions have been entered into (1) on normal commercial terms; (2) on an arm's length basis; and (3) in the ordinary and usual course of business of the Company, and that the terms of the above continuing connected transactions were fair and reasonable to the shareholders and the Company as a whole.

PUBLIC FLOAT

Based on the information that is publicly available to the Company and within the knowledge of the directors at the date of this annual report, there is a sufficient prescribed public float of the issued shares of the Company under the Listing Rules.

AUDIT COMMITTEE

The Audit Committee of the Company currently comprises of three independent non-executive directors, Mr. Liu Jin, Mr. Char Shik Ngor, Stephen and Mr. Law Tze Lun. Mr. Law Tze Lun serves as the chairman of the Audit Committee.

The Audit Committee together with the management, have reviewed the accounting principles and practices adopted by the Company and discussed auditing, internal control and financial reporting matters including a review of the audited consolidated financial statements for the year.

託管協議

EVENTS AFTER THE END OF THE REPORTING PERIOD

On 27 January 2016, the Company completed the placing of 200,000,000 new ordinary shares of HK\$0.01 each through a placing agent to not less than six independent investors at a price of HK\$0.32 per placing share. The net proceeds of the placing is in the amount of approximately HK\$61 million, which represents a net price of HK\$0.305 per placing share. HK\$60 million out of the net proceeds was used for repayment of the existing loans of the Group, while the balance of approximately HK\$1 million was used for general working capital. Details of the placing were disclosed in the announcements of the Company dated 15 January 2016 and 27 January 2016.

AUDITORS

The consolidated financial statements for the years ended 31 December 2014 and 2015 were audited by HLB Hodgson Impey Cheng Limited who will retire at the conclusion of the forthcoming annual general meeting and being eligible, offer themselves for re-appointment. A resolution for the re-appointment of HLB Hodgson Impey Cheng Limited as auditors of the Company is to be proposed at the forthcoming annual general meeting.

Notes to Consolidated Financial Statements

1. CORPORATE INFORMATION

The Company was incorporated on 28 June 2002 as an exempted company with limited liability in the Cayman Islands under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. Its substantial shareholder is CCM Financial Corporation, a company incorporated in the British Virgin Islands.

The principal activity of the Group is investment in listed and unlisted companies. Particulars of the subsidiaries are set out in Note 37 to the consolidated financial statements.

The address of the registered office of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business of the Company is located at 20/F., Octa Tower, 8 Lam Chak Street, Kowloon Bay, Hong Kong.

The shares of the Company were listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") with effect from 27 September 2002.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs"), which is a collective term that includes all applicable HKFRSs, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"), and accounting principles generally accepted in Hong Kong. In addition, the consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") and the Hong Kong Companies Ordinance.

These consolidated financial statements are presented in Hong Kong dollars, which is also the functional currency of the Company. All values are rounded to the nearest thousand (HK\$'000) except otherwise indicated.

1. 公司資料

本公司於二零零二年六月二十八日根據開曼群島法例第二十二章公司法（一九六一年第三冊，經綜合及修訂）在開曼群島註冊成立為獲豁免有限公司。其主要股東為CCM Financial Corporation（於英屬處女群島註冊成立之公司）。

本集團之主要業務為投資於上市及非上市公司。附屬公司之詳情載於綜合財務報表附註37。

本公司之註冊辦事處地址為Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands。本公司之主要營業地點位於香港九龍灣臨澤街8號傲騰廣場20樓。

本公司之股份由二零零二年九月二十七日起在香港聯合交易所有限公司（「聯交所」）上市。

2. 主要會計政策概要

(a) 合規聲明

綜合財務報表乃根據香港財務報告準則（為一個統稱，包括由香港會計師公會頒佈之所有適用香港財務報告準則、香港會計準則及詮釋）以及香港公認會計原則編製。此外，綜合財務報表亦符合聯交所證券上市規則（「上市規則」）及香港公司條例之適用披露規定。

本綜合財務報表以港元（亦為本公司之功能貨幣）呈列。除另有指明者外，所有數值乃四捨五入至最接近千位數（千港元）。

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(a) Statement of compliance (Continued)

The preparation of consolidated financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in areas where assumptions and estimates are significant to the consolidated financial statements, are discussed in Note 4.

(b) Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

The provisions of the new Hong Kong Companies Ordinance (Cap. 622) (the “new CO”) regarding preparation of accounts and directors’ reports and audits became effective for the Company for the financial year ended 31 December 2015. Further, the disclosure requirements set out in the Listing Rules regarding annual accounts have been amended with reference to the new CO and to streamline with HKFRSs. Accordingly the presentation and disclosure of information in the consolidated financial statements for the financial year ended 31 December 2015 have been changed to comply with these new requirements. Comparative information in respect of the financial year ended 31 December 2014 are presented or disclosed in the consolidated financial statements based on the new requirements. Information previously required to be disclosed under the predecessor CO or Listing Rules but not under the new CO or amended Listing Rules are not disclosed in these consolidated financial statements.

2. 主要會計政策概要 (續)

(a) 合規聲明 (續)

在編製符合香港財務報告準則之綜合財務報表時，需運用若干關鍵會計估計。管理層亦須在涉及對綜合財務報表而言屬重大之假設及估計之範疇作出判斷，有關論述見附註4。

(b) 編製基準

綜合財務報表以歷史成本法編製，惟如下文會計政策所闡述，若干金融工具於各呈報期末按公允價值計量除外。

歷史成本一般按就交換貨品及服務給予之代價之公允價值計量。

新香港公司條例（第622章）（「新公司條例」）關於編製賬目及董事報告以及審計之條文對本公司截至二零一五年十二月三十一日止財政年度生效。再者，上市規則中關於年度賬目之披露規定已參照新公司條例作出修訂，以與香港財務報告準則保持一致。因此，截至二零一五年十二月三十一日止財政年度之綜合財務報表之資料呈列方式及披露已更改，以符合該等新規定。截至二零一四年十二月三十一日止財政年度之比較資料已依照新規定於綜合財務報表內呈列或披露。以往根據前身公司條例或上市規則須披露，而根據新公司條例或經修訂上市規則無須披露之資料並無於本綜合財務報表中披露。

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(b) Basis of preparation (Continued)

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2, leasing transactions that are within the scope of HKAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 or value in use in HKAS 36.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

2. 主要會計政策概要 (續)

(b) 編製基準 (續)

公允價值為於計量日期按市場參與者之間之有序交易出售一項資產而將收取或轉讓一項負債而將支付之價格，而不論該價格是否可以直接觀察或運用另一種估值技巧估算。倘市場參與者於計量日期對資產或負債定價時會考慮資產或負債之特點，則本集團於估計資產或負債之公允價值時會考慮該等特點。該等綜合財務報表中作計量及／或披露用途之公允價值乃按此基準釐定，惟不包括屬香港財務報告準則第2號範圍內之以股份為基礎之付款交易、屬香港會計準則第17號範圍之租賃交易及與公允價值部份類似但並不屬公允價值之計量（如香港會計準則第2號之可變現淨值或香港會計準則第36號之使用價值）。

此外，就財務報告而言，按公允價值計量之輸入數據之可觀察程度及公允價值計量之輸入數據對其整體之重要性，公允價值計量可分類為第1級、第2級或第3級，詳情如下：

- 第1級輸入數據乃自實體於計量日期可獲得有關相同資產或負債於活躍市場中所報之未經調整價格；
- 第2級輸入數據乃除第1級計入之報價外，就資產或負債可直接或間接可觀察之輸入數據；及
- 第3級輸入數據乃資產或負債之不可觀察輸入數據。

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(c) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company (its subsidiaries). Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

(c) 綜合賬目基準

綜合財務報表包含本公司及由本公司控制之實體(其附屬公司)之財務報表。當出現下列情況時,即擁有控制權:

- 本公司對被投資公司擁有權力;
- 本公司因參與被投資公司之營運而可獲得或有權獲得可變回報;及
- 本公司有能力運用權力影響回報。

倘有事實及情況顯示上述三項控制權元素中有一項或以上出現變動,則本集團會重新評估其是否對被投資公司擁有控制權。

當本集團於被投資公司之投票權未能佔大多數,但只要投票權足以賦予本集團實際能力可單方面掌控被投資公司之相關活動時,本集團即對被投資公司擁有權力。在評估本集團於被投資公司之投票權是否足以賦予其權力時,本集團會考慮所有相關事實及情況,包括:

- 本集團所持投票權之規模相較其他投票權持有人所持投票權之規模及分散程度;
- 本集團、其他投票權持有人或其他人士持有之潛在投票權;
- 其他合約安排所產生之權利;及
- 可顯示於需要作出決定時,本集團當前能否掌控相關活動之任何其他事實及情況(包括於過往股東大會上之投票模式)。

(c) Basis of consolidation (Continued)

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

(c) 綜合賬目基準 (續)

本集團於取得附屬公司之控制權時開始將綜合附屬公司綜合入賬，並於本集團失去附屬公司之控制權時終止將綜合附屬公司綜合入賬。具體而言，於年內收購或出售附屬公司之收入及開支，會由本集團取得控制權當日起直至本集團失去附屬公司之控制權當日止計入綜合損益及其他全面收益表。

溢利或虧損及其他全面收益之各個部份乃歸屬於本公司擁有人及非控股權益。附屬公司之全面收益總額乃歸屬於本公司擁有人及非控股權益，即使此舉會導致非控股權益出現虧絀結餘亦如是。

如有需要，本集團會調整附屬公司之財務報表，以令其會計政策與本集團之會計政策一致。

所有集團內資產及負債、權益、收入、開支及與本集團成員公司間交易有關之現金流量會於綜合賬目時悉數撇銷。

本集團於現有附屬公司之擁有權權益變動

不會導致本集團失去對附屬公司控制權之本集團附屬公司擁有權權益變動，會入賬列作股權交易。本集團會調整其權益及非控股權益之賬面金額，以反映該等項目於附屬公司之相關權益。非控股權益之調整金額與已付或已收代價公允價值之間如有任何差異，則會直接於權益內確認並撥歸本公司擁有人。

Changes in the Group's ownership interests in existing subsidiaries (Continued)

When the Group loses control of a subsidiary, a gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKAS 39 or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

(d) Business combination

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

本集團於現有附屬公司之擁有權權益變動 (續)

當本集團失去對附屬公司之控制權，會按(i)已收代價之公允價值及任何保留權益之公允價值之總額；與(ii)該附屬公司資產（包括任何商譽）及負債之先前賬面金額及任何非控股權益之差額計算收益或虧損並於損益表確認。所有先前於其他全面收益確認有關該附屬公司之金額會按與本集團直接出售該附屬公司相關資產或負債之情況相同之方式入賬（即重新分類至損益表或轉撥至適用香港財務報告準則所列明／允許之另一權益類別）。於失去控制權當日所保留前附屬公司之任何投資之公允價值會於根據香港會計準則第39號進行其後會計處理時列作初步確認時之公允價值，或（如適用）列作初步確認於聯營公司或合營企業之投資之成本。

(d) 業務合併

業務收購採用收購法入賬。於業務合併中轉讓之代價按公允價值計量，而公允價值乃按本集團所轉讓資產於收購日之公允價值、本集團結欠被收購公司前擁有人之負債，以及本集團為換取被收購公司控制權而發行之股權之總和計算。收購相關成本一般於產生時在損益表確認。

(d) Business combination (Continued)

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 *Income Taxes* and HKAS 19 *Employee Benefits* respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 *Share-based Payment* at the acquisition date; and
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 *Non-current Assets Held for Sale and Discontinued Operations* are measured in accordance with that standard.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

於收購日，所收購之可識別資產及所承擔之負債按公允價值確認，惟：

- 遞延稅項資產或負債及有關僱員福利安排之資產或負債分別根據香港會計準則第12號「所得稅」及香港會計準則第19號「僱員福利」確認及計量；
- 與被收購公司以股份為基礎之付款安排或本集團為取代被收購公司以股份為基礎之付款安排而訂立之本集團以股份為基礎付款安排有關之負債或股本工具於收購日根據香港財務報告準則第2號「以股份為基礎之付款」計量；及
- 根據香港財務報告準則第5號「持作出售之非流動資產及已終止經營業務」分類為持作出售之資產（或出售組別）按該準則計量。

商譽按已轉讓代價、被收購公司之任何非控股權益金額與收購方先前所持被收購公司之股權（如有）公允價值之總和超出所收購可識別資產及所承擔負債於收購日之金額之差額計量。倘經重估後，所收購可識別資產及所承擔可識別負債於收購日之金額超出已轉讓代價、被收購公司之任何非控股權益金額與收購方先前所持被收購公司之權益（如有）公允價值之總和，則該高出數額即時於損益表確認為廉價收購收益。

(d) Business combination (Continued)

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation may be initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets. The choice of measurement basis is made on a transaction by-transaction basis. Other types of non-controlling interests are measured at fair value or, when applicable, on the basis specified in another HKFRS.

When the consideration transferred by the Group in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments against goodwill. Measurement period adjustments are adjustments that arise from additional information obtained during the measurement period about facts and circumstances that existed at the acquisition date. Measurement period cannot exceed one year from the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured at subsequent reporting dates in accordance with HKAS 39, or HKAS 37 *Provisions, Contingent Liabilities and Contingent Assets*, as appropriate, with the corresponding gain or loss being recognised in profit or loss.

(d) 業務合併 (續)

非控股權益(屬現時擁有權權益,並賦予持有人權利按比例在清盤時分佔實體淨資產)可初步按公允價值或按非控股權益分佔被收購公司可識別淨資產之比例計量。計量基準乃逐項交易選擇。其他類別之非控股權益按公允價值或(如適用)另一項香港財務報告準則指定之基準計量。

當本集團於業務合併中轉讓之代價包括或然代價安排所產生之資產或負債時,或然代價會按收購日之公允價值計量,並計入於業務合併中轉讓之代價之一部份。本集團會追溯調整合資格作為計量期調整之或然代價公允價值變動,並相應調整商譽。計量期調整為於「計量期」內就於收購日存在之事實及情況獲得之其他資料所產生之調整。計量期不得超過由收購日起計一年時間。

不合資格作為計量期調整之或然代價公允價值變動之其後會計處理,會取決於或然代價如何分類。分類為權益之或然代價不會於其後呈報日期重新計量,而其隨後結算則會於權益內入賬。分類為資產或負債之或然代價於其後呈報日期根據香港會計準則第39號或香港會計準則第37號「撥備、或然負債及或然資產」(如適用)重新計量,而相應之收益或虧損於損益表確認。

(d) Business combination (Continued)

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to its acquisition-date fair value and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss where such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period, or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

(e) Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units ("CGUs") (or groups of CGUs) that is expected to benefit from the synergies of the combination.

(d) 業務合併 (續)

當業務合併分階段完成，本集團先前於被收購公司持有之股權會重新計量至其收購日期之公允價值，而所產生之收益或虧損（如有）會於損益表確認。先前於其他全面收益確認之被收購公司於收購日前之權益所產生之金額乃於有關處理方法適用於所出售權益時重新分類至損益表。

倘業務合併之初步會計處理未能於合併發生之呈報期結束前完成，則本集團會呈報未完成會計處理之項目之暫定金額。該等暫定金額於計量期內調整，或確認額外資產或負債，以反映收購日已存在之事實及情況之新資料（如獲悉）可能對該日所確認之金額構成之影響。

(e) 商譽

收購業務所產生之商譽按成本（於收購業務當日制定）減累計減值虧損（如有）列賬。

就減值測試而言，商譽會分配至預期受惠於合併協同效應之本集團各個現金產生單位（或現金產生單位組別）。

(e) Goodwill (Continued)

A CGU to which goodwill has been allocated is tested for impairment annually, or more frequently when there is an indication that the unit may be impaired. If the recoverable amount of the CGU is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit pro rata based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant CGU, the attributable amount of goodwill is included in the determination of the profit or loss on disposal.

(f) Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting, except when the investment, or a portion thereof, is classified as held for sale, in which case it is accounted for in accordance with HKFRS 5. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

(e) 商譽 (續)

獲分配商譽之現金產生單位每年進行減值測試，或於單位有可能出現減值之跡象時更頻密地進行減值測試。倘現金產生單位之可收回金額少於其賬面金額，則會首先分配減值虧損以削減獲分配至該單位之商譽之賬面金額，其後以該單位內各資產之賬面金額為基準，按比例分配到該單位內其他資產。任何商譽減值虧損會直接於損益表確認。已確認之商譽減值虧損不會於其後期間撥回。

出售相關現金產生單位後，商譽之應佔金額會計入出售損益。

(f) 於聯營公司之投資

聯營公司為本集團擁有重大影響力之實體。重大影響力指參與被投資公司之財務及經營政策決定而非控制或共同控制該等政策之權力。

聯營公司之業績、資產及負債以權益會計法計入該等綜合財務報表，惟當投資或其部份分類為持作出售，則按香港財務報告準則第5號入賬。根據權益法，於聯營公司之投資初步於綜合財務狀況表按成本確認，其後進行調整，以確認本集團應佔該聯營公司之損益及其他全面收益。當本集團應佔聯營公司之虧損超過本集團於該聯營公司之權益（其包括實質上構成本集團於該聯營公司之投資淨額一部份之任何長期權益），本集團不再繼續確認其應佔之進一步虧損。本集團僅就本集團已承擔法定或推定責任或已代表該聯營公司支付款項之數額確認額外虧損。

(f) Investments in associates (Continued)

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 *Impairment of Assets* as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate, or when the investment is classified as held for sale. When the Group retains an interest in the former associate and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with HKAS 39. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing of a part interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) when the equity method is discontinued.

(f) 於聯營公司之投資 (續)

於聯營公司之投資由被投資公司成為聯營公司當日起以權益法入賬。收購於聯營公司之投資時，投資成本超出本集團應佔被投資公司可識別資產及負債之淨公允價值之任何差額會確認為商譽，而商譽乃計入投資之賬面金額中。本集團應佔可識別資產及負債之淨公允價值超出投資成本之任何差額，於重新評估後即時在收購投資當期之損益表確認。

香港會計準則第39號之規定乃用於釐定是否需要就本集團於聯營公司之投資確認任何減值虧損。如有需要，投資之全部賬面金額（包括商譽）會根據香港會計準則第36號「資產減值」作為單一資產進行減值測試，方法為將可收回金額（即使用價值與公允價值減出售成本之較高者）與賬面金額進行比較。已確認減值虧損構成投資賬面金額之一部份。有關減值虧損之任何撥回於該項投資可收回金額其後增加時根據香港會計準則第36號確認。

本集團由投資不再屬聯營公司當日起，或於投資分類為持作出售時終止使用權益法。當本集團保留於前聯營公司之權益，而該保留權益為金融資產，本集團會按當日之公允價值計量保留權益，而公允價值根據香港會計準則第39號被視為初步確認時之公允價值。聯營公司於終止使用權益法當日之賬面金額與任何保留權益之公允價值及出售部份於聯營公司之權益之任何所得款項之差額，會計入出售該聯營公司之收益或虧損。此外，本集團將先前於其他全面收益就該聯營公司確認之所有金額入賬，基準與假設該聯營公司直接出售相關資產或負債時所規定之基準相同。因此，倘該聯營公司先前已於其他全面收益確認之收益或虧損將於出售相關資產或負債時重新分類至損益表，則本集團會於終止使用權益法時，將收益或虧損由權益重新分類至損益表（作為重新分類調整）。

(f) Investments in associates (Continued)

The Group continues to use the equity method when an investment in an associate becomes an investment in a joint venture or an investment in a joint venture becomes an investment in an associate. There is no remeasurement to fair value upon such changes in ownership interests.

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

(g) Property, plant and equipment

Property, plant and equipment including leasehold improvement, furniture and fixtures, office equipment, computer, motor vehicles and yacht, are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any. The cost of an item of property comprises its purchase price and any directly attributable costs of bringing the assets to its location and working condition for its intended use. Expenses incurred after item of property, plant and equipment have been put into operation, such as repair and maintenance, is normally charged to the consolidated statement of profit or loss and other comprehensive income in the period in which it is incurred. In situation where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of an item of property, plant and equipment and where the cost of the item can be measured reliably, the expenditure is capitalised as an additional cost of assets and as a replacement.

(f) 於聯營公司之投資 (續)

當於聯營公司之投資成為於合營企業之投資或當於合營企業之投資成為於聯營公司之投資，本集團會繼續使用權益法。發生該等擁有權權益變動時，不會重新計量公允價值。

當本集團減少於聯營公司之擁有權權益但仍繼續使用權益法，則本集團會按比例將先前就該擁有權權益減少而於其他全面收益確認之收益或虧損重新分類至損益表，前提是該收益或虧損會於出售相關資產或負債時重新分類至損益表。

當集團實體與本集團之聯營公司進行交易，則會於本集團之綜合財務報表確認與該聯營公司交易所產生之損益，惟僅限於與本集團無關之聯營公司權益。

(g) 物業、廠房及設備

物業、廠房及設備（包括租賃物業裝修、傢俬及裝置、辦公室設備、電腦、汽車及遊艇）於綜合財務狀況表按成本減其後累計折舊及其後累計減值虧損（如有）列賬。物業、廠房及設備項目之成本包括購買價及將該等資產付運至運作地點及達至擬定用途之狀態而直接產生之費用。物業、廠房及設備項目投入運作後產生之開支（如維修及保養）一般於產生之期間從綜合損益及其他全面收益表扣除。倘能清楚顯示該等支出能增加預計日後運用該項物業、廠房及設備而產生之經濟效益，而該項目之成本能可靠地計量，則該等支出會撥作資產之額外成本，並列作取代。

(g) Property, plant and equipment (Continued)

Depreciation is calculated on the straight-line method basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful lives. The principal annual rates used for the purpose are as follows:

Leasehold improvement	33%
Furniture and fixtures	10-50%
Office equipment	20%
Computer	50%
Motor vehicles	20%
Yacht	10%

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item allocated on a reasonable basis among the parts and each part is depreciated separately.

Residual values, useful lives and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

(h) Art works and diamonds

Art works and diamonds are stated at cost less accumulated impairment loss.

Art works and diamonds are derecognised upon disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in the profit or loss in the period in which the item is derecognised.

折舊按每項物業、廠房及設備之估計可使用年期以直線法計算，以撇銷成本值至其剩餘價值。計算折舊時所採用之主要年率如下：

遊艇	10%

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Income is recognised on an effective interest basis for debt instruments other than those financial assets classified as FVTPL.

Loans and receivables (including deposits and other receivables, promissory note receivable and cash and bank balances) are measured at amortised cost using the effective interest method, less any impairment.

Interest income is recognised by applying the effective interest rate, except for short-term receivables where the recognition of interest would be immaterial.

Interest expense is recognised on an effective interest basis.

Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group continues to recognise the asset to the extent of its continuing involvement and recognises an associated liability. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

終止確認

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash at banks and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Revenue is measured at the fair value of the consideration received or receivables.

Revenue represents dividend income from securities investments, bank interest income, other interest/dividend income from financial assets and net gain/loss on financial assets at FVTPL.

Provided it is probable that the economic benefits will flow to the Group and the revenue can be measured reliably, revenue is recognised in the consolidated statement of profit or loss and other comprehensive income as follows:

- i. Dividend income from investments is recognised when the Group's rights to receive payment have been established.
- ii. Interest income from financial assets including financial assets at FVTPL are recognised on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which are the rates that exactly discounts and the estimated future cash receipts through the expected life of the financial assets to that asset's net carrying amount on initial recognition.
- iii. Net gain/loss on financial assets at FVTPL is recognised on the transaction dates when the relevant contracts are executed.

(l) Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "profit before taxation" as reported in the consolidated statement of profit or loss and other comprehensive income because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

現行應繳稅項乃根據年內應課稅溢利計算。應課稅溢利有別於綜合損益及其他全面收益表呈報之「除稅前溢利」，原因為前者並無計入其他年度之應課稅或可扣稅收支項目及毋須課稅或不可扣稅之項目。本集團之即期稅項採用呈報期末已實施或實質上已實施之稅率計算。

(I) Taxation (Continued)

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

(I) 稅項 (續)

遞延稅項

本集團就綜合財務報表之資產及負債賬面金額與計算應課稅溢利所用相應稅基兩者之暫時差額確認遞延稅項。本集團一般將會就所有應課稅暫時差額確認遞延稅項負債。遞延稅項資產一般於可能有應課稅溢利以供動用所有可扣減暫時差額時就該等可扣稅暫時差額確認。倘暫時差額因於一項不影響應課稅溢利或會計溢利之交易初步確認(業務合併除外)資產及負債而產生,則不會確認有關遞延稅項資產及負債。此外,倘暫時差額因初步確認商譽而產生,亦不會確認遞延稅項負債。

本集團就與於附屬公司及聯營公司之投資相關之應課稅暫時差額確認遞延稅項負債,惟倘本集團可控制暫時差額撥回,且暫時差額有可能不會於可見將來撥回則除外。因與有關投資及權益相關之可扣減暫時差額而產生之遞延稅項資產僅於可能產生足夠應課稅溢利以供動用暫時差額利益並預期可於可見將來撥回時確認。

遞延稅項資產賬面金額於各呈報期末審閱,並按不可能有足夠應課稅溢利以收回所有或部份資產之金額減少。

Deferred tax (Continued)

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax liabilities or deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

Current and deferred tax for the year

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

(I) 稅項 (續)

遞延稅項 (續)

遞延稅項資產及負債根據於呈報期末已實施或實質上已實施之稅率(及稅法),按清償負債或變現資產期間預期之適用稅率計量。

遞延稅項負債和資產之計量反映本集團於呈報期末預期能收回或清償其資產和負債賬面金額之稅務影響。

為就利用公允價值模型計量之投資物業計量遞延稅項負債或遞延稅項資產,該等物業之賬面金額乃推定為將全數透過銷售收回,除非有關推定遭推翻則作別論。當投資物業可計算折舊,並於旨在隨時間而非透過銷售耗用投資物業內含之絕大部份經濟利益之業務模型內持有時,即推翻有關推定。

年內即期及遞延稅項

即期及遞延稅項於損益表確認,惟當即期及遞延稅項與其他全面收益確認或直接於權益確認之項目相關,亦會分別於其他全面收益或直接於權益確認。倘就業務合併於初步入賬後產生現行稅項或遞延稅項,本集團會於就業務合併入賬時計入稅務影響。

(m) Impairment of tangible assets other than goodwill

At the end of each reporting period, the Group reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the CGU to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual CGUs, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or the CGU) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

When an impairment loss subsequently reverses, the carrying amount of the asset (or CGU) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or CGU) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

(m) 有形資產 (商譽除外) 減值

於各呈報期末，本集團檢討其有形資產之賬面金額，以釐定是否有跡象顯示該等資產出現減值虧損。倘出現任何有關跡象，則須估計資產之可收回金額，以釐定減值虧損 (如有) 之程度。倘無法估計個別資產之可收回金額，本集團則估計該資產所屬現金產生單位之可收回金額。當能確定合理及貫徹之分配基準，公司資產亦分配至個別現金產生單位，否則將分配至可確定合理及貫徹之分配基準之最小現金產生單位組別。

可收回金額為公允價值減出售成本與使用價值之較高者。於評估使用價值時，估計未來現金流量使用稅前貼現率貼現至現值，該貼現率反映當前市場對貨幣時間價值之評估及未調整估計未來現金流量之資產之特有風險。

倘估計資產 (或現金產生單位) 之可收回金額少於賬面金額，則會扣減資產 (或現金產生單位) 之賬面金額至其可收回金額。減值虧損即時於損益表確認。

倘減值虧損其後撥回，則該資產 (或現金產生單位) 之賬面金額將增至重新估計之可收回金額，但增加後之賬面金額不得超過資產 (或現金產生單位) 於過往年度若未確認減值虧損所釐定之賬面金額，而減值虧損撥回會即時於損益表確認。

(n) Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

(o) Contingent liabilities and contingent assets

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. It can also be a present obligation arising from past events that is not recognised because it is not probable that outflow of economic resources will be required or the amount of obligation cannot be measured reliably.

A contingent liability is not recognised but is disclosed in the notes to the consolidated financial statements. When a change in the probability of an outflow occurs so that outflow is probable, they will then be recognised as a provision.

(n) 撥備

當本集團因過往事件而須承擔現時責任(法定或推定)，本集團很可能須履行該責任，且能可靠地估計責任金額，即確認撥備。

確認為撥備之金額乃對於呈報期末履行現時責任所需代價之最佳估計，當中已計及有關責任之風險及不確定因素。當撥備按利用履行現時責任估計所需之現金流量計量時，其賬面金額為有關現金流量之現值(如金錢時間價值之影響重大)。

當清償撥備所需之部份或全部經濟利益預期將從第三方收回，且實際上可確定會收到付還及應收款項金額能可靠地計量，則會將應收款項確認為資產。

(o) 或然負債及或然資產

或然負債指因過去事件而產生之可能債務，而其存在與否僅由不屬本集團全然掌握之一件或以上未確定未來事件之發生或不發生所確定。或然負債亦可以是過去事件所產生之現時債務，而由於不大可能導致經濟資源流失，或債務數額不能可靠地衡量而未予確認。

或然負債雖不作確認，惟於綜合財務報表附註披露。當資源外流之可能性有變，以致有可能流出經濟資源時，會確認或然負債為撥備。

(o) Contingent liabilities and contingent assets (Continued)

A contingent asset is a possible asset that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain events not wholly within the control of the Group.

A contingent asset is not recognised but is disclosed in the notes to the consolidated financial statements when an inflow of economic benefits is probable. When inflow is virtually certain, an asset is recognised.

(p) Employee benefits

Retirement benefits scheme

The Group has participated in the Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Mandatory Provident Fund Scheme Ordinance. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The MPF Scheme is generally funded by payments from employees and by the Group. The Group’s contributions to the MPF Scheme are expensed as incurred in accordance with the rules of the MPF Scheme and are not reduced by contributions forfeited by those employees who leave the MPF Scheme prior to vesting fully in the contributions.

Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long-service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity or paternity leave are not recognised until the time of leave.

(o) 或然負債及或然資產 (續)

或然資產指因過往事件而可能獲得之資產，其存在與否僅可視乎將來發生或不發生一件或以上非本集團所能完全控制之不明確事件確定。

或然資產雖不作確認，惟於有可能流入經濟利益時在綜合財務報表附註披露。當實際上可確定有關利益流入時，即會確認資產。

(p) 僱員福利

退休福利計劃

本集團已根據強制性公積金計劃條例參與強制性公積金計劃（「強積金計劃」）。強積金計劃之資產與本集團之資產分開持有，並由獨立管理之基金管理。強積金計劃之款項一般是由僱員及本集團支付。本集團之強積金計劃供款於根據強積金計劃之規則向強積金計劃作出供款時支銷，且不會以僱員在取得全數供款前退出強積金計劃而被沒收之供款扣減。

僱員應有假期

僱員年假及長期服務假期於僱員應享時確認。本公司已就截至呈報期末僱員提供之服務所產生之年假及長期服務假期之估計負債作出撥備。

僱員應有病假及產假或陪產假期在申請假期時方予確認。

(p) Employee benefits (Continued)

Profit sharing and bonus plans

The expected cost of profit sharing and bonus payments are recognised as a liability when the Group has a present legal or constructive obligation as a result of services rendered by employees and a reliable estimate of the obligation can be made.

Liabilities for profit sharing and bonus plan are expected to be settled within twelve months and are measured at the amounts expected to be paid when they are settled.

(q) Equity-settled share-based payments transactions

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date. Details regarding the determination of the fair value of equity-settled share-based payments transactions are set out in Note 36.

The fair value determined at the grant date of the equity-settled share-based payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share option reserve).

At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share option reserve.

For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to profit or loss.

When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained earnings.

(p) 僱員福利 (續)

溢利分享及花紅計劃

當本集團因僱員提供服務而承擔現有法律或推定責任，且能夠對責任作出可靠估計，溢利分享及花紅付款之預期成本會確認為負債。

溢利分享及花紅計劃之負債預期於十二個月內償付，並按預期於償付時支付之款額計量。

(q) 按股權結算以股份為基礎付款之交易

向僱員或提供類似服務之其他人士支付按股權結算以股份為基礎支付之款項按股本工具於授出日期之公允價值計量。有關釐定按股權結算以股份為基礎付款之交易之公允價值之詳情，載於附註36。

於授出按股權結算以股份為基礎支付之款項當日釐定之公允價值根據本集團對最終將會歸屬之股本工具之估計，按直線法於歸屬期內支銷，而權益（購股權儲備）則相應增加。

於各呈報期末，本集團修訂對預期將會歸屬之股本工具數目之估計。修訂原估計所產生之影響（如有）於損益表確認，致使累計開支反映經修訂之估計，而購股權儲備則作出相應調整。

就於授出日期已即時歸屬之購股權而言，已授出購股權之公允價值即時於損益表支銷。

當購股權獲行使時，先前已在購股權儲備確認之金額會轉撥至股份溢價。倘購股權於歸屬日期後被沒收或於到期日仍未行使，先前已於購股權儲備確認之金額將轉撥至保留盈利。

(r) Leasing

The Group as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight-line basis, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

(s) Related parties transactions

A party is considered to be related to the Group if:

- (a) A person or a close member of that person's family is related to the Group if that person:
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group or of a parent of the Group.

經營租賃租金於租期以直線法確認為開支，惟倘另有系統基準更能代表租賃資產消耗經濟利益之時間模式則作別論。根據經營租賃產生之或然租金於產生期間確認為開支。

倘訂立經營租賃時收取租賃優惠，則有關優惠會確認為負債。優惠利益總額以直線法確認為租金開支扣減，惟倘另有系統基準更能代表租賃資產耗用經濟利益之時間模式則作別論。

(s) 關連人士交易

倘屬下列情況，一方即被視為與本集團有關連：

- (a) 倘屬以下情況，則該人士或其近親與本集團有關連：

(t) Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise except for:

- exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings;

某個別人士之近親指與實體進行買賣時預期可影響該人士或受該人士影響之家庭成員。

不論有否收取價款，凡本集團與關連人士之間轉讓資源或責任之交易，均屬關連人士交易。

(t) 外幣

編製各個別集團實體之財務報表時，以實體功能貨幣以外之貨幣（外幣）進行之交易按交易日通行之匯率確認。於各呈報期末，以外幣列值之貨幣項目按該日之通行匯率重新換算。以外幣列值並按公允價值列賬之非貨幣項目按釐定公允價值當日之通行匯率重新換算。以外幣列值並按歷史成本計量之非貨幣項目不予重新換算。

貨幣項目所產生之匯兌差額均於產生期間在損益表確認，惟以下各項除外：

- 與作未來生產用途之在建資產有關之外幣借貸之匯兌差額，該等匯兌差額於被視為該等外幣借貸利息成本之調整時計入該等資產之成本；

For the purposes of presenting consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of foreign currency translation reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

For all other partial disposals (i.e. partial disposals of associates or joint arrangements that do not result in the Group losing significant influence or joint control), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments to identifiable assets acquired and liabilities assumed through acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

(u) Borrowing costs

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

(v) Segment reporting

Operating segments, and the amounts of each segment item reported in the consolidated financial statements, are identified from the financial information provided regularly to the Group's most senior executive management for the purposes of allocating resources to, and assessing the performance of, the Group's various lines of business and geographical locations.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type of class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The critical judgements, apart from those involving estimations are that management has made in the process of applying the Group’s accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Critical judgements in applying accounting policies, accounting estimates and assumptions

Impairment of AFS financial assets

The Group follows the guidance of HKAS 39 when determining whether an investment in AFS financial assets is other than temporarily impaired. This determination requires significant judgement. In making this judgement, the Group evaluates, among other factors, the duration and extent to which the fair value of an AFS financial asset is less than its cost, and the expected time span the Group will hold on to this investment.

Impairment of other receivables and promissory note receivable

The Group estimates impairment losses for other receivables and promissory note receivable resulting from the inability of the debtors to make the required payments. The Group bases the estimates on the ageing of the other receivables and promissory note receivable balance, receivables creditworthiness, and historical write-off experience. If the financial conditions of the receivables were to deteriorate, actual write-offs would be higher than estimated.

Estimated impairment of interests in associates

In determining whether there is an impairment loss, the Group takes into consideration the estimation of future cash flows to be generated by the associates. The amount of the impairment loss is measured as the difference between the carrying amount of the interests in associates and the share of the present value of estimated future cash flows expected to be generated by the associates. Where the actual future cash flows are less than expected, a material impairment loss may arise.

可供出售金融資產之減值

本集團於釐定於可供出售金融資產之投資是否並非短暫減值時，乃依照香港會計準則第39號內之指引。此釐定過程需作出重大判斷。進行判斷時，本集團評估（其中包括）可供出售金融資產之公允價值低於其成本之持續時間及程度，以及本集團持有該項投資之預計年期。

其他應收款項及應收承兌票據之減值

本集團因債務人無力作出所需付款而產生之其他應收款項及應收承兌票據估計減值虧損。本集團根據其他應收款項及應收承兌票據結餘之賬齡、應收款項之信譽及過往撇銷經驗作出估計。倘應收款項之財務狀況惡化，則實際撇銷可能高於估計數字。

於聯營公司之權益之估計減值

於釐定有否出現減值虧損時，本集團考慮對聯營公司將產生之未來現金流量之估計。減值虧損之金額乃根據於聯營公司之權益之賬面金額與分估預期聯營公司將產生之估計未來現金流量之現值之差額計量。倘實際未來現金流量少於預期，則可能出現重大減值虧損。

Impairment of property, plant and equipment and other tangible assets

Determining whether property, plant and equipment are impaired requires an estimation of the value in use of the cash-generating units to which property, plant and equipment have been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate the present value. The Group tests annually whether the assets have suffered any impairment. The recoverable amount of an asset or a cash generating unit is determined based on value in use calculations which require the use of assumptions and estimates.

Determining whether other tangible assets are impaired requires an estimation of the fair value less cost to disposal to which other tangible assets have been allocated. The recoverable value calculation requires the Group to estimate the future cash flows expected to arise from the assets. Impairment loss has been made if the recoverable amounts of the other tangible assets were below their carrying amounts. Details of the recoverable amount calculations are disclosed in notes 17.

Fair value of conversion options embedded in convertible notes

Conversion options embedded in convertible notes represented the conversion option element of the convertible notes subscribed by the Group and are measured at fair value using the binomial option pricing model at initial recognition and at the end of each reporting period. The debt element of the convertible notes is classified as AFS financial assets.

Income taxes

The Group is subject to income taxes. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of the business. The Company recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

於釐定物業、廠房及設備有否出現減值時，本集團需估計獲分配物業、廠房及設備之現金產生單位之使用價值。於計算使用價值時，本集團需估計現金產生單位預期產生之未來現金流量及適當之貼現率，藉此計算現值。本集團每年測試資產有否出現減值。資產或現金產生單位之可收回金額乃根據使用價值計算法釐定，當中需要作出假設及估計。

於釐定其他有形資產是否出現減值時，本集團需估計獲分配其他有形資產之現金產生單位之公允價值減出售成本。於計算可收回價值時，本集團需估計資產預期產生之未來現金流量。倘其他有形資產之可收回金額少於其賬面金額，則出現減值虧損。有關計算可收回金額之詳細資料載於附註17。

可換股票據內含之換股權之公允價值

可換股票據內含之換股權指本集團所認購可換股票據之換股權部份，於初步確認時及各呈報期末使用二項式期權定價模型按公允價值計量。可換股票據之債務部份則分類為可供出售金融資產。

所得稅

本集團須繳納所得稅。釐定所得稅撥備時須作出重大判斷。在日常業務過程中，大部份交易及計算之最終稅務決定均不明朗。本公司根據附加稅項會否到期之估計來確認預計稅項審核事宜之負債。倘此等事宜之最終稅務結果有別於首次錄得之金額，有關差額將對作出決定期間之所得稅及遞延稅項撥備構成影響。

Share-based payments

The Group follows the guidance of HKFRS 2 when determining the fair value of the share options granted at the grant date. This determination requires significant estimate. In making this judgement, the Group incorporates all factors and assumptions that knowledgeable, willing market participants would consider in setting the price and the valuation technique should be consistent with the generally accepted valuation methodologies for pricing financial instruments.

Fair value of AFS financial assets

The fair value of AFS financial assets that are not traded in active market is determined by valuation techniques. Fair value of AFS financial assets is determined by independent valuer with reference to the market value of underlying net assets. Valuation techniques that include inputs that are not based on observable market data and make assumptions that are primarily based on market conditions existing at the end of each reporting period. Note 19 provide detailed information about key assumptions used in the determination of the fair value.

Useful lives of property, plant and equipment

In accordance with HKAS 16, the Group estimates the useful lives of property, plant and equipment in order to determine the amount of depreciation expenses to be recorded. The useful lives are estimated at the time the asset is acquired based on historical experience, the expected usage, wear and tear of the assets, as well as technical obsolescence arising from changes in the market demands. The Group also performs annual reviews on whether the assumptions made on useful lives continue to be valid.

本集團按照香港財務報告準則第2號之指引，釐定於授予日所授出購股權之公允價值。釐定時需要進行大量估計。作出此判斷時，本集團計及知情之自願市場參與者訂定價格時將考慮之所有因素及假設，且估值技巧應與為金融工具定價之公認估值方法一致。

可供出售金融資產之公允價值

並無於活躍市場買賣之可供出售金融資產之公允價值採用估值技巧釐定。可供出售金融資產之公允價值由獨立估值師參考相關淨資產市值釐定。估值技巧包括並非以可見市場數據為基礎之輸入數據，並主要根據各呈報期末當時之市場情況作出假設。有關用於釐定公允價值之主要假設之詳細資料載於附註19。

(b) 金融風險管理目標及政策

The Group's principal financial instruments comprise AFS financial assets, conversion options embedded in convertible notes, financial assets at FVTPL, and loans and receivables. The main purpose of holding these financial instruments is to generate short-term appreciation gain and gain from trading of these financial instruments. The Group has other financial assets and liabilities such as other receivables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are market risk (including foreign currency risk, interest rate risk and price risk), credit risk and liquidity risk. The Board of Directors reviews and agrees policies for managing each of these risks and they are summarised below.

Market risk

The Group's activities expose it primarily to the financial risks of changes in foreign currency exchange rates, interest rates and equity prices.

Market risk exposures are measured by sensitivity analysis.

There has been no change to the Group's exposure to market risks or the manner in which these risks are managed and measured. Details of sensitivity analysis for foreign currency risk and interest rate risk are set out below.

Foreign currency risk

Foreign exchange risk is the risk that the value of financial instruments will fluctuate due to changes in foreign exchange rates. The Group carries out its business mainly in Hong Kong and all of the transactions are denominated in HK\$. The Group's assets and liabilities are mainly denominated in HK\$, except certain bank balances and financial assets at FVTPL are denominated in United States dollars ("US\$"). As Hong Kong dollar are pegged to US\$, it is assumed that there would be no material currency risk exposure between these two currencies. The Group does not have any formal hedging policies.

Interest rate risk

The Group's cash flow interest rate risk relates primarily to the Group's variable interest bearing bank balances, fixed interest bearing financial assets at FVTPL, promissory note receivable and promissory notes. The exposure to cash flow interest rate risk is minimal. The Group did not enter into interest rate swap to hedge against its exposures.

The Group is exposed to fair value interest rate risk related to the Group's interest bearing AFS financial assets.

市場風險

本集團業務主要承受外幣匯率、利率及股本價格變動之財務風險。

所承受之市場風險以敏感度分析計量。

本集團所面對之市場風險或管理及計量該等風險之方法概無改變。外幣風險及利率風險之敏感度分析詳情載列於下文。

外幣風險

外匯風險指金融工具之價值因匯率變動而波動之風險。本集團主要於香港從事業務，而所有交易均以港元計值。本集團之資產及負債主要是以港元計值，惟若干銀行結餘及於損益表按公允價值列賬之金融資產按美元計值。由於港元與美元掛鈎，故假設兩種貨幣之間並無重大貨幣風險。本集團並無任何正式對沖政策。

Sensitivity analysis

On that date, the Group held 1.30% equity interest of HEC which directly and indirectly owned 100% equity interest of Cordoba and HCG respectively. No dividend was entitled to the Group during the years ended 31 December 2015 and 2014.

On 17 June 2015, the Group has entered into a loan agreement with Longtop Enterprises Limited ("Longtop Loan Agreement"), a company incorporated in Hong Kong with limited liability on 5 February 2007. Pursuant to the terms of the Longtop Loan Agreement, the Group transferred the AFS financial assets with 8,200,000 shares in HEC (representing 0.89% issued shares of HEC) and 210 shares in Co-Lead (representing 5.11% issued shares of Co-Lead), in exchange for partial repayment of the loan amounting to HK\$22,500,000. 38. EVENTS AFTER THE REPORTING PERIOD

On 15 January 2016, the Company and placing agent entered into the placing agreement to place 200,000,000 new ordinary shares at HK\$0.32 per share (the "Placing"). The gross proceeds from the Placing are HK\$64,000,000 and the net proceeds from the Placing are approximately HK\$61,000,000 after deducted the transaction expenses. The Placing was completed on 27 January 2016. Details of the Placing are set out in the Company's announcements dated 15 January 2016 and 27 January 2016.

39. MAJOR NON-CASH TRANSACTION

- (a) On 19 June 2015, Up Wonderful, a wholly owned subsidiary of the Group, has entered into a share swap agreement with Co-Lead, a company incorporated under the laws of British Virgin Islands with limited liability. Under the share swap agreement, the Group transferred the AFS financial assets with 21,000,000 shares in Freeman (representing 1.80% issued shares of Freeman) in exchange of 210 new issued shares of Co-Lead with approximately 5.11% of the enlarged issued shares capital of Co-Lead. The transaction was completed on 24 June 2015. Please refer to Note 19 for details of the transaction.
- (b) The Group entered into a loan agreement with a financial institution amounted to HK\$30,000,000 on 17 June 2015 which was secured by a charge over its interest in its subsidiaries, namely Shine Full Capital Limited, Top Flame Investments Limited and Up Wonderful Limited in favour of the lender. The loan was repayable on the date of one month from the date of drawdown with 1% per month. On 28 July 2015, the AFS financial assets held by the subsidiaries were transferred to the financial institution in exchange for partial repayment of the loan amounted to HK\$22,500,000 and the remaining balance of approximately HK\$7,905,000 was settled by cash on 31 July 2015.
- (c) On 25 February 2014, the loan receivable of approximately HK\$18,208,000 was reclassified from other receivable to AFS financial assets in relation to the Subscription Agreement entered on 24 December 2013. Detail please refer to Note 19.
