CHAIRMAN'S STATEMENT 主 席 報 告

Dear Shareholders

On behalf of the board (the "Board") of directors (the "Directors") of Upbest Group Limited (the "Company"), I am very pleased to share with you an encouraging business performance by the Company and its subsidiaries (collectively the "Group") for the year ended 31st March 2016.

FINANCIAL, MARKET AND BUSINESS REVIEW FINANCIAL REVIEW

For the year ended 31st March, 2016, the Group recorded revenue of HK\$443.4 million, an increase of 70.9% as compared with HK\$259.5 million in the preceding year, and the Group's profit for the year was HK\$518.2 million, an increase of 64.3% as compared with HK\$315.4 million in the preceding year.

The annual results of the Group for the year ended 31st March, 2016 recorded an increase in profit as compared with the preceding year. It was mainly attributable to the gain on disposal of the Group's investment of HK\$463.6 million incurred during the year.

MARKET REVIEW

Throughout the past year, the market experienced gluts of volatility like the schedule of rise in interest rate by the US Government, fears of slowdown in worldwide economy, particularly in China and European countries.

In China, the economy seemed losing its momentum soon after the mainland stock market rose to its peak in mid-June of Year 2015 as negative news and disappointing economic indicators then prevailing in the mainland indicated on subsequent quarters. One of the most prominent indicators showing the tough economic environment was the 6.9% GDP growth rate which had for the first time dropped below 7% since 1990. In addition, the collapse of China's security markets since June as well as the decision of the People's Bank of China to devalue RMB by 4.4% in August further weakened the confidence of the investors in China's economy. To support the economy and encourage the investors, the Chinese government continues to maintain an easy monetary policy and a slack fiscal policy to stabilize the economy.

The Federal Reserve in US decided to increase the interest rate to reflect their expectation of better economy in US in 2016. Furthermore, the uncertainty of the pace of rise in interest rate by the US government will also cause lots of volatility in the worldwide economy.

In most of European countries, they adopt the quantitative-easing measures as one of the major elixir to remedy the economy. Years after years, the economy of those countries does not have any signs of critical recovery.

本人非常榮幸代表美建集團有限公司(「本公司」) 董事(「董事」)會(「董事會」)跟閣下分享本公司及其附屬公司(統稱「集團」)二零一六年三月三十一日止年度讓人鼓舞的業務表現。

財務、市場及業務回顧 財務回顧

截至二零一六年三月三十一日止年度,本集團錄得收入約443,400,000港元,較去年的259,500,000港元上升70.9%,而本集團的年內溢利則為518,200,000港元,較去年的315,400,000港元上升64.3%。

本集團截至二零一六年三月三十一日的年度業績 與去年相比乃錄得溢利增長,此乃主要由於本集 團於年內出售其集團投資而錄得463,600,000港 元的收益。

市場回顧

回顧上一年度整年,市場經歷了多項不穩定因素,如美國政府實施加息時間表,全球(尤其中國及歐洲各國)對經濟放緩的恐懼等。

在中國方面,自內地股票市場於二零一五年六月中升至最高峰以來,隨著負面消息湧現以及其後幾個季度內地經濟指標表現均不如理想,中國經濟動力似乎有所減弱。其中國民生產總值增速僅為6.9%,為自一九九零年以來首度跌破7%,每關指標最能反映經濟環境的嚴峻。此外,受中國證券市場自六月以來的崩盤及中國人民銀行於八月決定將人民幣貶值4.4%的消息拖累,投資者信心,中國政府已持續維持寬鬆貨幣及財政政策,以進一步穩定經濟。

在美國方面,美國聯邦儲備局已決定加息,顯示 其預期美國經濟於二零一六年度將會轉好。不 過,美國政府加息步伐的不確定性亦將為全球經 濟帶來更多波動。

在歐洲方面,歐洲大部份國家目前仍採用量化寬 鬆措施作為挽救經濟的其中一項主要手段。然 而,多年過去有關國家的經濟仍未出現明顯復甦 的跡象。

CHAIRMAN'S STATEMENT

主 席 報 告

Amid in the sluggish world economy, the property market in China, Hong Kong and Macau is also affected.

In Hong Kong, the sale in primary residential market were robust in the first half of Year 2015/16, especially for small flats. However, anticipation of further interest hikes in the US, together with increasing supply in the primary residential market, had weighed on both transaction prices and volumes thereafter.

In Mainland China, following the progressive relaxation of home-buying restrictions, overall sentiment in the property market in mid-2015 was improved with the surge of both transaction prices and volumes in the first-tier and the prime second-tier cities. However, the secondary second-tier, third- and fourth-tier cities, especially those with excess supply, have not benefited from the improving sentiment, with no sign of recovery in the transaction prices and volumes. Many of these cities still face heavy inventory pressure recently.

In Macau, gross gaming revenue continued to decline considerably throughout Year 2015/16 which has adversely affected the performance of the economy. The property market was also unfavorably impacted and the appetite for potential home purchasers was upset amid such economic environment. Consequently, transaction volumes and overall residential prices fell substantially throughout the year.

BUSINESS REVIEW

Brokerage and Financing

These segments are one of the core profit drivers of the Group recording the segment result HK\$46.8 million this year as compared with HK\$28.7 million in the preceding year.

Brokerage

For the year ended 31st March 2016, this segment recorded brokerage revenue of HK\$15.2 million, an increase of 38.2% as compared with HK\$11.0 million in the preceding year. The segment result was HK\$3.9 million as compared with HK\$0.8 million in the preceding year.

During the first half of the year, affected by the China "A" share market, the 'Mad Bull' market appeared which boosted the Hang Seng Index to its highest point of 28,589 with the average daily turnover over HK\$150 billion. After sequential measures taken by the China Securities Regulatory Commission to cool down the overwhelming of the stock market, and the foreign investors harvested and withdrawn from the market, Hong Kong stock market dropped by 36% to the lowest point of the financial year of 18,279 in February 2016. Average daily turnover dropped to around HK\$50 billion. The low trading volume adversely affected our business in the second half of this financial year.

在全球經濟放緩的陰霾下,中國、香港及澳門的 房地產市場亦受到影響。

在香港,一手住宅市場(尤其小型單位)銷售於二零一五/一六年度上半年錄得強勁增長。然而,受對美國進一步加息的預期及一手住宅市場供應量持續上升的影響,成交價格及成交量往後必然受壓。

在中國大陸,隨著購房限制持續放寬,房地產市場整體氣氛於二零一五年年中好轉,一線及主要二線城市房地產的成交價及成交量均出現急升。然而,二三四線城市(尤其供應過剩的城市)並未受惠於良好氣氛,成交價及成交量仍沒有出現反彈跡象。故此,大多數有關城市近期仍面臨嚴峻的去庫存壓力。

在澳門,二零一五/一六年度娛樂總收入繼續大幅下滑,此舉已對澳門經濟表現造成不利影響,並拖累房地產市場,在經濟不景氣的狀況下,潛在置業買家入市意欲大減。因此,成交量及整體住宅價格年內錄得大跌。

業務回顧

經紀及財務

這分部業務是本集團核心溢利增長的驅動者之一,在今年內,其錄得分部業績46,800,000港元,去年則為28,700,000港元。

經紀

截至二零一六年三月三十一日止年度,本分部錄得經紀收入15,200,000港元,較去年的11,000,000港元上升38.2%。本分部業績錄得3,900,000港元,去年則為800,000港元。

於本年度上半年期間,受內地A股市場帶動,本港股市出現「狂牛」市場,將恆生指數推高至最高28,589點,平均每日成交量超過1,500億港元。 其後隨著中國證券監督管理委員會推出一連串措施以為過度熾熱的股票市場降溫,以及外國投資者獲利離場,本港股市轉為下跌,並於二零一六年二月下挫至本個財政年度最低點18,279點,最大跌幅達36%。平均每日成交量亦跌至500億港元左右。低成交量乃對本財政年度下半年的業務產生不利影響。

CHAIRMAN'S STATEMENT

Financing

For the year ended 31st March 2016, this segment recorded revenue of HK\$49.3 million, an increase of 45.4% as compared with HK\$33.9 million in the preceding year. The segment results was HK\$42.9 million as compared with HK\$27.8 million in the preceding year.

The Group's financing segment derives its interest income from both providing securities margin financing service and money lending service.

Throughout the year, as the stock market in Hong Kong is volatile, our Group utilizes our abundant cash reserve to provide loans to customers, thereby boosting up this segment revenue and result.

Corporate Finance and Assets Management

For the year ended 31st March 2016, this segment recorded revenue of HK\$2.8 million, a substantial decrease of 77.4% as compared with HK\$12.4 million in the preceding year. The segment result was HK\$1.8 million as compared with HK\$11.3 million in the preceding year.

The corporate finance segment contributed the least approximately HK\$0.04 million and HK\$0.03 million to the Group's revenue and segment results for the year respectively. The management will continue to focus on fund raising and pre-IPO investment.

The assets management segment recorded revenue of HK\$2.7 million, a substantial decrease of 75.2% as compared with HK\$10.9 million in the preceding year. The segment result was HK\$1.7 million as compared with HK\$9.9 million in the preceding year. The substantial decrease in both revenue and result of this segment is due to a sharp decrease in the performance fee earned during the year from acting as the investment advisor of a company listed on the Main Board of the Stock Exchange under Chapter 21 of the Listing Rules.

Precious Metals Trading

For the year ended 31st March 2016, this segment recorded revenue of HK\$347.3 million, a sharp increase of 90.0% as compared with HK\$182.8 million in the preceding year. The segment loss was HK\$0.9 million as compared with HK\$0.5 million in the preceding year.

Property Investments

For the year ended 31st March 2016, this segment recorded revenue of HK\$28.8 million, an increase of 49.2% as compared with HK\$19.3 million in the preceding year. The segment result was HK\$23.1 million as compared with HK\$14.9 million in the preceding year.

財務

截至二零一六年三月三十一日止年度,本分部錄得收入49,300,000港元,較去年的33,900,000港元增加45.4%。本分部業績錄得42,900,000港元,去年則為27,800,000港元。

本集團財務分部的利息收入源於提供證券孖展融 資服務及貸款融資服務。

於本年度內,藉著香港股票市場出現波動,本集 團動用其充裕的現金儲備為客戶提供貸款,從而 有助提高本分部收入及業績。

企業融資及資產管理

截至二零一六年三月三十一日止年度,本分部錄得收入2,800,000港元,較去年的12,400,000港元大跌77.4%。本分部業績錄得1,800,000港元,去年則為11,300,000港元。

企業融資分部於本年度為本集團的收入和分部業績,分別貢獻約40,000港元及30,000港元。管理層將繼續專注於融資和上市前的投資業務。

資產管理分部錄得收入2,700,000港元,較去年的10,900,000港元大跌75.2%。本分部業績錄得1,700,000港元,去年則為9,900,000港元。該分部收入及分部業績均出現大跌的原因在於年內作為一間根據上市規則第21章於聯交所主板上市公司的投資顧問而賺取的表現酬金大減所致。

貴金屬買賣

截至二零一六年三月三十一日止年度,本分部錄得收入347,300,000港元,較去年的182,800,000港元大幅上升90.0%。本分部虧損為900,000港元,去年則為500,000港元。

物業投資

截至二零一六年三月三十一日止年度,本分部錄得收入28,800,000港元,較去年的19,300,000港元上升49.2%。分部業績錄得23,100,000港元,去年則為14,900,000港元。

CHAIRMAN'S STATEMENT

主 席 報 告

Property investment segment has been another driving force of the boosting financial performance of the Group particularly at the recent years of low interest rate and loose liquidity due to a couple countries adopted quantitative-easing measures. The rental income will continue to contribute to the Group a stable income stream yearly and its capital appreciation will bring a huge and considerable profit on its disposal.

The current year's rental revenue amounted to HK\$24.7 million. Segment result increase from HK\$14.9 million to HK\$23.1 million, representing approximately 32.7% of the Group's total operating profit for the year. It is contributed by the well performance on renewal of rental contracts at the prevailing market rate.

Administration Performance

The management has continuously maintained a lean staff team with efficiency, as evident by being able to securing the administrative expenses to revenue ratio to within 6.2% (2015: 9.1%).

Material Disposals of Group Companies

In year 2015, Upbest Macau Land Company Limited, a wholly owned subsidiary of the Company, had entered into two conditional sale and purchase agreements in relation to the disposal of its entire equity interests and shareholder's loan in Kam Ho Investment Limited ("Kam Ho") and Pearl Star Holding Limited ("Pearl Star") to two independent third parties at an aggregated consideration of HK\$558.9 million. The primary asset of Kam Ho is a piece of land situated in Macau which Kam Ho holds 55% of the entire interests. The primary asset of Pearl Star is a piece of land situated in Macau which Pearl Star holds 45% of the entire interests. Completion of the above transactions contribute a huge gain of HK\$180.8 million and HK\$282.8 million respectively.

The disposals are considered as an opportunity for the Group to realize its investments in properties. The sales proceeds will both be used in appropriate investment opportunities for better return for its shareholders and also robustness of the Group's cash flow as well as the resources to be deployed for our future development.

Prospect

Year 2016 will be a year full of opportunity and challenges, the volatility and the uncertainties fill up with the market like the pace of interest rate rise by the US Government, fears of slowdown in worldwide economy, particularly in China and European countries and the recent breaking sudden news of the United Kingdom withdrawal from the European Union (Brexit) which immediately caused a market crash on the day that the result is known. UK exit may signal a prolong period of uncertainty around global investment markets. The Federal Reserve may halt its plan to raise interest rate at least during the second half of 2016. This on the other hand maybe a good opportunity for Hong Kong. Since Hong Kong currency is pegged to the US dollars, this may help to attract funding inflow to invest in Hong Kong.

物業投資分部長期以來為本集團盈利另一個的驅動者,特別是於近年低利率和因多個國家實施量化寬鬆措施而帶動寬鬆的流動資金時代。租金收入將繼續每年為本集團帶來穩定的收入,而有關物業資本增值則可於出售物業時帶來雄厚及可觀的溢利。

本年度的租金收入為24,700,000港元。分部溢利從14,900,000港元增加至23,100,000港元,佔本集團本年總營業溢利約32.7%。有關增長乃因以貼近市場價值續簽租賃合同。

行政表現

管理層不斷確保有效率的精幹員工隊伍,明顯確保行政開支與收入比率在6.2%內(二零一五年:9.1%)。

主要出售集團公司

於二零一五年,美建澳門置業有限公司,為本公司的全資附屬公司,已訂立兩份有條件買賣協議有關出售其於金豪投資有限公司(「金豪」)及Pearl Star Holding Limited(「Pearl Star」)之全部股本權益及股東貸款,以總代價558,900,000港元予兩名獨立第三方。金豪的主要資產是一塊位於澳門的土地,其中金豪持有全部權益之5%。Pearl Star的主要資產是一塊位於澳門的土地,其中Pearl Star持有全部權益之45%。上述交易完成分別帶來180,800,000港元及282,800,000港元之巨額收益。

出售事項被認為給予本集團一個良機套現該物業 投資。出售所得款項除可用於進行合適的投資, 為各股東獲得更好回報外,亦能加強本集團的現 金狀況及調配其資源作未來發展之用。

展望

二零一六年將為機遇及挑戰並存的一年,美國加息步伐、全球(尤其中國及歐洲各國)對經濟放緩的恐懼、以及近來得知英國退出歐洲聯盟最新消息當日即時導致市場崩盤,都是影響市場的波動及不明朗因素。英國脱離歐盟將為環球投資市場等來一段較長的不明朗時期。聯邦儲備局可能場所不明期。計劃,至少二零一六年下半年如此。然而,在另一角度對香港而言可能視之為良機金曲於香港貨幣與美元掛鈎,此舉將有助吸引資金流入及投資於香港。

CHAIRMAN'S STATEMENT 主 席 報 告

The on-going uncertainty in the world and China economies, have all resulted in a significant uncertainty in the outlook for the business environment going forward. However, the government of China recently laid down various regulatory measures, fiscal policy and monetary policy in order to maintain the stability of the economies.

目前全球及中國經濟的不明朗因素將導致日後的 經營環境前景出現重大不明朗因素。可幸中國政府為穩定經濟,近期已推出各項監管措施、財政政策及貨幣政策。

In the near term, Hong Kong's economic outlook will remain dull, as suggested by the cooling property prices. The uncertainties in regional monetary regimes will also dampen investor sentiment, our financial services and property investment businesses are inevitably affected.

就短期而言,在物業價格停滯的情況下,香港經濟前景仍然未明朗。地區貨幣政策的不明朗因素亦將壓抑投資者情緒,此舉必然對我們的金融服務及物業投資業務造成影響。

Looking forward, to cope with the uncertainties, we will cautiously review and adjust our business strategies from time to time. Furthermore, with available abundant cash, our management will strive to look for better opportunity for investment to further robustness of our financial performance in order to sustain the overall business of the Group with orderly and steady growth.

FINANCIAL REVIEW

Liquidity and Financial Resources

As at 31st March 2016, the Group had bank balance and cash of approximately HK\$388.6 million (2015: HK\$228.2 million) of which approximately HK\$10.0 million (2015: HK\$10.0 million) were pledged to bank for facilities granted to the Group. The Company has given guarantees to the extent of HK\$172.0 million (2015: HK\$172.0 million) to secure the facilities granted to subsidiaries. As at 31st March 2016 the Group had available aggregate banking facilities of approximately HK\$188.0 million (2015: HK\$188.0 million) of which HK\$187.0 million (2015: HK\$174.0 million) was not utilized.

As at 31st March 2016, the Group's borrowings decreased from HK\$15.5 million as at 31st March 2015 to HK\$2.7 million.

Gearing Ratio

As at 31st March 2016, the total equity attributable to owners of the Company amounted to HK\$2,189.1 million (2015: HK\$1,726.8 million). The Group's consolidated net assets per share as at the reporting date was HK\$1.63 (2015: HK\$1.32).

FOREIGN EXCHANGE EXPOSURE

The Group operates in Hong Kong, Macau and the PRC and majority of transactions are denominated in Hong Kong dollars ("HK\$"), United State dollars ("US\$") and Macau Pataca. Foreign exchange risk arises from commercial transactions, recognized assets and liabilities, which are denominated in a currency that is not the functional currency of the Group and the Company.

During the year, the Group mainly uses Hong Kong dollars, Macau Pataca and United States dollars to carry out its business transactions. The Board considers the foreign currency exposure is insignificant.

As at 31st March 2016, the Group had 44 staff including those staff of Macau (2015: 45). For the year ended 31st March 2016, the staff costs of the Group amounted to approximately HK\$14.3 million (2015: HK\$12.6 million), 3.2% and 4.9% of the Group's revenue in FY2016 and FY2015 respectively.

The Group continues to maintain and upgrade the capabilities of its workforce by providing them with adequate and regular training in order to enhance their technical skills and update their industry knowledge with regards to laws and regulations.

The Group remunerates its employees mainly based on industry practices, market remuneration and individual's performance and experience. On top of regular remuneration, discretionary bonus may be granted to eligible staff by reference to the Group's performance as well as individual's performance.

SHARE OPTION

The Company does not have share option scheme.

CREDIT CONTROL

The Group has been practicing tight credit control policy. A credit committee composed of two executive Directors and other members is responsible for overseeing the granting of credit facilities. Daily operation of money lending will be guided by the stringent procedures as prescribed by the internal control manual.

COMPLIANCE AND RISK STEERING COMMITTEE AND STRATEGY MANAGEMENT COMMITTEE

The Group has established a Compliance and Risk Steering Committee and a Strategy Management Committee which aims to maintain a good corporate governance environment for the Group. The Board believed that this will help to enhance the Group's expanding process in the future.

The Company's reserves available for distribution represent the share premium, contributed surplus, retained profits and proposed final dividend under the Companies Law of the Cayman Islands. The share premium of the Company is available for paying dividends to shareholders subject to the provisions of its Memorandum and Articles of Association and provided that immediately following the distribution of dividend the Company is able to pay its debts as they fall due in the ordinary course of business. In accordance with the Company's Articles of Association, dividends can be distributed out of the share premium, contributed surplus, retained profits and proposed final dividend of the Company which in aggregate amounted to approximately HK\$368.5 million as at 31st March 2016.

Property, plant and equipment and investment properties

The Group's investment properties were revalued at 31st March 2016, resulting a decrease in net fair value amounting to approximately HK\$3.0 million which has been recognised in the consolidated income statement.

Details of these and other movements during the year in the property, plant and equipment and investment properties are set out in notes 14 and 15 on the consolidated financial statements, respectively.

Borrowings

Borrowings repayable within one year or on demand are classified as current liabilities. A repayment analysis of borrowings is set out in note 24 on the consolidated financial statements. No interest was capitalised by the Group during the year.

Major clients

The independent non-executive Directors have reviewed the connected transactions and continuing connected transactions in note 32 on the consolidated financial statements and have confirmed that the connected transactions and continuing connected transactions have been entered into (i) in the ordinary and usual course of business of the Group; (ii) on normal commercial terms or on terms no less favourable to the Group than terms available to or from (as appropriate) independent third parties; and (iii) in accordance with the relevant agreements governing them on terms that are fair and reasonable and in the interests of the shareholders of the Company as a whole.

The auditors of the Company have reviewed the continuing connected transactions during the year as set out in note 32 to the consolidated financial statements and confirmed that these transactions:

- (i) were approved by the Board of Directors of the Company;
- (ii) where applicable, were in accordance with the pricing policies of the Company;
- (iii) had been entered into in accordance with the relevant agreements governing the transactions; and
- (iv) have not exceeded the caps stated in the relevant announcement.

As disclosed in the joint announcement of the Company and UBA Investments Limited ("UBA", together with its subsidiaries as the "UBA Group") dated 26th January 2016, various members of the Group entered into certain conditional agreements with the UBA Group, which would constitute continuing connected transactions (the "CCT") on the part of the Group for the years ending 31st March 2017, 2018 and 2019. The CCT are subject to approvals by the independent shareholders of the Company and the independent shareholders of UBA respectively. The relevant resolutions of the Company approving the CCT have been passed at the extraordinary general meeting of the Company held on 30th March 2016 and the date of the extraordinary general meeting of UBA has to yet be fixed.

Management contracts

No contracts concerning the management and administration of the whole or any substantial part of the business of the Company was entered into or existed during the year.

Pre-emptive rights

There are no provisions for pre-emptive rights which would oblige the Company to offer new shares on a pro-rata basis to existing shareholders under the Company's Memorandum and Articles of Association and the Companies Laws of the Cayman Islands.

Audit committee

The Company has established an Audit Committee according to "A Guide for the Formation of an Audit Committee" published by the Hong Kong Institute of Certified Public Accountants. The primary duties of the Audit Committee are to review and supervise the financial reporting process and internal control system of the Group.

As at 31st March 2016, the Audit Committee of the Group is comprised of three independent non-executive Directors, namely Mr. CHAN Chung Yee, Alan, Mr. POON Kai Tik and Mr. HUI Man Ho, Ivan. Two independent non-executive Directors have appropriate professional qualifications or accounting or related financial management expertise as prescribed by the Listing Rules. The main duties of the Audit Committee include the review of the relationship with external auditors of the Company, review of financial information of the Group and oversight of the Group's financial reporting system and internal control procedures.

Code on corporate governance practices

The Listing Rules have been amended by the Stock Exchange by replacing the Code of Best Practice in Appendix 14 by a new Code on Corporate Governance Practices ("CG Code") and adding a new Appendix 23 on the requirements for a Corporate Governance Report to be included in annual reports of Listed Issuers.

The Company has complied with the CG Code throughout the year ended 31st March 2016, with deviations from code provisions A.4.1 of the CG Code only in respect of the service term of Directors.

None of the existing non-executive Directors (including independent non-executive Directors) of the Company is appointed for a specific term. This constitutes a deviation from code provision A.4.1 of the CG Code. However, all the Directors of the Company are subject to the retirement provisions under article 116 of the Articles of Association of the Company. As such, the Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the CG Code.

企業管治報告

The Board of Directors of the Upbest Group Limited (the "Company") (the "Board") is committed to maintain high standards of corporate governance practices, which are crucial to the smooth, effective and transparent operation of the Company and its ability to attract investment, protect rights of shareholders and stakeholders, and enhance shareholder value.

美建集團有限公司(「本公司」)董事會(「董事會」) 致力維持高水平之企業管治常規,對本公司平 穩、有效及具透明度之營運及吸引投資、保障股 東及權益持有人之權益以及提升股東價值之能力 最為重要。

Corporate Governance Practices

This report describes the Company's corporate governance practices and structures that were in place during the financial year ended 31st March 2016, with specific reference to the principles and guidelines of the Corporate Governance Code (the "CG Code") as set out in Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") issued by The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). In developing and reviewing its corporate governance policies and practices, the Company has sought to adopt a balanced approach.

Compliance with Corporate Governance Code

The Company complied with the code provisions as set out in the Corporate Governance Code contained in Appendix 14 to the Listing Rules throughout year ended 31st March 2016, except for the following.

Code Provision A.4.1

Under the Code Provision A.4.1, non-executive Directors should be appointed for a specific term and subject to re-election. None of the independent non-executive Directors of the Company were appointed for a specific term. None of the non-executive Directors has entered or proposed to enter into any service contracts with the Company or its subsidiaries. But all Directors of the Company are subject to the retirement by rotation according to the provisions under Article 157 of the Articles of Association of the Company. As such, the Board considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the CG Code.

Model Code for Securities Transactions by Directors

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers ("Model Code") as set out in Appendix 10 of the Listing Rules as the codes of conduct regarding securities transactions by Directors. All Directors have confirmed, following specific enquiry by the Company, that they fully complied with the Model Code throughout the year.

The Company has also established written guidelines regarding securities transaction on no less exacting terms of the Model Code for senior management and specific individual who may have access to price sensitive information in relation to the securities of the Company.

董事進行證券交易之標準守則

本公司已採納上市規則附錄十所載之《上市發行人董事進行證券交易的標準守則》(「標準守則」),作為董事進行證券交易之操守指引。本公司經向全體董事作出特定查詢後確認,彼等於年內均全面遵守《標準守則》之規定。

本公司亦已就高級管理層及可能接觸到有關本公司證券之股價敏感資料之特定人士訂立有關證券 交易之書面指引,其條款比《標準守則》所訂標準 更高。

Corporate Governance Structure

With the assistance of the Compliance Department, the Board has designed a proper corporate governance structure. Currently, there are seven board committees, including Audit Committee, Remuneration Committee, Nomination Committee, Credit Committee, Executive Committee, Compliance and Risk Steering Committee and Strategy Management Committee. Audit Committee, Remuneration Committee and Nomination Committee perform their distinct roles in accordance with their respective terms of reference. Executive Committee assists the Group to set up business strategy and planning, and Credit Committee oversees the granting of credit facilities. Compliance and Risk Steering Committee maintains and promotes the fairness, efficiency, competitiveness transparency and orderliness of the Group's business. Strategy Management Committee aims to review and formulate the Group's operations and business activities development.

Board Composition, Function and Practices

As at 31st March 2016, the Board comprises of the chairman (nonexecutive Director), one non-executive Director, three executive Directors and three independent non-executive Directors. Mr. IP Man Tin, David acts as chairman ("Chairman") and non-executive Director of the Board. Dr. SZE Ping Fat is a non-executive Director. Other executive Directors are Ms. CHENG Wai Ling, Annie, Mr. CHENG Wai Lun, Andrew and Mr. MOK Kwai Hang. There are three independent non-executive Directors, Mr. CHAN Chung Yee, Alan, Mr. POON Kai Tik and Mr. HUI Man Ho. Mr. CHAN Chung Yee, Alan and Mr. HUI Man Ho, Ivan have appropriate professional accounting experience and expertise. During the year, Mr. SUEN Man Tak, Stephen tendered his resignation as non-executive Director of the Company with effect from 1st January 2016. All Directors are subject to election by shareholders at the first General Meeting after their appointment and are subject to retirement by rotation at least once every three years and eligible for re-election in accordance with the Company's Articles and Association.

All Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. The biographical details of each Director are disclosed in pages 15 to 18 of this Annual Report.

Each independent non-executive Director has pursuant to the rule 3.13 of the Listing Rules, confirmed that he is independent of the Company and the Company also considers that they are independent.

There is no relationship (including financial, business, family or other material relationship) among members of the Board except that Mr. CHENG Wai Lun, Andrew is the brother of Ms. CHENG Wai Ling, Annie.

The Board, headed by the Chairman, is responsible for formulation and approval of the Group's development and business strategies and policies, approval of annual budgets and business plans, overseeing the Group's compliance with statutory and regulatory obligations, scrutinizing the performance of the Group in achieving agreed corporate goals and objectives, financial reporting and ensuring proper internal control, risk management have been implemented, recommendation of dividend, and supervision of management in accordance with the rules governing the meeting of the Board, articles of association and rules governing the meeting of shareholders.

Notice of at least fourteen days are given to all Directors and all Directors have an opportunity to attend. The Directors who cannot attend in person might through other electronic means of communications to participate. Senior management executives may, from time to time, be invited to attend the Board meeting for making presentation and/or answering any queries that may be raised by the Board.

To ensure Directors' contribution to the Board remains informed and relevant, the Company encourages Directors to participate in continuous professional development to develop and refresh their knowledge and skills and understanding of the business and markets in which the Group operates. Directors are also provided with monthly performance and position updates of the Group, and information such as performance and key operational highlights to enable the Board as a whole as well as each Director to discharge their duties. For the financial year ended 31st March 2016, all Directors have participated in appropriate continuous professional development and provided the Company with their records of training. Independent Professional Advice

The Company has set up a procedure agreed by the Board for its Directors to seek independent professional advice in appropriate circumstances, and at the Company's expense to discharge their duties to the Company.

Chairman and Management

The roles of the Chairman is separate from that of the CEO and their responsibilities are clearly established. The Chairman and CEO of the Company are Mr. IP Man Tin, David and Ms. CHENG Wai Ling, Annie respectively. The Chairman is responsible for providing leadership to the Board to ensure the Board will act in the best interests of the Group.

The CEO will work with executive committee (including head of each department) and other executive Directors to manage the businesses of the Group. The CEO is responsible for the day-to-day management of the business of the Group, attends to formulation and successful implementation of policies, and assumes full accountability to the Board for all operations of the Group.

Two of the independent non-executive Directors, namely Mr. CHAN Chung Yee, Alan and Mr. HUI Man Ho. Ivan have the appropriate professional accounting experiences and expertise. The Board membership is covered by professionally qualified and widely experienced personnel so as to bringing in valuable contribution and different professional advices and consultancy for the development of the Company. Over one-half of the Board members have recognised legal, professional securities and/or accounting qualifications.

In the course of discharging their duties, the Directors act in good faith, with due diligence and care, and in the best interests of the Company and its shareholders. Their responsibilities include:

- Regular Board meetings focusing on business strategy, operational issues and financial performance.
- Active participation on the boards of subsidiaries and associated companies.
- Approval of annual budgets for each operating company covering strategy, financial and business performance, key risks and opportunities.
- Monitoring the quality, timeliness, relevance and reliability of internal and external reporting.

A number of Board Committees, including Audit Committee, Remuneration Committee, Nomination Committee, Credit Committee, Executive Committee, Compliance and Risk Steering Committee and Strategy Management Committee have been established by the Board to strengthen its functions and to enhance its expertise. These committees have been formed with specific written terms of reference which deal clearly with the committees authority and duties.

Audit Committee

The Company has established an Audit Committee according to "A Guide for the Formation of an Audit Committee" published by the Hong Kong Institute of Certified Public Accountants. In accordance with the requirements of the CG Code, the terms of reference of the Audit Committee was revised and approved on 18th July 2005 and 16th March 2012 to comply with the provisions set out in the CG Code. The primary duties of the Audit Committee are to review and supervise the financial reporting system and internal control procedures, review of the relationship with the auditors and financial information of the Group. The revised terms of reference, explaining its role and the authority delegated to it by the Board are available for inspection on request at the Company's principal place of business in Hong Kong.

As at 31st March 2016, the Audit Committee of the Company is comprised of three independent non-executive Directors, namely Mr. CHAN Chung Yee, Alan, Mr. POON Kai Tik and Mr. HUI Man Ho, Ivan. It is chaired by Mr. CHAN Chung Yee, Alan. It reports directly to the Board and reviews matters within the scope of audit, such as financial statements and internal controls, to protect the interests of the Company's shareholders.

The Audit Committee meets regularly with the Company's external auditors to discuss audit process and accounting issues, and reviews effectiveness of internal controls and risk evaluation. Written terms of reference, which describes the authority and duties of the Audit Committee are regularly reviewed and updated by the Board.

The terms of reference of the Nomination Committee, which is available on the Company's website, set out details of the Committee's duties, powers and functions, nomination procedures and the process and criteria adopted for selection and recommendation of candidates for directorship of the Company, summary of which in financial year 2015/2016 is set out below:

- to determine the policy for the nomination of Directors;
- to review and recommend the implementation of the Diversity Policy;
- to review the size and composition (including the skills, knowledge and experience and length of service) of the Board annually; and making recommendations to the Board regarding any proposed changes to implement the Company's corporate strategy;
- to identify individuals suitably qualified to become Board members and select or make recommendations to the Board on the selection of individuals nominated for directorships;
- to assess the independence of independent non-executive Directors; and
- to make recommendations to the Board on the relevant matters relating to the appointment or re-appointment of Directors.

It is believed that better and balanced corporate governance environment will help to enhance the Group's expanding process which in turn translates into shareholder value in the future.

Strategy Management Committee

The Group has established a Strategy Management Committee headed by an executive Director. The Strategy Management Committee meeting is held on a bi-weekly basis. The objectives of the Strategy Management Committee include:

- formulation of medium and long-term strategies of the Group;
- review of operations and business activities of the Group; and
- making recommendations to improve operational efficiencies.

Corporate Governance Functions

The Board as a whole is responsible for performing the corporate governance duties including:

- (a) to develop and review the Company's policies and practices on corporate governance;
- (b) to review and monitor the training and continuous professional development of Directors and senior management;
- (c) to review and monitor the Company's policies and practices in compliance with legal and regulatory requirements;

Pursuant to Article 72 of the Articles of Association of the Company, general meetings shall also be convened on the written requisition of any two or more members of the Company deposited at the principal office of the Company in Hong Kong or, in the event the Company ceases to have such a principal office, the registered office specifying the objects of the meeting and signed by the requisitionists, provided that such requisitionists held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company. General meetings may also be convened on the written requisition of any one member of the Company which is a recognised clearing house (or its nominee) deposited at the principal office of the Company in Hong Kong or, in the event the Company ceases to have such a principal office, the registered office specifying the objects of the meeting and signed by the requisitionist, provided that such requisitionist held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company.

1. GENERAL

Upbest Group Limited (the "Company") is a public limited company incorporated in the Cayman Islands with its shares listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The address of its registered office is P.O. Box 309, Ugland House, Grand Cayman, KY1-1104, Cayman Islands. The principal place of business is 2nd Floor, Wah Kit Commercial Centre, 300 Des Voeux Road Central, Hong Kong.

As at the date of this report, CCAA Group Limited held direct interests in 996,360,748 (2015: 987,720,748) shares of the Company, representing approximately 74.29% (2015: 73.65%) of the issued share capital of the Company.

The Company is principally engaged in investment holding. Its subsidiaries are principally engaged in the provision of a wide range of financial services including securities broking, futures broking, securities margin financing, money lending, corporate finance advisory, assets management, property investment and precious metals trading.

The consolidated financial statements are presented in Hong Kong dollars, which is the same as the functional currency of the Company.

2.1 BASIS OF PREPARATION

i) The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). The consolidated financial statements have been prepared under the historical cost convention except that the investment properties are stated at fair value.

1. 概況

本公司的主要業務是投資控股。其附屬公司之主要業務為提供廣泛種類金融服務,包括證券經紀、期貨經紀、證券孖展融資、貸款融資、企業融資顧問、資產管理、物業投資及貴金屬買賣。

本綜合財務報表以港元呈列,與本公司之 功能貨幣相同。

ii) Basis of consolidation:

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31st March 2016. The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date of acquisition, being the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases. All intra-group balances, transactions, unrealised gains and losses resulting from intra-group transactions and dividends are eliminated on consolidation in full.

Losses within a subsidiary are attributed to the non-controlling interest even if that results in a deficit balance.

Further information about those HKFRSs that are expected to be applicable to the Group is as follows:

In September 2014, the HKICPA issued the final version of HKFRS 9, bringing together all phases of the financial instruments project to replace HKAS 39 and all previous versions of HKFRS 9. The standard introduces new requirements for classification and measurement, impairment and hedge accounting. The Group expects to adopt HKFRS 9 from 1st April 2018. The Group is currently assessing the impact of the standard upon adoption and expects that the adoption of HKFRS 9 will have an impact on the classification and measurement of the Group's financial assets.

HKFRS 15 establishes a new five-step model to account for revenue arising from contracts with customers. Under HKFRS 15, revenue is recognised at an amount that reflects the consideration to which any entity expects to be entitled in exchange for transferring goods or services to a customer. The principles in HKFRS 15 provide a more structured approach for measuring and recognising revenue. The standard also introduces extensive qualitative and quantitative disclosure requirements, including disaggregation of total revenue, information about performance obligations, changes in contract asset and liability account balances between periods and key judgements and estimates. The standard will supersede all current revenue recognition requirements under HKFRSs. In September 2015, the HKICPA issued an amendment to HKFRS 15 regarding a one-year deferral of the mandatory effective date of HKFRS 15 to 1st January 2018. The Group expects to adopt HKFRS 15 on 1st April 2018 and is currently assessing the impact of HKFRS 15 upon adoption.

HKFRS 16 sets out the principles for the recognition, measurement, presentation and disclosure of leases. The standard introduces a single lessee accounting model and requires a lessee to recognize assets and liabilities for all leases with a term of more than 12 months, unless the underlying asset is of low value. A lessee is required to recognize a right-of use asset representing its right to use the underlying leased asset and a lease liability representing its obligation to make lease payments. HKFRS 16 substantially carries forward the lessor accounting requirements in HKAS 17. Accordingly, a lessor continues to classify its leases as operating leases or finance leases, and to account for those two types of leases differently. The Group is yet to assess the full impact of the standard on its financial position and results of operations. The standard is mandatorily effective for annual periods beginning on or after 1st April 2019.

Amendments to HKAS 1 include narrow-focus improvements in respect of the presentation and disclosure in financial statements. The amendments clarify:

- i) the materiality requirements in HKAS 1;
- ii) that specific line items in the income statement and the statement of financial position may be disaggregated;
- iii) that entities have flexibility as to the order in which they present the notes to financial statements; and
- iv) that the share of other comprehensive income of associates and joint ventures accounted for using the equity method must be presented in aggregate as a single line item, and classified between those items that will or will not be subsequently reclassified to profit or loss.

Furthermore, the amendments clarify the requirements that apply when additional subtotals are presented in the statement of financial position and the income statement. The Group expects to adopt the amendments from 1st April 2016. The amendments are not expected to have any significant impact on the Group's financial statements.

2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented.

a) Goodwill:

Goodwill arising on an acquisition of a subsidiary or an associate represents the excess of the cost of acquisition over the interest in the fair value of the identifiable assets, liabilities and contingent liabilities of the relevant subsidiary or associate at the date of acquisition. Such goodwill is carried at cost less any accumulated impairment losses.

Capitalised goodwill arising on an acquisition of a subsidiary is presented separately in the consolidated statement of financial position. Capitalised goodwill arising on an acquisition of an associate (which is accounted for using the equity method) is included in the cost of the investment of the relevant associate.

For the purpose of impairment testing, goodwill arising from an acquisition is allocated to each of the relevant cashgenerating units, or groups of cash-generating units, that are expected to benefit from the synergies of the acquisition. A cash-generating unit to which goodwill has been allocated is tested for impairment annually, and whenever there is an indication that the unit may be impaired. For goodwill arising on an acquisition in a financial year, the cash-generating unit to which goodwill has been allocated is tested for impairment before the end of that financial year. When the recoverable amount of the cash-generating unit is less than the carrying amount of the unit, the impairment loss is allocated to reduce the carrying amount of any goodwill allocated to the unit first, and then to the other assets of the unit pro rata on the basis of the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in the consolidated income statement. An impairment loss for goodwill is not reversed in subsequent periods.

On subsequent disposal of a subsidiary or an associate, the attributable amount of goodwill capitalised is included in the determination of the amount of profit or loss on disposal.

Excess of an acquirer's interest in the net fair value of an acquirer's identifiable assets, liabilities and contingent liabilities over cost ("discount on acquisitions")

A discount on acquisition arising on an acquisition of a subsidiary represents the excess of the net fair value of an acquiree's identifiable assets, liabilities and contingent liabilities attribute to the Group over the cost of the business combination. Discount on acquisition is recognised, after reassessment, immediately in the consolidated income statement. A discount on acquisition arising on an acquisition of an associate or a joint venture is included as income in the determination of the investor's share of results of the associate or joint venture in the period in which the investment is acquired.

b) Property, plant and equipment:

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the assets to working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance and overhaul cost, is normally charged to the consolidated income statement in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of an item of property, plant and equipment, the expenditure is capitalised as an additional cost of the asset.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use or no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the consolidated income statement in the year in which the item is derecognised.

d) Subsidiaries:

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in consolidated income statement. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's statement of financial position, the investments in subsidiaries are stated at cost less impairment losses.

d) 附屬公司:

e) Associates:

An associate is an entity in which the Group has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

An investment in an associate is accounted for in the consolidated financial statements under the equity method. unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment. Any acquisitiondate excess over cost, the Group's share of the postacquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated income statement, whereas the Group's share of the post-acquisition post-tax items of the associates' other comprehensive income is recognised in the consolidated statement of comprehensive income.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate.

Unrealised profits and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in the consolidated income statement.

When the Group ceases to have significant influence over an associate, it is accounted for as disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when significant influence is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset.

f) Intangible assets:

On initial recognition, intangible assets acquired are recognised at cost. After initial recognition, intangible assets with finite useful lives are carried at cost less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is provided on a straight-line basis over their estimated useful lives. Intangible assets with indefinite useful lives are carried at cost less any subsequent accumulated impairment. Gains or losses arising from derecognition of an intangible asset are measured at the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in the consolidated income statement when the asset is derecognised.

Intangible assets with indefinite useful lives are tested for impairment annually by comparing their carrying amounts with their recoverable amounts, irrespective of whether there is any indication that they may be impaired. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

When an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years.

Intangible assets with finite useful lives are tested for impairment when there is an indication that an asset may be impaired.

g) Inventories:

Inventories are stated at the lower of cost and net realisable value. Cost includes cost of purchase computed using the first-in-first-out method. Net realisable value is determined by reference to the sales proceeds of items sold in the ordinary course of business after the end of the reporting period or to management estimates based on prevailing market conditions.

h) Investments:

The Group classifies its investments in the following categories: trade and other receivables, available-for-sale financial assets, financial assets or liabilities at fair value through profit or loss and loan receivables. The classification depends on the purpose for which the investments were acquired. Management determines the classification of its investments at initial recognition and re-evaluates this designation at every reporting date.

 i) Financial assets or liabilities at fair value through profit or loss:

At the end of the reporting period subsequent to initial recognition, financial assets or liabilities at fair value through profit or loss are measured at fair value, with changes in fair value recognised directly in the consolidated income statement in the period in which they arise. All derivative financial assets or liabilities are also categorised as financial assets or liabilities at fair value through profit or loss unless they are designated as hedges.

ii) Trade and other receivables:

Trade and other receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. At the end of the reporting period subsequent to initial recognition, trade and other receivables are carried at amortised cost using the effective interest method, less any identified impairment losses. An impairment loss is recognised in the consolidated income statement when there is objective evidence that the asset is impaired, and is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the original effective interest rate. Impairment losses are reversed in subsequent periods when an increase in the asset's recoverable amount can be related objectively to an event occurring after the impairment was recognised, subject to a restriction that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

iii) Available-for-sale financial assets:

Available-for-sale financial assets are non-derivatives that are either designated or not classified as any of the other categories (set out above).

After initial recognition, available-for-sale financial assets are subsequently measured at fair value, with unrealised gains or losses recognised as other comprehensive income in the available-for-sale assets fair value reserve until the investment is derecognised, at which time the cumulative gain or loss is recognised in the consolidated income statement, or until the investment is determined to be impaired, at which time the cumulative gain or loss is recognised in the consolidated income statement and removed from the available-for-sale assets fair value reserve.

When the fair value of unlisted equity securities cannot be reliably measured because (a) the variability in the range of reasonable fair value estimates is significant for that investment or (b) the probabilities of the various estimates within the range cannot be reasonably assessed and used in estimating fair value, such securities are stated at cost less any impairment losses.

iv) Loan receivables:

Loan receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market, including placements with banks and other financial institutions, investment debt securities without an active market and loans and advances to customers. Loan receivables are carried at amortised cost using the effective interest method.

i) Properties held for development:

Properties held for development are stated at the lower of cost and net realisable value. Net realisable value is determined by reference to sale proceeds received after the end of the reporting period less selling expenses, or by management estimates based on prevailing market conditions.

Costs of properties include acquisition costs, development expenditure, interest and other direct costs attributable to such properties. The carrying values of properties held by subsidiaries are adjusted in the consolidated financial statements to reflect the Group's actual acquisition costs where appropriate.

Properties held for development included in the current assets are expected to be realised, or is intended for sales in the Group's normal operation cycle.

j) Impairment of assets:

At the end of each reporting period, the Group reviews the carrying amounts of its assets to determine whether there is any indication that those assets have suffered an impairment loss. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

In case of equity securities classified as available-for-sale financial assets, a significant or prolonged decline in the fair value of the equity securities below their cost is considered in determining whether the securities are impaired. Impairment losses recognised in consolidated income statement on equity securities are not reversed through consolidated income statement.

k) Income tax expense:

Income tax expense comprises current and deferred tax.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustments to tax payable in respect of previous years, current tax is recognised in the consolidated income statement, except it relates to items that are recognised in other comprehensive income or directly in equity, in which case, the current tax is also recognised in other comprehensive income or directly in equity, respectively.

Deferred taxation is recognised on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences except where the deferred tax liabilities arise from the initial recognition of assets or liabilities and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss.

Deferred tax assets are recognised for all deductible temporary differences, carry forward of unused tax assets and unused tax losses, to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences, and the carry forward of unused tax assets and unused tax losses can be utilised except where the deferred tax assets relating to the deductible temporary differences arises from the initial recognition of assets or liabilities and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient future taxable profit will be available to allow all or part of the deferred tax assets to be utilised. Conversely, previously unrecognised deferred tax assets are recognised to the extent that it is probable that sufficient future taxable profit will be available to allow all or part of the deferred tax assets to be utilised.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the assets are realised or the liabilities are settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the end of the reporting period. Deferred taxation is recognised in the consolidated income statement, except when it relates to items that are recognised in other comprehensive income or directly in equity, in which case the deferred taxation is also recognised in other comprehensive income or directly in equity respectively.

I) Borrowing costs:

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of these assets until such times as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing cost eligible for capitalisation.

All other borrowing costs are recognised in the consolidated income statement in the period in which they are incurred.

m) Foreign currency translation:

i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated income statement.

The results and financial positions of all the Group's entities that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- a) assets and liabilities for each of the statement of financial position presented are translated at the closing rates at the date of that statement of financial position;
- b) income and expenses for each of the income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the dates of the transactions); and
- the resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange reserve.

n) Financial guarantees issued, provision and contingencies:

i) Financial guarantees issued

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the "holder") for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where the Group issues a financial guarantee, the fair value of the guarantee (being the transaction price, unless the fair value can otherwise be reliably estimated) is initially recognised as deferred income within trade and other payables. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in the consolidated income statement on initial recognition of any deferred income.

The amount of the guarantee initially recognised as deferred income is amortised in the consolidated income statement over the term of the guarantee as income from financial guarantees issued. In addition, provisions are recognised if and when it becomes probable that the holder of the guarantee will call upon the Group under the guarantee, and the amount of that claim on the Group is expected to exceed the amount currently carried in trade and other payables in respect of that guarantee i.e. the amount initially recognised, less accumulated amortisation.

ii) Provisions and contingencies

A provision is recognised when there is a present obligation, legal or constructive, as a result of a past event and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation. Provisions are reviewed regularly and adjusted to reflect the current best estimate. Where the effect of the time value of money is material, the amount of a provision is the present value of the expenditures expected to be required to settle the obligation.

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. It can also be a present obligation arising from past events that is not recognised because it is not probable that outflow of economic resources will be required or the amount of obligation cannot be measured reliably.

A contingent liability is not recognised but is disclosed in the note on the consolidated financial statements. When a change in the probability of an outflow occurs so the outflow is probable, it will then be recognised as a provision.

o) Revenue recognition:

- i) Commission and brokerage income, placement and underwriting commission, management and handling fees, corporate finance advisory fees and investment management fee and performance fee are recognised when the services are rendered, the amount for which can be reliably estimated and it is probable that they will be received
- ii) Interest income is accrued, on a time proportion basis, by reference to the principal outstanding and at the effective rate applicable.
- iii) Rental income is recognised on a straight-line basis over the period of the respective leases.
- iv) Sale of precious metals is recognised, when the significant risks and rewards of ownership have been transferred to the buyer, provided that the Group maintains neither managerial involvement to the degree usually associated with ownership; nor effective control over the goods sold.

p) Operating lease:

Leases in which a significant portion of the risks and rewards of ownership are retained by the lessor are classified as operating leases. Receipts or payments made under operating leases (net of any incentives received from the lessor) are credited or expensed in the consolidated income statement on a straight-line basis over the period of the lease.

q) Related parties:

- a) A person or a close member of that person's family is related to the Group if that person:
 - i) has control or joint control over the Group;

r) Cash and cash equivalents:

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

s) Segment reporting:

Operating segments, and the amount of each segment item reported in the consolidated financial statements, are identified from the financial information provided regularly to the Group's most senior executive management for the purposes of allocating resources to, and assessing the performance of, the Group's various lines of business and geographical locations.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

t) Employees benefits:

The Group participates a defined contribution Mandatory Provident Fund Scheme (the "MPF Scheme") which is available to all employees. Contributions to the MPF Scheme by the Group and its employees are calculated based on a percentage of employees' relevant income. The Group's contributions to the fund are expensed as incurred and the assets of the MPF Scheme are held separately from those of the Group in an independently administrated fund.

Payments to the Group's MPF Scheme are charged to the consolidated income statement as they fall due.

3. CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The Group did not use any critical accounting estimates in the preparation of the consolidated financial statements.

In the process of applying the Group's accounting policies, management has made the following judgments, apart from those involving estimations, which have the most significant effect on the amounts recognised in the consolidated financial statements:

Impairment loss on trade receivables

The policy for impairment loss on trade receivables of the Group is based on the evaluation of collectability, aging analysis of accounts, the values of underlying collaterals and on management's judgment. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables, including the current creditworthiness and the past collection history of those clients in default of settlement. If the financial conditions of debtors and their ability to make payments worsen, additional impairment loss may be required.

Estimated fair value of investment properties

The fair values of investment properties are determined at the end of the reporting period by an independent professional valuer. Valuations were made on the basis of either, investment approach by capitalizing the net rental income receivable from the existing tenancies and the reversionary rental income potentials, and residual approach by referencing to its development potential by deducting costs and developer's profits from its estimated completed development value. These methodologies are based upon estimates of future results and a set of assumptions as to income and expenses of the property and future economic conditions.

4. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of equity reserves attributable to equity holders of the Company, comprising mainly issued share capital, other reserves and retained profits.

貿易應收款項減值

本集團於貿易應收款項減值政策以可收回性,賬齡分析,相關抵押品之價值及管理層的評估為基礎。於評估該等應收款項最終變現價值時,管理層需作出大量判斷,包括該等拖欠還款客戶現時之信譽及以往付款記錄。倘此等客戶因財務欠佳而導致其還款能力減損,將會就此作出額外減值。

投資物業之估計公平值

投資物業的公平值乃根據獨立專業估值師 於報告期末之評估作基準。估值按收入資 本化方法將來自現有租金收入淨值及續租 租金收入潛力資本化或按剩餘法通過參考 其發展潛力,及其估計完成開發價值並減 去預計成本及發展商盈利作基準。這些方 法都是以對未來業績估算及一系列對物業 的收入及支出的估算以及未來的經濟狀況 的假設作基準。

4. 資本風險管理

本集團管理資本以確保本集團能繼續以持續經營基準經營,同時透過優化債務及權益之平衡為股東爭取最大回報。本集團以往年度之全面策略維持不變。

本集團資本結構包括公司權益持有人應佔 股本儲備主要包含股本,其他儲備及保留 溢利。

The directors of the Company review the capital structure on a semi-annual basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors, the Group will balance its overall capital structure through the payment of dividends and new share issues.

a) Financial risk factors:

The Group's major financial instruments comprise amount due from/to an associate, available-for-sale financial assets, trade and other receivables, deposits, other assets, bank balances and cash, borrowings, amounts due to related parties, amount due to ultimate holding company and creditors and accrued expenses.

The Group's activities expose it to a variety of financial risks: credit risk, liquidity risk, interest rate risk and foreign currency risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

i) Credit risk

The Group takes on exposure to credit risk, which is the risk that a counterparty will be unable to pay amounts in full when due. Impairment provisions are provided for losses that have been incurred by the end of the reporting period, if any. The Group is responsible for monitoring the amount of credit exposure to any financial institution.

The concentration risk to major customers is set out in note 7 (b)(iii) on the consolidated financial statements.

ii) Liquidity risk

The Group invests in unlisted securities which are designated as available-for-sale financial assets. Those unlisted securities may not be traded in an organised public market and may be illiquid. As a result, the Group may not be able to liquidate quickly its investments in these instruments at an amount close to their fair value in order to meet its liquidity requirements or to respond to specific events such as deterioration in the creditworthiness of any particular issuer. Prudent liquidity risk management implies maintaining sufficient cash and marketable securities, the availability of funding through an adequate amount of credit facilities and the ability to close out market positions.

The following table details the Group's remaining contractual maturity for its financial liabilities. For non-derivative financial liabilities, the table has been drawn up based on the undiscounted cash flows of the financial liabilities based on the earliest date on which the Group can be required to pay. The table includes both interest and principal cash flows.

The Group's interest rate risk arises primarily from the Group's borrowings from financial institution, other loans, bank deposits, interest-bearing loan receivable and margin client receivables.

The majority of the borrowings bear interest at interest rates with reference to the HIBOR whereas loans to customers bear interest at interest rates with reference to the prime rate. As the prime rate in Hong Kong basically changes in line with the HIBOR, the Group's exposure to the risk of changes in market interest rates is minimal.

The following table demonstrates the sensitivity to a reasonably possible change in interest rates, with all other variables held constant, the Group's profit before tax (through the impact on floating rate borrowings, interest-bearing accounts receivables, loans and advances) and the Group's equity.

The residual approach is valued by referencing to its development potential by deducting costs and developer's profits from its estimated completed development value. A range of values may be attributable to the subject land depending upon the assumption mode.

A subsidiary of the Company, Upbest Assets Management Limited ("UAML") as investment manager, and UBA Investments Limited ("UBA") had entered into a Supplemental Investment Management Agreement dated 28th January 2013 ("Supplemental Investment Management Agreement") and agreed that the original investment management agreement and any supplemental agreements pursuant to which UAML provided investment management services to UBA be extended for a period of three years to 31st March 2016. This agreement can be terminated by either UAML or UBA serving not less than six months' notice in writing prior to the expiration. Pursuant to the investment management agreement, monthly investment management fee is receivable at 1.5% per annum of the consolidated net asset value of UBA as at the immediately preceding valuation date on the actual number of days in the relevant calendar month over 365 days a year.

In addition to the above, UAML and UBA had on 2nd May 2008 entered into a supplemental agreement whereby in addition to the management fee, a performance fee payable in Hong Kong dollars equivalent to 20% of net profit of UBA and its subsidiaries before taxation and before deduction of the management fee payable under the investment management agreements shall be paid to UAML for each financial year.

The supplemental agreement had further renewed the service period for three years up to 31st March 2016.

The annual cap for the management fee and performance fee for the financial year ended 31st March 2016 is HK\$13,600,000 (2015: HK\$10,900,000). These continuing connected transactions were approved on the extraordinary general meeting of the shareholders held on 26th March 2013. There was no performance fee for the year ended 31st March 2016 (2015: performance fee approximated HK\$8,777,000 had been received).
