This announcement is made by the Company pursuant to rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the Shareholders and potential investors that the Group is expected to record a significant increase of more than 100% in net profit for the six months ended 30 June 2016 as compared to that for the corresponding period in 2015.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Plover Bay Technologies Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap.571, Law of Hong Kong) (the “**SFO**”).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on information currently available to the Board, the Group is expected to record a substantial increase of more than 100% in its net profit for the six months ended 30 June 2016 as compared with that for the corresponding period in 2015, primarily attributable to the significant increase in revenue generated from warranty and support services during the relevant period.

The Company is still in the process of preparing and completing the interim results of the Group for the six months ended 30 June 2016 (the “**2016 Interim Results**”). The information contained in this announcement is a preliminary assessment made by the Board based on the latest management accounts of the Group which have not been audited or reviewed by the independent auditors of the Company. The actual results of the Group for the six months ended 30 June 2016 may be different from what is disclosed in this announcement. Shareholders and potential investors are advised to read the Company’s announcement of the 2016 Interim Results carefully, which is expected to be published before the end of August 2016.
