(1) With effect from 3 June 2017, the conversion price of the Convertible Bonds due 2018 was adjusted from HK\$1.80 per share to HK\$1.77 per share as a result of the declaration of the final dividend of HK3.20 cents per share for the year ended 31 December 2016. Accordingly, the number of new shares which may be issued upon fully conversion of the outstanding convertible bonds based on the outstanding principal amount of HK\$447,000,000 was adjusted from 248,333,335 shares to 252,542,372 shares after the adjustment. For details, please refer to the announcement dated 2 June 2017 of the Company.
