



(1) With effect from 14 September 2017, the conversion price of the Convertible Bonds due 2018 was adjusted from HK\$1.77 per share to HK\$1.75 per share as a result of the declaration of the interim dividend of HK1.60 cents per share for the six months ended 30 June 2017. Accordingly, the number of new shares which may be issued upon fully conversion of the outstanding convertible bonds based on the outstanding principal amount of HK\$447,000,000 was adjusted from 252,542,372 shares to 255,428,571 shares after the adjustment. For details, please refer to the announcement dated 14 September 2017 of the Company.
