This announcement is made by the Board pursuant to Rule 13.09(2)(a) of the Listing Rules and Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the SFO.

Reference is made to the announcement of the Company dated 9 February 2015 in relation to the exit of CTS Tycoon Golf Course, the Company's 2014 Annual Report published on 16 April 2015, each of the 2015, 2016 Interim Report and Annual Report published by the Company on 4 September 2015, 19 April 2016, 2 September 2016 and 19 April 2017, respectively, and the Company's 2017 Interim Report published on 14 September 2017.

The Board announces that on 30 October 2017, the Bao'an District Government of Shenzhen, the PRC (the "**District Government**") issued a reminder (the "**Notice**") to CTS Tycoon (Shenzhen) Golf Club, a wholly-owned subsidiary of the Company, and demanded it to close down the CTS Tycoon Golf Course and related facilities which was built in the drinking water source protection zone in Tiegang reservoir, within ten days from the issue date of the Notice. On 1 November 2017, CTS Tycoon (Shenzhen) Golf Club issued notices to all its club members, informing that the business of CTS Tycoon Golf Course will be closed on 6 November 2017.

The settling arrangements for club members and employees of CTS Tycoon (Shenzhen) Golf Club will be carried out steadily as planned. The Company has undertaken various negotiations with the District Government in respect of the exit of the CTS Tycoon Golf Course and the transformation and development of CTS Tycoon (Shenzhen) Golf Club, and has made initial achievements. The relevant plan is still in the implementation stage. The Company preliminarily assess that no financial loss would be incurred as a result, and could take this as an opportunity for further development in Shenzhen.

The relevant plan is still in the implementation stage, Shareholders and public investors are advised to exercise caution when dealing in the shares of the Company.
