On January 8, 2018, the Company entered into the Purchase Agreement with Goldman Sachs, Haitong International, Morgan Stanley, HSBC and Citigroup in connection with the issue of US\$300,000,000 3.90% senior notes due 2023 and US\$500,000,000 4.50% senior notes due 2028.

The estimated gross proceeds of the Notes Issue will amount to approximately US\$798.1 million. The Company expects that the proceeds from the Notes Issue will be used for refinancing, in accordance with the approval that the Company obtained from the PRC National Development and Reform Commission on October 24, 2017.

Approval in-principle has been obtained for listing of the Notes on the SGX-ST.
