Application has been made by the Company to the Listing Committee of the Stock Exchange for the listing of, and permission to deal in, the Shares in issue and to be issued pursuant to the Share Offer (including any additional Shares which may be issued pursuant to the Capitalisation Issue and the exercise of any options which may be granted under the Share Option Scheme).

The Share Offer comprises (a) the Public Offer of initially 46,000,000 new Shares (subject to reallocation), representing 10% of the total number of Offer Shares initially available under the Share Offer, and (b) the Placing of initially 414,000,000 Shares (comprising 276,000,000 new Shares offered by the Company and 138,000,000 Sales Shares offered by the Vendor) (subject to reallocation), representing 90% of the total number of Offer Shares initially available under the Share Offer. The allocation of the Offer Shares between the Public Offer and the Placing will be subject to reallocation as described in the section headed “Structure and Conditions of the Share Offer” in the Prospectus.

Subject to the granting of the approval by the Stock Exchange for the listing of, and permission to deal in, the Shares on the Main Board and compliance with the stock admission requirements of HKSCC, the Shares will be accepted as eligible securities by HKSCC for deposit, clearance and settlement in CCASS with effect from the Listing Date or on any other date as determined by HKSCC. Settlement of transactions between participants of the Stock Exchange is required to take place in CCASS on the second Business Day after any trading day. All activities under CCASS are subject to the General Rules of CCASS and CCASS Operational Procedures in effect from time to time. All necessary arrangements have been made to enable the Shares to be admitted into CCASS.

The Offer Price is expected to be determined by agreement between our Company (for itself and on behalf of the Vendor) and Wealth Link (for itself and on behalf of the Joint Lead Managers and the Underwriters) on the Price Determination Date. The Price Determination Date is expected to be on or around Tuesday, 6 February 2018 and, in any event, not later than Friday, 9 February 2018. If, for any reason, the Offer Price is not agreed between Wealth Link (for itself and on behalf of the Joint Lead Managers and the Underwriters) and our Company (for itself and on behalf of the Vendor) by Friday, 9 February 2018, the Share Offer will not proceed and will lapse.
