**ANNOUNCEMENT IN RELATION TO

IN THE PRC BY SHANGHAI YONGDA INVESTMENT

A WHOLLY-OWNED SUBSIDIARY OF THE COMPANY**

This is a voluntary announcement made by China Yongda Automobiles Services Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”).

Reference is made to the announcement of the Company dated 9 March 2017 (the “**Announcement**”) in relation to the issue of Super Short-term Commercial Papers by 上海永達投資控股集團有限公司 (Shanghai Yongda Investment Holdings Group Co., Ltd.*), a wholly-owned subsidiary of the Company incorporated in the PRC. Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Announcement.

The Board is pleased to announce that the Issuer has completed the issue of the second tranche of the Super Short-term Commercial Papers of 2018 in the PRC on 10 April 2018. The aggregate principal amount of the second tranche Super Short-term Commercial Papers of 2018 is RMB0.5 billion, at the interest rate of 6.5% per annum, and with a term of 250 days. Both the par value and the issuing price of the second tranche Super Short-term Commercial Papers of 2018 are RMB100 per unit.

The net proceeds from the issue of the second tranche Super Short-term Commercial Papers of 2018 are intended to be used for repayment of existing debts of the Issuer.

In accordance with the relevant laws and regulations in the PRC, the relevant documents in relation to the Issuer and the second tranche Super Short-term Commercial Papers of 2018 will be published on the websites of Shanghai Clearing House (<http://www.shclearing.com>) and China Money (www.chinamoney.com.cn).
