## **ANNOUNCEMENT POWER GENERATION FOR JUNE 2018**

The announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited\* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for June 2018 on a consolidated basis amounted to 3,400,353 MWh, representing an increase of 10.94% compared with the corresponding period of 2017. In particular, the wind power generation registered an increase of 15.81%, the coal power generation registered a decrease of 0.41% and other renewable energy power generation registered a decrease of 28.97%. As of 30 June 2018, the total power generation of the Group for 2018 amounted to 25,830,203 MWh, representing an increase of 13.63% compared with the corresponding period of 2017. In particular, the wind power generation registered an increase of 21.55%, the coal power generation registered a decrease of 9.96%, and other renewable energy power generation registered a decrease of 19.00%.
