BUSINESS REVIEW

For the year ended 31st March, 2018, UBA Investments Limited and its subsidiaries (the "Group") recorded a loss attributable to equity holders of approximately HK\$21.5 million (2017: profit of HK\$4.8 million) of which a HK23.4 million unrealized loss (2017: unrealized profit of HK\$8.1 million) in relation to the financial assets at fair value through profit or loss. The loss per share was HK\$0.0203 (2017: profit per share of HK\$0.0046). Gross proceeds from disposal of trading securities significantly decreased 56% from HK\$286 million to HK\$125 million as the Group have to focus more on unlisted shares investments which expecting to bring better returns than trading in listed securities based on historical record. Therefore, it is not in line with the increasing transaction volume of 56% in Hang Seng Index comparing with last year. There was no impairment loss for the year (2017: loss of HK\$3.5 million) and the Group recorded a loss was mainly due to the unrealized loss on financial assets at fair value through profit or loss as stated above.

As at 31st March, 2018, the net assets of the Group were approximately HK\$146.3 million (2017: HK\$170.9 million). The net assets decreased by 14.4% when compared with last year, which is opposite to the Hang Seng Index ("HSI") increase during the year.

During the year, the global and local equity markets had experienced intense volatility. The Group's proactive investment strategy was to maximize profit for shareholders during this period and through investments in listed securities with relatively high yield and high stability, especially the bank and telecommunication sectors which contributed around HK\$76.5 million turnover and HK\$2.5 million dividend, also the dividend from unlisted shares also contributed around HK1.67 million to the Group during the year.

As at 31st March, 2018, the Group's investment portfolio was well diversified and comprised of different sectors of businesses including telecommunications, retail businesses, properties and manufacturing, etc, in which the available-for-sales financial assets and financial assets at fair value through profit or loss totaled approximately HK\$28 million and HK\$105 million respectively (2017: HK\$28 million and HK\$126 million respectively). For available-for-sales financial assets during the year, there was no further investment of listed securities but an increase in the investment of unlisted shares of HK\$2.9 million. The Group expected this unlisted investment may have high potential to become listed securities in the future.

業務回顧

開明投資有限公司及其附屬公司(「本集團」)截 至二零一八年三月三十一日年度止,本集團權益 持有人應佔虧損約為21,500,000港元(二零一七 年:溢利4,800,000港元),其中關於按公平值於 損益賬列賬之財務資產未變現虧損為23,400,000 港元(二零一七年:未變現溢利8,100,000港元)。 每股虧損為0.0203港元(二零一十年:每股溢利 0.0046港元)。出售交易證券的所得款項總額由 286,000,000港元下跌56%至125,000,000港元, 是因為本集團集中投資非上市股本證券,根據經 驗此等非上市股本證券較上市股票交易更能為本 集團帶來更好回報。因此這與恆生指數(「恆指」) 去年上升約56%的交易量相比不一致。本年度沒 有減值虧損(二零一七年:3,500,000港元),及 本集團錄得虧損主要來自上述按公平值於損益賬 列賬之財務資產未變現虧損。

本集團於二零一八年三月三十一日之資產淨值為 146,300,000港元(二零一七年:170,900,000港元)。資產淨值與去年比較下跌為14.4%,此與 本年上升之恆指相反。

在相應期間,全球及本地股票市場經歷了劇烈的波動。本集團本期間的積極投資策略為股東把利潤最大化,並主要投資於收益率及穩定性相對較高的證券,尤其是銀行及電訊板塊,共為本集團提供本年度的營業額及股息收入分別約76,500,000港元及2,500,000港元,其投資非上市股本證券股息收入亦佔約1,670,000港元。

於二零一八年三月三十一日,本集團之投資組合頗多元化,其中包括電訊服務、零售、地產及製造業等不同業務。當中可供出售財務資產及按公平值於損益賬列賬之財務資產分別為28,000,000港元及105,000,000港元(二零一七年:分別為28,000,000港元及126,000,000港元)。本年度並沒有新增上市之可供出售財務資產但非上市股本證券則新增2,900,000港元。本集團預計此非上市股本證券將來可上市機會頗高。

During the corresponding period, the global and local equity markets had experienced intense volatility like roller coaster, especially 10-month rally in global stock markets that peaked in January 2018 have been followed by an around 10% correction afterward to the end of March 2018. Such volatilities were mainly due to uncertainties around the financial world, starting with the Federal Reserve (the "Fed") decisions on rate hikes then good economic data in U.S., the tax reform in U.S., the valuation of RMB going strong and stable political scene in PRC, but also affected by the economic red flags overseas including the escalating trade war between the U.S. and China, the valuation of U.S. dollar become weak in 2018.

在相應期間,全球及本地股票市場經歷了劇烈的波動,一如像坐過山車般起伏不定。尤其是全球股市長達10個月的反彈並於二零一八年一月份達到頂峰,及後於二零一八年三月份回調約10%。這些波動主要是緣於世界各地的許多不確定因素,先是由美國聯邦儲備局(「聯儲局」)會議決定加息及期間良好經濟數據、美國的稅務改革方案、人民幣價值強勢以及其政治穩定所致。但亦有許多海外經濟的警號,當中包括於二零一八年美國與和中國之間的可能貿易戰不斷升溫及美元價值轉弱。

In the first half of 2017, the U.S. stock market was supported by good economic data, with low inflation and stabilizing force of strong earnings growth. In addition, the persistently low interest rates and no further rate hike as of at the end of third guarter by the Fed, the U.S. equity market has advanced in recent months to yet another string of all-time highs. Although the Fed announced in September 2017 to start its balance sheet normalization process in October, from a balance sheet drawdown of around \$10 billion per month, possibly up to around \$50 billion per month if the conditions warrant in the future and finally led U.S. to increase 0.25% interest rate in December 2017. The framework of this process is consistent with the expectation of market participants who viewed the process to be very slow and uneventful, so these negative effect is immaterial to the overall market. Thereafter, a new tax system proposed by U.S. President Donald Trump was passed and implemented after the December 2017 ruling, which was the largest tax reform over recent years in U.S.. Under the new tax system, the corporate tax rate decreased from 35% to 21% and the individual tax rate decreased from 39.6% to 37% which the U.S. corporation can reduce their tax liabilities and made improvement in their performance. As well as U.S. will become more competitive and attractive in relation to the world which lead to a repatriation of sizable amounts of cash by US and overseas corporations which stimulus the U.S. economy. Therefore, the Dow Jones Index rose 28.8% from 20,663 at end of March 2017 to the record high 26,616 at the end of January 2018. However, the stock market started to drop in February 2018 as more usage of the artificial intelligence stock trading programme ("A. I.") starting to lead a high fluctuation in the stock market. In addition, President Trump proposed \$50 billion U.S. tariffs on Chinese goods which include large aircrafts, electric vehicles and robots leading a possible trade war between China and U.S., together with the Fed increased interest rate of 0.25% again in March 2018 and the valuation of greenback became weak. The Dow Jones Index dropped 9.4% from its peak to 24,103 at the end of March 2018.

二零一七年上半年,美國股市得到良好的經濟數 據、通貨膨脹率低以及企業盈利增長強勁所支 持。加上聯儲局持續低利率及直至第三季度末暫 緩加息,致使美國股市近月再次上升至歷史新 高。雖然聯儲局在二零一七年九月宣布將於十月 份開始縮減資產負債表,從每月開始縮減約100 億美元資產負債表,直至將來如條件許可下增至 每月縮減約500億美元,而此舉會導致美國於二 零一十年十二月加息0.25%。幸好,這個縮表的 框架與市場參與者的期望一致,並且預期這個 過程可能非常緩慢甚至停止,所以這種負面影 響對於整體市場來說是無關重要的。再者,美國 總統唐納德●特朗普(「特朗普」)於於二零一七 年十二月提出新税制獲得通過並實施,這是近 年來美國最大的税制改革。在新税制下,公司税 率從35%下降到21%,個人所得稅稅率從39.6% 下降到37%,此舉可減少美國公司稅務負擔並改 善其業績。美國亦在全球變得更具競爭力和吸引 力,導緻美國和海外公司大量現金回流,刺激美 國本地經濟。因此,道瓊斯指數從二零一七年三 月底的20,663上漲約28.8%至二零一八年一月底 的26,616。然而,隨著更多使用人工智能股票交 易(「A.I.」)炒作開始導致股市大幅波動,股市在 二零一八年二月開始下跌。此外總統特朗普亦於 三月提議對中國商品徵收500億美元的關稅,其 中包括大型飛機,電動汽車和機器人,引發中美 之間的可能貿易戰。而聯儲局亦於二零一八年三 月再次加息0.25%, 連同美元疲弱, 導致道瓊斯 指數從高位下跌約9.4%至二零一八年三月底的 24.103 °

On the other side, the China stock market sentiment was similar to the US and European markets. The metrics such as Chinese GDP and the China Purchasing Manufacturing Managers' Index ("PMI") reaching the record high at 52.4 at the end of September 2017 gave the impression that things are going well in the first half of 2017. The GDP maintained at 6.9% for the year ended 2017 and the expectation on the A-shares entering into MSCI in June 2018, as well as the value of RMB become stronger since January 2018 has stimulated the Shanghai Composite Index to rise 11.3% from 3.222 at end of March 2017 to 3.586 at the end of January 2018. However, the action from U.S. for imposing tariffs on Chinese goods led the Chinese government to take revenge and proposed to increase duties on over 100 U.S. goods. As a result, the China stock market sentiment was being affected by this and together with the tightening monetary policies and enhancing the risk management on equities and debts by the Chinese government may have negative impact, the Shanghai Composite Index dropped 11.7% to 3.168 at the end of March 2018.

Back to the Hong Kong Stock Market, which was highly sensitive to the news of the global economy, especially the effect from U.S. and China factors. Excellent stock market sentiment from PRC and the positive effect of Shanghai-Hong Kong Stock Connect Programme and Shenzhen-Hong Kong Stock Connect Programme attracted more capital inflow to Hong Kong and China in 2017. Together with the weak U.S. dollar and strong RMB which led more fund inflow to Hong Kong equity market as well in early 2018. As a result of these good impacts, the HSI increased 38.9% from 24,111 in March 2017 to 33,484 at the end of January 2018. However, being the control by A.I. in U.S. equity market, the atmosphere of the potential to start trade war between U.S. and China since February 2018 together with the increase in interest rate again in U.S. These negative news led the HSI dropped around of 10.1% to 30,093 at end of March 2018.

另一方面,與此同時,中國股市氣氛與歐美市場 相若。二零一七年上半季中國國內生產總值及中 國製造業採購經理人指數(「PMII)等指標令人眼 前一亮,於二零一七年九月底的PMI為52.4,為 有紀錄之高位。而國內生產總值增長於二零一七 年年底約在6.9%水平及憧憬中國A股將於二零 一八年六月納入MSCI,加上於二零一八年一月 份人民幣估值仍然強勁並刺激上海綜合指數從二 零一十年三月底的3.222 上漲11.3%至二零一八年 一月底的3,586。然而,美國對中國商品徵收關 税的行動導致中國政府進行報復,並建議增加對 100多種美國商品的關税。因此,中國股市氣氛 受此影響,以及中國政府收緊貨幣政策,並加強 對股票和債務的風險管理有可能帶來負面影響, 上海綜合指數因此下跌11.7%至二零一八年三月 底的3.168。

至於香港股票市場,其對環球經濟形勢十分敏感,尤其是來自美國及中國的消息。二零一七年中國股票市場良好氣氛及滬港股票市場交易互聯互通及深港股票市場交易互聯互通等機制程正面影響,吸引更多資金流入本港及中國股票市場。加上二零一八年初美元疲弱及人民幣強勢亦導等,恆指由二零一七年三月底的24,111上升38.9%至二零一八年一月底的33,484。但是,自二零一八年二月起由於人工智能股票交易在美國股票市場炒作、美國與和中國潛在貿易戰的氣氛及美國股件、美國與和中國潛在貿易戰的氣氛及美國股票市場的的影響下,這些負面消息導致恆指下跌約10.1%至二零一八年三月底的30,093。

PROSPECTS

With the expectation of at least 3 times interest rate hike by the Fed in the year of 2018 and in the escalating potential trade war between the U.S. and China, we expect the global stock markets to be full of challenges in the coming few months. Especially, the Hong Kong Monetary Authority ("HKMA") triggered of the weak-side Convertibility Undertaking ("CU") at 7.85 in April 2018, which was the first time after CU introduced by HKMA since May 2005. Under CU, HKMA will buy Hong Kong Dollar and sell U.S. Dollar at 7.85 level to ensure that the HKD exchange rate will not weaken beyond 7.85 and will reduce the balance of the reserve in banking system. Together with the effect of 2 to 3 times interest rate hike more in U.S. in 2018, it will lead the upward pressure on gradually increase of the interest rate in Hong Kong. In addition, we also remain cautious of the impact on the potential trade war between the U.S. and China until the trade tantrum on tariffs is resolved. On the flip side, the expansion of daily quota under Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect will further enhance the smoothness and certainty of trading, and help ensure that the process for the inclusion of A-shares in the MSCI Emerging Markets Index this year which may bring positive effect to both Hong Kong and China equity markets.

The Group remains cautiously optimistic about the outlook of the global and Hong Kong equity markets. We will seek and evaluate good investment opportunities to enrich our investment portfolios. We will invest in more unlisted equity securities with good potential to be listed is our future business decisions by building on our successful experience in the past. We will also continue to adopt and maintain a cautious and pragmatic investment approach in order to bring better returns for our shareholders.

前景

隨著預期聯儲局將於二零一八年內加息3次及美 國與和中國之間的可能貿易戰不斷升溫下,我們 預期未來數月仍充滿挑戰。尤其香港金融管理局 (「金管局」)於二零一八年四月首次觸發自二零零 五年五月引入的7.85的弱方兑换保證(「弱方兑换 保證」)。根據弱方兑換保證,金管局將會在7.85 水平買港元沽美元,保證港元不會弱於7.85並會 降低銀行體系結餘,再加上二零一八年美國將 會加息2-3次的影響,勢將導致香港息率逐漸上 升。此外,我們對中美之間潛在貿易戰的影響仍 保持謹慎態度,直至關税的貿易發展趨於穩定。 另一方面,擴大滬港股票市場交易互聯互通機制 及深港股票市場交易互聯互通機制每日額度將進 一步提升交易的流暢度和確定性,亦有助確保中 國A股於今年納入MSCI的過程順利為本港及中國 股票市場帶來正面影響。

本集團對全球及香港股票市場的前景仍保持審 慎樂觀的態度。我們將尋求及評估投資良機,以 優化我們的投資組合,尤其是基於以往的成功經 驗。我們將會於未來的業務發展投資更多有上市 潛力的非上市股本證券。同時我們將繼續採取及 保持謹慎和務實的投資方針,為我們的股東帶來 更好的回報。

FINANCIAL REVIEW

Liquidity and financial resources

As at 31st March, 2018, the Group had bank balances and cash of HK\$10,532,557 (2017: HK\$12,539,728). The Board believes that the Group has sufficient financial resources to satisfy its commitments and working capital requirements.

As at 31st March, 2018, none of listed equity securities of the Group had been pledged to secure margin facilities and loans granted by a related company.

Gearing ratio

Gearing ratio had not been presented (2017: Nil) as there was no debt as at 31st March, 2018 (2017: HK\$Nil).

Dividend

The Board has resolved not to recommend any payment of final dividend

Capital structure

There was no change to the Group's capital structure for the year ended 31st March, 2018.

Capital commitment and contingent liabilities

As at 31st March, 2018, the Group has capital commitment of approximately HK\$7 million (2017: HK\$10 million) for long term equity investment and no contingent liabilities.

Material Acquisition and Disposal

During the year, the Group had not made any material acquisition or disposal of subsidiaries and associates.

Exposure to foreign currency fluctuation and related hedges

The Board believes that the foreign exchange risk is minimal as the Group mainly uses Hong Kong dollars to carry out its business transactions. Therefore, there was no material foreign exchange exposure to the Group.

Employment and remuneration policies

As at 31st March, 2018, the Group employed a total of 3 full-time employees (2017: 3), including the executive directors of the Group. Employees' remuneration are fixed and determined with reference to the market rate.

Share options

The Company does not have share option scheme.

Sound corporate governance practices are crucial to the smooth, effective and transparent operation of a company and its ability to attract investment, protect rights of shareholders and stakeholders, and enhance shareholder value. The Company is committed to high standards of corporate governance with a view to being transparent, open and accountable to our shareholders.

This report describes the Company's corporate governance practices and structures that were in place during the financial year ended 31st March, 2018, with specific reference to the principles and guidelines of the Corporate Governance Code (the "CG Code") as set out in Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") issued by The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). In developing and reviewing its corporate governance policies and practices, the Company has sought to adopt a balanced approach.

COMPLIANCE WITH CORPORATE GOVERNANCE CODE

The Company complied with the code provisions as set out in the Code contained in Appendix 14 to the Listing Rules throughout year ended 31st March, 2018, except for the following.

Code Provision A.4.1

Under the code provision A.4.1, non-executive directors should be appointed for a specific term and subject to re-election. None of the independent non-executive directors of the Company were appointed for a specific term. None of the non-executive directors has entered or proposed to enter into any service contracts with the Company or its subsidiaries. But all directors of the Company are subject to the retirement by rotation according to the provisions under article 157 of the Articles of Association of the Company. As such, the Board considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the CG Code.

CORPORATE GOVERNANCE PRACTICE

With the assistance of the Compliance Department, the Board has designed a proper corporate governance structure. Currently, there are three board committees, including Audit Committee, Remuneration Committee and Nomination Committee. Audit Committee, Remuneration Committee and Nomination Committee perform their distinct roles in accordance with their respective terms of reference.

The Company has three independent non-executive directors, they are Mr. CHAN Chung Yee, Alan, Dr. FUNG Lewis Hung and Mr. TANG Hon Bui, Ronald. One of whom namely, Mr. CHAN Chung Yee, Alan has appropriate professional accounting experience and expertise.

All directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. The biographical details of each director are disclosed in page 13 to page 14 of this Annual Report.

Each independent non-executive director has pursuant to the Rule 3.13 of the Listing Rules, confirmed that he is independent of the Company and the Company also considers that they are independent.

The Company has adopted the Model Code set out in Appendix 10 of the Listing Rules as the code of conduct regarding securities transaction by the directors (the "Model Code"). Having made specific enquiry of all directors, the Company confirmed that all directors have complied with the required standards as set out in the Model Code during the year.

There is no relationship (including financial, business, family or other material relationship) among members of the Board.

The Company adopted a Board Diversity Policy (the "Diversity Policy") which became effective in September 2013. This Diversity Policy aims to set out the approach to achieve diversity on the Company's Board of Directors. All Board appointments are based on merits, and have paid due regard for the benefits of diversity on the Board in selecting candidates.

Pursuant to the Articles of Association of the Company, the directors shall hold office subject to retirement by rotation at the annual general meeting of the Company at least once every three years and eligible for re-election.

Function

The Board of Directors, headed by the Chairman, is responsible for formulation and approval of the Group's development and business strategies and policies, approval of annual budgets and business plans, recommendation of dividend, and supervision of management in accordance with the rules governing the meeting of the Board of Directors, the Managing Director's working guides, articles of association and rules governing the meeting of shareholders.

The executive directors are responsible for day-to-day management of the Company's operations. These executive directors conduct regular meetings with the senior management of the Company and its subsidiaries and associated companies, at which operational issues and financial performance are evaluated.

The Company considers well-developed and timely reporting systems and internal controls are essential, and the Board of Directors plays a key role in the implementation and monitoring of internal financial controls.

The Board of Directors has established procedure to enable directors, upon reasonable request, to seek independent professional advice in appropriate circumstances, at the Company's expenses.

The Articles of Association of the Company contain description of responsibilities and operation procedures of the Board of Directors. The Board of Directors holds regular meeting and listens to the operating reports of the Company and makes policies. Significant operating policies of the Company have to be discussed and passed by the Board of Directors. Board meetings include regular meetings and irregular meetings. The Board of Directors meets formally at least 4 times a year.

Besides regular and irregular meetings, the Board of Directors obtains adequate information through working meetings, presided by the Chairman in a timely manner, to monitor objectives and strategies of the management, financial conditions and operating results of the Company and provisions of significant agreements.

Chairman and Managing Director

The roles of the Chairman and the Managing Director are segregated and assumed by two separate individuals who have no relationship with each other to strike a balance of power and authority so that the job responsibilities are not concentrated on any one individual.

The Chairman of the Board is responsible for the leadership and effective running of the Board. The Chairman is also responsible for deciding the agenda of each Board meeting, taking into account, where appropriate, matters proposed by other directors for inclusion in the agenda.

The Managing Director is delegated with the authorities to manage the Group's business in all aspects effectively, implement major strategies, make day-to-day decision and coordinate overall business operation.

- Reviewing of the effectiveness of the risk management and internal control systems of the Company through the Audit Committee.
- Monitoring and managing potential conflicts of interest of management, Board members and shareholders, including misuse of corporate assets and abuse in related party transaction.
- Ensuring processes are in place to maintain the overall integrity of the Company, including financial statements, and relationship with other stakeholders, and compliance with all laws and ethics.

To enable the Company's directors to meet their obligations, an appropriate organizational structure is in place with clearly defined responsibilities and limits of authority.

Board Committees

A number of Board Committees, including Audit Committee, Remuneration Committee and Nomination Committee, have been established by the Board of Directors to strengthen its functions and to enhance its expertise. These committees have been formed with specific written terms of reference which is available on the Company's website set out details of the Committee's duties, powers and functions.

INTERNAL CONTROL AND RISK MANAGEMENT

It is the responsibility of the Board to ensure that the Company maintains sound and effective risk management and internal control systems to safeguard the Shareholders' investment and the Group's assets at all times. The Audit Committee assists the Board in fulfilling its corporate governance roles in the Group's financial, operational, compliance, risk management and internal controls, and the resourcing of the finance and internal audit functions

The Board has established an on-going process for identifying, evaluating and managing the significant risks faced by the Group and this process includes updating the system of internal controls when there are changes to business environment or regulatory guidelines.

The Board is of the view that the system of internal controls in place for the year under review and up to the date of issuance of the annual report and consolidated financial statements is sound and is sufficient to safeguard the interests of shareholders and employees, and the Group's assets.

The investment manager assists the Board in the implementation of the board's policies and procedures on risk and control by identifying and assessing the risks faced, and involving in the design, operation and monitoring of suitable internal controls to mitigate and control these risks.

The key processes that have been established in reviewing the adequacy and integrity of the system of internal controls include the following:

- The Executive Board is responsible to ensure the effectiveness of the daily operations and that the operations are in accordance with the corporate objectives and strategies.
- The Audit Committee of the Company reviews internal control issues identified by external auditors, regulatory authorities and management, and evaluates the adequacy and effectiveness of the Group's risk management and internal control systems.

COMPANY SECRETARY

The Company Secretary reports to the Directors of the Company and is responsible for advising the Board on governance matters. According to the Rule 3.29 of the Listing Rules, the Company Secretary has taken not less than 15 hours of relevant professional training during the year.

DISSEMINATION OF INSIDE INFORMATION

The Board ensures the inside information is kept strictly confidential until the relevant announcement is made. The Directors are not aware of any significant areas which need to be brought to the attention of the Shareholders.

Finance

The Company's assets were used in an appropriate manner, the expenditures in each of the operating units of the Group were under a strict control, expenditures exceeding certain predetermined amounts needed management's authorisation. Accounting records were properly maintained. The allocation of resources and manpower in performing accounting and financial reporting function are adequate to comply with the requirement of Listing Rules.

Operation

A hierarchical system with proper work flow and reporting procedures was duly established in each of the operating units. Every employee was assigned with a specific area of duty and responsibility.

Regular meetings with the attendance of senior management and representatives from each of the operating units were held during the year so as to improve communication and identify potential issues within the Group.

SHAREHOLDER AND INVESTORS COMMUNICATION

The objective of shareholder communication is to provide our shareholders with detailed information about the Company so that they can exercise their rights as shareholders in an informed manner.

The Company uses a range of communication tools to ensure its shareholders are kept well informed of key business imperatives. These include annual general meeting, annual report, various notices, announcements and circulars. All resolutions put forward at a shareholders meeting will be taken by poll pursuant to the Listing Rules and the poll results will be posted on the websites of the Company and of the Stock Exchange after the shareholders meeting.

An annual general meeting ("AGM") held on 18th August, 2017, the Chairman of the Board and the representative of external auditors was available to answer questions at the meeting. The chairman of the meeting had explained the procedures of conducting a poll during the meeting. All resolutions were proposed by the Chairman at the meeting and voted separately by way of poll. All the votes cast at the said meeting were properly counted and recorded.

SHAREHOLDER'S RIGHT

Way to Convene an Extraordinary General Meeting

Pursuant to Article 89 of the Articles of Association of the Company, general meetings shall also be convened on the written requisition of any two or more members of the Company deposited at the principal office of the Company in Hong Kong or, in the event the Company ceases to have such a principal office, the registered office specifying the objects of the meeting and signed by the requisitionists, provided that such requisitionists held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company. UBA Investments Limited (the "Company") is an investment company and principally engages in investments in a diversified portfolio of listed and unlisted companies. As an investment company, the Company does not directly participate in the production and operation of its subsidiaries. While actively seeking to optimise its investment portfolio and maximise shareholder return, the Company lives up to its corporate social responsibility and strikes a balance between the interests of stakeholders such as the shareholders and the community, with the ultimate goal of achieving a sustainable corporation.

In accordance with the requirements of Appendix 27 to the Listing Rules, the Company hereby presents its environmental, social and governance report for the year ended 31st March, 2018.

A. ENVIRONMENTAL

Emissions, Use of Resources and Environment and Natural Resources

The Group operates in the investment field and it's operation is mainly office-based and the Group is committed to minimising the impact of businesses on the environment through adopting eco-friendly measures at the office.

The Group encourages employees to implement the following environmental initiatives:

- to reduce paper consumption by using duplex printing, reusing papers printed on one side and place for paper waste recycling;
- using electronic storage and communication wherever possible;
- setting air-conditioning temperature at 25 degree in summer whenever possible to energy saving;
- to switch off lights and air-conditioning in the meeting room and the computer at the workstation when not in use; and
- Conference calls instead of face-to-face meetings are arranged where possible.

In view of the business nature, the Group's operations do not directly involve the use of natural resources as the Group do not involve in any industrial process nor use any motor vehicles. Hence there had been no direct emission relation to air pollutants and greenhouse gases ("GHG"), no discharges into water and land (Scope 1 as below table). The main emissions

The Company also believes that its business operations have minimal direct impact on the environment.

Electricity

The electricity consumed by the Group was mainly used in the office during its normal business operation and supplied by The Hong Kong Electric Co., Ltd. During the Year, the Group has consumed 16,624 kWh of electricity with a monthly average usage of 1,385 kWh and 5,541 kWh per person, which producing $\rm CO_2$ equivalent emissions of approximately 13,133 kg. These consumption of the electricity was mainly attributable by the use of air-conditioning in the office.

Water

There is no direct water supply to the office apart from water uses/affluent discharges at shared facilities of the office building. Water consumption by the Group for the year involved mainly bottled drinking water uses at its offices premises and the Group's business operations do not require any other water usage. The Group's office utilised a total of approximately 24 bottles of drinking water with total of 454 Liter, an average 2 bottles drinking water per month during the year.

Paper

The Company encourages employees to reduce paper consumption by using duplex printing, reusing papers printed on one side and place for paper waste recycling, also using electronic storage and communication wherever possible. During the year, the Group used a total of approximately 7.5 kg of paper in its normal office operations for printing documents and the total CO_2 equivalent emissions for the paper used was approximately 36 kg.

B. SOCIAL

Employment

Employees is the most valuable asset to the Group. It is the policy of the Group to employ person which is suitable to the position with equal opportunity (non-discrimination against gender, marital status, disability, age, race, family status, sexual orientation, nationality and religion). Competitive remuneration package will be provided for the employees. The Group is in full compliance with relevant employment laws and regulation just like the "Employment Ordinance" (Chapter 57), "Minimum Wage Ordinance" (Chapter 608), "Sex Discrimination Ordinance" (Chapter 480), "Mandatory Provident Fund Schemes Ordinance" (Chapter 487) and "Race Discrimination Ordinance" (Chapter 602), etc. The Group is not aware of any non-compliance in relation to employment laws and regulations during the Reporting Period.

用電

本公司鼓勵僱員減少用紙、多採用雙面列印、重用已經單面打印的紙張及設置地方回收廢紙,並在可行的情況下均以電子方式儲存資料及進行通訊。於本年度,本集團正常辦公室運作以列印文件為主使用紙張合共約7.5公斤,用紙的總二氧化碳當量排放約為36公斤。

B. 社會

僱傭

As at 31st March, 2018, we have 1 employee, 2 executive directors and 3 independent non-executive directors of the Company. All of our employees including directors are located in Hong Kong and no turnover during the period. By gender, 100% male. By age group, 50% and 50% between age group of 35 to 55 and over 55 respectively.

Health and Safety

The Group will provide a healthy and safety working environment to the employees. The Group has provided a guideline for work safety including environmental hygiene and cleanliness, machine operation, smoking ban and fire prevention, hazardous materials handling, arrangements in times of typhoons and rainstorms, as well as response to emergencies, etc. By offering opportunities for a flexible work arrangement, the Group also encourage our employees to maintain a healthy work-life balance.

The Group is in full compliance with the "Occupational Safety and Health Ordinance" (Chapter 509), and is not aware of any non-compliance with relevant laws and regulations in relation to health and safety working environment during the Reporting Period that have significant impact on the Group. During the period, there was no staff suffer work-related fatalities and injury.

Development and Training

On-the-job training and continuous professional development are important elements to enhance the industry knowledge of the employees of the Group. The Group provide relevant training opportunities to its employees from time to time and encourage employees to attend seminars by themselves for their own professional assertions which include Listing Rules and accountancy update which can boost the competence and efficiency of the employees and hence the Company's professionalism and performance. During the period, all staff participated in training and the average number of the hours spent on training per staff is more than 15 hours.

Labour standards

It is the policy of the Group to comply with the relevant laws and regulations which prohibit the employment of child and force labour.

The Group is not aware of any non-compliance with relevant rules and regulations on preventing child or forced labour during the Reporting Period.

During the period, the major office supplies are bottle of drinking water and printing paper which all suppliers were located in Hong Kong.

Product responsibility

The Group does not have products or services provided to customers and hence the product responsibility is not applicable to the Group.

Anti-corruption

The Group is committed to ensuring that no bribes, payment or advantages are solicited from or given or offered to any persons, whether in the public or private sector, for any purpose, which can ensure the strict adherence to the Prevention of Bribery Ordinance. The Group regard honesty, integrity and fair play as the core values that must be upheld by our colleagues at all times.

During the reporting period, the Group had no legal cases regarding corrupt practices brought against the Group or its employees.

Community investment

The Group encourages employees to contribute their time and efforts in participating in various local community activities and events.

The Group aiming at sponsor inmates and discharged prisoners events such as charity fundraising activities for assisting discharged prisoners organized by Christian Prison Pastoral Association Limited for the year 2018.

1. GENERAL

The UBA Investments Limited (the "Company") is a public limited company incorporated in the Cayman Islands with its shares listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The address of its registered office is P.O. Box 309, Ugland House, Grand Cayman, KY1-1104, Cayman Islands. The principal place of business of the Company is Flat B, 16th Floor, Wah Kit Commercial Centre, 300 Des Voeux Road Central, Hong Kong.

The Company and its subsidiaries (the "Group") are engaged in investment holding and trading of securities.

The consolidated financial statements are presented in Hong Kong dollars, which is the same as the functional currency of the Company.

2. NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS ("HKFRSs")

The Hong Kong Institute of Certified Public Accountants ("HKICPA") has issued a number of amendments to HKFRSs that are first effective for the current accounting period of the Group. None of these developments have had a material impact on the Group's results and financial position for the current or prior periods.

The directors anticipate that all of the pronouncements will be adopted in the Group's accounting policy for the first period beginning after the effective date of the pronouncement. The directors are currently assessing the impact of the new or amended HKFRSs upon initial application. So far, the directors have preliminarily concluded that the initial application of these HKFRSs will not result in material financial impact on the consolidated financial statements. Information on new or amended HKFRSs that are expected to have an impact on the Group's accounting policies is provided below.

HKFRS 9 Financial Instruments

HKFRS 9 will replace HKAS 39 Financial Instruments: Recognition and Measurement. HKFRS 9 introduces new requirements for classification and measurement of financial asset, new rules for hedge accounting and a new impairment model for financial assets.

Based on an analysis of the Group's financial assets and financial liabilities as at 31st March, 2018 on the basis of the facts and circumstances that exist at that date, the directors of the Company have assessed the impact of HKFRS 9 to the Group's consolidated financial statements as follows:

(a) Classification and measurement

HKFRS 9 contains three principal classification categories for financial assets: measured at amortised costs, fair value through profit or loss ("FVTPL") and fair value through other comprehensive income ("FVOCI"). Classification is driven by the entity's business model for managing the debt instruments and their contractual cash flow characteristics.

(a) Classification and measurement (continued)

Based on the preliminary assessment, the Group expects that investment currently measured at fair value through profit or loss will continue with their classification and measurements upon the adoption of HKFRS 9.

The financial assets held by the Group include listed and unlisted equity currently classified as available-for-sale financial assets at fair value and at cost less impairment. The Group has reviewed the intention and situation of each of the investment held as available-for-sale-financial assets and will reclassify these investments to measured at FVOCI in the coming year.

(b) Hedge accounting

The new hedge accounting rules will align the accounting for hedging instruments more closely with the Group's risk management practices. As a general rule, more hedge relationship might be eligible for hedge accounting, as the standard introduces a more principles-based approach. While the Group does not involve any hedging, it does not expect a significant impact on the accounting for its hedging relationships.

(c) Impairment

The new impairment model requires the recognition of impairment provision based on expected credit losses ("ECL") rather than only incurred credit losses as is the case under HKAS 39. It applies to financial assets classified at amortised cost, debt instruments measured at FVOCI, contract assets under HKFRS 15 Revenue from Contracts with Customers, lease receivables, loan commitments and certain financial guarantee contracts. Based on the assessments undertaken to date, the Group does not expect significant increase or decrease in the loss allowance for investment.

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented.

(a) Basis of preparation:

The consolidated financial statements have been prepared in accordance with HKFRSs which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the HKICPA, accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclose provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). The consolidated financial statements have been prepared under the historical cost convention except that certain available-for-sale financial assets and financial assets at fair value through profit or loss are stated at fair value and on the basis that the Group is a going concern.

(b) Basis of consolidation:

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31st March, 2018. The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date of acquisition, being the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases. All intra-group balances, transactions, unrealised gains and losses resulting from intra-group transactions and dividends are eliminated on consolidation in full.

(c) Property, plant and equipment:

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the assets to working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance and overhaul cost, is normally charged to the profit or loss in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of an item of property, plant and equipment, the expenditure is capitalised as an additional cost of the asset.

Depreciation is provided to write off the cost of property, plant and equipment over their estimated useful lives using the straight-line method. The annual rate used for furniture, fixtures and equipment is 20%.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continuing use of the asset. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is recognised in profit or loss in the year in which the item is derecognised.

(d) Subsidiaries:

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's statement of financial position, the investments in subsidiaries are stated at cost less impairment losses.

(e) Investments:

The Group classifies its investments in the following categories: loans and receivables, financial assets at fair value through profit or loss and available-forsale financial assets. The classification depends on the purpose for which the investments were acquired. Management determines the classification of its investments at initial recognition and re-evaluates this designation at every reporting date.

(i) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. At the end of each reporting period subsequent to initial recognition, loans and receivables are carried at amortised cost using the effective interest method, less any identified impairment losses. An impairment loss is recognised in profit or loss when there is objective evidence that the asset is impaired, and is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the original effective interest rate. Impairment losses are reversed in subsequent periods when an increase in the asset's recoverable amount can be related objectively to an event occurring after the impairment was recognised, subject to a restriction that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

(ii) Financial assets at fair value through profit or loss

At the end of each reporting period subsequent to initial recognition, financial assets at fair value through profit or loss are measured at fair value, with changes in fair value recognised directly in profit or loss in the period in which they arise. All derivatives financial assets are also categorised as financial assets at fair value through profit or loss unless they are designated as hedges.

Available-for-sale financial assets are nonderivatives that are either designated or not classified as any of the other categories (set out above).

After initial recognition, available-for-sale financial assets are subsequently measured at fair value, with unrealised gains or losses recognised as other comprehensive income in the fair value reserve until the investment is derecognised, at which time the cumulative gain or loss is recognised in the income statement, or until the investment is determined to be impaired, at which item the cumulative gain or loss is recognised in the income statement and removed from the fair value reserve.

When the fair value of unlisted equity securities cannot be reliably measured because (a) the variability in the range of reasonable fair value estimates is significant for that investment or (b) the probabilities of the various estimates within the range cannot be reasonably assessed and used in estimating fair value, such securities are stated at cost less any impairment losses.

(f) Impairment of assets:

At the end of each reporting period, the Group reviews the carrying amounts of its assets to determine whether there is any indication that those assets have suffered an impairment loss. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

In case of equity securities classified as available-forsale financial assets, a significant or prolonged decline in the fair value of the equity securities below their cost is considered in determining whether the securities are impaired. Impairment losses recognised in profit or loss on equity securities are not reversed through profit or loss.

(g) Cash and cash equivalents:

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short-term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

(h) Foreign currency translation:

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

(iii) Group companies

The results and financial position of all the Group's entities that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (a) assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (b) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the dates of the transactions); and
- (c) the resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange reserve.

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit as reported in income statement because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

(j) Provisions and contingent liabilities:

Provisions are recognised for liabilities of uncertain timing or amount when the Group or the Company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(k) Revenue recognition:

- (i) Sales of investments in equity securities and futures including available-for-sale financial assets and financial assets at fair value through profit or loss are recognised on a trade date basis when the risks and rewards of ownership are transferred and title has passed.
- (ii) Interest income is recognised as it accrues using the effective interest method.
- (iii) Dividend income from equity securities is recognised when the shareholders' rights to receive payment have been established.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

The Group participates a defined contribution mandatory provident fund scheme (the "MPF Scheme") which is available to all employees. Contributions to the MPF Scheme by the Group and its employees are calculated based on a percentage of employees' relevant income. The Group's contributions to the fund are incurred as expenses and the assets of the MPF Scheme are held separately from those of the Group in an independently administrated fund.

Payments to the Group's MPF Scheme are charged as expenses as they fall due.

5. CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The Group did not use any critical accounting estimates in the preparation of the consolidated financial statements.

In the process of applying the Group's accounting policies, management has made the following judgments, apart from those involving estimations, which have the most significant effect on the amounts recognised in the consolidated financial statements.

Impairment of unlisted available-for-sale financial assets

In determining whether there is any objective evidence that impairment has occurred on unlisted available-for-sale financial assets, the Group assesses periodically whether there has been a significant or prolonged decline in the carrying value of the investments below its cost or carrying amount, or whether other objective evidence of impairment exists based on the investee's financial conditions and business prospects, including industry outlook, technological changes as well as operating and financing cash flows. This requires a significant level of management judgment which would affect the amount of impairment losses.

6. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of equity reserves attributable to equity holders of the Company, comprising issued share capital, other reserves and retained profits.

The directors of the Company review the capital structure on a semi-annual basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors, the Group will balance its overall capital structure through the payment of dividends and new share issues.

The Group's major financial instruments comprise available-for-sale financial assets, amounts due from investee companies, amounts due from related companies, account receivable and deposits, financial assets at fair value through profit or loss, cash and bank balances and accruals.

The Group's activities expose it to a variety of financial risks: equity price risk, credit risk, liquidity risk, interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(i) Equity price risk

The Group are exposed to equity securities which are classified in the consolidated statement of financial position either as available-for-sale financial assets or financial assets at fair value through profit or loss. These are susceptible to equity price risk arising from uncertainties about the future prices of the instruments. The Group's equity price risk is managed through diversification of the investment portfolio ratios by exposures.

The Company and a subsidiary of Upbest Group Limited, (a) Upbest Assets Management Limited ("UAML") as investment manager, had entered into a Third Investment Management Agreement dated 26th January, 2016 and agreed that UAML provided investment management services to the Company for a period of three years from 1st April, 2016 to 31st March, 2019. This agreement can be terminated by either the Company or UAML serving not less than six months' notice in writing prior to the expiration. Pursuant to the investment management agreement, monthly investment management fee is payable at 1.5% per annum of the consolidated net asset value of the Group as at the immediately preceding valuation date on the actual number of days in the relevant calendar month over 365 days a year.

In addition to the management fee, a performance fee payable in Hong Kong dollars equivalent to 20% of net profit of the Group before taxation and before deduction of the investment management fee payable under the investment management agreements shall be paid to UAML for each financial year.

The annual cap for the management fee and performance fee for the financial years ended 31st March, 2018 and financial year ending 2019 are HK\$11,600,000 and HK\$13,300,000 (2017: HK\$10,100,000). These continuing connected transactions were approved on the extraordinary general meeting of the shareholders held on 24th August, 2016. There was no performance fee for the financial year ended 31st March, 2018 (2017: HK\$1,824,325) has been included under administrative and other operating expenses.

PCCW Limited ("PCCW")

PCCW is incorporated in Hong Kong and is principally engaged in the provision of telecommunication services, internet and multimedia services, sale and rental of equipment and technical services. Investment in and development of infrastructure, properties and technology-related business.
