- In the case of joint registered holders of any share, this revised form of proxy may be signed by any joint registered holder, but if more than one joint registered holder is present at the Meeting, whether in person or by proxy, that one of the joint registered holders whose name stands first on the register of members in respect of the relevant jointly registered share shall alone be entitled to vote in respect thereof to the exclusion of the votes of the other joint registered holders.
- This revised form of proxy must be signed by a shareholder, or his/her/its attorney duly authorised in writing, or if the shareholder is a corporation, either under its common seal or under the hand of an officer or attorney so authorised.
- To be valid, this revised form or proxy together with any power of attorney or other authority (if any) under which it is signed or a certified copy of such power or authority must be deposited at the principal share registrar and transfer office of the Company, Tricor Tengis Limited, at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong not later than 48 hours before the time of the Meeting or any adjournment thereof.
- Any alteration made to this revised form of proxy should be initialed by the person who signs the form.
- Completion and return of this revised form of proxy will not preclude you from attending and voting in person at the Meeting or any adjournment thereof if you so wish.
