## **CHARACTERISTICS OF THE GROWTH ENTERPRISE MARKET (“GEM”) OF THE STOCK EXCHANGE OF HONG KONG (THE “STOCK EXCHANGE”)**

**GEM has been positioned as a market designed to accommodate companies to which a higher investment risk may be attached than other companies listed on the Stock Exchange. Prospective investors should be aware of the potential risks of investing in such companies and should make the decision to invest only after due and careful consideration. The greater risk profile and other characteristics of GEM mean that it is a market more suited to professional and other sophisticated investors.**

**Given the emerging nature of companies listed on GEM, there is a risk that securities traded on GEM may be more susceptible to high market volatility than securities traded on the Main Board and no assurance is given that there will be a liquid market in the securities traded on GEM.**

# *Highlights*

## NOTES:

### 1. BASIS OF PREPARATION

The Group's unaudited condensed consolidated financial statements have been prepared in accordance with the applicable disclosure requirements set out in Chapter 18 of the GEM Listing Rules and Hong Kong Financial Reporting Standards ("HKFRS") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA").

The HKICPA has issued a number of new and revised HKFRSs and interpretations that are first effective or available for early adoption for the current accounting period of the company. There have been no significant changes to the accounting policies applied in these financial statements for the current and prior accounting periods presented as a result of these developments.

The unaudited condensed consolidated financial statements have been prepared under the historical cost convention, as modified by the revaluation of available-for-sale financial assets, financial assets and financial liabilities at fair value through profit or loss.

The preparation of financial statements in conformity with the HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise their judgements in the process of applying the Group's accounting policies.

The accounting policies adopted in preparing the unaudited condensed consolidated financial statements were consistent with those applied for the financial statements of the Group for the year ended 31 December 2011.

These unaudited condensed consolidated financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand (HK\$'000), unless otherwise stated.

The condensed consolidated accounts have not been audited by the Company's auditors but have been reviewed by the Company's audit committee.

## 3. SEGMENT INFORMATION

No business segment analysis and geographical segment analysis are presented for the periods as substantially all of the Group's revenue was derived from provision of financial services in Hong Kong.

## 4. OTHER REVENUE

Other revenue represents bank interest income earned for the period.

## 5. INCOME TAX

Hong Kong profits tax is calculated at 16.5% of the estimated assessable profit for the year.

## 6. EARNINGS PER SHARE — BASIC AND DILUTED

The calculation of basic earnings per share is based on profit attributable to equity holders of approximately HK\$1,836,000 (2011: profit of approximately HK\$266,000) and the weighted average of 640,000,000 shares in issue (2011: 640,000,000 shares) during the year.

There were no dilute potential ordinary shares during the relevant period and therefore diluted earnings per share are not presented.

## 7. DIVIDEND

The Directors do not recommend the payment of any dividend for the nine months ended 30 September 2012 (for the nine months ended 30 September 2011: nil).

# *Management Discussion and Analysis*

## **BUSINESS REVIEW**

For the nine months ended 30 September 2012, the Group continued to focus on its principal business in relation to the provisional of corporate finance advisory services in Hong Kong. Although our corporate finance advisory operations experienced severe competition from competitors, we have managed to complete around 26 corporate finance advisory related projects as of 30 September 2012.

## **OUTLOOK**

In view of the economic outlook for the rest of 2012 is still subject to various uncertainties, global and local markets are still expected to be weak. For the rest of this year, the Group will continue to focus on its principal business in relation to the provisional of corporate finance advisory services in Hong Kong. Meanwhile the Group will also continue to seek for business opportunities in other financial related services so as to generate greater value for the shareholders.

## **FINANCIAL REVIEW**

Turnover of the Group for the nine months ended 30 September 2012 was approximately HK\$12.99 million (2011: approximately HK\$7.10 million), representing an increase of approximately 82.96% as compared with the corresponding period in 2011.

The Group's total operating expenses for the nine months ended 30 September 2012 was approximately HK\$11.16 million, representing an increase of 63.16% from approximately HK\$6.84 million for the corresponding period of last fiscal year.

For the three months ended 30 September 2012, loss attributable to shareholders was approximately HK\$0.07 million and profit attributable to the equity holders of the Company as of 30 September 2012 was approximately HK\$1.84 million.

The Group has adopted a prudent financial management strategy and maintained a health liquidity position. The Group has no borrowing and the gearing ratio of the Group was nil as at 30 September 2012 (2011: nil).

## CONTINGENT LIABILITIES

As at 30 September 2012, the Group did not have any significant contingent liabilities.

A.2 The Chairman and Chief Executive Officer of the Company were performed by the same individual.

The Company's size is still relatively small and thus not justified in separating the role of Chairman and Chief Executive Officer.

The Group has in place internal control system to perform the check and balance function.

The Company is also in the progress of accessing the effect of the implementation of CCGP on the Company's operation. Save as disclosed, the Company has met the code provisions set out in the CCGP throughout the nine months ended 30 September 2012.

## **Securities Transactions by Directors**

During the period under review, the Company has adopted the standards set out in Rules 5.48 to 5.67 of the GEM Listing Rules as the code of conduct regarding the Directors' securities transactions in securities of the Company. Having made specific enquiry to all Directors and the Company was not aware of any non-compliance with the required standards of dealings its code of conduct regarding securities transactions by Directors.

## **REMUNERATION COMMITTEE**

The Company established a remuneration committee with written terms of reference in compliance with the GEM Listing Rules. The primary duties of the remuneration committee are to review and make recommendation for the remuneration policy of the directors and senior management. The remuneration committee comprises one executive Director, namely Mr. Chung Ho Yan and two independent non-executive Directors, namely Mr. Lee Wing Lun (chairman of the remuneration committee) and Mr. William Wu.

## **NOMINATION COMMITTEE**

The Company established a nomination committee with written terms of reference in compliance with the GEM Listing Rules. The principal duties of the nomination committee are formulating nomination policy and making recommendations to the Board on nomination and appointment of directors and board succession. The remuneration committee comprises one executive Director, namely Mr. Chung Ho Yan (chairman of the nomination committee) and two independent non-executive Directors, namely Mr. William Wu and Mr. Lee Wing Lun.

## **AUDIT COMMITTEE**

The Company has established an audit committee with written terms of reference in compliance with the GEM Listing Rules. The primary duties of the audit committee are to review and to supervise the financial reporting process and internal control systems of the Group. The audit committee comprises three independent non-executive Directors, namely Mr. Yip Tai Him (chairman of the audit committee), Mr. William Wu and Mr. Lee Wing Lun.

The audit committee has reviewed the financial statements of the Group for the nine-month period ended 30 September 2012 pursuant to the relevant provisions contained in the Code on Corporate Governance Practices as set out in Appendix 15 of the GEM Listing Rules and was of the opinion that the preparation of such statements complied with applicable accounting standards and that adequate disclosure has been made in respect thereof.
