This report, for which the directors (the "Directors") of Haitian Hydropower International Limited (the "Company") collectively and individually accept full responsibility, includes particulars given in compliance with the Rules Governing the Listing of Securities on GEM (the "GEM Listing Rules") for the purposes of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this report is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this report misleading.

FINANCIAL HIGHLIGHTS

- Turnover for the nine months ended 30 September 2013 amounted to approximately RMB22.7 million (2012: RMB23.2 million), representing a decrease of 2% as compared with the corresponding period in 2012.
- Gross profit for the nine months ended 30 September 2013 amounted to approximately RMB17.1 million (2012: RMB18.0 million), representing a decrease of 5% as compared with the corresponding period in 2012.
- Basic earnings per share for the nine months ended 30 September 2013 amounted to RMB0.53 cents (2012: RMB0.38 cents).
- The Directors do not recommend the payment of a dividend for the nine months ended 30 September 2013.

MANAGEMENT DISCUSSION AND ANALYSIS

Business Review

The Company and its subsidiaries (hereinafter collectively referred to as the "Group") are principally engaged in the operation and management of small hydropower plants in the People's Republic of China (the "PRC") which were either developed by itself or acquired from other parties.

Operating Hydropower Plants

As at 30 September 2013, the Group possessed four wholly-owned operating hydropower plants namely, Ma Tou Shan Hydropower Plant, Qianping Hydropower plant, Jiulong Hydropower Plant and Jinxi-1 Hydropower Plant which are located in Fujian Province, the eastern part of the PRC. The Group's revenues have been derived from the sale of electricity generated by the operating hydropower plants to local power grids in Fujian Province.

Extension Development of Jiulong Hydropower Plant

To strengthen the future cash flow and further expand our operation, the Group plans to develop an additional hydropower plant in Bapu Stream (八蒲溪), Zhouning County, Fujian Province, the PRC. The Group was granted the development right by the relevant authority to develop additional hydropower plants in Bapu Stream for an operating period of 50 years. Such development was regarded as an extension of the existing Jiulong Hydropower Plant as it will make use of the water resources of the same river, Bapu Stream, as Jiulong Hydropower Plant.

In September 2012, the preliminary preparation works for Jiulong Hydropower Plant extension project have been initiated. As of September 2013, the Group has: 1. completed the "Report on the Construction Feasibility Studies" for project construction with respect to the commissioned design works; 2. Completed the approval of the integrated planning in Bapu Stream area; 3. commissioned the preparation of the "Assessment Report on the Environmental Impact"; 4. conducted geological exploration; 5. accomplished the requisition and measurement of land for the roads leading to the plants; 6. made application for the feasibility review; 7. completed the preliminary work of land requisition; 8. finished the preliminary work of the confirmation of the project; 9. completed the preparation of the "Assessment Report on the Risks of Project Construction" and the government review and approval; 10. entered into an access roads construction agreement; 11. obtained the review opinions and approval on the "Report on the Construction Feasibility Studies" from experts. It is expected that the major construction will commence in the fourth quarter of 2013. Depending on the construction progress, the Directors expect that the major construction will be completed in the first quarter of 2015 and the project will start to contribute revenue to the Group in 2015.

Acquisition of Hydropower Plants

Acquisition is the key to the success of the Group's expansion. The Group continues to explore opportunities in small and medium-size hydropower plants acquisition with attractive return and appreciation potential. On 24 April 2013, the Group acquired the Ningde city Jinxi-1 Hydropower Station, with a total installed capacity of 3.2MW, an annual average generating output of 9,350,000 kWh and annual utilization hours of 2,922 hours.

In October 2013, Fuan Liyuan Hydraulic Power Co., Ltd., one of the Group's subsidiaries, together with an independent third party, jointly established 福建省海天華金匯富能源發展有限公司 (Fujian Haitian Hua Jin Hui Fu Energy Development Co.,Ltd), and invested RMB6 million, representing 10% equity interest in this new company. The main purpose of establishing this new company is to identify and acquire hydropower plant projects with good potentials.

Financial Review

Turnover

The Group recorded a turnover of approximately RMB22.7 million for the nine months ended 30 September 2013, representing a 2% decrease as compared to approximately RMB23.2 million for the corresponding period in 2012 due to decrease of power sales resulting from reduction in precipitation.

Gross Profit and Gross Profit Margin

The Group achieved a gross profit of approximately RMB17.1 million for the nine months ended 30 September 2013 (2012: RMB18.0 million) representing a decrease of 5% as compared to that for the corresponding period in 2012. Gross margin, calculated as gross profit divided by turnover, for the nine months ended 30 September 2013 amounted to 76% (2012: 77%). The decrease in gross profit margin in 2013 was mainly attributable to revenue decrease of 2% and cost of sales increase of 6% compared to the last corresponding period.

Administrative Expenses

The administrative expenses of the Group primarily comprised of legal fees and staff costs. For the nine months ended 30 September 2013, the Group's administrative expenses decreased to approximately RMB3.4 million (2012:RMB6.6 million), represented a decrease of 48% mainly due to the incurring of listing expenses for the nine months ended 30 September 2012 as the Group was listed on the GEM of the Stock Exchange on 6 July 2012.

Finance Costs

The finance costs of the Group represented interest expenses on bank loans. For the nine months ended 30 September 2012 and 2013, finance costs recorded by the Group were approximately RMB7.0 million and RMB6.3 million respectively. The decrease of finance costs for the nine months ended 30 September 2013 was due to the decreased borrowing during the period.

Income Tax Expense

The Group income tax expense was maintained at the level of approximately RMB2.4 million for the nine months ended 30 September 2013 and 2012.

Profit and Total Comprehensive Income

The profit and total comprehensive income of the Group for the nine months ended 30 September 2013 amounted to approximately RMB5.3 million (2012: RMB3.2 million), representing an increase of 68%, mainly due to the incurring of listing expenses during the nine months ended 30 September 2012.

Outlook

The PRC government has adopted policies to promote the generation and the use of clean and renewable energy, including hydropower, in the recent years. Hydropower plants, especially small hydropower plants, have benefited from such policies. One of the benefits will be the on-grid tariff.

Hydropower is the cheapest power generation resources in the PRC. With continued encouragement by the PRC government, small hydropower plants is expected to grow further. Several policies had taken place over the last few years in an effort to reduce the dependence on thermal fuels as the resource of power generation, which would, as a result, encourage further investments in the hydropower industry.

The Group currently operates in Fujian Province which is rich in hydropower resources. The hydropower on-grid tariff for hydropower plants in Fujian Province is generally lower than other hydropower rich provinces of the southeastern coast of China. The Directors believe that there is great potential for increase of hydropower tariff in Fujian Province in the coming years.

There is a large number of small hydropower plants all over China. The Company believes that there are over 5,000 hydropower plants in Fujian Province and a lot more in other parts of the PRC. The Group will keep on identifying potential hydropower plants and there will be further acquisitions in the future if there are suitable targets and available funds.

Since the Scheme has become effective, no share options were granted, exercised or cancelled by the Company under the Scheme during the period under review and there were no outstanding share options under the Scheme as at 30 September 2013.

The Company has complied with the code provisions of the Code on Corporate Governance Practice set out in Appendix 15 of the GEM Listing Rules throughout the period under review.

Code of Conduct for Securities Transactions by Directors

The Company has adopted a code of conduct regarding securities transactions by Directors on terms which are the same as the required standard of dealings set out in Rules 5.48 to 5.67 of the GEM Listing Rules. The Company has confirmed, having made specific enquiry of the Directors, that all the Directors have complied with the required standards of dealings throughout the period under review.

Compliance Adviser's Interest in the Company

As at 30 September 2013, as notified by the Company's compliance adviser, Ample Capital Limited (the "Compliance Adviser"), except for the compliance adviser agreement entered into between the Company and the Compliance Adviser dated 28 June 2012, neither the Compliance Adviser nor its directors, employees or associates had any interests in relation to the Company which is required to be notified to the Group pursuant to Rule 6A.32 of the GEM Listing Rules.

Audit Committee

The Company has established the audit committee in accordance with the requirements of the Code on Corporate Governance Practice as set up in Appendix 15 of the GEM Listing Rules. The Audit Committee of the Company has reviewed with the management of the Company the accounting principles and practices adopted by the Group and discussed the auditing, internal control and financial reporting matters including the review of the unaudited third quarterly financial results of the Group for the nine months ended 30 September 2013.

Notes to the Condensed Consolidated Financial Statements

For the nine months ended 30 September 2013

1. General Information

Haitian Hydropower International Limited (the "Company") was incorporated in the Cayman Islands on 27 August 2010 as an exempted company with limited liability under the Companies Law, Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The addresses of the registered office and the principal place of business of the Company are Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands and Unit 606, 6th Floor, Alliance Building, 133 Connaught Road Central, Hong Kong respectively.

The condensed consolidated financial statements are presented in Renminbi ("RMB"), which is the same as the functional currency of the Company and its primary subsidiaries. RMB is the currency of the primary economic environment in which the principal subsidiaries of the Company operate (the functional currency of the principal subsidiaries).

The directors of the Company consider that Victor River Limited, a company incorporated in the British Virgin Islands ("BVI") with limited liability, is the ultimate holding company of the Company and Mr. Lin Yang is the ultimate controlling shareholder.

Pursuant to a group reorganisation (the "Reorganisation") to rationalise the structure of the Company and its subsidiaries (hereinafter collectively referred to as the "Group") in preparation of the listing of the Company's shares on Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), the Company became the holding company of the Group on 19 June 2012. Details of the Reorganisation were set out in the section headed "History and Development — Reorganisation" to the prospectus of the Company dated 28 June 2012 (the "Prospectus"). The share of the Company has been listed on the Stock Exchange on 6 July 2012.

1. General Information (Continued)

The Group resulting from the Reorganisation is regarded as a continuing entity. Accordingly, these condensed consolidated financial statements have been prepared on the basis as if the Company has always been the holding company of the companies comprising the Group before the completion of Reorganisation, using the principles of merger accounting as prescribed in Hong Kong Accounting Guideline 5 "Merger Accounting for Common Control Combinations" issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). The condensed consolidated statement of profit or loss and other comprehensive income and consolidated statement of changes in equity including the result of companies comprises the Group have been prepared as if the current group structure had been in existence throughout the nine months ended 30 September 2012.

The Company is engaged in investment holding while the Group is principally engaged in hydropower generation.

2. Basis of Preparation

The unaudited condensed consolidated financial statements for the three months and nine months ended 30 September 2013 have been prepared in accordance with the accounting principles generally accepted in Hong Kong and comply with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the HKICPA and the applicable disclosure requirements of Chapter 18 of the Rules Governing the Listing of Securities on the GEM of the Stock Exchange.

3. Principal Accounting Policies

The accounting policies adopted in preparing the unaudited condensed consolidated financial statements for the three months and nine months ended 30 September 2013 were consistent with those used in the preparation of the Group's annual financial statements for the year ended 31 December 2012.

4. Turnover

Turnover represents the amounts received and receivable for electricity sold in the normal course of business, net of sales related taxes.

5. Segment Information

HKFRS 8 requires operating segments to be identified on the basis of internal reports about components of the Group that are regularly reviewed by the chief operating decision maker (the board of directors) in order to allocate resources to the segment and to assess its performance.

For management purpose, the Group operates in one business unit based on their products, and has one reportable and operating segment: hydropower generation. The board of directors monitors the revenue of its business unit as a whole based on the monthly sales and delivery reports for the purpose of making decisions about resource allocation and performance assessment. Segment revenue and results are presented in the condensed consolidated statement of profit or loss and other comprehensive income.

10. Dividends

The Directors do not recommend the payment of a dividend for the nine months ended 30 September 2013 (nine months ended 30 September 2012: nil).

11. Earnings (Loss) Per Share

The calculation of the basic earnings (loss) per share for the three and nine months ended 30 September 2013 is based on the profit attributable to the owners of the Company of RMB2,668,000 and RMB5,309,000 respectively (three months and nine months ended 30 September 2012: loss of RMB1,993,000 and profit of RMB3,161,000 respectively) and the weighted average of 1,000,000,000 ordinary shares in issue during the three months and nine months ended 30 September 2013. The weighted average number of ordinary shares in issue during the three months and nine months ended 30 September 2012 was the assumption that 750,000,000 shares of HK\$0.01 each, representing the number of shares of the Company immediately after the Reorganisation and the capitalisation issue as disclosed in Appendix V to the Prospectus but excluding any shares to be issued pursuant to the placing had been effective on 1 January 2012.

The dilutive earnings (loss) per share is equal to the basic earnings (loss) per share as there were no dilutive potential ordinary shares outstanding during the three months and nine months ended 30 September 2013 and 2012.
