#### 1. BASIS OF PREPARATION

The unaudited accounts have been prepared in accordance with accounting principles generally accepted in Hong Kong and complied with accounting standards issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). They are prepared under the historical cost convention.

The unaudited consolidated results for the three months ended 28 February 2014 have not been audited by the Company's auditors, but have been reviewed by the Company's audit committee.

The accounting policies and basis of preparation used in the preparation of the unaudited consolidated results are consistent with those used in the Company's annual financial statements for the year ended 30 November 2013, except for the adoption of certain new and revised Hong Kong Financial Reporting Standards ("HKFRS") and Hong Kong Accounting Standards ("HKAS") as disclosed in note 2 below.

#### 2. IMPACT ON NEW HKFRSs AND HKASs

The Hong Kong Institute of Certified Public Accountants ("HKICPA") has issued a number of new and revised HKFRSs and HKASs which are effective for accounting periods commencing on or after 1 January 2013. The Group has adopted, for the first time for the current year's financial statements. Except for in certain cases, giving rise to new and revised accounting policies and additional disclosures, the adoption of these new and revised standards and interpretation has had no material effect on these financial statements.

The potential unaudited deferred tax asset of approximately HK\$18,507,000 (As at 28 February 2013: approximately HK\$18,110,000) relating to tax losses available for carry forward and other timing differences as at 28 February 2014 has not been recognized due to the unpredictability of the future profit streams.

#### 7. LOSS PER SHARE

The calculation of basic loss per share attributable to the owners of the Company for the three months ended 28 February 2014 is based on the unaudited net loss for the period of approximately HK\$1,470,000 (For the three months ended 28 February 2013 unaudited net loss: approximately HK\$670,000) and on the weighted average number of 216,202,356 ordinary shares (2013: 202,344,618 ordinary shares, restated) in issue during the period. On 27 January 2014, a total of 80,295,483 new ordinary shares of the Company were issued at HK\$0.10 each as at result of the rights issue to the shareholders of the Company, on the basis of one rights issue for every two shares held on the record date. The weighted average number of ordinary shares adopted in calculation of the basic loss per share for the three months ended 28 February 2014 has been adjusted to reflect the impact of the rights issue in January 2014. The comparative figures have also been restated accordingly.

#### Diluted loss per share

The Group has no potentially dilutive ordinary shares in issue during the three months ended 28 February 2014 and 2013. Diluted loss per share for the three months ended 28 February 2014 and 28 February 2013 were the same as the basic loss per share.

#### **INTERIM DIVIDEND**

The Board does not recommend the payment of an interim dividend for the three months ended 28 February 2014 (2013: Nil).

#### **MANAGEMENT DISCUSSION AND ANALYSIS**

#### **Financial Review**

The Group recorded an unaudited turnover of approximately HK\$2,465,000 for the three months ended 28 February 2014, a 23% decrease from approximately HK\$3,195,000 for the corresponding period of the previous year. Of the total unaudited turnover amount, approximately HK\$716,000 or 29% was generated from software license sales and professional services, approximately HK\$1,734,000 or 70% was generated from maintenance services and approximately HK\$15,000 or 1% was generated from sales of computer hardware. As at 28 February 2014, the Group had approximately HK\$1.3 million worth of contracts that were in progress. The unaudited net loss attributable to shareholders for the three months ended 28 February 2014 was approximately HK\$1,470,000 whereas the Group recorded an unaudited net loss of approximately HK\$670,000 for the same period of the previous year.

During the period, the unaudited operating expenditures amounted to approximately HK\$3,434,000 for the three months ended 28 February 2014, a 7% increase from approximately HK\$3,224,000 for the corresponding period of the previous year. The increase was mainly attributed to expenses of rights issue of shares amounted to approximately HK\$331,000 during the period. Factor out this effect, the operating expenses is slightly decreased by 4% during the period when compared to the same period of previous year. The Group continued to implement stringent cost control measures throughout the current period in a move to strengthen the Group's financial footing. These measures helped to maintain the operating expenses incurred by the Group at similar level as seen in last year.

As a result of the most of the property, plant and equipment in the Group was fully depreciated, depreciation expenses decreased from approximately HK\$40,000 for the three months ended 28 February 2013 to approximately HK\$22,000 in the current period.

During the current period, the Group invested approximately HK\$1,206,000 in developing new modules for its OCTO Straight Through Processing ("STP") system.

For the three months ended 28 February 2014, the Group has no provision made for impairment of trade receivables.

Total unaudited staff costs (excluding directors' remuneration) are approximately HK\$2,382,000 for the three months ended 28 February 2014, a 4% increase from approximately HK\$2,297,000 for the previous period. The increase was mainly attributed to overall salary increment of staff during the period.

The Company completed a rights issue of 80,295,483 ordinary shares of HK\$0.10 each at a subscription price of HK\$0.10 per share on 27 January 2014 (the "2013 Rights Issue") on the basis of one rights share for every two shares held on the record date. Accordingly, the issued share capital of the Company has been increased from HK\$16,059,097 to HK\$24,088,645. These new shares rank pari passu in all respect with the existing shares. The net proceeds from the 2013 Rights Issue amounted to approximately HK\$7.51 million which will be used for working capital and repayment of Ioan.

#### **Operation Review**

For the three months ended 28 February 2014, Financial Solutions unaudited turnover is approximately HK\$2,420,000, a decrease of 23% when compared to approximately HK\$3,157,000 for the corresponding period of the previous year. The decreases of turnover were mainly attributed to less project delivery to customers; software license maintenance and rental income decreased during the period. According to The Stock Exchange's tentative timeline, Orion Central Gateway ("OCG") will be launch in the third quarter 2014. The implement work of OCG continued to record satisfactory results. During the period, the Group has completed the batch of end-to-end test and the next batch of market rehearsals is scheduled in the second quarter 2014.

For the three months ended 28 February 2014, CRM Solutions unaudited turnover is approximately HK\$45,000, remains stable when compared to approximately HK\$38,000 for the same period of previous year. On 1 December 2013, the Group has entered a renewal International Authorized Agent Agreement with Maximizer Services Inc. ("MSI") (formerly known as Maximizer Software Inc.). The Group continues to take a role to a business agent with MSI with providing professional services in place of sales of CRM software for its customers in the Asian Pacific region.

#### Prospects

To maintain our competitiveness in the market, the Group will more focus on our core business and technology development to improve product functionality and expand service dimensions to our customers. To channel our resources to new business development in the high growth solutions area will continue to be top priorities for the Group for 2014. The directors believed that the Group has a well diversified product range that is fitted to the market needs and it is well equipped to face challenges from the market.

Maximizer Software Inc. is held as to 58.2% by The City Place Trust, which is a discretionary trust and its beneficiaries include the direct family members of Mr. Kau Mo Hui. Mr. Kau Mo Hui is the father of Mr. Terence Chi Yan Hui, whereas the remaining 41.8% is indirectly held by Mr. Kau Mo Hui. Maximizer Software Inc. is engaged in the business of the design and development of CRM Solutions, and has operations in North America, Europe, Pacific Region and South America. Maximizer Software Inc. and the Group share the same product lines including, Maximizer, Maximizer Enterprise, Maximizer CRM, Maximizer CRM Live, ecBuilder and their respective product lines. The directors believe that the business of Maximizer Software Inc. and the possible future businesses conducted by Maximizer Software Inc. may compete with the business of the Group.

In addition, Mr. Terence Chi Yan Hui is involved in a range of business and investment activities that include companies involved in technology investments and incubation. The directors believe that these businesses may, in some respects, compete with the business of the Group.

Save as disclosed above, none of the directors or the initial management shareholders is interested in any business that competes with or is likely to compete with or is likely to compete with the business of the Group.

#### AUDIT COMMITTEE

Pursuant to the GEM Listing Rules, an audit committee was established on 22 January 2001, comprising three independent non-executive directors, namely Messrs. Kwong Sang Liu, Edwin Kim Ho Wong and William Keith Jacobsen. On 28 September 2004, Mr. Kwong Sang Liu was appointed as independent non-executive director and member of audit committee of the Company. On 29 August 2008, Mr. Edwin Kim Ho Wong was appointed as independent non-executive director and member of the Company. Mr. William Keith Jacobsen was appointed as independent non-executive director and member of audit committee of the Company. Mr. William Keith Jacobsen was appointed as independent non-executive director and member of audit committee of the Company on 10 July 2009. Mr. Kwong Sang Liu is the chairman of the audit committee for the year.

The written terms of reference which describe the authorities and duties of the audit committee were prepared and adopted with reference to "A Guide for the Formation of an Audit Committee" published by the Hong Kong Institute of Certified Public Accountants. The terms of reference of the audit committee should also require it to review arrangement employees of the Company can use to raise concerns about possible improprieties in financial reporting, internal control or other matters. The audit committee should ensure that proper arrangements are in place for fair and independent investigation of these matters and for appropriate follow-up action and to act as the key representative body for overseeing the Company's relations with the external auditors. The audit committee provides an important link between the board of directors and the Company's auditors in matters coming within the scope of the Group audit. It also reviews the financial reporting process and the adequacy and effectiveness of the Group's internal control system.

During the three months ended 28 February 2014, the audit committee held a meeting for the purpose of reviewing the Company's reports and accounts, and providing advice and recommendations to the Board. The minutes of the audit committee meeting are kept by the Company Secretary.

The Group's unaudited results for the three months ended 28 February 2014 have been reviewed by the audit committee, which was of the opinion that the preparation of such results complied with the applicable accounting standard.

#### PURCHASE, SALE OR REDEMPTION OF LISTED SECURITIES

During the three months ended 28 February 2014, the Company has not redeemed any of its listed securities. Neither the Company nor any of its subsidiaries has purchased or sold any of the Company's listed securities during the period.
