ī. **Basis** of preparation

The unaudited consolidated results of the Group have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRS") and Hong Kong Accounting Standards ("HKAS") (collectively "HKFRSs"), accounting principles generally accepted in Hong Kong, the disclosure requirements of the Hong Kong Companies Ordinance and the Rules Governing the Listing of Securities on the GEM of the Stock Exchange (the "GEM Listing Rules").

The accounting policies adopted in preparing the unaudited consolidated results for the three months ended 31 March 2014 are consistent with those followed in the preparation of the Group's annual financial statements for the year ended 31 December 2013.

The condensed consolidated results for the three months ended 31 March 2014 are unaudited and have been reviewed by the audit committee of the Company.

2. Revenue

The Group is principally engaged in the design, manufacture and sale of controller systems for various consumer electrical and electronic appliances and mobile phones, and the manufacture of TV sets and the assembly of mobile phones in the PRC. Turnover stated net of value added tax is as follows:

- (a) No provision for Hong Kong profits tax has been made as the Group has no estimated assessable Hong Kong profits for the period (2013: Nil).
- The Group is subject to an income tax rate of 25% on their taxable profit in accordance (b) with the income tax law in the PRC (2013: 25%).

5. Loss per share

Loss per share is calculated based on the Group's loss attributable to shareholders for the three months ended 31 March 2014 of approximately RMB2,257,000 (loss) (2013: RMB2,610,000 (loss)) and 500,000,000 (2013: 500,000,000) shares in issue during the periods respectively.

Diluted loss per share has not been presented as the Company has no dilutive potential ordinary shares during the periods.

6. Administrative expenses

The decrease in administrative expenses was mainly due to the decrease in depreciation expense of approximately RMB309,000 for the three months ended 31 March 2014 (2013: RMB523,000).

7. Finance cost

The increase in finance cost was mainly due to the new bank borrowings of approximately RMB19,000,000 financed in April 2013.

DIVIDEND

The Board does not recommend payment of dividend for the three months ended 31 March 2014 (three months ended 31 March 2013: nil).

MANAGEMENT DISCUSSION AND ANALYSIS

Business review

The Group is principally engaged in the design, manufacture and sales of intelligent controller systems for mobile phones, TV sets and various consumer electrical and electronic appliances and the assembly of mobile phones.

During the period under review, the Group continued to seek improvement in the manufacturing and selling of mobile phones and other consumer electrical and electronic appliances. Required capital would be introduced if the prospect is good and the developments are going on in stable manner.

The Group is waiting for emergence of profitable opportunities before expanding current operation. Active sourcings are done to fit our production advantages to current market situation.

Financial review

Results

The Group recorded a turnover of approximately RMB9,642,000 (2013: RMB990,000) for the three months ended 31 March 2014, representing an increase of approximately RMB8,652,000, and loss attributable to shareholders was approximately RMB2,257,000 (2013: RMB2,610,000), representing a decrease of loss of approximately RMB353,000. Main reason for the lower in 2013's turnover was due to the planned factory's removal during March 2013. We also expect to catch up the turnover in the coming months.

Gross profit

Gross profit margin was 4.6% (2013: 23.3%). The Group will continue to procure cost control to mitigate the impact of price competition caused by intense competition in the electronics industry.

Overheads were maintained at reasonable level leading to controllable losses comparable to that of the annual report 2013. Please also refer notes to the unaudited consolidated results.

Prospect

The Group understands that our own competitive capability in product innovation and quality are important to future growth in sales and operation. Production processes are continuously improved during the difficult time and out of the tight budgets. The Group are moving forwards with realistic measures and work and in accordance with feasible plans.

CORPORATE GOVERNANCE

For the three months ended 31 March 2014, the Company has also complied with the code provisions set out in the Code on Corporate Governance Code as stated in Appendix 15 of the GEM Listing Rules except the following deviations (Code Provisions A.2.1 and E.1.2):

Mr. Zhu Guo An is the Chairman of the board of directors. The Company has no such title as the chief executive officer and the daily operation and management of the Company is monitored by the executive directors as well as the senior management. The Board is of the view that although there is no chief executive officer, the balance of power and authority is ensured by the operation of the Board, which comprises experienced individuals and meet from time to time to discuss issues affecting the operations of the Company.

AUDIT COMMITTEE

The Company has established an audit committee since I June 2003 with written terms of reference (revised on 22 March 2012) based on the guidelines recommended by the Hong Kong Institute of Certified Public Accountants and the requirements as set out in Rules 5.28 and 5.29 of the GEM Listing Rules. The audit committee comprises three independent non-executive Directors of the Company, namely Mr. Kwok Kim Hung Eddie, who is the Chairman of such committee, Mr. liang Mei Yin and Mr. Lu Xiang Tai.

The Audit Committee has reviewed with the senior management of the Company the accounting principles and practices adopted by the Group and discussed internal controls and financial reporting matters, including the review of the Group's unaudited consolidated financial statements for the three months ended 31 March 2014.
