CHAIRMAN'S STATEMENT

主席報告

As the Chairman and on behalf of the Board of Directors (the "Board"), I am pleased to present the audited consolidated result of Jilin Province Huinan Changlong Bio-pharmacy Company Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2014.

During the year under review, the Group has spent significant efforts on further promoting its core products, namely Hai Kun Shen Xi capsule (海昆腎喜膠囊) and Compound Huonaoshu capsule (復方活腦舒膠囊). As a result, the total turnover of the Group for the year ended 31 December 2014 was RMB601,715,000, representing a sharp increase of 31% as compared with RMB457,746,000 for the previous year. Profit for the year attributable to owners of the Company increased to RMB132,785,000 from RMB79,274,000 last year. For the year ended 31 December 2014, basic earnings per share increased to RMB23.70 cents from RMB14.15 cents last year.

The notable achievements in 2014 were the results of joint effort of our staff at all levels. In fact, the Board of Directors has already expressed its optimistic view for 2014's profitability in the 2013 annual report. As such, the Board would like to share its view on the Company's competitive edges with shareholders since these edges would allow the Company to achieve further success in the coming years.

Firstly, basing on the sales growth of one single product, namely, the Hai Kun Shen Xi capsule (海昆腎喜膠囊) as our target; and through adapting innovative development as the guideline, academic promotion as the means, increase sales operation quality as the focus as well as ensuring clinical sales, we increased the sales of Compound Huonaoshu capsule (復方活腦舒膠囊). Meanwhile, we continued to make efforts on the production and marketing of injecting drugs, including Edaravone injection (依達拉奉注射液), and other products subject to business solicitation, and speed up the development of unexplored new markets to further improve our sales.

Secondly, we set aside a dedicated fund and actively organised and participated in various academic promotions in relation to nephrology at state level, and held specially designed product promotion meetings in targeted hospitals at provincial, city and district levels in the country, thereby achieving continued growth in product sales. At the same time, we communicated directly with frontline staffs through these activities so that we could carry out research and development more efficiently, and understand the market conditions better.

本人謹代表董事會(「董事會」)欣然提呈吉林省輝南長龍生化藥業股份有限公司(「本公司」)及其附屬公司(合稱「本集團」)截至二零一四年十二月三十一日止年度之經審核綜合業績。

於回顧年度內，本集團致力提升對其核心產品的推廣，包括海昆腎喜膠囊和復方活腦舒膠囊。因此，截至二零一四年十二月三十一日止年度本集團總營業額為人民幣601,715,000元，較去年人民幣457,746,000元大幅上升31%。本年度本公司股權持有人應佔溢利由去年人民幣79,274,000元上升至約人民幣132,785,000元。截至二零一四年十二月三十一日止年度每股基本盈利由去年人民幣14.15分增加至人民幣23.70分。

二零一四年有突出之業績是全體員工共同努力的成果。事實上，董事會於二零一三年年報內已就二零一四年度之盈利能力發表了樂觀的看法。因此，董事會欣然與各股東分享本公司具有以下競爭力的優勢，該等優勢將為本公司以後之年度的發展再創新的輝煌。

首先，我們緊緊圍繞「海昆腎喜膠囊」單品種銷售量的增長目標，以創新發展為指導，以學術推廣為手段，以提高營銷質量為重點，抓好臨床上市，提升「復方活腦舒膠囊」銷量，繼續加大「依達拉奉注射液」等針劑品種和招商品種產銷力度，加快開發空白市場，使銷售業績再上一個新台階。

另一方面，我們拿出專項資金積極組織和參與國家級腎病學術推廣工作，在全國各省、市、區等目標醫院針對性開展產品推廣會議，推動產品銷量持續增長，通過這類活動可以直接與前線人員交流，在研發及瞭解市場情況方面取得了很好的效果。

Thirdly, our production lines, including No. One solid dosage capsule production workshop, No. Three solid dosage pills (concentrated pills) production workshop and the production line for bulk drug (fucoidan), had obtained the new version of Good Manufacturing Practice Certificate during the year. Meanwhile, we have made efforts in business solicitation for the solid dosage non-mainline products produced by the No. Three workshop and also in the tender of basic drug in order to diversify the development of the Company while exerting efforts in exploring and developing more mainline products.

Lastly, the Company passed the review of "national high-tech enterprise" in July 2012, and Hai Kun Shen Xi capsule (海昆腎喜膠囊) was named "Branded Products".

Looking ahead, we will take the launch of our new plant as an opportunity to enhance our work on management and sales in every segment. We will adhere to our business philosophy, that is, focusing on "technological innovation and serving the public" in the course of globalization, and endeavour in the pursuit of health for people around the world, with the ultimate goal to achieve rapid growth and create a brighter future.

On behalf of the Board, I would like to express my heartfelt thanks to all levels of staff and the management for their efforts and contributions in 2014 and my deep gratitude to our clients, business partners and owners for their utmost support.

BUSINESS REVIEW

For the year ended 31 December 2014, the Group's turnover increased to RMB601,715,000 from approximately RMB457,746,000 while the profit for the year attributable to owners of the Company increased to RMB132,785,000 from RMB79,274,000. For the year ended 31 December 2014, basic earnings per share increased to RMB23.70 cents from RMB14.15 cents last year.

For the year ended 31 December 2014, the manufacturing and sales of Hai Kun Shen Xi capsule (海昆腎喜膠囊) continued to be the Group's core source of revenue. The medicine of Hai Kun Shen Xi capsule has penetrated into the market, the sales of 2014 rose as expected. Details of which were further elaborated under the Section "Financial Review".

OPERATION REVIEW

Good Manufacturing Practice (GMP)

During the year ended 31 December 2014, the Company has already obtained GMP certificates for the following:

1. Tablets (片劑) – valid until 8 August 2015
2. Capsules (硬膠囊劑) – valid until 8 August 2015

業務回顧

截至二零一四年十二月三十一日止年度，本集團營業額由約人民幣457,746,000元增加至人民幣601,715,000元。本年度本公司股權持有人應佔溢利由人民幣79,274,000元增加至人民幣132,785,000元。截至二零一四年十二月三十一日止年度，每股基本盈利由去年之人民幣14.15分上漲至人民幣23.70分。

截至二零一四年十二月三十一日止年度，「海昆腎喜膠囊」的生產及銷售繼續為本集團的核心收入來源。海昆腎喜膠囊已滲入市場，於二零一四年銷售額達到預期的增長，詳情於「財務回顧」一節中闡述。

RESEARCH AND DEVELOPMENT

The Research and Development (R&D) department is essential for the future success of a pharmaceutical company. In the past, our R&D department had successfully developed the medicine, Compound Huonaoshu capsule, which had generated huge profit to the Company and finally led to the listing of the Company in Hong Kong. In the year of 2003, our R&D department completed the development of Hai Kun Shen Xi capsule, which has now become the first largest contributor of revenue and its revenue rose as expected.

PRODUCTION FACILITIES

In 2013, the addition of the construction in progress included acquisition of a plot of land of approximately 50,000 sq.m., which will be the third phase of our new production line developments, while the lands acquired in the year 2012 represented the first and second development phase.

The first and second development phase represented an area of approximately 12,000 sq.m., which houses six production lines and two workshops for producing five medicaments under two Good Manufacturing Practice Certificates; and an area of approximately 20,000 sq.m., which houses six production lines and three workshops for producing six medicaments under two Good Manufacturing Practice Certificates, respectively. The first development phase has been completed and in use since 2012, while the second phase has been completed in 2013 and commenced operation in February 2014. The third phase is currently under construction as we have completed the construction of a workshop and obtained the GMP certification in December 2014. With the official commencement of operation of the third phase at the middle of 2015, we believe the production capacity of the Group will be further enhanced.

FINANCIAL REVIEW

For the year ended 31 December 2014, the Group's recorded a revenue amounted to approximately RMB601,715,000 (2013: RMB457,746,000), a growth of approximately 31% as compared with the figure of the previous year. The audited profit for the year attributable to owners of the Company was approximately RMB132,785,000, representing an increase of 67% as compared with RMB79,274,000 of the previous year. The basic earnings per share amounted to RMB23.70 cents (2013: RMB14.15 cents), representing an increase of RMB9.55 cents over the previous year.

The obvious growth in turnover was mainly attributable to the increase in the revenue from our core revenue generator, namely Hai Kun Shen Xi capsule (海昆腎喜膠囊). The medicine of Hai Kun Shen Xi capsule had penetrated into the market, with the sales in 2014 rose as expected.

研究及開發

製藥公司之研發部對公司日後成功與否起重要之作用。以往，我們的研發部成功開發復方活腦舒膠囊，為本公司帶來龐大溢利，並最後促使本公司於香港上市。於二零零三年，我們的研發部完成開發海昆腎喜膠囊，現已成為我們第一大收入來源，來自該藥品的收入達到預期的增長。

生產設施

於二零一三年度新增的在建工程中包括新購置土地約5萬平方米，為本集團進行第三期生產線的發展；而於2012年新購置土地則為本集團第一期和第二期生產線的發展。

第一期和第二期生產線的發展分別為約1.2萬平方米的廠房，配置六條生產線和兩個車間，已獲得兩個GMP認證並可生產五個劑型；及約2萬平方米的廠房配置六條生產線和三個車間，已獲得兩個GMP認證並可生產六個劑型。第一期已完成並於二零一二年內投入生產，第二期於二零一三年度內完成並於二零一四年度二月開始運作，第三期仍在建造中，現已完成一個生產車間的建設，並於二零一四年度十二月獲得了GMP認證，於二零一五年年中可正式投入生產。我們相信本集團的生產能力將進一步提升。

財務回顧

截至二零一四年十二月三十一日止年度，本集團錄得收入較去年增長約31%，至約人民幣601,715,000元（二零一三年：人民幣457,746,000元）。本年度本公司股權持有人應佔經審核溢利較去年人民幣79,274,000元增長67%，達到約人民幣132,785,000元。每股基本盈利較去年增長人民幣9.55分至人民幣23.70分（二零一三年：人民幣14.15分）。

營業額大幅增加主要由於本集團核心收入來源的收入增加，即海昆腎喜膠囊。海昆腎喜膠囊已滲入市場，於二零一四年銷售額達到預期的增長。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

The Board of Directors is pleased with the financial performance in 2014. It is believed that the remarkable growth in profitability is attributed to the following reasons.

Firstly, with its explicit therapeutic effects as well as pragmatic and innovative academic promotion, our dominant product, namely Hai Kun Shen Xi capsule (海昆腎喜膠囊), has become increasingly notable among similar drugs in the PRC in terms of its competitive strength and continuous expanding market, resulting in an increasing product sales. This together with the fact that our production lines, including No. One solid dosage capsule production workshop, No. Three solid dosage pills (concentrated pills) production workshop and production line for bulk drug (fucoidan), have obtained the new version of Good Manufacturing Practice Certificate in 2014, bolstered the growth and development of the Company.

Secondly, we strengthened our efforts on integrating market resources, encouraging reasonable mobility of personnel, unifying the price of products supplied and regulating sales practices. Focusing on enhancing clinical sales, efforts were made in various areas, such as soliciting business from the medicine departments of hospitals, in order to identify new profit drivers.

Thirdly, in addition to proactively organizing and participating in academic promotion in relation to nephrology at state level, we also focused on the annual activities held under the Academic Institute of Nephrology (腎病學術年會) and seminars on pharmaceutical products at provincial and prefecture levels. As the participants are clinical experts, we are in a better position to learn more about and expand the fundamental medical market through responding to patients' feedback more efficiency.

Fourthly, we enhanced our efforts to recruit new sales staffs and are dedicated to train sales teams in order to improve their overall quality and strengthen their capabilities. We have nurtured the sense of overall awareness and the sense of responsibilities among every salesperson in charge of regional markets and provincial sales managers. Meanwhile, we have also focused on getting our products covered by local medical insurance and included in the supplemental catalogue for the new rural cooperative medical system. We also put in efforts on product tender and filing of product prices. Through our concerted effort, we accelerated the development of markets and hence making our market coverage wider.

The gross profit margin for the year ended 31 December 2014 was approximately 80.9%, representing a 0.6% decrease as compared with that of 81.5% for the year ended 31 December 2013.

For the year ended 31 December 2014, the Group recorded other income and gains of approximately RMB18,309,000, contrasting to a figure of RMB14,877,000 for the year ended 31 December 2013.

董事會對二零一四年的財務業績表示滿意，董事會相信盈利能力的顯著增長乃歸功於以下幾點原因：

一是主導品種「海昆腎喜膠囊」因產品療效確切和學術推廣工作務實創新，在國內同類藥品中競爭優勢日益突出，市場開發面不斷擴展，產品銷量持續增長。二零一四年固體制劑一車間硬膠囊劑生產線、固體制劑三車間丸劑（濃縮丸）生產線、褐藻多糖硫酸酯原料藥生產線全面通過新版GMP認證，拉動了企業持續發展。

二是進一步加強市場資源整合，促進人員合理流動，統一供貨價格，規範銷售行為，圍繞臨床銷售增量開展各項工作，開發醫院拓展醫藥科室，尋找新的增長點。

三是積極組織和參與國家級腎病學術推廣工作，重點抓好區域的省、地級腎病學術年會活動和用藥科室的產品學術講座活動，省、地級腎病學術年會面對的都是臨床專家，能夠更好地學習和拓展基層醫療市場，回饋患者的評價。

四是加大招聘新銷售人員力度的基礎上，抓好銷售隊伍培訓工作，努力提高團隊綜合素質，增強團隊整體能力。各區域市場負責人和省級銷售經理亦加強大局意識，增強責任心，重點抓好產品進入地方醫保、新農合補充目錄、產品招投標和物價備案等基礎工作，從上而下團結一致，促使開發銷售市場的時間加快，版圖更遼闊。

截至二零一四年十二月三十一日止年度，邊際毛利約為80.9%，較截至二零一三年十二月三十一日止年度之81.5%減少0.6%。

截至二零一四年十二月三十一日止年度，本集團錄得其他收入及收益約人民幣18,309,000元，而截至二零一三年十二月三十一日止年度則約為人民幣14,877,000元。

MANAGEMENT DISCUSSION AND ANALYSIS

Distribution and selling costs rose to approximately RMB276,949,000 for the year ended 31 December 2014 from approximately RMB255,319,000 in last year. These expenses accounted for 46% of turnover in 2014, which represented a 10% decrease from 56% as compared with the corresponding period of last year. The distribution and selling costs increase approximately RMB21,630,000.

For the year ended 31 December 2014, administrative expenses increased to approximately RMB67,901,000 from approximately RMB37,347,000 last year.

LIQUIDITY AND FINANCIAL RESOURCES

The Group has maintained a sound financial position during this year. As at 31 December 2014, cash and bank balances of the Group amounted to RMB130,316,000 (2013: RMB70,359,000) with total borrowings of RMB8,830,000 (2013: RMB8,830,000) which were interest bearing at commercial rates and unsecured. As at 31 December 2014, the Group had total assets of RMB783,666,000 (2013: RMB650,123,000) which were financed by current liabilities of RMB151,239,000 (2013: RMB151,461,000), long term borrowings of RMB7,513,000 (2013: RMB8,148,000), deferred tax liabilities of RMB239,000 (2013: RMB338,000) and shareholders' equity of RMB606,317,000 (2013: RMB473,532,000).

GEARING RATIO

As at 31 December 2014, the Group had a net cash and cash equivalents of RMB130,316,000. As at 31 December 2014, the ratio of the total liabilities to the total assets of the Group was 23% (2013: 27%) which was calculated by dividing the Group's total liabilities of RMB177,349,000 (2013: RMB176,591,000) by the Group's total equity and liabilities of RMB783,666,000 (2013: RMB650,123,000). The Group's gearing ratio which derived from the total borrowings to total net assets was 1.5% (2013: 1.9%).

EMPLOYEES

The Group has a total of 550 full-time employees and has employed some temporary sales persons.

Remuneration is determined by reference to market conditions and the performance, qualifications and experience of individual employee. Discretionary bonuses based on individual performance will be paid to employees as recognition of and reward for their contribution. Other benefits include contributions to retirement scheme and medical scheme.

BASIS OF PREPARATION

The Company was established as a state-owned enterprise in the People's Republic of China (the "PRC") in 1989. On 29 December 1995, under the relevant provisions of the PRC Company Law, the Company was re-organised from a state-owned enterprise to a limited liability company. On 16 August 1996, with the approval of the Economic Restructuring Commission of Jilin Province, the Company was further converted into a joint stock limited company. On 20 April 1999, the Company made a bonus issue from capitalisation of retained profits at the proportion of one bonus share for every two existing shares.

The Company's H shares are listed on the Growth Enterprise Market ("GEM") of the Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 24 May 2001.

PRINCIPAL ACTIVITY

The Group is principally engaged in the manufacture and distribution of biochemical medicines in the PRC under the brand names of Changlong and Shendi. There were no changes in the nature of the Group's principal activities during the year.

SEGMENTAL INFORMATION

The Group has only one business segment which is the manufacture and distribution of biochemical medicines in the PRC. In 2014, turnover of the Group was generated entirely from sales in the PRC and all identifiable assets of the Group are located in the PRC. Accordingly, no business or geographical segmental analysis is prepared for the year.

RESULTS AND DIVIDENDS

The profit of the Group for the year ended 31 December 2014 and the state of affairs of the Company and of the Group at that date are set out in the financial statements on pages 35 to 107.

The Directors do not recommend the payment of a final dividend.

In the meantime, the Company has only one INED and Audit Committee member and thus is temporarily unable to strictly comply with Rules 5.05(1) and 5.28 of the GEM Listing Rules requiring the Company to retain at all times three INEDs and a minimum of three members to comprise the Committee. Also, the Company has breached the requirements of Listing Rules of 5.06 and 5.33 which require the Company to fill up the outstanding position within three months from the date of failing to meet these requirements.

The Board expects that the new appointment could be finalized as soon as possible and that the Company would be able to fully comply with Rules 5.05(1) and 5.28 of the GEM Listing Rules as soon as possible.

The committee has reviewed with the management the accounting principles and practices adopted by the Group and discussed internal controls and financial reporting matters, including a review of the audited results of the Group for the year ended 31 December 2014.

The Board is responsible for corporate strategy, annual and interim results, succession planning, risk management, major acquisitions, disposals and capital transactions, and other significant operational and financial matters. Major corporate matters that are specifically delegated by the Board of Directors to the management include the preparation of annual and interim accounts for Board approval before public reporting, execution of business strategies, implementation of adequate systems of internal controls and risk management procedures, and compliance with relevant statutory requirements and rules and regulations. Executive Directors are responsible for running the Group and executing the strategies adopted by the Board. The INEDs serve the relevant function of bringing independent judgement on the development, performance and risk management of the Group through their contributions in board meeting.

All Directors have given sufficient time and attention to the affairs of the Group. Each executive Director has sufficient experience to hold the position so as to carry out his duties effectively and efficiently.

The Board considers that each INED of the Company is independent in character and judgement. The Company has received from each INED a written confirmation of his independence pursuant to Rule 5.09 of the GEM Listing Rules.

The Board meets at least four times each year at approximately quarterly intervals to discuss the Group's business development, operation and financial performance. Board papers are circulated not less than 7 days before the Board meetings to enable the Directors to make informed decisions on matters to be raised at the board meetings. Minutes of board meetings are kept by the Company Secretary and are open for inspection at any reasonable time on reasonable notice by any Director.

To the best knowledge of the Directors, there is no financial, business and family relationship among the members of the Board.

Mr. Zhang Hong, the chairman, is a substantial shareholder of the Company and has considerable industry experience. He is motivated to contribute to the growth and profitability of the Group. The Board is of the view that it is in the best interests of the Group to have an executive chairman so that the Board can have the benefit of a chairman who is knowledgeable about the business of the Group and is most capable to guide discussions and brief the Board in a timely manner on pertinent issues and developments to facilitate open dialogue between the Board and the management.

INDEPENDENT NON-EXECUTIVE DIRECTORS

The Company appointed INEDs who have appropriate and sufficient experience and qualification to carry out their duties so as to protect the interests of shareholders. Mr. Gao Yong Cai is the INED.

All INEDs are subject to retirement by rotation in accordance with the articles of association of the Company. All the existing INEDs are appointed for an initial term of three years and the term of office shall continue after the expiration of the initial term until at least 1 month's prior written notice is given by either party or the Company to terminate the same.

DIRECTORS' CONTINUING PROFESSIONAL DEVELOPMENT PROGRAMME

Every Director receives comprehensive, formal and tailored induction on appointment and they are continually updated on developments in the statutory and regulatory regime, and the business and market changes to facilitate the discharge of their responsibilities and obligations under the GEM Listing Rules and relevant statutory requirements.

To ensure that all Directors' contribution into the Board remain informed and relevant, they have participated in continuous professional development for the year ended 31 December 2014 to develop and refresh their knowledge and skill. During the year under review, the Company has provided updates and coordinated training on the GEM Listing Rules and relevant regulatory requirements to the Directors.

REMUNERATION COMMITTEE

According to the Code, the Company has set up a Remuneration Committee on 29 September 2005. As at the date of this report, the chairman of the committee is Mr. Gao Yong Cai, an INED, and other members include Mr. Zhang Hong. The remuneration committee schedules meet at least once a year and the quorum necessary for the transaction of business is two.

STATUS OF OUTSTANDING APPOINTMENT OF INDEPENDENT NON-EXECUTIVE DIRECTORS, AUDIT AND REMUNERATION COMMITTEE MEMBERS

At 27 November, 2014, Mr. Shen Yu Xiang and Mr. Yan Li Jin have resigned as an independent non-executive director ("INED") and audit and remuneration committee members of the Company and ceased to be a member of the Committee. Pursuant to the rules 5.28 of the GEM Listing Rules, the audit and remuneration Committee must comprise a minimum of three members and the audit Committee is now composed of only one INED, namely Mr. Gao Yong Cai.

The Company requires more time than expected to identify suitable candidates as new INED, audit and remuneration committee members. The Group has identified suitable candidates, but there are formalities and procedures which the Group cannot finalize at that moment. In the meantime, the Company has only one INED and audit committee member and two remuneration committee members and thus is temporarily unable to strictly comply with Rules 5.05(1) and 5.28 of the GEM Listing Rules requiring the Company to retain at all times three INEDs and a minimum of three members to comprise the audit committee, and with Rules of 5.05A requiring the Company to appoint INEDs representing at least one-third of the board, and with Rules of 5.34 requiring the Company to establish a remuneration committee chaired by an independent non-executive director and comprising a majority of independent non-executive directors. Also, the Company has breached the requirements of Listing Rules of 5.06 and 5.33 which require the Company to fill up the outstanding position within three months from the date of failing to meet these requirements.

The Board expects that the new appointment could be finalized as soon as possible and that the Company would be able to fully comply with Rules 5.05(1), 5.05A, 5.28 and 5.34 of the GEM Listing Rules as soon as possible. Further announcement will be made by the Company once the new appointment is confirmed in due course.

1. GENERAL INFORMATION

The Company was established as a state-owned enterprise in the People's Republic of China (the "PRC") in 1989. On 29 December 1995, under the relevant provisions of the Company Law of the PRC, the Company was re-organised from a state-owned enterprise to a limited liability company. On 16 August 1996, with the approval of the Economic Restructuring Commission of Jilin Province, the Company was further converted into a joint stock limited company. On 20 April 1999, the Company made a bonus issue from capitalisation of retained profits in the proportion of one bonus share for every two existing shares.

The Company's H shares are listed on the Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 24 May 2001.

The Company is principally engaged in the manufacture and distribution of biochemical medicines in the PRC under the brand names of Changlong and Shendi. The principal activities of the subsidiaries are set out in Note 20.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretation issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong, applicable disclosure provisions of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") and requirements of the Hong Kong Companies Ordinance, which for this financial year and the comparative period continue to be those of the predecessor Hong Kong Companies Ordinance (Cap.32), in accordance with transitional and saving arrangements for Part 9 of the new Hong Kong Companies Ordinance (Cap.622), "Accounts and Audit", which are set out in sections 76 to 87 of Schedule 11 to that Ordinance.

1. 一般資料

本公司於一九八九年在中華人民共和國（「中國」）成立為一間國有企業。一九九五年十二月二十九日，根據中國公司法有關條文，本公司由一間國有企業重組為一間有限責任公司。其後於一九九六年八月十六日，經吉林省經濟改革委員會的批准，本公司再改組為一間股份制有限公司。於一九九九年四月二十日，本公司按每兩股現有股份派發一股紅股的比例，將保留溢利撥充資本以發行紅股。

本公司H股於二零零一年五月二十四日在香港聯合交易所有限公司（「聯交所」）創業板（「創業板」）上市。

本公司主要以長龍及神迪品牌在中國從事製造及分銷生化藥物。附屬公司的主要業務載於附註20。

New standards, amendments to standards and interpretations (continued)

The Group did not early adopt any of these new or revised HKASs and HKFRSs, amendments and interpretation to existing HKASs and HKFRSs. Management is currently assessing the financial impact of these revisions to the Group's financial position and performance.

In addition, the Hong Kong Companies Ordinance (Cap. 622) will affect the presentation and disclosure of certain information in the consolidated financial statements for the year ending 31 December 2015. The Group is in the process of making an assessment of the impact of these changes.

(d) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December.

(e) Subsidiaries

A subsidiary is an entity (including a structured entity) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

(i) *Business combination*

The Group applies the acquisition method to account for business combinations. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date. The Group recognises any non-controlling interest in the acquiree on an acquisition-by-acquisition basis, either at fair value or at the non-controlling interest's proportionate share of the recognised amounts of acquiree's identifiable net assets.

(c) 會計政策及披露之變更(續)

新訂準則、準則修訂及詮釋(續)

本集團並無提早採納任何此等新訂或經修訂香港會計準則及香港財務報告準則、對現有香港會計準則及香港財務報告準則之修訂及詮釋。管理層目前正在評估該等修訂對本集團財務狀況及表現之影響。

此外，香港《公司條例》(第622章)將影響截至二零一五年十二月三十一日止年度綜合財務報表內若干資料之呈列及披露。本集團正評估此等變動的影響。

(d) 綜合

綜合財務報表包括本公司及其附屬公司截至十二月三十一日止之財務報表。

(e) 附屬公司

附屬公司指本集團對其具有控制權的所有主體(包括結構性主體)。當本集團因為參與該主體而承擔可變回報的風險或享有可變回報的權益，並有能力透過其對該主體的權力影響此等回報時，本集團即控制該主體。附屬公司在控制權轉移至本集團之日起合併入賬。附屬公司在控制權終止之日起停止合併入賬。

(i) *業務合併*

本集團採用購買法將業務合併入賬。購買附屬公司的轉讓對價為本集團所轉讓資產、對被收購方前擁有人所產生負債及所發行股權的公平值。轉讓對價包括或有對價安排產生的任何資產或負債的公平值。於業務合併時所購買的可識別資產及所承擔的負債及或然負債，初步按購買日的公平值計量。就個別收購基準，本集團以公平值或按非控制性權益所佔被購買方資產淨值可確認的比例確認於被購買方之任何非控制性權益。

(i) *Business combination (continued)*

Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is re-measured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit or loss.

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or liability is recognised in accordance with HKAS 39 either in profit or loss or as a change to other comprehensive income. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

(ii) *Changes in ownership interests in subsidiaries without change of control*

Transactions with non-controlling interests that do not result in loss of control are accounted for as equity transactions – that is, as transactions with the owners of the subsidiary in their capacity as owners. The difference between fair value of any consideration paid and the relevant share acquired of the carrying value of net assets of the subsidiary is recorded in equity. Gains or losses on disposals to non-controlling interests are also recorded in equity.

收購相關成本於產生時支銷。

若業務合併分階段進行，則收購方先前所持被收購方權益於收購日期的賬面值按收購日期公平值重新計量，而任何因有關重新計量而產生的收益或虧損已於損益賬中確認。

集團所轉讓的或然代價於收購日期按公平值確認。或然代價(視作一項資產或負債)公平值的其後變動根據香港會計準則第39號於損益確認，或計作其他全面收益變動。分類為權益的或然代價毋須重新計量，而其後結算於權益入賬。

(iii) Disposal of subsidiaries

When the Group ceases to have control, any retained interest in the entity is re-measured to its fair value at the date when control is lost, with the change in carrying amount recognised in profit or loss. The fair value is the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss.

(iv) Separate financial statements

Investments in subsidiaries are included in the Company's balance sheet at cost less impairment. The results of subsidiaries are accounted for the Company on the basis of dividends received and receivables.

Impairment testing of the investments in subsidiaries is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statement exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

(iii) 出售附屬公司

倘集團不再擁有控制權，其於該實體之任何保留權益按其於失去控制權當日之公平值重新計算，而賬面值變動則於損益中確認。就其後入賬列作聯營公司、合營公司或財務資產之保留權益而言，公平值指初始賬面值。此外，先前於其他全面收益內確認與該實體有關之任何金額按猶如該集團已直接出售有關資產或負債之方式入賬。這可能意味著先前在其他全面收益內確認之金額重新劃分為溢利或虧損。

(iv) 獨立財務報表

在本公司之資產負債表內，於附屬公司的投資是按成本扣除減值列賬。附屬公司之業績由本公司按已收及應收之股息入賬。

投資於附屬公司之減值測試於自此等投資收取之股息超逾附屬公司宣派股息期間內之全面收益總額或投資賬面值於獨立財務報表超逾被投資公司之資產淨值(包括商譽)於綜合財務報表內之賬面值而作出。

(f) Biological assets

Biological assets are living animals and plants managed by the Group which is involved in the agricultural activities of the transformation of biological assets for sale or into agricultural product.

Biological assets are measured at fair value less estimated point-of-sale costs at initial recognition and at each balance sheet date. The fair value of these biological assets is determined based on active market prices in the local market with reference to comparable age, breed and genetic merit. The gain or loss arising on initial recognition and subsequent changes in fair values less estimated point-of-sale costs of biological assets is recognised in profit or loss in the period in which it arise. Biological assets that are in the stage of cultivation or do not have a quoted market price in an active market and whose fair value cannot be reliably measured are recognised in the balance sheet at cost less any impairment losses.

(g) Property, plant and equipment

Property, plant and equipment is stated at historical cost less accumulated depreciation and any impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Subsequent costs are included in the assets carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the consolidated statement of profit or loss and other comprehensive income during the financial period in which they are incurred.

Depreciation is calculated using the straight-line method to allocate their costs or revalued amounts to their residual value over their estimated useful lives. The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period. The principal annual rates are as follows:

(f) 生物資產

生物資產為本集團管理之牲畜及植物，包括通過農業活動而轉變待售的生物資產或農產品之生物資產。

生物資產於初始確認及於各結算日以公平值減估計銷售點成本計量。該等生物資產之公平值乃根據當地市場之活躍市價參考可資比較之年期、品種及基因優點釐定。生物資產於初步確認時及其後公平值變動減估計銷售點成本所產生之盈利或虧損於產生期間於損益賬確認。在種植階段或在活躍市場並無市場報價且其公平值不能可靠計量之生物資產按成本值扣減任何減值虧損確認入資產負債表。

(g) 物業、廠房及設備

物業、廠房及設備按歷史成本值減累計折舊及任何減值虧損列賬。歷史成本值包括收購項目直接應佔的開支。其後成本僅於項目隨附未來經濟利益可能流入本集團及項目成本可以可靠地計量時計入資產賬面值或確認為個別資產(倘適用)。被取代部份之賬面值獲終止確認。所有其他維修及保養開支均於產生之財政期間於綜合損益及其他全面收益表扣除。

(g) Property, plant and equipment (continued)

An assets carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gain or loss on the disposal are determined by comparing the proceeds with the carrying amount and are recognised in the consolidated statement of profit or loss and other comprehensive income.

(h) Prepaid land lease payments

Prepaid land lease payments under operating leases are initially stated at historical cost and subsequently recognised on the straight-line basis over the lease terms.

(i) Construction in progress

Construction in progress represents buildings, plant and equipment under construction and pending installation, and is stated at historical cost less any impairment losses. No depreciation is made on construction in progress until such time as the relevant property, plants and equipment are available for use. Cost comprises all construction expenditure and other direct costs of construction. Construction in progress is transferred to the appropriate category of property, plant and equipment when the asset being constructed becomes available to use.

(j) Intangible assets

(i) Purchased know-how and prescription

Purchased know-how and prescription are stated at historical cost less accumulated amortisation and impairment losses. Amortisation is charged on a straight-line basis over their estimated useful lives, which range from 5 to 12 years from the date of commercial production. The estimated useful life and amortisation method are reviewed at the end of each balance sheet date, with the effect of any changes in estimate being accounted for on a prospective basis.

倘一項資產之賬面值大於其估計可收回金額，其賬面值將即時減至其可收回金額。

出售所產生的盈虧乃指該款項與賬面值的比較數字，有關盈虧於綜合損益及其他全面收益表確認。

(h) 預付土地租金

經營租賃下之預付土地租金初始按歷史成本值入賬及隨後於租約期間以直線法確認。

(i) 在建工程

在建工程指興建中的樓宇、廠房及待安裝的設備，以歷史成本值扣除減值虧損入賬。直至有關物業、廠房及設備可供使用前，在建工程並無折舊。成本包括所有建造支出及其他直接建造成本。在建工程於在建資產可使用時重新轉撥為物業、廠房及設備之適當類別。

(j) 無形資產

(i) 購入技術及藥方

購入技術及藥方按歷史成本值扣除累計攤銷及減值虧損入賬。購入技術及藥方乃以直線法按其估計可使用年期(於商業生產日期起5至12年)進行攤銷。估計可使用年期及攤銷方法乃於各結算日結束時檢討，估計變動之影響按預先計提之基準入賬。

(ii) Research and development expenditure

Expenditure on research activities is recognised as an expense in the financial period in which it is incurred. Expenditure on development activities is capitalised if the product or process is technically and commercially feasible and the Group has sufficient resources and the intention to complete development. The expenditure capitalised includes the costs of materials, direct labour, and appropriate proportion of overheads and borrowing costs, where applicable. Capitalised development costs are stated at historical cost less accumulated amortisation and impairment losses. Amortisation begins when development is completed and the assets is available for use. Other development expenditure is recognised as an expense in the financial period in which it is incurred.

(iii) Purchased in-process research and development assets acquired through separate purchase

In-process research and development assets acquired through separate purchase are recognised as intangible assets at historical cost less accumulated amortisation and impairment losses.

Amortisation and impairment assessment are accounted for in a similar manner as internal development expenditure set out in (ii) above.

(k) Impairment of non-financial assets

Assets that have an indefinite useful life – for example, goodwill or intangible assets not ready to use – are not subject to amortisation and are tested annually for impairment. Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purpose of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

(ii) 研發開支

研究活動的費用於其產生財政期間內確認為開支。倘若產品或程序在技術上和商業上可行，且本集團有足夠的資源和意願完成開發，則開發活動的費用會予以資本化。資本化的費用包括材料成本、直接員工成本及適當比例的間接費用及借貸成本。資本化之開發成本以歷史成本值減除累計攤銷及減值虧損列賬。攤銷於開發完成及資產可用時開始。其他開發開支於其產生財政期間內確認為開支。

(iii) 個別購入而獲得的進行中之研發資產

個別購入而獲得的進行中研發資產按歷史成本值減除累計攤銷及減值虧損確認為無形資產。

攤銷及減值評估按類似方法作上述(ii)中所載之內部開發開支列賬。

(k) 非財務資產減值

擁有無限可用年期(如商譽)或尚未可用之無形資產毋須作出攤銷，並每年測試減值情況。每當發生事件或環境轉變顯示賬面值可能無法收回時，則應對須作攤銷的資產作減值檢討。倘該項資產之賬面值超過其可收回金額時，會就其差額確認減值虧損。資產之可收回金額為公平值減出售成本與其可使用價值中之較高者。評估資產減值準備時，資產乃按最低水平之可單獨識別之現金流量(現金產生單位)予以分類。對已發生減值之除商譽外之非財務資產於每個報告日檢討其可能之轉回。

(l) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average cost formula. The cost of finished goods and work in progress comprises raw materials, direct labour, other direct costs and related production overheads (based on normal operating capacity). It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

(m) Financial assets

(i) Classification

The Group classifies its financial assets in the following categories: at fair value through profit or loss, loans and receivables, and available for sale. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

(a) Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are financial assets held for trading. A financial asset is classified in this category if acquired principally for the purpose of selling in the short term. Derivatives are also categorised as held for trading unless they are designated as hedges. Assets in this category are classified as current assets if expected to be settled within 12 months; otherwise, they are classified as non-current.

(b) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for the amounts that are settled or expected to be settled more than 12 months after the end of the reporting period. These are classified as non-current assets. The Group's loans and receivables comprise "trade and other receivables", "loans receivables" and "cash and cash equivalents" in the balance sheet.

(l) 存貨

存貨按成本值及可變現淨值兩者之較低者列賬。成本值乃按加權平均成本法釐定。製成品及在製品之成本包括原料、直接員工成本、其他直接成本及相關之產品間接費用(根據正常經營能力)，惟不包括借貸成本。可變現淨值乃按正常業務過程中的估計售價，減去適用的變動銷售開支計算。

(m) 財務資產

(i) 分類

本集團將其財務資產分為以下三個類別：按公平值列賬及於損益表處理；貸款及應收款項；及可供出售。分類視乎收購財務資產之目的而定。管理層會於初次確認時釐定其財務資產的分類。

(a) 按公平值列賬及於損益表處理之財務資產

按公平值列賬及於損益表處理之財務資產乃持有作買賣之財務資產。倘若購入財務資產之主要目的是用作短期內出售，即歸入此類。除非衍生工具被指定為對沖工具，否則歸類為持有作買賣用途。於此類別之資產如預期於12個月內償還，會分類作流動資產；否則分類為非流動。

(b) 貸款及應收款項

貸款及應收款項為有固定或可確定付款額且沒有在活躍市場報價的非衍生工具財務資產。此等款項列入流動資產，惟不包括於報告期末起計十二個月後結算或預期結算之金額，該等金額會列作非流動資產。本集團貸款及應收款項包括資產負債表「應收貿易賬款及其他應收款項」、「貸款及應收款項」以及「現金及現金等價物」。

(c) Available-for-sale financial assets

Available-for-sale financial assets are non-derivatives that are either designated in this category or not classified in any of the other categories. They are included in non-current assets unless the investment matures or management intends to dispose of it within 12 months of the end of the reporting period.

(ii) Recognition and measurement

Regular way purchases and sales of financial assets are recognised on the trade-date – the date on which the Group commits to purchase or sell the asset. Investments are initially recognised at fair value plus transaction costs for all financial assets not carried at fair value through profit or loss. Financial assets carried at fair value through profit or loss are initially recognised at fair value, and transaction costs are expensed in the income statement. Financial assets are derecognised when the rights to receive cash flows from the investments have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership. Available-for-sale financial assets and financial assets at fair value through profit or loss are subsequently carried at fair value. Loans and receivables are subsequently carried at amortised cost using the effective interest method.

When securities classified as available-for-sale are sold or impaired, the accumulated fair value adjustments recognised in equity are included in the income statement as “gains and losses from investment securities”.

Interest on available-for-sale securities calculated using the effective interest method is recognised in the income statement as part of other income. Dividends on available-for-sale equity instruments are recognised in the income statement as part of other income when the Group's right to receive payments is established.

(c) 可供出售財務資產

可供出售財務資產為被指定為此類別或並無分類為任何其他財務資產類別的非衍生工具。除非投資到期或管理層計劃於報告期末起計十二個月內出售有關投資，否則此等資產將計入非流動資產內。

(ii) 確認及計量

正規買賣財務資產於交易日(即本集團承諾買賣該資產之日期)獲確認。投資初步按公平值加並非透過損益按公平值計值之所有財務資產之交易成本確認。透過損益按公平值計值之財務資產初步按公平值計值，交易成本於收益表扣除。財務資產於自投資收取現金流之權利屆滿或已獲轉移且本集團已轉移擁有權之大部份風險與回報時終止確認。可供出售財務資產及透過損益按公平值計值之財務資產主要以公平值計量。貸款及應收款項主要按實際利率法以攤銷成本計值。

當獲分類為可供出售之證券獲出售或出現減值時，於權益確認之累計公平值調整計入收益表之「來自投資證券之收益及虧損」。

按實際利率法計算之可供出售證券利息於收益表確認為其他收入一部份。可供出售股本工具之股息在本集團收取款項之權利獲確立後於收益表確認為其他收入一部份。

Assets carried at amortised cost

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or a group of financial assets is impaired. A financial asset or a group of financial assets is impaired and impairment losses are incurred only if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a "loss event") and that loss event (or events) has an impact on the estimated future cash flows of the financial asset or group of financial assets that can be reliably estimated.

Evidence of impairment may include indications that the debtors or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation, and where observable data indicate that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

For loans and receivables category, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate. The carrying amount of the asset is reduced and the amount of the loss is recognised in the consolidated income statement. If a loan or held-to-maturity investment has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract. As a practical expedient, the Group may measure impairment on the basis of an instrument's fair value using an observable market price.

集團於各報告期末評核有否客觀證據證明有一項或一組財務資產出現減值。僅當存在客觀證據證明於首次確認資產後發生一宗或多宗事件(「虧損事件」)，而該宗(或該等)虧損事件導致出現減值及對該項或該組財務資產的未來估計之現金流構成可以合理估計的影響，有關的財務資產才算出現減值及產生減值虧損。

減值跡象可包括一名或一組借款人正面臨重大經濟困難、違約或未能償還利息或本金、彼等有可能破產或進行其他財務重組，以及有可觀察得到的數據顯示估計未來現金流量出現可計量的減少，例如欠款數目變動或出現與違約相關的經濟狀況。

就貸款及應收款項類別而言，虧損金額以該資產之賬面值與按財務資產原本之實際利率用折現方式計算預計未來現金流量之現值差額(但不包括未發生之信貸損失)來計量。該資產之賬面值會在收入表扣除，而虧損會在綜合收益表確認。倘一項貸款或持至到期日投資具可變動利率，用於計算任何減值虧損之折讓率則為合約項下釐訂之現時實際利率。作為一項實際合宜事項，集團可採用可供觀察之市價以工具之公平值基準計算減值。

Impairment testing of trade and other receivables is described in note 3b.

(iv) Assets classified as available-for-sale

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or a group of financial assets is impaired. For debt securities, the Group uses the criteria refer to (a) above. In the case of equity investments classified as available-for-sale, a significant or prolonged decline in the fair value of the security below its cost is also evidence that the assets are impaired. If any such evidence exists for available-for-sale financial assets, the cumulative loss – measured as the difference between the acquisition cost and the current fair value, less any impairment loss on the that financial asset previously recognised in profit or loss – is removed from equity and recognised in the profit or loss. Impairment losses recognised in the consolidated statement of profit or loss on equity instruments are not reversed through the consolidated statement of profit or loss. If, in a subsequent period, the fair value of a debt instrument classified as available-for-sale increases and the increase can be objectively related to an event occurring after the impairment loss was recognised in profit or loss, the impairment loss is reversed through the consolidated statement of profit or loss.

本集團於各報告期末評估財務資產或一組財務資產有否出現客觀之減值憑證。就債務證券而言，本集團使用上文(a)項所述之準則。就分類為可供出售之股本投資而言，證券公平值之重大或持續下跌至低於其成本亦為資產出現減值之憑證。倘可供出售財務資產出現任何有關憑證，其累計虧損(收購成本與當前公平值兩者之差額減該財務資產以往於損益內確認之任何減值虧損)則於權益中撇銷，並於損益表中確認。於綜合損益表中確認之權益工具減值虧損不會透過綜合損益表撥回。倘於其後之期間，分類為可供出售之債務工具之公平值增加，而且能夠客觀地釐定增加與於損益確認減值虧損後發生之事項相關，減值虧損則透過綜合損益表撥回。

(n) Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents include cash in hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. In the consolidated and entity balance sheet, bank overdrafts are shown within "bank borrowings" in current liabilities.

(o) Current and deferred income tax

The tax expense for the period comprises current and deferred tax. Tax is recognised in the income statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (or laws) that have been enacted or substantially enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

(n) 現金及現金等值物

綜合現金流量表之現金及現金等值物包括手頭現金及銀行通知存款，以及於三個月或以內到期之其他短期高流動性投資及銀行透支。銀行透支於綜合及實體資產負債表中流動負債之「銀行借貸」呈列。

(o) 即期及遞延所得稅

期內稅項開支包括即期及遞延稅。稅項於收益表確認，惟與於其他全面收益或直接於權益確認的項目有關的稅項則除外。在此情況下，稅項亦分別於其他全面收益或直接於權益內確認。

即期所得稅開支根據該公司及其附屬公司經營業務及產生應課稅收入的國家於結算日已頒佈或實際上於報告期末已頒佈的稅法計算。管理層會定期評估須對適用稅項法規作出詮釋的情況下在報稅中的稅務狀況，並在恰當時按預期須向稅務機關繳納的金額為基準設定撥備。

遞延所得稅採用負債法就資產及負債的稅基與資產及負債在綜合財務報表內之賬面值產生的暫時性差額進行確認。然而，若遞延所得稅負債因初步確認商譽而產生，則不予以確認。若遞延所得稅來自在交易（不包括業務合併）中對資產或負債的初步確認，而在交易時不影響會計損益或應課稅盈虧，則不予列賬。遞延所得稅採用在結算日前已頒佈或實質頒佈，並預期在有關遞延所得稅項資產變現或遞延所得稅項負債結算時預期適用之稅率（或法例）釐定。

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

(p) Provisions

Provisions for environmental restoration, restructuring costs and legal claims are recognised when: the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resource will be required to settle the obligation; and the amount has been reliably estimated. Restructuring provisions comprised lease termination penalties and employee termination payments. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

當有若干類似責任時，須就該等責任類別整體釐定付款現金流出。即使同類責任包括之任何一個項目之現金流出金額較小，仍須作出撥備。

撥備採用稅前利率按照預期需結算有關責任的支出現值計量，該利率反映當時市場對金錢時間值和有關責任固有風險的評估。隨著時間過去而增加的撥備確認為利息費用。

(q) Foreign currency translation

(i) *Functional and presentation currency*

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Renminbi ("RMB"), which is the Company's functional and the Group's presentation currency.

(ii) *Transactions and balances*

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated statement of profit or loss, except when deferred in equity as qualifying cash flow hedges and qualifying net investment hedges.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in the consolidated statement of profit or loss within "finance income or cost". All other foreign exchange gains and losses are presented in the income statement within "other gains and/(losses)". Currency translation differences arising are recognised in other comprehensive income.

Changes in the fair value of monetary securities denominated in foreign currency classified as available for sale are analysed between translation differences resulting from changes in the amortised cost of the security and other changes in the carrying amount of the security. Translation differences related to changes in amortised cost are recognised in profit or loss, and other changes in carrying amount are recognised in other comprehensive income.

(i) *功能及呈列貨幣*

各集團實體財務報表中包括的項目採用其經營所在地區的主要經濟環境通行的貨幣(「功能貨幣」)計量。綜合財務報表以人民幣(「人民幣」)呈列，人民幣為本公司的功能及本集團呈列貨幣。

(ii) *交易及結餘*

外幣交易採用交易當日或進行項目重估的估值當日的匯率換算為功能貨幣。清償該等交易及按年終匯率換算以外幣列值的貨幣資產及負債而產生的匯兌損益乃在綜合損益表確認，惟於權益中遞延作為合資格現金流量對沖及合資格淨投資對沖者除外。

與借貸和現金及現金等值項目有關的匯兌損益，均於綜合損益表的「融資收入或成本」內呈列。全部其他匯兌損益乃於損益表的「其他收益及／(虧損)」內呈列。所產生之換算差額於其他全面收益確認。

Translation differences on non-monetary financial assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss. Translation differences on non-monetary financial assets, such as equities classified as available for sale, are included in other comprehensive income.

(iii) Group companies

The results and financial position of all the group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (a) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (b) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the dates of the transactions); and
- (c) all resulting exchange differences are recognised in other comprehensive income.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate. Currency translation differences arising are recognised in other comprehensive income.

(r) Government grants

Grants from the PRC government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with the attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated statement of profit or loss over the period necessary to match them with the costs that they are intended to compensate.

Government grants relating to prepaid land lease payment and intangible assets are included in non-current liabilities as deferred income and are credited to the consolidated statement of profit or loss and other comprehensive income on a straight-line basis over the expected useful lives of the related assets.

(s) Employee benefits

(i) *Employee leave entitlements*

Employee entitlements to annual leave are recognized when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognized until the time of leave.

(ii) Pension obligations

The employees in Mainland China participate in the defined contribution retirement plans managed by the local government authorities whereby they are required to contribute to the schemes at fixed rates of the employees' salary costs. The Group's contributions to these plans are charged to profit or loss when incurred.

The Group has no obligations for the payment of the retirement and other post-retirement benefits of staff other than the contributions described above.

(t) Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of profit or loss and other comprehensive income over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facilities will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

中國內地公司的僱員均參與由當地政府機關管理的定期供款退休計劃。公司需要按僱員薪金成本的固定比率向有關計劃作出供款。本集團向有關計劃作出的供款在其發生時計入當期損益。

除上述供款外，集團並無支付員工退休及其他退休後福利的責任。

(t) 借貸

借貸初步按公平值(經扣除所產生的交易成本)確認。借貸其後按攤銷成本列賬；所得款項(經扣除交易成本)與贖回價值之間的任何差額乃採用實際利率法於借貸期內在綜合損益及其他全面收益表確認。

在貸款很有可能部分或全部提取的情況下，就設立貸款融資支付的費用乃確認為貸款交易成本。在此情況下，該費用將遞延至提取貸款發生時。在並無跡象顯示該貸款很有可能部分或全部提取的情況下，該費用撥充資本作為流動資金服務的預付款項，並於其相關融資期間內予以攤銷。

除非本集團有權無條件遞延償付負債至報告期末後至少十二個月，否則借貸會分類為流動負債。

(v) Revenue recognition

Revenue comprises the fair value of the consideration received or receivable for the sale of goods and services in the ordinary course of the Group's activities. Revenue is shown net of value-added tax, returns, rebates and discounts and after eliminating sales with the Group.

The Group recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and when specific criteria have been met for each of the Group's activities as described below. The Group bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement.

(i) Sales of goods

Sales revenue is recognised when the merchandise is delivered and title has been passed to the customers.

(ii) Interest income

Interest income is recognised as it accrues using the effective interest method.

(w) Trade and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Accounts payable are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

(x) Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors that makes strategic decisions.

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's financial statements in the period in which the dividends are approved by the Company's shareholders.

3. CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and judgements are continuously evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

(a) Impairment of assets (other than trade and other receivables)

The Group tests annually whether assets have suffered any impairment in accordance with the accounting policy stated in note 2(k). The recoverable amounts of cash-generating units have been determined based on value-in-use calculations. The value-in-use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate present value, which has been prepared on the basis of management's assumptions and estimates.

(b) Impairment of trade and other receivables

Provision for impairment of trade and other receivables is made based on assessment of the recoverability of trade receivables and other receivables. The identification of doubtful debts requires management judgement and estimates. Where the actual outcome or expectation in future is different from the original estimate, such differences will impact the carrying value of trade receivables and other receivables and doubtful debt expenses/written back in the period in which the estimate has been changed.

(c) Estimation of useful lives of property, plant and equipment and intangible assets

The Group's management determines the estimated useful lives and related depreciation or amortisation charges for its property, plant and equipment and intangible assets. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment and purchase know-how and prescription of similar nature and functions. It could change significantly as a result of technical innovations and competitor actions in response to severe industry cycles. Management will increase the depreciation or amortisation charge where useful lives are less than previously estimated lives, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

(d) Income taxes

The Company is subject to income tax in the PRC. Significant judgement is required in determining the provision for income tax. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Company recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

4. TURNOVER

The principal activities of the Group are manufacture and distribution of biochemical medicines. Revenue represents the invoiced value of merchandise sold less allowances for returns, discounts, value-added tax and other sales related taxes.

37. CAPITAL RISK MANAGEMENT

Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to ensure optimal capital structure and shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes judgements to the capital structure in light of changes in economic conditions.

Consistent with industry practice, the Group monitors its capital structure using a gearing ratio, which is total debts divided by adjusted capital. Total debts represent total borrowings. Adjusted capital includes all components of shareholders' equity less unrealized reserves.

In order to maintain or adjust the gearing ratio, the Group may issue new shares, return capital to shareholders, raise new debt financing or sell assets to reduce debt.

38. FINANCIAL RISK MANAGEMENT

Financial risk management

The Group's activities expose it to a variety of financial risks, including credit risk, liquidity risk, interest rate risk, currency risk, price risk and fair values risk. The Group does not hold or issue derivative financial instruments either for hedging or for trading purposes. These risks are managed by the Group's financial management policies and practices as described below to minimise potential effects on the Group's financial performance.

(a) Credit risk

The Group's principal financial assets are cash and bank balances, trade and other receivables and loans receivables. The Group's credit risk is primarily attributable to its trade, other and loans receivables. The Group allows an average credit period of 180 days to its trade customers. The amounts presented in the balance sheets are net of allowance for doubtful receivables. An allowance for impairment is made where there is an identified loss event which, based on previous experience, is evidence of a reduction in the recoverability of the cash flows.

The Group does not have any significant credit risk exposure to any single trade counterparty or any Group of trade counterparties having similar characteristics. It has policies in place to ensure that sales are made to customers with an appropriate credit history.

The carrying amount of the trade and other receivables, loans receivables and cash and bank balances included in the consolidated balance sheet represents the Group's maximum exposure to credit risk in relation to the Group's financial assets.

(b) Liquidity risk

Individual operating entities within the Group are responsible for their own cash management, including the short term investment of cash surpluses and the raising of loans to cover expected cash demands, subject to approval by the Company's board of directors when the borrowings exceed certain predetermined levels of authority. The Group's policy is to regularly monitor its liquidity requirements and its compliance with lending covenants, to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.

The following table details the remaining contractual maturities at the balance sheet date of the Group's financial liabilities, which are based on contractual undiscounted cash flows (including interest payments computed using contractual rates, or if floating, based on rates current at the balance sheet date) and the earliest date the Group and the Company can be required to pay.

The fair value of financial assets that are not traded in an active market (for example, over-the-counter derivatives) is determined by using valuation techniques. These valuation techniques maximise the use of observable market data where it is available and rely as little as possible on entity specific estimates. If all significant inputs required to fair value an instrument are observable, the financial assets is included in level 2.

If one or more of the significant inputs is not based on observable market data, the instrument is included in level 3.

Specific valuation techniques used to value financial assets include:

- Quoted market prices or dealer quotes for similar instruments.
- The fair value of interest rate swaps is calculated as the present value of the estimated future cash flows based on observable yield curves.
