Characteristics of The Growth Enterprise Market (“GEM”) of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”)

GEM has been positioned as a market designed to accommodate companies to which a high investment risk may be attached than other companies listed on the Stock Exchange. Prospective investors should be aware of the potential risks of investing in such companies and should make the decision to invest only after due and careful consideration. The greater risk profile and other characteristics of GEM mean that it is a market more suited to professional and other sophisticated investors.

Given the emerging nature of companies listed on GEM, there is a risk that securities traded on GEM may be more susceptible to high market volatility than securities traded on the Main Board and no assurance is given that there will be a liquid market in the securities traded on GEM.

香港聯合交易所有限公司（「交易所」）創業板市場（「創業板」）的特色

創業板的定位，乃為相比起其他在本交易所上市的公司帶有較高投資風險的公司提供一個上市的市場。有意投資的人士應瞭解投資於該等公司的潛在風險，並應經過審慎周詳的考慮後方作出投資決定。創業板的較高風險及其他特色表示創業板較適合專業及其他經驗豐富的投資者。

由於創業板上市的公司屬新興性質，在創業板買賣的證券可能會較在交易所主板買賣的證券承受較大的市場波動風險，同時無法保證在創業板買賣的證券會有高流通量的市場。

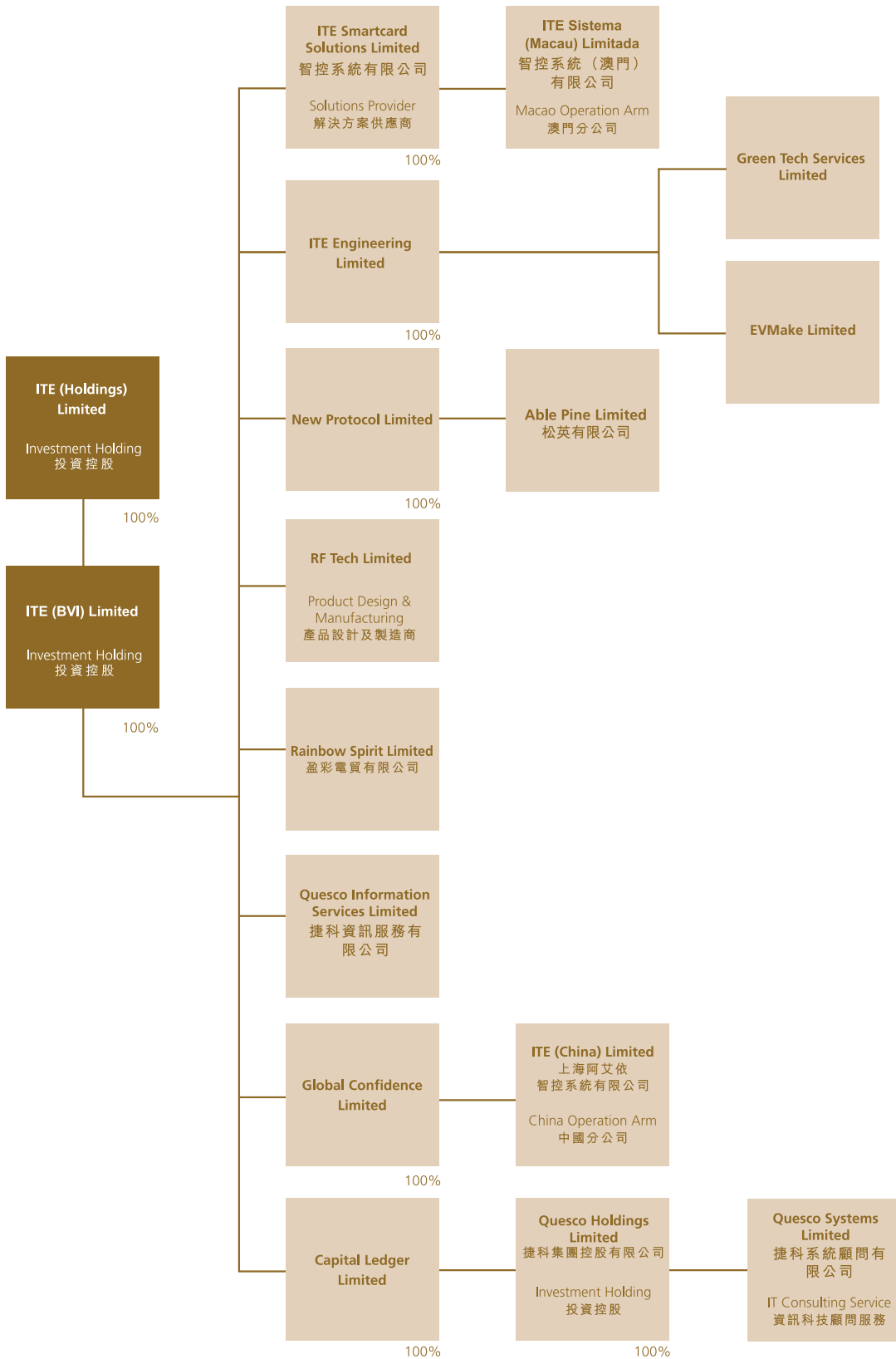

He is an associate member of each of the Institute of Chartered Accountants in England and Wales (“ICAEW”) and the Hong Kong Institute of Certified Public Accountants (“HKICPA”). Mr. Liu is the younger brother of Mr. Lau Hon Kwong, Vincent.

Management Discussion and Analysis

管理層討論及分析

Management of the Group has continued to utilise our professional and committed workforce and financial resources to achieve maximum return to our shareholders.

Business Review

During the Year, our solution and professional services arm, ITE Smartcard Solutions Limited (“ITES”), has been awarded with a number of new contracts by our clients. The orders covered the supply of hardware and software and the provision of professional services to expand or enhance their smartcard application platforms. For the sixth consecutive year, ITES provided the production and personalization services of the student smartcards for various institutes of the Hong Kong Vocational Training Council. More than 10,000 pieces of student smartcards were produced and delivered.

Teamed with one of the world leading electrical and mechanical equipment manufacturers, we have been awarded with a new contract for the supply and delivery of an electronic payment system for the electric vehicle fast charging stations of a local utility company. The system supports the use of Octopus Card for spot payment or direct debit of electricity bill registered by the electric vehicle user. Total twelve e-payment kiosks will be delivered and integrated with the latest Direct Current (“DC”) fast charging stations. The DC fast charging stations are all equipped with couplers for electric vehicles which have CHAdeMO or IEC62196 Combined Charging Standard interface, for example, Nissan Leaf, BMW i3, Volkswagen e-Golf, KIA Soul, Renault Zoe and Tesla Model S.

Our Macao operation arm, ITE (Macao) Limited (“ITEM”) has been awarded with a new contract by the University of Macau (“UMAC”) to supply and install around 300 units of washing machines and dryers for the hostels located at the new campus of UMAC on Hengqin Island, Guangdong. With the establishment of the new campus, UMAC is now the largest residential university in Asia. ITE has been providing our solutions and services to this client for more than 10 years. The delivery was successfully completed in the Year. We are ready to provide an e-purse management system to be integrated with the system seamlessly. ITEM also received a contract from another university client, the Macau University of Science and Technology, to supply a smartmeter system for their new hostel development. The completion has been scheduled in mid of 2015.

本集團的管理人員憑藉專業知識、集團賦予的人力及財政資源，為股東創建最高的回報。

業務回顧

期內，本集團提供方案及專業服務的子公司，智控系統有限公司（「智控系統」），獲取多份客戶群的新合約。合約包括提供硬件、軟件以擴容或優化現有智能系統應用平臺及相關的專業服務。同時，「智控系統」已連續六年取得為「職業訓練局」屬下各學院提供個人化智能學生證服務合約，超過一萬張智能學生證已完成交付。

「智控系統」與世界領先之電力和機械設備製造商合作，獲取本地一間公用電力機構合約設計、開發及提供應用於電動汽車快速充電站的電子付費系統。系統為使用者提供以八達通卡即時付費或經用者預先登記的電子帳單直接扣繳。合共十二台電子付費站快將交付，並與最新的直流快速充電站結合使用。該批直流快速充電站配備充電接口完全支持CHAdeMO及IEC62196快充標準，例如，日產Leaf、寶馬i3、大眾e-Golf、起亞Soul、雷諾Zoe和特斯拉型號S等都可使用。

本集團澳門子公司，智控系統（澳門）有限公司（「智控澳門」）獲取一份合約，為「澳門大學」新宿舍提供並安裝洗衣機及乾衣機合共三百台，該大學校園宿舍位處於廣東省珠海市橫琴島。新校區的建立使「澳門大學」成為亞洲區最大的住宿型大學。ITE一直為「澳門大學」提供最專業的解決方案和服務超過十年。項目已於年內成功交付。我們已準備提供電子錢包管理系統，隨時與該系統實現無縫集成。此外，「智控澳門」亦獲取「澳門科技大學」合約，為的新建宿舍提供一套智能電錶管理系統，預計二零一五年中可以完成交付。

During the Year, our R&D arm, RF Tech Limited, has added new hardware and software to our product family. The new HOMAC SPM-10 is a new intelligent parking meter product which can support the e-payment schemes of Octopus Card, MacauPass Card, and PayWave/Paypass/Quickpass. SPM-10 has been designed and made to a durable and waterproof parking meter product which can operate in an outdoor environment for more than 10 years' service life. Powered by either alkaline or lithium battery packs, it can operate in either an online or offline mode. SPM-10 has sophisticated wireless connectivity features including 3G, Wi-Fi and Bluetooth. Operator can make use of any Android or iOS mobile device for the testing and commissioning, and also the on-going maintenance and service of the meter without the need of proprietary handheld device.

SPM-10 Smart Parking Meter works with the intelliSPM software packages of ITE. The new software supports all functions from administration and monitoring of meters to the e-payment clearing management with various financial institutions. The unique battery management module can monitor and control the status of individual power pack of the meter and alert the central management station. This can greatly enhance the energy efficiency of meter. Other salient features include alarm sensors against tampering and theft. The software also works with another product of ITE, intelliPBS "Pay-by-Smartphone", which was recently launched. Users can use their smart phones to pay for the parking fee remotely through the payment platform provided by ITE.

Our continual efforts in innovation and R&D gained results by receiving a US patent granted on November 11, 2014. The US Patent No. US8,885,048 B2, "Device for registering and managing book based on computer vision and radio frequency identification technique", is an invention which discloses a computer vision and radio frequency technology based book enrolment management apparatus, which comprises an image acquisition working platform, an image acquisition device, a RFID tag reader/writer and antenna group for extracting information characteristics of the book to control and operate embedded firmware modules to analyze the image acquired information characterizes of each registered book and record them in a storage database and RFID tag.

The EFS-50 Smart Electric Vehicle Fast Charging Station, jointly developed with the Hong Kong Automotive Parts and Accessory Systems R&D Centre, has been assessed and certified to be in accordance with the requirements of CHAdeMO standard. Two EFS-50 charging stations have been installed at the Government complex and undergoing a public trial scheme funded by the Innovation Technology Commission of the Hong Kong Government.

期內，本集團的科研及產品子公司RF Tech Limited，持續開發並增加了新的硬件和軟件產品。HOMAC SPM-10是創新的智能泊車咪錶產品，它可以同時支援八達通卡、澳門通卡、和PayWave/Paypass/Quickpass的電子支付方式。SPM-10的設計能確保持久使用，是具防水功能的泊車咪錶產品，適合室外環境操作，可使用長達十年。電池系統可以用鹼性或鋰電池組合，並可以在線或離線模式下操作。SPM-10擁有先進的無線連接功能，包括3G和Wi-Fi和藍牙。操作員可以利用任何Android或iOS的移動設備以調試和進行維修保養服務，不需要專用的手提設備。

SPM-10智能泊車咪錶使用ITE的intelliSPM軟件，支援多間金融機構的電子付費清算及管理要求。特有的電池管理模塊可監控個別泊車咪錶的電池組件狀態，並提醒中央管理站，因此能大大提高泊車咪錶的能量效率。其它顯著功能包括：具有先進的防盜報警傳感器。軟件同時可以與ITE其他產品兼容，包括最新推出的intelliPBS「Pay-by-Smartphone」，用戶可以使用智能手機通過ITE提供的支付平台進行遠程支付泊車費。

通過不斷的創新和努力，研發工作得到良好的成果，集團於二零一四年十一月十一日獲授予美國發明專利，專利名稱「基于計算機視覺和射頻識別技術的書本登記管理裝置」，美國專利編號US8,885,048 B2。該項專利是以計算機視覺和射頻識別技術作基礎的書本登記管理裝置，包括圖像採集工作平台、圖像採集裝置、射頻識別標籤讀寫器和天線群合組提取書籍的特徵信息，及利用嵌入式控制器調控和操作硬件模塊來分析所述圖像，再將所獲取的每本登記書籍的信息放入存儲器的數據庫和射頻識別標籤作記錄。

與本港「香港汽車零部件研究中心」合作研發的「智能電動車快速充電站EFS-50」已通過日本「CHAdeMO」的認證。兩台EFS-50充電站已安裝於政府總部及機構並按「創新科技署」資助的公共試驗計劃使用。

Management Discussion and Analysis

管理層討論及分析

ITE has continued to demonstrate our quality assurance commitment through our strict compliance with the ISO 9001 system. Both subsidiaries, ITES and ITE Engineering Limited, have successfully completed and passed the ISO9001:2008 Quality Assurance System audit carried out, and received the continual accreditation of ISO9001:2008 Certificates by British Standards Institution.

During the Year, ITE entered into the businesses and technologies of precision medicine and life science with the formation of a new subsidiary, Precision Instrument and Optics Limited (“PIO”). Founded by Professor Chen Shih-chi who received his PhD from Massachusetts Institute of Technology (“MIT”), Professor Yam Yeung ScD Degree (MIT) and ITE, the new company focuses on the businesses and technologies of precision instrument and optics devices for medical and life science applications. PIO also acts as the commercialization vehicle for the deliverables from the R&D project under Innovation and Technology Supporting Program which was previously sponsored by ITE in 2013-14 Project Title: Multi-modality High-speed Microscope System for Volumetric Imaging (Project Reference: ITS/094/13FP).

Environmental Protection

At the launch ceremony co-organized by the Environment Bureau (“EN”) and Hong Kong Exchanges and Clearing Limited on December 15, 2014, ITE was presented with the Certificate of Commendation in recognition of our first-mover contributions and efforts in auditing our carbon footprints and disclosing the carbon data through the Carbon Footprint Repository of EN.

Climate change has posed an unprecedented, global challenge for everyone. Being part of the international community, we should contribute to the solution. Through carbon audits, listed companies like ITE could obtain a clear account of the amount of greenhouse gases emitted as a result of our operation, and this would help the companies to identify effective emission reduction measures.

The Environmental, Social and Governance Reporting Guide published by The Hong Kong Exchanges and Clearing Limited in 2012 encourages listed companies in Hong Kong, as a recommended practice, to report on, among other things, their carbon emissions and intensity, and to describe the measures adopted in mitigating emissions and the results achieved.

ITE嚴格恪守ISO 9001品質系統以確保專業承諾。兩家子公司，「智控系統」和ITE Engineering Limited持續成功通過ISO9001：2008品質認證審核，並獲British Standards Institution頒發ISO9001：2008證書。

期內，ITE邁進光學與精密儀器技術和業務，成立一間新的子公司－派光科技有限公司（「派光」）。「派光」由ITE、陳世祈教授「美國麻省理工學院機械工程學系博士」和任揚教授「美國麻省理工學院航空及航天學系博士」聯同創立。新公司專注於精密儀器技術和光學設備作精密醫療和生命科學應用。技術研發始於二零一三至一四年，由「創新科技署」研發基金，ITE合作夥伴贊助，專案號ITS/094/13FP「多模式高速立體成像光學顯微鏡系統」，並將成果市場化。

環境保護

香港環境局和香港交易及結算所有限公司於二零一四年十二月十五日啟動儀禮中，頒發ITE嘉許證書，以表彰我們在減碳排放的貢獻和努力，並列入上市公司碳足跡資料庫。

氣候變化已為全球造成前所未有的挑戰，作為地球村的一部份，我們有義務提供解決方案。通過碳審計，上市公司如ITE可獲得一個清晰的溫室氣體排放量操作結果，這將幫助企業找出有效的減排措施。

香港交易及結算所有限公司於二零一二年作出指引，鼓勵香港上市公司對環境、社會和治理，作出積極驅動，通過報告表述其碳排放量和強度，並描述在採取減少排放的措施和分享取得的成果。

Charity and Social Responsibility

Colleagues and friends of ITE continued to support social caring activities. We participated in the "Action for Love 2014" and "Charity Walk 2015" of Suicide Prevention Services ("SPS") and achieved our fund-raising target. All donations will be used in SPS services for serving people of all ages in Hong Kong who are suicidal, in despair or emotionally distressed by befriending them, and offering services to help them to regain control of their emotions and find the will to carry on. We also welcome new interns joining the Group. They came from The Hong Kong Polytechnic University, The City University of Hong Kong and The Chinese University of Hong Kong with different engineering disciplines ranging from computing, electronic, information, mechanical and mechatronic engineering. ITE has been supporting internship program for university undergraduates since 2006. We assist the students to gain solid experience and knowledge in their fields through actual work responsibilities.

Future Prospect

Since our establishment, we have been focusing on our core business and technologies, we continue to devote our efforts and resources for the long term growth of the Group building on our **Innovation, Technology and Excellency**; three words which best explain the name of ITE.

All members of the Company performed professionally under the corporate vision, mission and core values. Every year, new intellectual assets are created and accumulated and the range of professional services continues to expand to meet the fast growing needs of the changing market. We have firmly maintained our position as the pure rider to provide multi-applications solutions to our clients.

With improving efficiency and effectiveness, new product development and professional services enhancement, the Directors are optimistic that our profitability will continue to improve throughout the year.

Financial Performance

For the year ended 31 March 2015, the Group recorded a turnover of approximately HK\$29 million, representing an increase of 28% over last year. Profit for the year attributable to owners of the Company for the year ended 31 March 2015 was approximately HK\$3.2 million as compared to that of approximately HK\$2.1 million for last year.

公益及社會責任

同事們及家屬友好持續承擔社會責任，發揮企業精神，身體力行參與慈善公益活動，為「生命熱線」兩項活動「死神休假企劃2014」及「愛•喜•行2015」慈善步行籌款。「生命熱線」以義工為本，為失落、無助、感到絕望及有情緒困擾的人士提供益友及預防自殺服務，使他們情緒得以舒緩，從而積極面對人生。集團持續為大學學員提供實習名額，本年度的學員來自香港理工大學，香港城市大學及香港中文大學的不同工程學系，當中包括計算機工程、電子工程、資訊工程、機械及系統工程等。本集團始於二零零六年已積極參與大學工讀及學生實習計劃，為大學學員提供職前培訓及工作實習機會。

展望

本集團成立至今，我們的目標及承諾仍然堅定不移，持續專注核心業務及致力創新，全力落實長遠發展的目標，正如本集團的名稱「ITE」以「**創新、科技、優才**」清晰表述了企業的座右銘。

專業的管理團隊帶領集團所有成員堅守企業宗旨、目標及核心價值。年復年，不斷加強建立及累積自主知識資產，為新增速的市場提供最高端的專業產品和服務。我們堅守市場定位 — 提供多功能應用方案與客戶的專業領航者。

通過提升效率及效益，持續新產品的研發及專業服務的擴容，董事們對集團盈利能力保持增長的勢頭充滿信心。

財務表現

截至二零一五年三月三十一日止年度，本集團錄得營業額約為29,000,000港元，較去年上升28%。截至二零一五年三月三十一日止年度的本公司擁有人應佔溢利約為3,200,000港元，比對去年度約為2,100,000港元。

Segmental Information

During the year, the Group recorded an increase in turnover for about 28% when compared with last year. However, the Group's gross profit margin had dropped from 43% in last year to 39% in current year.

The service revenue generated from core business, i.e. the provision of the smartcard systems, RFID and information technology ("IT") services and related sales, was HK\$15,748,502 (2014: HK\$9,013,702) which increased significantly by 75%. On the other hand, the income from maintenance services increased by 8% to HK\$11,586,449 (2014: HK\$10,696,765).

For consultancy service segment, the turnover decreased by 35% to HK\$2,060,255 (2014: HK\$3,191,743).

The Group's administrative expenses increased by 11% to HK\$9,203,259 (2014: HK\$8,280,701). This increase was mainly due to the increase of research and development cost to HK\$1,659,950 (2014: HK\$629,030). Expenditure on research and development activities was totally expensed in profit or loss during the year.

During the year, the Group maintained a healthy liquidity position and therefore the finance costs was HK\$nil (2014: HK\$nil).

Liquidity and Financial Resources

The Group generally financed its operations with its internally generated cash flows. At 31 March 2015, the Group did not have any outstanding borrowings. At 31 March 2015, the current ratio of the Group was 2.88 (2014: 3.47) while the liquidity ratio was 2.71 (2014: 3.23).

The Group continues to adopt a conservative approach in its treasury policy. The Group strives to reduce exposure to credit risk by performing ongoing credit evaluations of the financial condition of its customers. Besides, the Group's liquidity and financing arrangements are also reviewed regularly.

Taking into consideration the stringent cost control and the existing financial resources available to the Group, it is believed that the Group should have adequate financial resources to meet its operation, development requirements and investments in the future.

分部資訊

年內，本集團錄得營業額較去年上升約28%，但本集團實際毛利率卻從去年43%下跌至本年度39%。

本集團的核心業務收入，即：提供智能卡系統、射頻識別系統及資訊科技服務及其相關銷售，比去年大幅增加75%至15,748,502港元（二零一四年：9,013,702港元），而在保養收入方面則上升8%至11,586,449港元（二零一四年：10,696,765港元）。

顧問服務範疇方面，營業額較去年下跌35%至2,060,255港元（二零一四年：3,191,743港元）。

本集團行政費用增加11%至9,203,259港元（二零一四年：8,280,701港元），此增加乃主要由於研發成本增加至1,659,950港元（二零一四年：629,030港元），而研發開支乃於年內產生時在損益確認為開支。

年內，本集團都能維持穩健的流動資金，所以並無任何財務費用（二零一四年：零港元）。

資金流動性及財務資源

本集團主要以內部產生的現金流量應付其營運所需。於二零一五年三月三十一日，本集團並沒有任何未償還借款。本集團於二零一五年三月三十一日的流動比率為2.88（二零一四年：3.47），而流動現金比率則為2.71（二零一四年：3.23）。

本集團繼續採取審慎庫務政策。本集團不斷為各客戶的財政狀況進行信貸評估，致力減低所承擔的信貸風險。此外，本集團亦會定期檢討流動資金及融資安排。

於考慮嚴格成本控制及本集團現有可動用的財務資源後，本集團相信具備充裕的財務資源以應付日後的營運、發展及投資所需。

Gearing Ratio

At 31 March 2015, the gearing ratio of the Group, which is calculated as the ratio of total borrowings to total equity, was nil (2014: nil).

Treasury Policy

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the period under review. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

Significant Investments

The Group had no significant investments during the year under review.

Material Acquisitions or Disposals of Subsidiaries and Affiliated Companies

During the year under review, the Group had no acquisitions and disposals of subsidiaries and affiliated companies.

Employment Information

The Group recognises that its staff is one of the Group's most important assets. Aiming at providing competitive salary packages, the Group adjusts employees' salary level in close association with the performance, qualifications and experience of individual staff as well as labour market conditions. In addition to the regular remuneration, discretionary bonus and share options may be awarded to eligible employees with reference to individual performance and the Group's business performance.

The Group enjoys good relations with its staff and has not experienced any disruption of operations due to major labour disputes. In addition to the remuneration as mentioned above, the Group also provides fringe benefits which comply with the relevant laws and regulations of the PRC and Hong Kong including contributions to the Social Security Scheme in the PRC and the Mandatory Provident Fund Scheme in Hong Kong. Besides, the Group also provides on-going training programmes for its employees to keep them abreast of the latest market trends and new technologies.

資產負債比率

本集團的資產負債比率乃指借貸總額除以總權益的百分比。於二零一五年三月三十一日，本集團的資產負債比率為零（二零一四年：零）。

庫務政策

本集團已對其庫務政策採取審慎的財務管理方針，故在整個回顧期內維持健康的流動資金狀況。本集團致力透過進行持續的信貸評估及評估其客戶的財務狀況以降低信貸風險。為管理流動資金風險，董事會緊密監察本集團的流動資金狀況以確保本集團的資產、負債及其他承擔的流動資金結構可應付其不時的資金需求。

重大投資

本集團於年內並沒有任何重大投資。

重大的收購或出售附屬公司及聯屬公司

本集團於年內並沒有任何附屬公司及聯屬公司的收購或出售。

僱員資料

本集團認為，員工為本集團最重要的資產。本集團的整體目標旨在提供優厚的薪金待遇，僱員薪酬水平將按個別員工的工作表現、學歷、經驗以及勞動市場狀況作出調整。除基本待遇外，本集團亦會評估個別員工的工作表現及參考本集團的業務表現向合資格僱員發放酌情花紅及授出購股權。

本集團一向維持良好融洽的勞資關係，從未經歷任何影響業務運作之重大勞資糾紛。除上述的薪酬待遇外，本集團亦按照中國內地及香港有關法例及法規提供其他僱員福利，包括中國內地的社會保障計劃供款及香港強制性公積金計劃供款。此外，本集團亦為僱員提供持續培訓計劃，協助他們緊貼市場的最新動態及新科技。

Management Discussion and Analysis

管理層討論及分析

At 31 March 2015, the Group had 56 (2014: 62) full-time employees, of which 51 (2014: 57) are based in Hong Kong and the rest are in the PRC and Macao. Staff costs, including directors' remuneration, was approximately HK\$13 million (2014: HK\$14 million) for the year ended 31 March 2015. During the year, the Company has not granted any share option to any of its Directors and employees.

Charges on Group Assets

At 31 March 2015, HK\$nil time deposit (2014: HK\$2,018,503) was pledged to banks to secure certain banking facilities of the Group.

Future Plans for Material Investments

The Group did not have any plans for material investment and acquisition of material capital assets as at 31 March 2015.

Exposure to Fluctuations in Exchange Rates and Related Hedges

The Group's assets, liabilities, revenues and expenses are mainly denominated in HK\$, United States dollars ("US\$"), Macao Patacas ("MOP") and Renminbi ("RMB"). The exchange rates between HK\$, US\$, MOP and RMB have been very steady for the past few years. During the year, the Group generally used the receipts from customers and bank loans to pay its suppliers and meet its capital requirements. They are denominated in the local currency of the place in which the subsidiaries operate. The Group does not currently engage in hedging to manage possible exchange rate risk as the Group considers the cost associated with such hedging arrangements would exceed the benefits. However, management will continue to monitor the possible exposure to exchange rate risk and will take such measures as it deems prudent.

Contingent Liability

At 31 March 2015, the Company did not have any contingent liability.

資產押記

於二零一五年三月三十一日, 並沒有任何(二零一四年: 2,018,503港元)定期存款抵押予若干銀行, 作為擔保本集團的銀行融資。

日後的重大投資計劃

本集團於二零一五年三月三十一日並無任何重大投資及收購重大資本資產的計劃。

匯率波動風險及任何相關對沖措施

本集團的資產、負債、收入及開支主要以港元、美元、澳門幣及人民幣為單位。港元、美元、澳門幣及人民幣的匯率在過去數年表現均十分穩定。年內, 本集團將一般所收客戶款項及銀行貸款用以支付供應商及資本開支。該等收支均以附屬公司經營所在地的貨幣進行。由於本集團認為對沖安排的成本高於利益, 因此本集團目前並無採取對沖措施控制潛在的匯率風險。然而, 管理層會採取審慎態度, 不斷監察有關情況並且在有需要時採取相應措施。

於二零一五年三月三十一日, 本公司並無任何或然負債。

Corporate Governance Report

企業管治報告

The Company is firmly committed to maintaining statutory and regulatory standards and adherence to the principles of corporate governance emphasising transparency, independence, accountability, responsibility and fairness. The Board ensures that effective self-regulatory practices exist to protect the interests of the shareholders of the Company.

The Company has applied the principles and complied with all the code provisions as set out in the Corporate Governance Code (the “Code”) contained in Appendix 15 of the Rules Governing the Listing of Securities on the Growth Enterprises Market of the Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”) throughout the year ended 31 March 2015, save for the deviations discussed below.

Under the code provision A.2.1 stipulates that the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive officer should be clearly established and set out in writing.

Mr. Lau Hon Kwong, Vincent is both the chairman and chief executive officer of the Company who is responsible for managing the Board and the Group’s business. Mr. Lau has been both chairman and chief executive officer of the Company since its incorporation. The Board considers that, with the present board structure and scope of business of the Group, there is no imminent need to separate the roles into two individuals as Mr. Lau is perfectly capable of distinguishing the priority of these roles in which he has been acting. However, the Board will continue to review the effectiveness of the Group’s corporate governance structure to assess whether the separation of the positions of chairman and chief executive officer is necessary.

Under the code provision A.4.1 stipulates that non-executive Directors should be appointed for a specific term, subject to re-election. However, the non-executive Directors do not have a specific term of appointment, but are subject to rotation in accordance with the articles of association of the Company.

本公司堅決致力維持有關法定及監管標準，並緊守企業管治的原則，強調透明、獨立、問責、負責及公平。董事會確保訂立有效的自我監管常規，以保障本公司股東的利益。

除下文詳述者外，本公司於截至二零一五年三月三十一日止年度，均遵守香港聯合交易所有限公司《創業板證券上市規則》（「創業板上市規則」）附錄十五的企業管治守則（「守則」）的所有規定。

守則條文A.2.1規定主席與行政總裁的角色應有區分，並不應由一人同時兼任。主席與行政總裁之間的職責分工須清晰訂明並以書面形式列載。

劉漢光先生為本公司主席兼行政總裁，負責管理董事會及本集團業務。劉先生自本公司註冊成立以來即一直擔任本公司主席兼行政總裁。董事會考慮到現有董事會的架構及本集團的業務範疇，暫時沒有迫切需要改變現狀，認為劉先生同時間擔當兩個角色，有足夠能力作出優先次序，履行任務。但是，董事會會不斷地檢討本集團企業管治架構的成效，以評估是否有分開主席與行政總裁角色的需要。

守則條文A.4.1規定非執行董事的委任應有指定任期，並須接受重選。然而，本公司非執行董事的委任並沒有指定任期，但仍須根據本公司組織章程細則輪值告退。

Directors' Securities Transactions

The Company has adopted a code of conduct regarding Directors' securities transactions on terms no less exacting than the required standard of dealings as set out in Rules 5.48 to 5.67 of the GEM Listing Rules throughout the year ended 31 March 2015. Having made specific enquiry of all Directors, the Directors have complied with such code of conduct and the required standard of dealings throughout the year ended 31 March 2015.

Board of Directors and Board Meeting

The Board which currently comprises four executive Directors and three independent non-executive Directors, is responsible for the overall strategic planning and business development of the Group. Details of the Directors are set in the section "Biographical Details of Directors and Senior Management" of this report. All Directors give sufficient time and attention to the affairs of the Group. To the best knowledge of the Board, there is no financial, business and family relationship among the members of the Board except that Mr. Liu Hoi Wah is the younger brother of Mr. Lau Hon Kwong, Vincent.

The independent non-executive Directors, Dr. Lee Peng Fei, Allen and Mr. Kam Hau Choi, Anthony, have been serving the Board as independent non-executive Directors for more than nine years and have consistently demonstrated their willingness to exercise independent judgments and provide objective challenges to management. They have actively participated in board meetings and board committee meetings held during the year and have shown themselves able to give constructive and independent advice to the Board over significant issues. Therefore, the Board considers that both of them remain independent, notwithstanding the length of their tenure as independent non-executive Directors.

All independent non-executive Directors, do not have any business or significant financial interests with the Group and each of them have confirmed their independence to the Group pursuant to Rule 5.09 of the GEM Listing Rules. Based on the above-mentioned, the Board considers that all independent non-executive Directors are independent as required under the GEM Listing Rules.

董事的證券交易

截至二零一五年三月三十一日止年內，本公司已就董事的證券交易採納一套守則，其條款不遜於創業板上市規則第5.48條至5.67條所載的交易所需標準。在向所有董事作出查詢後，董事截至二零一五年三月三十一日止年內均一直遵守有關的守則及交易所需標準。

董事會及董事會會議

現時，董事會由四名執行董事及三名獨立非執行董事組成，負責本集團整體策略計劃及業務發展。董事的詳細資料列載於本報告書中「董事及高級管理層履歷」一項中。每一位董事均能付出足夠時間及精神以處理本集團的事務。就董事會所知，除劉海華先生乃劉漢光先生的弟弟外，概無董事會成員有財務、業務及家屬關係。

李鵬飛博士及關孝財先生作為獨立非執行董事為董事會服務超過九年，並一貫顯示其願意作出獨立判斷，並對管理層作出客觀的質詢。彼等積極參與年內舉行的董事會會議及董事委員會會議，並能於會議上向董事會就重大事項提出有建設性的獨立意見。因此，董事會認為彼等仍屬獨立人士，不論其作為獨立非執行董事的任期時間。

所有獨立非執行董事於本集團並無任何業務及重大財務利益，而彼等亦已就創業板上市規則第5.09條確認其獨立性。根據以上所述，董事會認為所有獨立非執行董事均獨立自主。

With the various experience of both the executive Directors and the independent non-executive Directors and the nature of the Group's business, the Board considers that the Directors have a balance of skills and experience for the business of the Group.

All Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. All Directors have been updated on the latest developments regarding the GEM Listing Rules and other applicable regulatory requirements to ensure compliance and enhance their awareness of good corporate governance practices. Continuing briefings and professional development to Directors will be arranged wherever necessary.

The Board meets regularly at least four times a year at approximately quarterly intervals. Such regular meetings will normally involve the active participation, either in person or through other electronic means of communication, of a majority of Directors entitled to be present.

During the year ended 31 March 2015, four board meetings were held and the following is an attendance record of the meetings by each Director.

During regular meetings of the Board, the Directors discuss and formulate the overall strategies of the Group, monitor financial performances and discuss the annual, interim and quarterly results, as well as discuss and decide on other significant matters. Execution of daily operational matters is delegated to management.

有鑑於各執行董事及獨立非執行董事擁有的經驗及本集團的業務性質，董事會認為各董事於本集團的經營技巧及經驗方面取得適當的平衡。

本公司鼓勵全體董事參與持續專業發展，以發展並更新其知識及技能。全體董事亦已獲提供有關創業板上市規則及其他適用監管規定的最新發展資料，從而確保合規並加強彼等對良好企業管治常規的意識。於需要時，亦會為董事安排持續簡報及專業發展。

董事會每年最少定期召開四次會議，每次相隔約三個月。定期會議一般獲大多數有權出席會議的董事（親身或經其他電子通訊方式）積極參與。

於截至二零一五年三月三十一日止年度，董事會共舉行四次會議，以下是該等會議的出席記錄。

於董事會定期會議中，董事們商討並釐定本集團的整體策略，監察財政表現及商討年報、中期及季度業績、商討及作出其他重大決定。管理本集團日常運作的責任則交予管理層執行。

Notice of regular board meeting is usually given at least 14 days in advances to give all Directors an opportunity to attend. An agenda for each board meeting will be prepared and normally distributed to the Directors together with necessary board papers and related materials at least four days before the board meeting. Directors are free to add any items on the agenda as they may think fit. The Company Secretary is responsible for recording the matters considered and decisions reached by the Board including any concerns or dissenting views raised by Directors. Minutes of board meetings and the board committees meetings will be sent to all Directors for their comments and records as soon as after the board meeting.

Minutes of board meetings and board committees meetings are kept by the Company Secretary and such minutes are open for inspection within reasonable advance notice.

All Directors have access to relevant and timely information, and they can ask for further information or retain independent professional advisors if necessary. They also have unrestricted access to the advice and service of the Company Secretary, who is responsible for providing Directors with board papers and related materials and ensuring that board procedures are followed.

Should a potential conflict of interest involving a substantial shareholder or Director arise, the matter is discussed in an actual meeting, as opposed to being dealt with by written resolution. Independent non-executive Directors with no conflict of interest are present at meetings dealing with conflict issues. Board committees, including the Audit, Remuneration and Nomination Committees, all follow the applicable practices and procedures used in board meetings for committee meetings.

Chairman and Chief Executive Officer

The Code stipulates that the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. The Company did not segregate the roles of the chairman and chief executive officer. The role of the chief executive officer was performed by Mr. Lau Hon Kwong, Vincent, who was the then existing chairman of the Company during the year under review. Apart from the reason of such deviation mentioned above, the Board also believes that vesting the roles of both chairman and chief executive officer in the same person provides the Company with strong and consistent leadership, and allows for effective and efficient planning and implementation of business decisions and strategies.

在董事會召開會議前最少十四天發出通知，供所有董事撥冗出席。各董事會會議的議程連同所需董事會資料文件一般最少在董事會會議舉行前四天編製及分送給董事。董事可視乎需要於議程上加入任何新項目。公司秘書負責記錄董事會省覽的事項及達成的決定，包括董事提出的任何關注事項或發表的任何異見。董事會會議及董事委員會會議記錄將在會議後盡早發送予全體董事供其表達意見及存檔。

董事會及董事委員會的會議記錄由公司秘書備存，於事先合理知會情況下可供查閱。

所有董事均掌握有關及適時的資料，並可在有需要的情況卜索取進一步資料或尋求獨立專業意見。所有董事亦可不受限制地取得公司秘書的意見及享用其提供的服務。公司秘書負責向董事提供董事會的文件及有關物料，並確保遵照董事會程序。

若有大股東或董事出現潛在的利益衝突，有關事宜將於實際會議上討論，並非透過書面決議案處理。並無涉及利益衝突的獨立非執行董事將會出席會議，以處理衝突事宜。董事委員會，包括審核委員會、薪酬委員會以及提名委員會，均採納董事會沿用的適用會議原則、程序及安排。

主席及行政總裁

按守則規定，主席及行政總裁的職責須分開，不應由同一人士擔任。本公司並無分開主席及行政總裁的職責。於年內，行政總裁的職責由本公司現任主席劉漢光先生履行。除上文提及的理由外，董事會相信，由同一人士擔任主席兼行政總裁可加強及統一領導，可更有效計劃及實行業務決策及策略。

The Board will periodically review the merits and demerits of such management structure and will adopt such appropriate measures as may be necessary in the future taking into consideration of the nature and extent of the Group's operation.

Audit Committee

The Company has established an audit committee (the "Audit Committee") with written terms of reference in compliance with Rules 5.28 to 5.33 of the GEM Listing Rules. The Audit Committee comprises three independent non-executive Directors, Dr. Lee Peng Fei, Allen (being the chairman of the Audit Committee), Mr. Kam Hau Choi, Anthony and Mr. Wong Wang Fat, Andrew.

The primary duties of the audit committee are to review the Company's annual report and accounts, half-yearly report and quarterly reports and to provide advices and comments thereon to the Board. The audit committee meets at least four times a year with management to review the accounting principles and practices adopted by the Group and to discuss auditing, internal control and financial reporting matters. The principal terms of reference includes, inter alia, its relationship with the Company's external auditor, review of the Company's financial information and oversight of the financial reporting system and internal control procedures of the Company.

During the year ended 31 March 2015, four audit committee meetings were held and the following is an attendance record of the meetings by each Director.

Internal Control

The Board is responsible for overseeing the system of internal control of the Group and for reviewing its effectiveness. To facilities the effectiveness and efficiency of operations and to ensure compliance with relevant laws and regulations, the Group emphasizes on the importance of a sound internal control system which is also indispensable for mitigating the Group's risk exposures. A sound and effective internal control system is designed for (i) safeguarding the interests of shareholders; (ii) safeguarding assets of the Group against misappropriation; (iii) ensuring proper maintenance of accounting records for the provision of reliable financial information; and (iv) ensuring compliance with the relevant laws, regulations, and internal policies. Such system of internal control is designed to provide reasonable, but not absolute, assurance against material misstatement or loss and to manage and eliminate risks of failure in operational systems and fulfilment of the business objectives.

The internal control policies and procedures mainly cover areas of finance, operations and compliance. The Company shall conduct an annual review of the internal control policies and procedures to assess its effectiveness and shall make recommendations to the Board if any significant areas of concern are identified.

During the year, the Board, through the audit committee, has assessed the effectiveness of the internal control system of the Group including financial, operational and compliance controls and risk management functions and has considered the adequacy of resources, staff qualifications and experience, training programmes, and budget of the Group's accounting and financial reporting function. The Board is satisfied that, the present system of internal control is effective. The Group does not have an internal audit function and does not see the need to have one.

Company Secretary

The Company Secretary has taken no less than 15 hours of relevant professional trainings to update her skills and knowledge during the Year.

In particular, the audit committee will consider, in advance of them being contracted for such service, whether such non-audit service could lead to any potential material conflict of interest. Nothing has come to its attention to cause the audit committee to believe that the non-audit services provided by the external auditors affect their independence, objectivity and effectiveness in the audit process in accordance with applicable standard.

For the year ended 31 March 2015, the fee payable to the auditors in respect of audit services amounted to HK\$348,000 while the fee payable to the auditors in respect of non-audit services relating to the taxation amounted to HK\$30,000.

Shareholders' Rights

Procedures for Shareholders to Convene an Extraordinary General Meeting and to Put Forward Proposal

There are no provisions allowing shareholders to propose new resolutions at the general meetings under the Cayman Islands Companies Law (2012 Revision). However, shareholders are requested to follow article 64 of the Articles of Association of the Company, general meetings shall be convened on the written requisition of any one or more members holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisition(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

No person other than a Director retiring at the meeting shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting unless a notice in writing of the intention to propose such person for election as a Director, signed by a shareholder (other than the person to be proposed for election as a Director) duly qualified to attend and vote at the meeting for which such notice is given, and a notice in writing signed by such person of his willingness to be elected shall have been lodged at the head office or at the Registration Office. The minimum length of the period during which such notices are given shall be at least seven (7) days and the period for lodgement of such notices shall commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and end no later than seven (7) days prior to the date of such general meeting.

Procedures for Sending Enquiries to the Board

For putting forward any enquiries to the Board, shareholders may send written enquiries to the Company. Shareholders may send their enquiries or requests in respect of their rights to the Company's principal place of business in Hong Kong.

Communication with Shareholders

The Board is committed to maintaining an ongoing and transparent communication with all shareholders. The Directors host annual general meeting each year to meet the shareholders and answer their enquiries. The Company uses various communication channels, such as publication of annual and quarterly reports, press announcements and circulars, to update the shareholders on the Group's business developments and financial performance. 1 General information

ITE (Holdings) Limited (the “company”) was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The address of the principal place of business of its operating subsidiaries is Level 10, Park Building, 476 Castle Peak Road, Kowloon, Hong Kong. The company’s shares are listed on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The consolidated financial statements for the year ended 31 March 2015 comprise the company and its subsidiaries (collectively referred to as the “group”). The company is an investment holding company. The principal activities of its subsidiaries are set out in note 16 to the consolidated financial statements.

2 Significant accounting policies

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. The consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange (the “GEM Listing Rules”).

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis except as otherwise stated in the significant accounting policies set out below.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), except where indicated otherwise, which is also the functional currency of the company.

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

(a) 合規聲明 (續)

香港會計師公會已頒佈若干新訂及經修訂的香港財務報告準則，並於本集團及本公司的本期會計期間首次生效或可供提早採納。附註3提供有關首次應用有關發展所引致的會計政策變動的資料，惟只限於有關本集團及本公司於綜合財務報表內所反映本會計期間及以前會計期間者。

本集團採用的重大會計政策概要載列如下。

(b) 綜合財務報表的編製準則

除以下會計政策列明外，本綜合財務報表均以歷史成本為編製基準。

除非另有說明，否則綜合財務報表均以港元（亦即本公司的實用貨幣）的單位列報。

所編製符合香港財務報告準則的綜合財務報表，要求管理層就可影響政策應用以資產、負債、收入及開支的呈報金額作出判斷、估計及假設。有關估計及相關假設乃根據過往經驗，以及多項在此情況下相信屬合理的其他因素而作出，有關結果構成對未能在其他資料來源顯示的資產及負債的帳面作出判斷的基礎。實際結果可能與有關估計有所不同。

(b) Basis of preparation of the consolidated financial statements (continued)

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the consolidated financial statements and major sources of estimation uncertainty are discussed in note 35.

(c) Subsidiaries

Subsidiaries are entities controlled by the group. The group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the group has power, only substantive rights (held by the group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances and transactions and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

In the company's statement of financial position, investments in subsidiaries are stated at cost less impairment losses (see note 2(j)(ii)). The results of subsidiaries are accounted for by the company on the basis of dividend received or receivable.

本公司會持續評估及對相關假設進行估計。倘若會計估計的更改僅影響該期間，則有關影響在估計變更期間被確認，或倘若有關的更改影響本期間及未來期間，則有關影響於更改期間及未來期間被確認。

附註35論述管理層採用香港財務報告準則所作出的判斷及估計對綜合財務報表的重大影響，及存在於下年度作出重大調整的巨大風險。

(c) 附屬公司

附屬公司乃本集團控制的公司。本集團可控制一實體，通過參予該實體從而享有不同回報的權利或風險及運用其控制權以影響回報金額。當考慮本集團是否有控制權是指持有主要權益(本集團及其他人士持有)。

附屬公司於投資獲擁有控制權日期起被合併入綜合財務報表，直至該控制權終止時結束。集團內部往來的結餘和交易及其產生的任何未變現溢利，均在編制綜合財務報表內全數抵銷。在無出現減值的情況下，集團內部交易所產生的未變現虧損，會按與未變現收益相同的方法抵銷。

本公司的財務狀況表內，於附屬公司的投資按成本減去減值虧損列帳(見附註2(j)(ii))。附屬公司的業績乃由本公司按已收或應收股息列帳。

(d) Associate

An associate is an entity in which the group or company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

An investment in an associate is accounted for in the consolidated financial statements under the equity method. Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the group's share of the acquisition-date fair values of the associate's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the group's share of the associate's net assets and any impairment loss relating to the investment (see note 2(j)(ii)). Any acquisition-date excess over costs, the group's share of the post-acquisition, post tax results of the associate and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the group's share of post-acquisition post tax items of the investees' other comprehensive income is recognised in the consolidated statement of other comprehensive income.

When the group's share of losses exceeds its interest in the associate, the group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the group has incurred legal or constructive obligations or made payments on behalf of the associate. For this purpose, the groups' interest in the associate is the carrying amount of the investment under the equity method together with the group's long-term interests that in substance form part of the group's net investment in the associate.

Unrealised profits and losses resulting from transactions between the group and its associate are eliminated to the extent of the group's interest in the associate, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

If the company's statement of financial position, investment in an associate is stated at cost less impairment losses (see note 2 (j)(ii)).

(d) 聯營公司

聯營公司乃指本集團或本公司對其持有重大影響力的實體，重大影響力指可參與受投資公司的財務及營運決策，但並非控制或共同控制其管理。

聯營公司投資於綜合財務報表以權益法入帳。根據權益法，於聯營公司的投資初步按成本確認，其後會就本集團應佔聯營公司可識別的淨資產於收購日的公平價值超出投資成本 (如有) 作出調整。其後，投資會於收購後本集團所佔聯營公司與投資相關的淨資產及減值虧損作出調整 (見附註2(j)(ii))。本集團所佔投資的收購後稅後業績 (包括任何收購後超出成本及年內投資於聯營公司的任何減值虧損) 在綜合損益確認，而本集團所佔投資於其他全面收益的收購後稅後項目，則在本集團的綜合其他全面收益中確認。

當本集團所佔虧損超出聯營公司權益，本集團的權益將減至零，除非本集團有法定或建設性義務或代替其支付，其未來虧損將不再確認。為此，本集團的權益以權益法及本集團的長遠利益作為事實根據，於本集團淨聯營投資以其投資帳面值列帳。

本集團與其聯營公司之間交易的未變現收益或虧損，按本集團所持聯營公司的權益為限予以對銷。除非有證據顯示交易中已轉讓資產出現減值，在此情況下會即時於損益中確認，否則未變現虧損亦予以對銷。

於聯營公司投資乃按成本減去減值虧損於本公司財務狀況表列帳 (見附註2(j)(ii))。

(e) Fixed assets

Fixed assets are stated in the statement of financial position at cost less accumulated depreciation and impairment losses (see note 2(j)(ii)).

Depreciation is calculated to write off the cost of items of fixed assets, less their estimated residual value, if any, using the straight-line method over their estimated useful lives as follows:

The useful life of an asset, its depreciation method and residual value, if any, are reviewed annually.

Gains or losses arising from the retirement or disposal of an item of fixed assets are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

(f) Inventories

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the first-in, first-out cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

存貨乃按成本與可變現淨值兩者間較低者列帳。

成本乃使用先入先出的成本公式計算。成本包括所有購買成本、轉換成本及使存貨達致其目前的位置及條件所產生的其他成本。

可變現淨值乃在日常業務過程中的估計售價減估計完成成本及進行銷售所需的估計成本。

(f) Inventories (continued)

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(g) Trade and other receivables

Trade and other receivables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less allowance for impairment of doubtful debts (see note 2(j)(i)), except where the receivables are interest-free loans made to related parties without any fixed repayment terms or the effect of discounting would be immaterial. In such cases, the receivables are stated at cost less allowance for impairment of doubtful debts.

(h) Service contracts

When the outcome of a service contract can be estimated reliably, contract costs are recognised as an expense by reference to the stage of completion of the contract at the end of the reporting period. When it is probable that total contract costs will exceed total contract revenue, the expected loss is recognised as an expense immediately. When the outcome of a service contract cannot be estimated reliably, contract costs are recognised as an expense in the period in which they are incurred.

(f) 存貨 (續)

在出售存貨時，該等存貨的帳面值乃確認為有關收益獲確認期間的開支。存貨折價至可變現淨值得數額及所有存貨虧損乃確認為產生折價或虧損期間的開支。任何撥回存貨折價的數額乃確認為作出有關撥回的期間確認為開支存貨數額的減少。

(g) 應收貿易及其他應收帳款

應收貿易及其他應收帳款初步以有效權益方法按公平值確認入帳，其後則按經攤銷成本扣除呆壞帳減值撥備（見附註2(j)(i)）列帳，惟應收款項屬於向關連人士所提供且無任何固定還款期的免息貸款或貼現並無重大影響則除外。於該等情況下，應收帳款項乃按成本扣除呆壞帳減值撥備列帳。

(h) 服務合約

於報告期末，當服務合約能可靠地估計結果，所涉成本將根據完工百分比確認。當中如有總合約成本超出合約收益，預計虧損會立即確認。當服務合約不能可靠地估計結果，所發生成本將於發生時確認。

Service contracts in progress at the end of the reporting period are recorded at the net amount of costs incurred plus recognised profits less recognised losses and progress billings, and are presented in the consolidated statement of financial position as the “Gross amounts due from customers for service contract works” (as an asset) or the “Gross amounts due to customers for service contract works” (as a liability), as when applicable. Progress billings not yet paid by the customers are included in the consolidated statement of financial position under “Trade and other receivables”. Amounts received before the related work is performed are included in the consolidated statement of financial position under “Trade and other payables”.

(i) Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are either investments classified as held for trading or designated as at fair value through profit or loss upon initial recognition. These investments are subsequently measured at fair value. Gains or losses arising from changes in fair value of these investments are recognised in profit or loss.

(j) Impairment of assets

(i) Impairment of receivables

Receivables (including amounts due from related parties) that are stated at cost or amortised cost are reviewed at the end of each reporting period for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable.

If any event or change in circumstances indicates that the carrying amount may not be recoverable, an impairment loss is determined and recognised as follows:

- For trade and other receivables carried at cost or at amortised cost, the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition of these assets), where the effect of discounting is material. This assessment is made collectively where financial assets carried at amortised cost share similar risk characteristics, such as similar past due status, and have not been individually assessed as impaired. Future cash flows for financial assets which are assessed for impairment collectively are based on historical loss experience for assets with credit risk characteristics similar to the collective group.

If in a subsequent period the amount of an impairment loss decreases and the decrease can be linked objectively to an event occurring after the impairment loss was recognised, the impairment loss is reversed through profit or loss. A reversal of an impairment loss shall not result in the asset's carrying amount exceeding that which would have been determined had no impairment loss been recognised in prior years.

Impairment losses are written off against the corresponding assets directly, except for impairment losses recognised in respect of trade receivables, whose recovery is considered doubtful but not remote. In this case, the impairment losses for doubtful debts are recorded using an allowance account. When the group is satisfied that recovery is remote, the amount considered irrecoverable is written off against trade receivables directly and any amounts held in the allowance account relating to that debt are reversed. Subsequent recoveries of amounts previously charged to the allowance account are reversed against the allowance account. Other changes in the allowance account and subsequent recoveries of amounts previously written off directly are recognised in profit or loss.

Internal and external sources of information are reviewed at each reporting period to identify indications that the following assets may be impaired or, except in the case of goodwill, an impairment loss previously recognised no longer exists or may have decreased:

- fixed assets;
- investments in subsidiaries;
- investment in an associate; and
- goodwill.

If any such indication exists, the asset's recoverable amount is estimated. In addition, for goodwill, the recoverable amount is estimated annually whether or not there is any indication of impairment.

– Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

內部和外來的信息來源會在每一個報告期間審閱，以確定下列資產 (若有商譽除外) 有否出現減值跡象，或是以往確認的減值虧損不復存在或已經減少：

- 固定資產；
- 於附屬公司的投資；
- 於聯營公司的投資；及
- 商譽。

如果發現任何減值跡象，資產的可收回金額便會作出評估。此外，若商譽不作任何用途，則每年根據是否有任何減值跡象而對可收回金額作出重申評估。

– 計算可收回金額

資產的可收回金額是其公平值減去其出售成本及使用價值。在評估使用價值時，預期未來現金流量會按照當時市場對貨幣時間值及資產特定風險評估的稅前貼現率，貼現至其現值。如果資產所產生的現金流入基本不能獨立於其他資產所產生的現金流入，則會以可獨立產生現金流入的最小一組資產來釐定可收回金額 (即現金產生單位)。

– Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash-generating unit (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable), or value in use (if determinable).

– Reversals of impairment losses

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

(k) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or equity respectively.

減值虧損於一項資產或其所屬現金產生單位的帳面值超逾其可收回金額時在損益確認。就現金產生單位確認的減值虧損，首先會分攤以減低任何已分攤至現金產生單位 (或一組單位) 的任何商譽的帳面值，然後按比例減低單位 (或一組單位) 內其他資產的帳面值，惟將不會減低資產帳面值至低於其個別公平值減出售成本 (若可計量)，或其使用價值 (若可確定)。

– 減值虧損回撥

倘若用以釐定可收回金額的估計發生有利變化，便會將減值虧損回撥，有關商譽的減值虧損並不會回撥。

所回撥的減值虧損限於該資產於過往年度並無確認減值虧損時所釐訂的帳面值。所回撥的減值虧損於確認回撥年度計入損益。

(k) 所得稅

本年度所得稅包括本期稅項及遞延稅項資產及負債的變動。本期稅項及遞延稅項資產及負債的變動均在損益確認，但與直接確認為其他全面收益或權益項目相關者，則分別確認為其他全面收益或權益。

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

本期稅項乃按本年度應課稅收入，根據已生效或在報告期末實質上已生效的稅率計算出預期應付的稅項，並就過往年度應付稅項作出任何調整。

遞延稅項資產及負債分別由可抵扣及應課稅暫時差異產生。暫時差異是指資產及負債就財務呈報目的的帳面值與其稅基的差異。遞延稅項資產亦可以由未用稅項虧損及未用稅項抵免產生。

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities, if the company or the group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

(i) Financial guarantees issued

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the "holder") for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where the group issues a financial guarantee, the fair value of the guarantee (being the transaction price, unless the fair value can otherwise be reliably estimated) is initially recognised as deferred income within trade and other payables. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

(ii) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the group or the company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was determined.

The results of foreign operations are translated into HK\$ at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items, are translated into HK\$ at the closing foreign exchange rates ruling at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

(i) Service revenue

Service revenue comprises revenue from smartcard systems, radio frequency identification ("RFID"), information technology ("IT") and related service contracts.

Revenue from a fixed price service contract is recognised using the percentage of completion method, measured by reference to the percentage of contract costs incurred to date to estimated total contract costs for the contract. When the outcome of a service contract cannot be estimated reliably, revenue is recognised only to the extent of contract costs incurred that it is probable will be recoverable.

(ii) Consultancy income

Consultancy income is recognised when the consultancy services are rendered.

(iii) Income from maintenance services

Income from maintenance services is recognised on a straight-line basis over the term of the maintenance service contracts.

Income received or receivable in respect of services which have not been completed on or before the end of the reporting period are shown in the statement of financial position as deferred maintenance income.

Revenue is recognised when the goods are delivered at the customers' premises which is taken to be the point in time when the customer has accepted the goods and the related risks and rewards of ownership. Revenue excludes value-added tax or other sales taxes, if any, and is after deduction of any trade discounts.

(v) Dividend income

Dividend income from listed investments is recognised when the share price of the investment goes ex-dividend.

(vi) Interest income

Interest income is recognised as it accrues using the effective interest method.

(r) Employee benefits

(i) Short-term employee benefits and contributions to defined contribution retirement plans

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Termination benefits

Termination benefits are recognised when, and only when, the group demonstrably commits itself to terminate employment or to provide benefits as a result of voluntary redundancy by having a detailed formal plan which is without realistic possibility of withdrawal.

28 Employee retirement benefits

The group operates a Mandatory Provident Fund Scheme (the “MPF scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance and not previously covered by the defined benefit retirement plan. The MPF scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$30,000 effective from 1 June 2014. Contributions to the plan vest immediately.

The subsidiary operating in the PRC is required to participate in a defined contribution retirement scheme, organised by relevant government authorities for the staff in the PRC. The subsidiary is required to make contributions to the retirement scheme at specified rates of the basic salary of its employees in the PRC.

The group’s retirement scheme contributions charged to profit or loss for the year were HK\$521,326 (2014: HK\$538,123).

29 Share options schemes

The company operates the 2011 Scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the group’s operations. Eligible participants of the 2011 Scheme include the company’s directors, including independent non-executive directors, other employees of the group, suppliers of goods or services to the group, customers of the group, advisers and consultants, etc. The 2011 Scheme became effective on 8 August 2011 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

In addition, any share options granted to a substantial shareholder or an independent non-executive director of the company, or to any of their associates, in excess of 0.1% of the shares of the company in issue at any time or with an aggregate value (based on the price of the company's shares at the date of the grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within 21 days from the date of the offer upon payment of a nominal consideration of HK\$1 in total by the grantee. The exercise period of the share options granted is determinable by the directors, and commences after a certain vesting period and ends on a date which is not later than 10 years from the date of the offer of the share options or the expiry date of the 2011 Scheme, if earlier.

The exercise price of the share option is determinable by the directors, but may not be less than the higher of (i) the closing price of the company's shares on the date of the offer of the share options, (ii) the average closing price of the company's shares for the five trading days immediately preceding the date of the offer; and (iii) the nominal value of the share.

For this purpose the group defines net debt as total debt (which includes trade and other payables) plus unaccrued proposed dividends, less cash and cash equivalents and pledged deposits. Adjusted capital comprises all components of equity less unaccrued proposed dividends.

During the year, the group's strategy, which was unchanged from 2014, was to maintain the net debt-to-adjusted capital ratio below 50%. In order to maintain or adjust the ratio, the group may adjust the amount of dividends to be paid to owners, issue new shares, return capital to owners, raise new debt financing or sell assets to reduce debt.

The group's credit risk is primarily attributable to trade and other receivables. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

In respect of trade and other receivables, individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are generally due within 30 to 45 days (2014: 30 to 45 days) from the date of billing. Normally, the group does not obtain collateral from customers.

The group's exposure to credit risk is influenced mainly by the individual characteristics of each customer. The default risk of the industry and country in which customers operate also has an influence on credit risk but to a lesser extent. At the end of the reporting period, the group has a certain concentration of credit risk as 22% (2014: 13%) and 71% (2014: 53%) of the total trade receivables were due from the group's largest customer and the five largest customers respectively.

The maximum exposure to credit risk without taking account of any collateral held is represented by the carrying amount of each financial asset in the statement of financial position. Except for the financial guarantees given by the company for the year ended 31 March 2014 as set out in note 33, the group did not provide any other guarantees which would expose the group or the company to credit risk. The maximum exposure to credit risk in respect of these financial guarantees at 31 March 2014 was disclosed in note 33. At 31 March 2015, all the financial guarantees given by the company has been released (note 33).

Further quantitative disclosures in respect of the group's exposure to credit risk arising from trade and other receivables are set out in note 20.

35 Key sources of estimation uncertainty

The management had made the following estimates and assumptions in the process of applying the group's accounting policies, which are described in note 2, that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities as discussed below.

(a) Revenue and profit recognition

The group estimates the percentage of completion of the service contracts by reference to the proportion that contract costs incurred for work performed to date to the estimated total costs for the contracts. When the final cost incurred by the group is different from the amounts that were initially budgeted, such differences will impact the revenue and the profit or loss recognised in the period in which such determination is made. Budgeted costs of each project will be reviewed periodically and revised accordingly where significant variances are noted during the revision.

(b) Fixed assets and depreciation

The group determines the estimated useful lives and related depreciation charges for the group's fixed assets. This estimate is based on the historical experience of the actual useful lives of fixed assets of a similar nature and function.

The policy for impairment on receivables of the group is based on the evaluation of collectability and ageing analysis of accounts and on management's judgement. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables, including the current creditworthiness and the past collection history of each customer. If the financial conditions of customers of the group were to deteriorate, resulting in an impairment of their ability to make payments, additional impairment adjustments may be required.

(d) Write-down of inventories

A write-down of inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the write-down amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and the write-down amount charge/reverse in the period in which such estimate has been changed.

(e) Deferred tax

Estimating the amount for deferred tax assets arising from tax losses requires a process that involves forecasting future years' taxable income and assessing the group's ability to utilise tax benefits through future earnings. Where the actual future profits generated are more or less than expected, a recognition or reversal of the deferred tax assets may arise, which would be recognised in the consolidated statement of profit or loss and other comprehensive income for the period in which such a recognition or reversal takes place. While the current operations indicate that the unused tax losses cannot be utilised in the future, any changes in assumptions, estimates and tax regulations can affect the recoverability of this unrecognised deferred tax asset.
