SUMMARY

- The Group recorded a turnover of approximately HK\$437,000 for the three months ended 30 June 2015.
- Loss attributable to shareholders was approximately HK\$1,285,000.
- The directors of the Company (the "Directors") do not recommend the payment of dividend for the three months ended 30 June 2015.

RESULTS

1. General information

The Company was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law (Cap.22 Law 3 of 1961, as consolidated and revised) of the Cayman Islands on 6 December 2000. The Group engages in (i) property leasing; (ii) trading business; and (iii) an information technology industry. In which, it is a developer and provider of a range of Linux solutions including Linux operating systems, application systems run on Linux.

2. Basis of preparation

The unaudited consolidated results of the Group have been prepared in accordance with the new Hong Kong Financial Reporting Standards ("HKFRS") and Hong Kong Accounting Standards ("HKAS") (collectively "HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants and the disclosure requirements of the GEM Listing Rules. They have also been prepared under the historical convention.

The details of adoption of new and revised HKFRSs have been set out in the Company's annual report for the year ended 31 March 2015.

The accounting policies adopted in preparing the unaudited consolidated results are consistent with those applied in the preparation of the Group's annual financial statements for the year ended 31 March 2015.

The Group has not early adopted any new standards or interpretations that have been issued but are not yet effective.

3. Turnover and other revenue

Turnover represents the invoiced value of the Group's trading income, software development income and rental income, after allowances for returns and discounts and net of value added tax. An analysis of the Group's turnover and other revenue is as follows:

5. Taxation

Hong Kong profits tax is calculated at 16.5% (2014: 16.5%) of the estimated assessable profit for the period and taxation for other jurisdictions is calculated on the rates prevailing in the relevant jurisdiction. No provision for taxation has been made as the Group incurred a taxation loss for the period.

Deductible temporary differences have not been recognised in these financial statements owing to the absence of objective evidence in respect of the availability of sufficient taxable profits that are expected to arise to offset against the deductible temporary differences.

6. Loss per share

The calculation of basic loss per share for the three months ended 30 June 2015 is based on the loss attributable to owners of the Company of HK\$1,283,000 (2014: HK\$1,531,000) and the weighted average of 225,570,261 (2014: 208,273,725 (restated)) ordinary shares in issue during the period.

DIVIDEND

The Board does not recommend the payment of dividend for the three months ended 30 June 2015 (2014: Nil).

BUSINESS REVIEW

Since this year (2015), the recovery of the global economy was weak. The growth of the Chinese economy has also slowed down. However, the overall performance of the global real estate market remained stable, including major cities such as Beijing, Shanghai and Guangzhou in mainland China, where the demand for real estate property still has not decreased. With the injection of stable rental income from commercial property leasing in Shanghai, the Group's turnover in the first quarter of the year (April to June 2015) still increased as compared with the same period last year.

PROSPECTS

The global economy is slowly recovering currently and certain signs of recovery are positive, of which it is especially apparent for the US. Although the Chinese government sees the slowdown in economic growth as the new norm, maintaining economic stability and development, under the keynote of seeking progress in stability, is still one of the essential goals in the 13th five-year plan of the Chinese government.

In the process of China's gradual transition from the world factory to the world market, the development of the service sector in Shanghai is expected to remain a consistent growth. The demand for office will also increase steadily. However, it is predictable that the supply of office in Shanghai region will increase by year. The pressure of competition in the real estate market cannot be neglected as well. But given the location and quality of the commercial property of the Group, the revenue from the leasing business of the Group is expected to increase consistently.

Financial Performance

The Group's consolidated turnover for the three months ended 30 June 2015 amounted to approximately HK\$437,000 (2014: HK\$420,000). During the period under review, loss from operations for the period was HK\$1,050,000, compared to HK\$1,217,000 in the corresponding period of last year. Further, loss attributable to owners of the Company for the period was HK\$1,283,000 while the corresponding period of last year was HK\$1,531,000.

Neither the Company, nor any of its subsidiaries has purchased, sold or redeemed any of the Company's shares during the three months ended 30 June 2015.

AUDIT COMMITTEE

The Company has established an Audit Committee with written terms of reference in compliance with Rules 5.28 to 5.33 of the GEM Listing Rules. The Audit Committee comprises three independent non-executive directors, namely Ms. Lin Yan Jenny, Mr. Chu Meng Chi and Ms. Chan Mei Sze. The Audit Committee is chaired by Mr. Chu Meng Chi. The primary duties of the Audit Committee are to supervise the financial reporting process and internal control of the Company. The Audit Committee has reviewed the unaudited results of the Group for the three months ended 30 June 2014 and has provided advice and comment thereon.

CODE ON CORPORATE GOVERNANCE PRACTICES

The Company applied the principles and complied with all the code provisions as set out in the Code on Corporate Governance Practices (the Code) contained in Appendix 15 of the GEM Listing Rules throughout the Period, save for the deviations discussed below.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under the code provision A.2.1 stipulates that the roles of Chairman and Chief Executive Officer should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and Chief Executive Officer should be clearly established and set out in writing.

Mr. Wong Hoi Wong is both the Chairman and Chief Executive Officer of the Company who is responsible for managing the Board and the Group business. The Board considers that, with the present board structure and scope of business of the Group, there is no imminent need to separate the roles into two individuals as Mr. Wong is perfectly capable of distinguishing the priority of these roles in which he has been acting. However, the Board will continue to review the effectiveness of the Group corporate governance structure to assess whether the separation of the positions of Chairman and Chief Executive Officer is necessary.

NON-EXECUTIVE DIRECTORS

Under the Code Provision A.4.1, all the non-executive directors should be appointed for a specific term, subject to re-election. At present, the non-executive Directors are not appointed for a specific term, but are subject to retirement by rotation and re-election in accordance with the Company's Articles of Association.

CODE OF CONDUCT FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the code for securities transactions by the Directors set out in Rules 5.48 to 5.67 of the GEM Listing Rules as its own code of conduct regarding securities transactions by Directors. The Company confirmed that, having made specific enquiry from all Directors, the Directors have complied with the required standard of dealings and its code of conduct regarding securities transactions by the Directors for the three months ended 30 June 2015.
