DISCLOSEABLE TRANSACTION PROVISION OF FINANCIAL ASSISTANCE

On 16 August 2017, the Lender entered into the Loan Agreement with the Borrower, pursuant to which the Lender agreed to grant an unsecured loan in amount of HK\$4,000,000 (the “Loan Amount”) to the Borrower.

On 31 July 2017, the Lender entered into a loan agreement with the Borrower, pursuant to which the Lender agreed to grant an unsecured loan in amount of HK\$3,000,000 to the Borrower (the “Prior Transaction II”).

On 29 June 2017, the Lender entered into a loan agreement with the Borrower, pursuant to which the Lender agreed to grant an unsecured loan in amount of HK\$8,000,000 to the Borrower (the “Prior Transaction I”).

The Loan Amount plus the loan amount of the Prior Transactions I and II granted to the Borrower within a 12-month period is HK\$15,000,000. As the applicable percentage ratios set out in Rule 19.07 of the GEM Listing Rules with respect to the grant of the Loan Amount on an aggregated basis with the Prior Transactions I and II exceeds 5% but less than 25% in accordance with the GEM Listing Rules, the provision of Loan Amount constitutes a discloseable transaction of the Company under Chapter 19 of the GEM Listing Rules.

LOAN AGREEMENT

Date : 16 August 2017

Lender : Yvonne Credit Service Company Limited, being an indirect wholly-owned subsidiary of the Company

Borrower : Customer A

Loan Amount : HK\$4,000,000

Loan Period : one month expiring on 15 September 2017 or such later date to be agreed between the Lender and the Borrower

Repayment : Borrower shall repay the interest and the principal amount on the due date

Interest : 10% per annum

The Loan Amount granted to the Borrower was funded by internal resources of the Group.

INFORMATION OF THE BORROWER

Customer A is an individual. To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Borrower is the Independent Third Party and not connected with the Group.

The Loan Amount is unsecured and carry an interest rate of 10% per annum which was determined with reference to the factors including, among others, (i) the usual practice of the Group comparing to the Group's other clients; and (ii) the rules under section 24 of the Money Lenders Ordinance.

REASONS FOR AND BENEFITS OF THE PROVISION OF FINANCIAL ASSISTANCE

The Group is principally engaged in money lending business, property investment, financial instruments, retail business, medicine store and quoted shares investment in Hong Kong. The Lender is an indirect wholly-owned subsidiary of the Company and a money lender licensed in Hong Kong under the provisions of the Money Lenders Ordinance. The terms of the Loan Agreement are negotiated on an arm's length basis between the Lender and the Borrower. The Directors are of the view that entering into of the Loan Agreement is in the Group's ordinary and usual course of business; and on normal commercial terms within the meaning of the GEM Listing Rules. The Directors consider that the terms of the Loan Agreement are fair and reasonable and entering into of the Loan Agreement is in the interests of the Company and the Shareholders as a whole.

GENERAL

The Loan Amount plus the loan amount of the Prior Transactions I and II granted to the Borrower within a 12-month period are HK\$15,000,000. As the applicable percentage ratios set out in Rule 19.07 of the GEM Listing Rules with respect to the grant of the Loan Amount on an aggregated basis with the Prior Transactions I and II exceeds 5% but less than 25% in accordance with the GEM Listing Rules, the provision of Loan Amount constitutes a discloseable transaction of the Company under Chapter 19 of the GEM Listing Rules.
